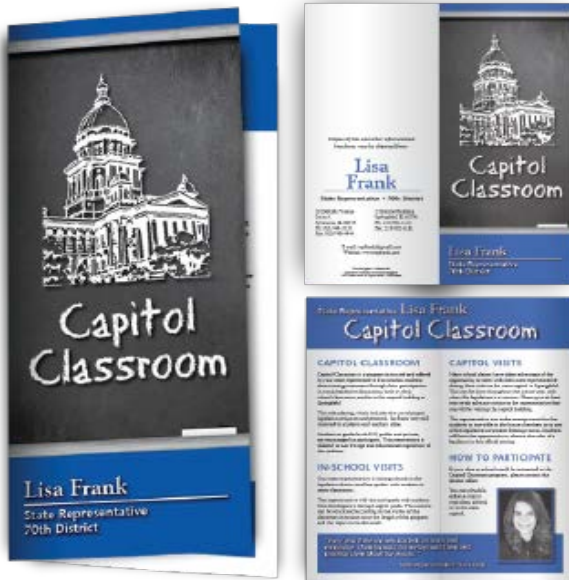
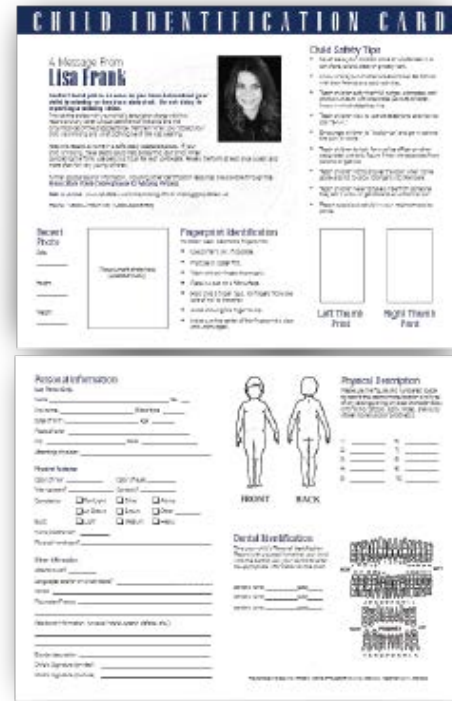


## Children/Teens



### Capitol Classroom

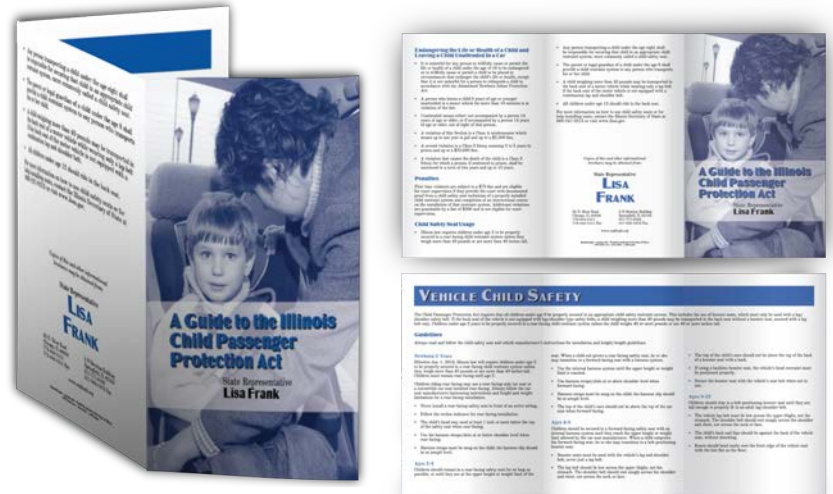
### Child Identification Card

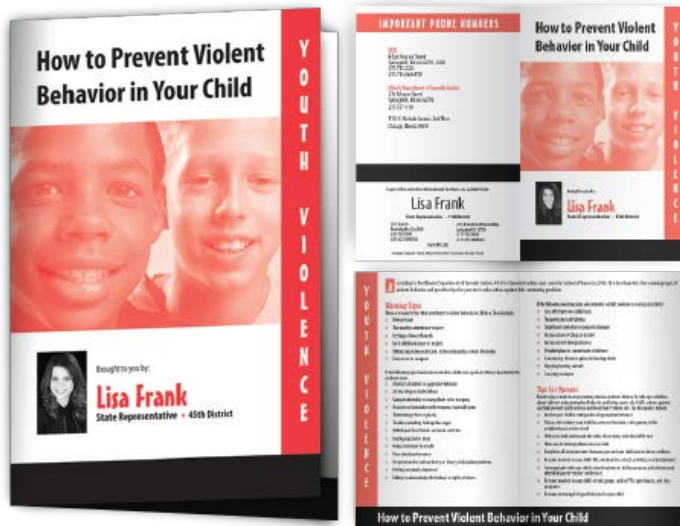


### A Guide to the Illinois Child Passenger Protection Act

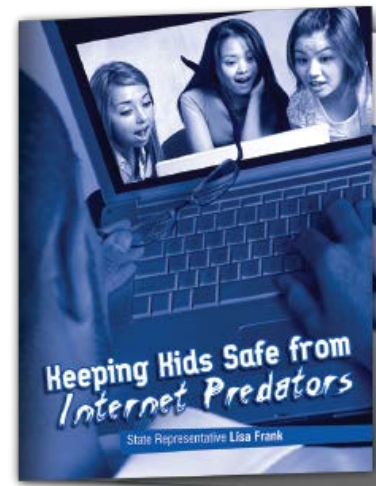

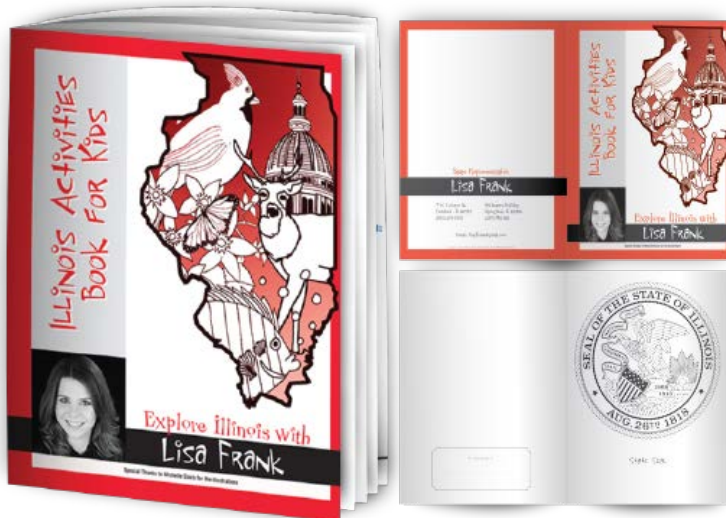
### How to Prevent Violent Behavior in Your Child

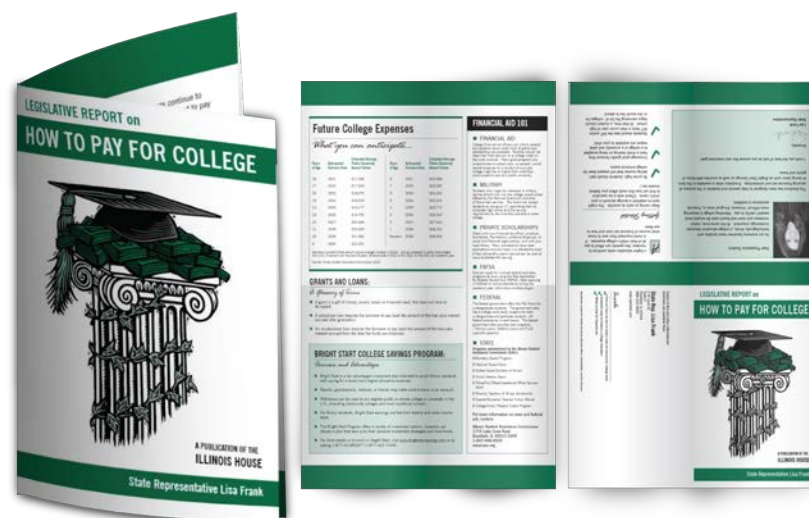


### Opioid Abuse: A Growing Epidemic
