## Illinois Democrats Retain Control; National Government Divided

The 2022 midterm election is expected to result in a divided Congress: Democrats will maintain control of the Senate, and Republicans took a slim majority in the House. Illinois' election results favored Democrats. Democrats will continue to hold all statewide offices; will maintain their veto-proof majority in the House and Senate; and gained one seat in Illinois' Congressional delegation.

J.B. Pritzker was elected to his second term as Governor (with Juliana Stratton as Lieutenant Governor). Kwame Raoul was re-elected as Attorney General, Susana Mendoza as Comptroller, and Michael Frerichs as Treasurer. Alexi Giannoulias was elected Illinois Secretary of State. Jesse White did not seek reelection after six terms in that office.

At publication time, one legislative race had not yet been decided: Jennifer "Jenn" Ladisch Douglass (D) vs. Deanne M. Mazzochi (R, incumbent), 45th House District.

Democrats will maintain veto-proof majorities in both houses. In the Senate, Republicans gained one net seat, but Democrats still have 40 seats, more than a supermajority. In the House, Democrats gained at least four net seats, for a total of 77.

After the 2021 redistricting, 28 members of the 102nd General Assembly ran for and were elected to the 103rd in different districts.

Thirty-eight members of the 103rd General Assembly won their first full terms in November 2022.



Thirteen Democrats will be new to the House, and three will return after being appointed to the 102nd General Assembly. Nine Republicans will be new.

In the Senate, six Democrats will be new, and three who were appointed to the 102nd General Assembly will return. Three Republicans will be new to the Senate, and one will return after being appointed. Three new Senators (a Democrat and two Republicans) will join the Senate after having served in the House in the 102nd General Assembly.

Democratic Senator Tammy Duckworth was re-elected to a second term in Congress. Illinois lost one Congressional seat after the 2020 Census.

## Biographies of New House Members

**Harry Benton (D-97, Plainfield)** is an ironworker and member of Ironworkers Local 444. He is a trustee in the Village of Plainfield, and has been on the board of his homeowners' association. He is an active volunteer in his community.



**Diane Blair-Sherlock (D-46, Villa Park)** has an associate's degree from the College of DuPage, a bachelor's degree in political science from Northern Illinois University, and a J.D. from John Marshall Law School. She has engaged in the private practice of law, and is an active volunteer on several boards and commissions.



**John M. Cabello (R-90, Machesney Park)** worked as a police officer and detective in South Beloit and Rockford. He represented the 68th district in the House from August 2012 through January 2021. He has also been a Harlem Township Trustee and a Winnebago County Board member.



**Mary Beth Canty (D-54, Arlington Heights)** has a B.A. in both English and literary and cultural studies from the College of William & Mary, and a J.D. from the University of Arizona. Her practice has focused on civil litigation, insurance coverage issues, project management, and change management. In 2019 she was elected to the Arlington Heights village board, where she serves as a trustee. In 2020 she was elected to the RTA board of directors. She is an active volunteer in her church and community.



**Sharon Chung (D-91, Bloomington)** attended Illinois Wesleyan University. In 2018 she was elected to the McLean County Board, where she has served on the Land Use and Development, Health, and Justice Committees. She is a professional violist and violinist.



**Jed Davis (R-75, Newark)** has a bachelor's degree in civil engineering from Valparaiso University. He currently is a regional director for an international energy company, and the president of the board of Parkview Christian Academy in Yorkville. He has served as a Village of Newark trustee, and is a licensed foster parent.



**Laura Faver Dias (D-62, Grayslake)** has a B.S. in secondary social studies education from Indiana University and an M.A. in bicultural education from Wayne State University. She held a social studies teaching license for 12 years; served as a legislator's district director; and had a leadership role for the Lake County Democratic Women. She served on Grayslake's Economic Development Commission in 2018 before being elected as a village trustee in 2021. She is involved in her church and community organizations, and owns rental real estate.



**Bradley Fritts (R-74, Dixon)** has a bachelor's degree in agricultural and consumer economics from the University of Illinois at Urbana-Champaign. He is a farmer, and serves as a substitute teacher in winter months. He serves as a precinct committeeman on the Lee County Republican Central Committee. He is a member of St. Patrick's Church, the Lee County Farm Bureau, and the Knights of Columbus, and volunteers with the Community Food Pantry, Meals on Wheels, and Buddy Bags of Dixon.



**Angelica Guerrero-Cuellar (D-22, Chicago)** was appointed to the House in February 2021 to replace Edward Guerra Kodatt, who had resigned a few days after being appointed to replace Michael Madigan. She has now been elected. She has a B.A. in international relations from Roosevelt University, and is an auxiliary board member for the National Museum of Mexican Art. In the House, she serves on the Appropriations—General Services; Health Care Availability & Access; Mental Health & Addiction; Police & Fire; Transportation: Vehicles & Safety; and Transportation: Regulation, Roads & Bridges Committees.

**Matt Hanson (D-83, Aurora)** is an engineer with the Burlington Northern Santa Fe Railroad. He has served on the Kane County Board and the Kane County Forest Preserve Board.



**William E. Hauter, M.D. (R-87, Morton)** graduated from the University of Illinois College of Medicine, and is board-certified in Emergency Medicine and Anesthesiology. He is a partner at Associated Anesthesiologists; an emergency physician at OSF Saint Francis Medical Center in Peoria; and an assistant clinical professor at the University of Illinois College of Medicine—Peoria. He was elected to the Tazewell County Board in 2020, and has been an officer in the Illinois Society of Anesthesiologists and the Peoria Medical Society. He and his wife are active in their church, and in adoption and pregnancy center ministries.



**Norma Hernandez (D-77, Melrose Park)** has a bachelor's degree in social work from Aurora University, and a master's degree in urban planning and policy from the University of Illinois at Chicago. She has worked in the foster care system and as an urban planner at the Great Cities Institute at the University of Illinois at Chicago. She was recently elected a trustee of Triton Community College.



**Hoan Huynh (D-13, Chicago)** has a bachelor's degree from Yale University and a master's degree from Harvard University, and has completed coursework at the University of Cambridge and University of Chicago. He previously was the investments and innovation lead at a social impact investments firm in Chicago. He has led social innovation initiatives at several technology startups, and conducted public policy research. A refugee from Vietnam, he is involved in a nonprofit providing language access for immigrant and refugee communities, and other organizations seeking to end homelessness and help veterans and small businesses.



**Lilian Jiménez (D-4, Chicago)** is a lawyer and Associate Director of the Illinois Department of Human Services' Office of Welcoming Centers. She previously served as Director of Policy and Chief of Staff for Jesús "Chuy" Garcia when he was a Cook County Commissioner, and as manager of the Illinois Department of Labor's Fair Labor Standards Division. She has a B.A. in Latin American and Latino studies and political science from DePaul University, and a J.D. from DePaul University College of Law.



**Gregg Johnson (D-72, East Moline)** retired after 32 years with the Illinois Department of Corrections, where he worked as a corrections officer and then as a supply supervisor. After retiring, he became president of his local union.



**Michael Kelly (D-15, Chicago)** was appointed to the House in November 2021 to replace John D'Amico, and has now been elected. He has a degree in business management from Quincy University, and has been a Chicago firefighter for 18 years. He also worked as an elementary school athletic coach and athletic director. His community involvement includes being a member of the Mayfair Park Advisory Council and Saint Patrick High School Advisory Council. In the House, he serves on the Cities & Villages; Police & Fire; and Transportation: Vehicles & Safety Committees.



**Cyril Nichols (D-32, Chicago)** was appointed to the House in April 2021 to replace André Thapedi, and has now been elected. He is a graduate of Colby College in Kansas and Columbia College in Chicago. He has worked for the Community Youth Creative Learning Experience, Chicago Park District, Chicago Youth Centers, YMCA, Cunningham Children's Home, and several institutions of higher education. He also created the Ashburn Family Youth Center. His House assignments are to the Transportation: Regulation, Roads & Bridges, and Elementary & Secondary Education: Administration, Licensing & Charter Schools Committees.

His professional career has been in nonprofit and government organizations. Most recently, he was a Cook County Recovery Specialist with the National Partnership for New Americans, helping small businesses access loans and grants during the COVID-19 pandemic, and preparing proposals for long-term pandemic recovery.



**Abdelnasser Rashid (D-21, Bridgeview)** has a B.A. in social studies and computer science from Harvard University; holds a professional certificate in municipal finance from the University of Chicago's Harris School of Public Policy; and is completing an M.B.A. at the University of Chicago Booth School of Business. He currently works for the Amalgamated Transit Union. He has served as policy director to Cook County officeholders; worked for the Illinois Coalition for Immigrant and Refugee Rights; and been on the board of directors of the Syrian Community Network.



**Wayne A. Rosenthal (R-108, Morrisonville)** is a family farmer and retired Brigadier General in the Illinois Air National Guard. He has a B.A. in mathematics from the former Sangamon State University (now the University of Illinois at Springfield). He represented the 98th House district from 2011 to 2012, and the 95th district from 2013 to January 2015. He then served as Director of the Illinois Department of Natural Resources until 2019.



**Jennifer Sanalidro (R-48, Hanover Park)** is a small business owner and a sales executive for a packaging company. She volunteers at her children's school, and with groups including a foundation for children with sudden arrhythmic death syndromes (SADS). Her family attends Corpus Christi Catholic Church in Carol Stream.



**Dr. Kevin Schmidt (R-114, Millstadt)** has a Doctor of Chiropractic degree and B.S. in human biology from Logan University. He owns and operates Schmidt Chiropractic in Millstadt and Freeburg. He has been president of the Millstadt Jaycees and Optimist Club, and a board member of the Millstadt Chamber of Commerce. He is a member of the Masons, Shriners, and NRA.



**Nabeela Syed (D-51, Palatine)** graduated from the University of California, Berkeley with a degree in political science and business. She worked for a nonprofit in digital strategy supporting civic engagement efforts, and has managed local school board campaigns. She is active in the Islamic Society of Northwest Suburbs.



**Dennis Tipsword, Jr. (R-105, Metamora)** has a B.S. in law enforcement administration from Western Illinois University, and is a graduate of the Police Training Institute of the University of Illinois and the School of Police Staff and Command at Northwestern University. He has been a police officer for 28 years, and now serves as Chief Deputy Sheriff of Woodford County. He is also the owner of an ammunition manufacturing company. His other service includes being a Woodford County Republican Precinct Committeeman and a youth baseball and hockey coach.



**Travis R. Weaver (R-93, Edwards)** has an M.B.A. from Northwestern University and a B.A. in finance and marketing from the University of Alabama. **Javier Loera Cervantes (D-1, Chicago)** studied visual communications at the International Academy of Design and Technology, and labor studies at the University of Illinois at Chicago School of Labor. He worked for 12 years at the Service Employees International Union, becoming coordinator for its nursing home division. He has also hosted a community podcast for small businesses and community members. After being elected in November 2022 to the seat vacated by retiring Senator Antonio Muñoz, he was also appointed to fill that seat for the remainder of the 102nd General Assembly.



**Andrew S. Chesney (R-45, Freeport)** represented the 89th House district from 2018 to 2022, and has now been elected to the Senate. He has a degree in communications from Arizona State University. He has been a Freeport City Council member; a board member for the Regional Access Mobilization Project; and a mentor with Big Brothers Big Sisters.



**Mary Edly-Allen (D-31, Libertyville)** represented the 51st House district in the 101st General Assembly; she has now been elected to the Senate. She has a B.A. in education from Northeastern Illinois University, and a master's degree in curriculum and instruction with bilingual certification from National Louis University. She is the assistant director of adult education at Mundelein High School, and teaches night classes to English language learners. She also co-founded an educational nonprofit called Foundation46, and was a founding member of her school district's diversity committee. She is active in many Lake County community organizations, and has served on the board of the Illinois Science Olympiad.



**Michael W. Halpin (D-36, Rock Island)** represented the 72nd House district since 2017, and has now been elected to the Senate. He has a B.A. in political science from Roger Williams University, and a J.D. from the University of Illinois at Urbana-Champaign. He completed a clerkship with former Illinois Supreme Court Justice Rita B. Garman, and has been in the private practice of law since 2010. He has served on the board of directors for Bridging the Gap: Stand Down for Homeless Veterans.





**Erica Harriss (R-56, Glen Carbon)** has a B.A. in speech communication and business from Southern Illinois University at Edwardsville. She was elected to the Madison County Board in 2016, where she chaired the Personnel Committee and was a member of the Finance, Government Operations, and Grants Committees. She is also a small business owner and community volunteer.



**Seth Lewis (R-24, Bartlett)** represented the 45th House district in the 102nd General Assembly, and has now been elected to the Senate. He has a degree in manufacturing engineering from the University of Iowa. She has served with a number of bodies promoting education, including the Illinois Early Learning Council and the Kindergarten Transition Advisory Committee of the P-20 and Early Learning Councils. In the Senate, she is vice-chairwoman of the Higher Education Committee and sub-vice-chairwoman of the Appropriations—Education and Redistricting—Chicago Northwest Committees. She also serves on the Education; Health; Human Rights; and Revenue Committees, and the Children & Family and Public Health Subcommittees.



**Mike Porfirio (D-11, Bridgeview)** graduated from the U.S. Naval Academy and served over 6 years on active duty overseas. He later deployed to Central and South America on a humanitarian mission, and served as a Naval Science Instructor and Company Officer at Purdue University. **Willie Preston (D-16, Chicago)** has studied at Chicago State University and worked as a carpenter, and is a small business owner. He also has served on his local school council, and on the board of the Chicago Metropolitan YMCA.



**Mike Simmons (D-7, Chicago)** was appointed to the Senate in February 2021, replacing Heather Steans after her resignation, and has now been elected. He has a B.A. in political science from Amherst College, and is the founder and CEO of Blue Sky Strategies & Co. He has served as the Deputy Commissioner and Policy Director of the Chicago Department of Planning and Development, and as Deputy Director of My Brother's Keeper Alliance. In the Senate, he is vice-chairman of the Healthcare Access and Availability Committee, and also serves on the Behavioral and Mental Health; Tourism and Hospitality; Transportation; and Appropriations—Health Committees, as well as being a sub-vice-chairman of a redistricting committee.



**Doris Turner (D-48, Springfield)** was appointed to the Senate in February 2021 to replace Andy Manar, who joined Governor Pritzker's administration, and has now been elected. She worked in state government for 33 years, mostly in the Department of Public Health. **Sally J. Turner (R-44, Beason)** was appointed to the Senate in January 2021 to replace William Brady, and has now been elected. She is a graduate of the University of Illinois, and has a master's degree in organizational leadership from Lincoln Christian University. She owns Sally J. Turner Government Consulting, and served as Logan County Clerk and Recorder from 1994 to 2018. In the Senate, she is minority spokesperson on the Tourism and Hospitality Committee, and serves on the Ethics; Higher Education; Human Rights; Public Safety; Revenue; State Government; Appropriations—Education; Appropriations—Health; Appropriations—State Law Enforcement; Appropriations—Criminal Justice; and Redistricting—West Central Illinois Committees.

## Illinois Democrats Retain Control; National Government Expected to be Divided *(continued from p. 1)*

The House delegation now has 14 Democrats and 3 Republicans—a gain of one Democrat and a loss of two Republicans. Democrat Jonathan L. Jackson was elected to replace retiring Representative Bobby Rush, and Democrat Eric Sorensen will replace Representative Cheri Bustos. Democrat Delia Ramirez will replace Representative Marie Newman; Democrat Nikki Budzinski will replace Republican Representative Rodney Davis. Finally, Republican Darin LaHood, who represented the former 18th Congressional district, was elected to the 16th district to replace Representative Adam Kinzinger. All other Illinois Congressional incumbents were re-elected.

The results of a statewide vote on a proposed constitutional amendment to guarantee workers the right to organize and bargain collectively have not yet been officially determined as of print time. It needs a 60% supermajority (or majority of all voters at the election) to be adopted.
