1 AMENDMENT TO HOUSE BILL 3337

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 3337 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The Illinois Municipal Code is amended by  
5 changing Section 3.1-25-95 and by adding Section 5-2-20 as  
6 follows:

7 (65 ILCS 5/3.1-25-95) (from Ch. 24, par. 3.1-25-95)

8 Sec. 3.1-25-95. Incorporated town officers.

9 (a) For each ~~the~~ general municipal election in the Town of  
10 Cicero, ~~to be held in the year 1985 in every incorporated town~~  
11 ~~with a population of 25,000 or more by the last official~~  
12 ~~census, and every 4 years thereafter,~~ the municipal clerk  
13 shall certify the names of the candidates to the proper  
14 election authority as provided by the general election law. A  
15 president, a clerk, an assessor, a collector, and a supervisor  
16 shall be elected for a term of 4 years and until their

1 successors are elected and have qualified. Whenever a vacancy  
2 occurs in the office of any of the specified officers, the  
3 vacancy shall be filled for the remainder of the term at the  
4 next general municipal election in that incorporated town as  
5 provided in Section 3.1-10-50. Whenever an election is held  
6 for this purpose, the municipal clerk shall certify the office  
7 to be filled and the candidates for that office to the election  
8 authorities as provided in the general election law. During  
9 the period from the time a vacancy occurs until a clerk,  
10 assessor, collector, or supervisor is elected and has  
11 qualified, the vacancy may be filled by appointment by the  
12 president and board of trustees of that incorporated town  
13 voting jointly. During the period from the time a vacancy  
14 occurs until a president is elected and has qualified, the  
15 vacancy may be filled by appointment by the board of trustees  
16 of that incorporated town.

17 (b) For every other incorporated town other than the Town  
18 of Cicero with a population of 25,000 or more by the last  
19 decennial census, a president must be elected every 4 years at  
20 the general municipal election with other officers to be  
21 elected or appointed as set forth by ordinance of the  
22 corporate authorities. Each officer shall continue to hold  
23 office until the officer's successor is selected and  
24 qualified. Each vacancy must be filled under Section  
25 3.1-10-50.

26 (c) The changes made to subsection (a) by this amendatory

1 Act of the 103rd General Assembly are declarative of existing  
2 law and shall be applied retroactively when substantively  
3 applicable, including all pending actions without regard to  
4 when the cause of action accrued.

6 (65 ILCS 5/5-2-20 new)

7 Sec. 5-2-20. Incorporated town officers. For each  
8 incorporated town that has adopted this Article, a president  
9 must be elected every 4 years at the general municipal  
10 election with other officers to be elected or appointed as set  
11 forth by ordinance of the corporate authorities. Each officer  
12 shall continue to hold office until the officer's successor is  
13 selected and qualified. Each vacancy must be filled under  
14 Section 3.1-10-50.

15 Section 99. Effective date. This Act takes effect upon  
16 becoming law."
