WHEREAS, Article IV, Section 5(b) of the Illinois Constitution empowers the President of the Senate and the Speaker of the House to convene special sessions of the General Assembly;

WHEREAS, Public Act 100-0021 provides for the Illinois State Board of Education to issue payments to school districts across Illinois pursuant to an evidence-based funding formula;

WHEREAS, the Governor vetoed Senate Bill 1 which provided for an evidence-based funding formula;

WHEREAS, the State has failed to issue two payments to school districts due to the veto of Senate Bill 1 and the absence of a law providing for an evidence-based funding formula;

WHEREAS, the continued absence of a law providing for an evidence-based funding formula threatens public education for millions of students across Illinois;

WHEREAS, a demonstrable emergency exists which requires immediate action by the General Assembly;

NOW THEREFORE, pursuant to Article IV, Section 5(b) of the Illinois Constitution, and in conformity with the Special Session Act, 25 ILCS 15, A SPECIAL SESSION OF THE 100<sup>th</sup> GENERAL ASSEMBLY IS HEREBY PROCLAIMED AND CALLED AS FOLLOWS:

1. The Special Session shall convene at 11:00 a.m. on August 28, 2017, at the State Capitol in Springfield, Illinois.
2. The purpose of the Special Session shall be to consider legislation and legislative actions that would establish, by law, an evidenced-based funding formula to provide State funding to school districts.
3. The Secretary of State, the Secretary of the Senate, and the Clerk of the House shall take whatever reasonable steps necessary to notify the members of the purpose and the date and time set for convening this emergency Special Session.

**RESOLVED**, that the Clerk inform the Senate that a majority of the House of Representatives has assembled, pursuant to the proclamation of the Governor, convening a Fifteenth Special Session of the General Assembly, and are now ready for the transaction of business.

#### **ADJOURNMENT RESOLUTION HOUSE JOINT RESOLUTION 1**

**RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE FIFTEENTH SPECIAL SESSION THEREOF, THE SENATE CONCURRING HEREIN**, that when the House of Representatives adjourns the Fifteenth Special Session, the House shall remain in continuous session and stands adjourned until the call of the Speaker, and when the Senate adjourns the Fifteenth Special Session, the Senate shall remain in continuous session and stands adjourned to the call of the President.

The motion prevailed and the resolution was adopted.

**SENATE BILL ON SECOND READING**

SENATE BILL 1947. Having been read by title a second time on August 16, 2017, and held on the order of Second Reading, the same was again taken up.

The foregoing motion prevailed and the amendment was adopted.

There being no further amendment(s), the bill, as amended, was advanced to the order of Third Reading.

**SENATE BILL ON THIRD READING**

The following bill and any amendments adopted thereto were reproduced. Any amendments still pending upon the passage or defeat of a bill on Third Reading are automatically tabled pursuant to Rule 40(a).

On motion of Representative Davis, SENATE BILL 1947 was taken up and read by title a third time. A three-fifths vote is required.

And the question being, "Shall this bill pass?" it was decided in the negative by the following vote:

46, Yeas; 61, Nays; 5, Answering Present.

(ROLL CALL 2)

This bill, as amended, having failed to receive the votes of three-fifths of the Members elected, was declared lost.

And on that motion, a vote was taken resulting as follows:

63, Yeas; 45, Nays; 0, Answering Present.

(ROLL CALL 3)

Having failed to receive the votes of three-fifths of the Members elected, the motion was declared lost.

And the House refused to concur with the Senate in the passage of the bill, over the Governor's Specific Recommendations for Change.

Ordered that the Clerk inform the Senate.

80, Yeas; 23, Nays; 2, Answering Present.

### **SENATE BILL ON THIRD READING**

The following bill and any amendments adopted thereto were reproduced. Any amendments still pending upon the passage or defeat of a bill on Third Reading are automatically tabled pursuant to Rule 40(a).

On motion of Representative Davis, SENATE BILL 1947 was taken up and read by title a third time. A three-fifths vote is required.

Pending discussion, Representative Zalewski moved the previous question.

And the question being, "Shall the main question be now put?" it was decided in the affirmative.

The question then being, "Shall this bill pass?" it was decided in the affirmative by the following vote:

73, Yeas; 34, Nays; 3, Answering Present.

(ROLL CALL 5)

This bill, as amended, having received the votes of three-fifths of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate thereof and ask their concurrence in the House amendment/s adopted thereto.

At the hour of 6:56 o'clock p.m., Representative Currie moved that the House do now adjourn.

The motion prevailed.

And in accordance therewith and pursuant to HOUSE JOINT RESOLUTION 1, the House stood adjourned until call of the Chair.
