HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 110

Offered by Representative Martwick:

WHEREAS, The Founders of our country empowered state legislators to be guardians of liberty against future abuses of power by the federal government; and

WHEREAS, The federal government has created a crushing national debt through improper and imprudent spending; and

WHEREAS, The federal government has invaded the legitimate roles of the states through the manipulative process of federal mandates, most of which are unfunded to a great extent; and

WHEREAS, The federal government has ceased to live under a proper interpretation of the Constitution of the United States; and

WHEREAS, It is the solemn duty of the states to protect the liberty of our people - particularly for the generations to come - by proposing Amendments to the Constitution of the United States through a Convention of the States under Article V for the purpose of restraining these and related abuses of power; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the State of Illinois hereby makes application to Congress under the provisions of Article V of the Constitution of the United States for the calling of a convention of the states limited to proposing amendments to the Constitution of the United States that impose fiscal restraints on the federal government, limit the power and jurisdiction of the federal government, and limit the terms of office for its officials and for members of Congress; and be it further

RESOLVED, That the Secretary of State is hereby directed to transmit copies of this application to the President and the Secretary of the United States Senate, the Speaker and the Clerk of the United States House of Representatives, and the members of the Senate and House of Representatives from this State; copies shall also be transmitted to the presiding officers of each of the legislative houses in the several states, requesting their cooperation; and be it further

RESOLVED, That this application constitutes a continuing application in accordance with Article V of the Constitution of the United States until the legislatures of at least two-thirds of the several states have made applications on the same subject; and be it further

RESOLVED, That a copy of this resolution be delivered to the Secretary of State.

HOUSE RESOLUTION 112

Offered by Representative Batinick:

WHEREAS, The State of Illinois has now completed a period of over two years of budget uncertainty; during the most recent 18 months of this period, the State has not been operating under a constitutional balanced budget of any kind; since January 1, 2017, Illinois has not even had a stopgap budget; and

WHEREAS, On February 1, 2017, Fitch Ratings, one of the three largest credit rating firms in the United States, again lowered the State's credit rating from BBB+ with a negative outlook to BBB with a negative outlook; the new rating is only one step above the lowest possible rating for a debtor to maintain as an issuer of investment-grade financing; and

WHEREAS, Steps to resolve this crisis can be listed in 1-2-3 order as the "1-2-3 Plan"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that first, Illinois will complete a budget to meet its immediate spending needs through 2018 that is based on the revenue the State will receive from existing revenue sources, and includes immediate pension reform; and be it further

RESOLVED, That second, Illinois will complete a plan to pay off the State's unpaid bills; this can be done in the form of revenue bonds or the sale of State assets; and be it further

RESOLVED, That third, Illinois will conduct a thorough discussion about possible reforms to the operations of State and local government units, and that this will be an integral part of any discussion about additional sources of funding for the general revenue fund; and be it further

RESOLVED, That suitable copies of this resolution shall be distributed to the Governor of Illinois, the Speaker of the Illinois House of Representatives, and the President of the Illinois Senate.

HOUSE RESOLUTION 113

Offered by Representative Stratton:

WHEREAS, Public Act 95-565 directed the Illinois Department on Aging (IDoA) to create a "determination of need" (DON) tool to accurately determine the level of need for services for seniors and persons with disabilities; and

WHEREAS, In Illinois, the Community Care Program serves people age 60 and older, and the Home Services Program (HSP) serves people with disabilities age 59 and younger; both programs utilize the same Determination of Need (DON) tool to determine program eligibility and allocate service dollars; and

WHEREAS, The Community Care Program operated by the Department on Aging provides home care services to over 100,000 elder adults, ensuring that they are able to stay in their homes and avoid the more costly institutional settings; and

WHEREAS, The Home Services Program operated by the Department of Human Services serves 26,000 adults with disabilities allowing them to stay and function in their own homes and improve their quality of life; and

WHEREAS, Governor Rauner has repeatedly tried to increase the DON Score from 29 to 37, placing thousands of seniors and people with disabilities at risk of losing services and ending up in institutional care; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we oppose any further attempts to raise the DON Score; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Department on Aging, the Department of Human Services, and Governor Rauner.

HOUSE RESOLUTION 114

Offered by Representative Feigenholtz:

WHEREAS, President Donald Trump is taking steps to fulfill his campaign promise to build a wall along the border between the United States and Mexico; and

WHEREAS, President Trump has suggested that a tariff of 20% should be placed on products imported from Mexico to pay for the border wall, which would essentially result in Americans paying for the wall; and

WHEREAS, Mexico is the second-largest export partner of Illinois and the third-largest import partner; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we formally invite Mexican President Enrique Pena Nieto to address a joint session of the Illinois General Assembly to discuss the proposed border wall, the impact of a 20% tariff on goods imported from Mexico to pay for the wall, and the economic impact that such a wall and President Trump's policies will have on Illinois and Mexico; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Enrique Pena Nieto, President of Mexico.

HOUSE RESOLUTION 115

Offered by Representative Fine:

WHEREAS, On January 27, 2017, President Donald J. Trump signed an executive order, "Protecting the nation from foreign terrorist entry into the United States", purportedly to protect Americans from terrorist attacks by foreign nationals admitted to this country; and

WHEREAS, The President's order barred citizens of seven Muslim-majority nations - Iran, Iraq, Libya, Somalia, Sudan, Syria, and Yemen - from entering the United States for 90 days; it suspended all refugee admissions to the country for 120 days, and indefinitely barred Syrian refugees from entering the United States; and

WHEREAS, The President's cruel, unnecessary, and bigoted executive order produced chaos in the United States immigration system in the hours and days immediately following its execution; and

WHEREAS, The order caused widespread confusion in the air and on the ground at U.S. and international airports; it resulted in travelers being detained for hours and questioned by U.S. authorities without legal representation, in some instances separating small children from their parents, and in one case, delaying an urgent medical appointment of a four-month old girl with a heart condition; it prompted vetted refugees and legal residents en route to the United States to be blocked and turned back; it triggered mass protests at airports throughout the country, including in Chicago, and it spurred legal action against the President; and

WHEREAS, President Trump's malicious and arbitrary order bears a striking resemblance to another episode when, during one of the darkest times in human history, America closed its doors to frightened refugees in search of sanctuary, ultimately resulting in the murder of many of them; in 1939, the German ocean liner, the SS St. Louis, set out for the United States by way of Cuba from Hamburg, Germany, with 900 Jewish refugees seeking asylum from Nazi persecution; the passengers were denied entry to the United States, Cuba, and Canada because of strict immigration quotas and were forced to return to Europe; more than half of the Voyage of the SS St. Louis passengers who returned to Europe were killed by Nazis in the Holocaust; and

WHEREAS, History has shown that executive decisions about immigration, refugee resettlement, and religious bans can have tragic life-or-death consequences that may go unrecognized for too long; and

WHEREAS, The United States, and Illinois in particular, have always welcomed, supported, and protected people of all races, ethnicities, religions, and nationalities, so much so that the very self-definition of our country, as expressed both in our founding documents and in our public consciousness, relies upon an open embrace of immigrants and refugees; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn President Donald J. Trump's executive order barring refugees from the United States and call on him to uphold and protect the values of all of the people of this great nation, which was founded by immigrants on principles that include religious freedom and the notion that all people are welcome and created equal; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President and Vice-President of the United States, the Majority and Minority Leaders of the United States Senate, the Speaker and Minority Leaders of the United States House of Representatives, and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 116

Offered by Representative McSweeney:

WHEREAS, Families have already suffered catastrophic damages as a result of the budget impasse and, according to the Pew Center, a food and drug tax is the most regressive tax that punishes citizens on a fixed income; and

WHEREAS, In 2015, there were a total of 160,569,757 retail prescription drugs filled at pharmacies in Illinois; and

WHEREAS, Prescription drug prices increased 12.6% in 2014, outpacing inflation; increasing taxes for prescription drugs will become more financially straining for Illinois residents, especially since 8.8% of Illinois senior citizens live in poverty; and

WHEREAS, According to the Consumer Healthcare Products Association, over-the-counter (OTC) medicines are a reliable and affordable way of maintaining wellness for millions of American families; and

WHEREAS, OTC medicines not only treat the symptoms of common ailments but also help prevent a number of costly chronic conditions through products like smoking cessation programs; and

WHEREAS, The average American household spends approximately \$185 on non-prescribed OTC medicines per year while the average senior citizen spends \$356 yearly; and

WHEREAS, Many states have already acknowledged the therapeutic value and cost-effectiveness of OTC medicines and allow a retail sales tax exemption for the purchase of these products; Florida, Maryland, Minnesota, New Jersey, New York, Pennsylvania, Rhode Island, Texas, Virginia, and the District of Columbia do not levy sales taxes on OTC medicines; and

WHEREAS, The value of OTC medicines in the United States found that OTC medicines offer \$102 billion in annual savings relative to available alternatives; and

WHEREAS, The Consumer Healthcare Products Association advocates for policies that support access to OTC medicines by exempting them from sales tax; and

WHEREAS, Food security is an issue that places an enormous burden on struggling families within Illinois; and

WHEREAS, According to the Illinois Commission to End Hunger, almost 1.7 million Illinois residents still face food insecurity, a number greater than the entire populations of Hawaii, Montana, and 10 other states; and

WHEREAS, According to the Illinois Commission to End Hunger, more than 449,000 low-income Illinois children participate in the National School Lunch Program but do not receive school breakfast; it is increasingly vital that food in the State be at a reasonable price; and

WHEREAS, The lowest-income Americans spent an average of \$3,667 on food in 2014, which amounts to 31.4% of their income according to the United States Department of Agriculture; and

ARTICLE VII
LOCAL GOVERNMENT

SECTION 13. UNFUNDED MANDATES

(a) If the General Assembly or any State executive action requires a unit of local government to establish, expand, or modify its activities in such a way as to necessitate additional expenditures of revenue by the unit of local government, then the State must provide funds to reimburse the unit of local government for the costs necessary to carry out the mandated requirement, except that the General Assembly may, but need not, provide funds for the following mandates:

(1) legislatively mandated requirements requested by the unit of local government affected; and

(2) legislatively mandated requirements that became effective before the effective date of this Section or State executive actions initially implementing legislation that became effective before the effective date of this Section.

(b) A mandated requirement that is not funded is not enforceable while not funded unless the bill implementing the mandated requirement passed with the concurrence of at least three-fourths of the members elected to each house of the General Assembly and specifically states that it is a non-reimbursable mandate under this subsection.

They shall keep the public records and maintain a residence at the seat of government during their terms of office. (Source: Illinois Constitution.)

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, ~~or Comptroller of the Treasury Comptroller or Treasurer~~, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election. (Source: Illinois Constitution.)

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, ~~or Comptroller of the Treasury Comptroller or Treasurer~~ fails to qualify or if the ~~his~~ office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if the ~~his~~ office becomes vacant, it shall remain vacant until the end of the term.

ARTICLE III

SUFFRAGE AND ELECTIONS

SECTION 7. INITIATIVE TO RECALL EXECUTIVE OFFICERS AND MEMBERS OF THE GENERAL ASSEMBLY ~~GOVERNOR~~

(a) The recall of any Executive Branch officer named in Section 1 of Article V ~~the Governor~~ may be proposed by a petition signed by a number of electors equal in number to at least ~~10%~~ 15% of the total votes cast for Governor in the preceding gubernatorial election, with at least 100 signatures from each of at least 25 separate counties. In addition, the recall of any member of the General Assembly may be proposed by a petition signed by a number of electors equal in number to at least 10% of the total votes cast for that office in the member's Legislative District or Representative District, as applicable, in the general election in which the member was last elected. A petition shall have been signed by the petitioning electors not more than 150 days after an affidavit has been filed with the State Board of Elections providing notice of intent to circulate a petition to recall the ~~Executive Branch officer or member of the General Assembly~~ Governor. The affidavit may be filed no sooner than 6 months after the beginning of the ~~officer's or member's~~ Governor's term of office. ~~The affidavit shall have been signed by the proponent of the recall petition, at least 20 members of the House of Representatives, and at least 10 members of the Senate, with no more than half of the signatures of members of each chamber from the same established political party.~~

(b) The form of the petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the petition was filed, and the question "Shall (name) be recalled from the office of ~~(office)~~ Governor?" must be submitted to the electors at a special election called by the State Board of Elections, to occur not more than 100 days after certification of the petition. A recall petition certified by the State Board of Elections may not be withdrawn and another recall petition may not be initiated against the ~~same officer or member~~ Governor during the remainder of ~~his or her~~ the current term of office. In the case of an Executive Branch officer, any ~~Any~~ recall petition or recall election pending on the date of the next general election at which ~~a candidate for that office~~ a candidate for Governor is elected is moot. In the case of a member of the General Assembly, any recall petition or recall election pending on the

date of the next general election at which a member is elected from that member's Legislative or Representative District is moot.

(c) If a petition to recall an Executive Branch officer or member of the General Assembly ~~the Governor~~ has been filed with the State Board of Elections, a person eligible to serve in the office with respect to which the recall petition has been filed ~~as Governor~~ may propose his or her candidacy by a petition signed by a number of electors equal in number to the requirement for petitions for an established party candidate for the office ~~of Governor~~, signed by petitioning electors not more than 50 days after a recall petition has been filed with the State Board of Elections. The form of a successor election petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the successor election petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the recall petition to recall the Governor was filed. Names of candidates for nomination to serve as the candidate of an established political party must be submitted to the electors at a special primary election, if necessary, called by the State Board of Elections to be held at the same time as the special election on the question of recall established under subsection (b). Names of candidates for the successor election must be submitted to the electors at a special successor election called by the State Board of Elections, to occur not more than 60 days after the date of the special primary election or on a date established by law.

(d) The Executive Branch officer or member of the General Assembly ~~Governor~~ is immediately removed upon certification of the recall election results if a majority of the electors voting on the question vote in favor of recall ~~to recall the Governor~~. If the Governor is removed, then (i) an Acting Governor determined under subsection (a) of Section 6 of Article V shall serve until the Governor elected at the special successor election is qualified and (ii) the candidate who receives the highest number of votes in the special successor election is elected Governor for the balance of the term. If an Executive Branch officer other than the Governor is removed, then the Governor shall appoint a successor as provided in Section 7 of Article V to serve until a successor is elected at the special successor election and qualified. If a member of the General Assembly is removed, then a successor shall be appointed as provided in Section 2 of Article IV to serve until a successor is elected at the special successor election and qualified.
