INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 4001. Introduced by Representative Davis, AN ACT concerning appropriations.

HOUSE BILL 4002. Introduced by Representative Hays, AN ACT concerning gaming.

HOUSE BILL 4003. Introduced by Representative Fine, AN ACT concerning government.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 181

Offered by Representative Fine:

WHEREAS, Many members of the Illinois House of Representatives have risen to condemn Donald Trump's proposed construction of a wall between the United States and Mexico; a wall will hurt the long-standing relationship between the U.S. and Mexico, hurt the country and the State of Illinois economically, and wreak havoc on the environment; and

WHEREAS, A wall will be a political and economic disaster; Mexico is one of America's largest trading partners; in 2015, the United States imported \$295 billion in products from Mexico, including cars and machinery; Mexico is also the second largest supplier of agriculture, including fruits and vegetables, for the U.S.; and

WHEREAS, According to the Illinois Department of Commerce and Economic Opportunity, in 2015, Illinois imported more than \$13 billion from Mexico; Mexico is the third largest import market for the United States; and

WHEREAS, A wall will come with an enormous cost; it is estimated a wall would cost between \$15-25 billion, paid for by a 20% tax on goods coming from Mexico; this will fall upon the American consumer; and

WHEREAS, A wall poses an ecological threat; a 2016 report based on U.S. Fish and Wildlife Service data explained that its construction could have a negative impact on 111 endangered species, 108 species of migratory birds, four wildlife refuges and fish hatcheries, and an unknown number of protected wetlands; and

WHEREAS, The climate impacts of a massive concrete wall running along the border of the United States and Mexico begin with the source of the materials; the production of cement is a major source of greenhouse gas emissions; and

WHEREAS, According to the Center for Biological Diversity, billions of dollars have already been spent on existing border fencing, with little to no environmental oversight; this has led to erosion and flooding in border communities as well as a roadblock for the natural movement of wildlife across the border; and

WHEREAS, The negative human impact of a wall is incalculable and goes against the very values upon which this nation of immigrants is built; children have written letters to representatives of the General Assembly about how the idea of a wall is a great concern for families that may be divided by a wall when they just want to have better lives; the idea of a wall is causing a great deal of stress for many children; and

WHEREAS, The Pew Research Center shows emerging evidence that illegal immigration flows have fallen to their lowest level in at least two decades; the nation's population of illegal immigrants has decreased by about one million since 2007; and

WHEREAS, Walls do not work; walls such as the one between East and West Germany have shown building walls to keep people out does not work; in the words of President Reagan regarding the Berlin wall,

such a wall, "...cannot withstand faith. It cannot withstand truth. The wall cannot withstand freedom."; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Donald Trump to cease his plans to build a wall on the southern border between the United States and Mexico; and be it further

RESOLVED, That we urge Congress to refuse any appropriation to fund the building of a wall along the southern border; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, U.S. Senate Minority Leader Chuck Schumer, U.S. Speaker of the House of Representatives Paul Ryan, U.S. House of Representatives Minority Leader Nancy Pelosi, and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 184

Offered by Representative McAuliffe:

WHEREAS, The State song, "Illinois", with lyrics by Civil War veteran, Charles H. Chamberlain, and music by Archibald Johnston, was adopted as the official State song of Illinois by the 54th General Assembly on June 30, 1925; and

WHEREAS, "Illinois", when played, should instill a sense of pride in all residents of the Prairie State; and
WHEREAS, The lyrics of "Illinois" serve to depict the beauty and wondrous history of Illinois; and

WHEREAS, Prior to his presidency, while serving as toastmaster at a reunion of the Army of the Potomac, William McKinley congratulated Charles H. Chamberlain for having "written a song which will never die"; and

WHEREAS, Illinois is the proud home of four U.S. presidents - Abraham Lincoln, Ulysses S. Grant, Ronald Reagan, and Barack Obama; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Illinois constitutional officers, members of the Illinois House of Representatives, and members of the Illinois Senate to encourage the playing of the official State song, "Illinois", at all official events; and be it further

RESOLVED, That we urge our State colleges and universities to play "Illinois" at their commencement exercises; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Illinois constitutional officers, the Speaker of the Illinois House of Representatives, the President of the Illinois Senate, as well as the presidents of State colleges and universities, the Chairpersons of the Boards of Trustees for State colleges and universities; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Stanley D. Banash as a recognition of our thanks for his initiative and proposal of this resolution.

HOUSE RESOLUTION 191

Offered by Representative Jones:

WHEREAS, The Affordable Care Act, also known as Obamacare, was signed into law by President Barack Obama on March 23, 2010; and

WHEREAS, The goal of the Affordable Care Act was to give more Americans access to affordable, quality health insurance by expanding the affordability, quality, and availability of private and public health insurance; and

WHEREAS, The Affordable Care Act helps young people by letting them stay on their parents' healthcare plan until the age of 26; and

WHEREAS, The Affordable Care Act expanded Medicaid to millions of people in the states that chose to expand the program; and

WHEREAS, The Affordable Care Act helps those who need health insurance the most by requiring all insurers to cover people with pre-existing conditions; and

WHEREAS, The Affordable Care Act has drastically decreased the number of uninsured Americans; and

WHEREAS, It is estimated that, as of 2016, 20 million additional Americans have health insurance because of the Affordable Care Act; and

WHEREAS, For the year 2017, nearly 500,000 Illinoisans applied for healthcare coverage provided under the Affordable Care Act; and

WHEREAS, In June of 2012, the Affordable Care Act was deemed constitutional by the United States Supreme Court; and

WHEREAS, President Donald Trump and Congress have discussed repealing the Affordable Care Act but have offered no plan to replace it; and

WHEREAS, Repealing the Affordable Care Act would be detrimental to the lives of millions of Americans; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Donald Trump and Congress to cease their efforts to repeal the Affordable Care Act; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, Speaker of the U.S. House of Representatives Paul Ryan, U.S. Senator Dick Durbin, U.S. Senator Tammy Duckworth, and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 192

Offered by Representative McSweeney:

WHEREAS, Millions of households in Illinois subscribe to services that provide audio and video entertainment, whether through a wire-based cable or through a satellite dish; this includes audio streaming, video streaming, and many other services; and

WHEREAS, One proposal for increasing Illinois tax revenue include the levying of a 6.25% State sales tax on media services that includes audio and video streaming; and

WHEREAS, Illinois should not increase taxes on citizens who depend on cable TV and satellite services for news and entertainment; these news programs are vital to a well-informed populace; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we oppose expanding the State sales tax to cover the delivery of audio and video services, by cable TV, satellite dish, or other infrastructure, to Illinois homes and households; and be it further

RESOLVED, That copies of this resolution be presented to the Governor of Illinois, the President of the Illinois Senate, and the Speaker of the Illinois House of Representatives.

HOUSE RESOLUTION 193

Offered by Representative McSweeney:

WHEREAS, Violence and threats against the Jewish people and against individual Jews, based upon their identified status as Jews, led to one of the darkest patterns in human history; and

WHEREAS, In recent days, the number and scale of threats and violent actions against Jewish people, offices, entities, places of worship, and places of burial, have multiplied within the United States; and

WHEREAS, These threats and actions have taken various forms, including the spray-painting of hostile graffiti upon synagogues, anonymous telephoned bomb threats against Jewish child care centers and community centers, and activities of vandals at Jewish cemeteries; and

WHEREAS, On Monday, February 27, 2017, the Jewish Community Center Association of North America reported that 31 separate bomb threats were called into 23 community centers and eight Jewish day schools throughout the United States; and

WHEREAS, In recent news stories, several key synagogues in the Chicago area, including synagogues on Chicago's North Shore such as Beth Hillel Congregation Bnai Emunah in Wilmette and North Shore Congregation Israel in Glencoe, have been compelled to take steps to increase security in and around their places of worship; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we stand with the Jewish residents of Illinois in fervent

and uncompromising opposition to any form of threats or violence against Jewish children, families, people, buildings, institutions, places of identity, and places of religious observance; and be it further

RESOLVED, That we commend the local law enforcement agencies with responsibility over those locations that are under actual or potential threat for the increased vigilance and security that they are being called upon to provide; and be it further

RESOLVED, That we call upon the federal government of the United States, and the State of Illinois, to increase the active enforcement of law enforcement and security policies intended to reduce and eliminate these types of threats; and be it further

RESOLVED, That copies of this resolution be delivered to the Governor of Illinois, the Director of the Illinois State Police, and the Director of the Federal Bureau of Investigation.

HOUSE JOINT RESOLUTION 37

Offered by Representative Andrade:

WHEREAS, According to the United States Census Bureau, Illinois is currently the fifth most populous state in the country, with approximately 12,800,000 residents; and

WHEREAS, The role of Illinois in the global marketplace is currently in flux as a new United States Trade Representative takes office and the new presidential administration has created a White House National Trade Council; and

WHEREAS, Illinois maintains 10 foreign trade offices: Mexico City, Mexico; Toronto, Canada; Brussels, Belgium; Pretoria, South Africa; Jerusalem, Israel; Sao Paulo, Brazil; Tokyo, Japan; New Delhi, India; and Hong Kong and Shanghai, China; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the International Job Protection Task Force is created within the Illinois Department of Commerce and Economic Opportunity - Office of Trade and Investment; and be it further

RESOLVED, That the International Job Protection Task Force is charged with the following duties: (1) analyze important issues relative to the growth of international trade from and to Illinois; (2) make recommendations to Congress, the United States Trade Representative, and the White House National Trade Council regarding trade policies that best serve Illinois; and (3) promote the protection of Illinois jobs relative to international trade; and be it further

RESOLVED, That the International Job Protection Task Force shall consist of the following members:

- (1) two appointed by the Speaker of the Illinois House of Representatives;
- (2) two appointed by the President of the Illinois Senate;
- (3) two appointed by the Minority Leader of the Illinois Senate;
- (4) one appointed by an Illinois business group;
- (5) one appointed by an Illinois agricultural group;
- (6) 20 appointed by the AFL-CIO; and
- (7) two appointed by the Minority Leader of the Illinois House of Representatives; and

be it further

RESOLVED, That the Illinois Department of Commerce and Economic Opportunity - Office of Trade and Investment shall provide administrative support for the International Job Protection Task Force and shall reimburse for their reasonable and prudent expenses; and be it further

RESOLVED, That the International Job Protection Task Force shall provide a final report by December 31, 2017.

HOUSE JOINT RESOLUTION 38

Offered by Representative Guzzardi:

WHEREAS, Overloaded school backpacks are causing increasing problems of back pain and spinal strain for students across the nation; and

WHEREAS, Because spinal ligaments and muscles are not fully developed until after age 16, overweight backpacks are a cause of repeated low-level stress that may result in chronic neck, shoulder, or back pain in children; and

WHEREAS, According to the United States Consumer Product Safety Commission, more than 7,000 emergency room visits each year are due to backpack-related injuries; in 2010 alone, doctor offices, clinics, and hospital emergency rooms treated nearly 28,000 strains, sprains, dislocations, and fractures from backpacks; and

WHEREAS, Studies have shown heavy loads carried on the back have the potential to damage the soft tissues of the shoulder, causing microstructural damage to the nerves and damage to internal organs; and

WHEREAS, Studies have shown an increase in curvatures of the spine and compressed intervertebral height when backpacks exceed 10% of the body weight of a child; and

WHEREAS, The Global Burden of Disease Study of 2010 showed back pain as the number one cause of disability worldwide and musculoskeletal disorders as the second cause; and

WHEREAS, School textbooks are much heavier now than many years ago; in addition to textbooks, students often carry computers, cell phones, water bottles, running shoes, band instruments, and other equipment considered essential to have readily available; and

WHEREAS, More than 90% of students carry backpacks, which have been found to weigh as much as 25% of the child's body weight; and

WHEREAS, Backpacks are often not worn correctly - often slung over one shoulder or allowed to hang significantly below the waistline, increasing the weight on the shoulders and making the child lean forward when walking or stoop forward when standing to compensate for the weight; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge that all school administrators, teachers, parents, and students be educated about the potential health impact of heavy backpacks and take proactive measures to avoid injury; and be it further

RESOLVED, That Doctors of Chiropractic be permitted to conduct mandatory interval scoliosis examinations on children; and be it further

RESOLVED, That schools should work with their Parent-Teacher Associations and Parent-Teacher Organizations to assess the extent to which students use overweight backpacks and to promote innovative homework strategies, lessening the need to take all school materials and books back and forth each day; and be it further

RESOLVED, That schools should consider the following points when developing their backpack education talking points:

- (1) Backpacks should weigh no more than a maximum of 10% of the body weight of the child;
- (2) Encourage ergonomic backpacks with individualized compartments to efficiently hold books and equipment;
- (3) Encourage children to wear both shoulder straps and not sling the backpack over one shoulder;
- (4) Encourage wide, padded adjustable straps to fit the body of the child;
- (5) Encourage the heaviest books be left at school and handouts or workbooks be used for homework assignments;
- (6) Schools should consider moving toward e-textbooks as federal and State funding becomes available; and
- (7) Schools should consider integrated education about backpacks by using a hanging scale in the classroom, allowing students to weigh their backpacks and enter the results into a graph that would track the weights, and then look at the data to determine what can be done to lighten loads; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to State Superintendent of Education Dr. Tony Smith.
