WHEREAS, There are various organizations and agencies that devote their full-hearted efforts to combating this vicious problem and seek to provide these at-risk children with options that help prevent and relieve afflicted children from the hardship that is child neglect and abuse; and

WHEREAS, Organizations like the Children's Advocacy Centers of Illinois, Children's Home + Aid, and Prevent Child Abuse America have provided children and families the opportunity of healing the wounds left from the harmful results of child neglect and abuse; and

WHEREAS, Established in 1995, the Children's Advocacy Centers of Illinois is a network that coordinates and provides a comprehensive response to child abuse in Illinois through 37 locations in the State, working closely with the Department of Children and Family Services and the Illinois Attorney General's Office; and

WHEREAS, Children's Home + Aid has regional offices in Bloomington, Rockford, Chicago, and Granite City; the organization is a leading child and family service agency in Illinois; each year, it protects, educates, and counsels more than 40,000 children in over 60 counties, youth, and families to overcome the overwhelming obstacles of poverty, abuse, and neglect; and

WHEREAS, Founded in Chicago in 1972, Prevent Child Abuse America works to ensure the healthy development of children nationwide; the organization promotes this mission through a network of chapters in 50 states and nearly 600 Healthy Families America home visiting sites in 39 states, the District of

Columbia, American Samoa, Guam, the Northern Commonwealth of the Marianas, Puerto Rico, the United States Virgin Islands, and Canada; and

WHEREAS, Illinois State law requires that Mandated Reporters, including most professionals in education, health care, law enforcement and social work, report suspected neglect or abuse; and

WHEREAS, Health care professionals and concerned individuals continue to try and raise awareness for and education in emotional child abuse in the community and among parents so as to produce a pro-active solution to the problem of child abuse and neglect; and

WHEREAS, The National Child Abuse Prevention Month is a time to acknowledge the importance of families and communities working together to prevent child abuse and neglect, and to promote the social and emotional well-being of children and families; therefore, be it

WHEREAS, Every child should be afforded his or her best opportunity to develop his or her speech, and with early intervention and appropriate therapy, most children with CAS will learn to communicate with their very own voices; while the act of learning to speak comes effortlessly to most children, those with apraxia require years of intensive speech therapy and face a lengthy struggle to learn to communicate, and although not life-threatening, the disorder is life-altering as families are left to cope with the emotional, physical, and financial challenges of having a child diagnosed with CAS; and

WHEREAS, The Apraxia Connection and Silent Stars Foundation, along with the national organization, the Childhood Apraxia of Speech Association of North America, are part of a local, State, and national effort to bring awareness to CAS, and are speaking up for children who do not have a voice; and

WHEREAS, These children, as well as their families, deserve our highest respect for their effort, determination, and resilience in the face of such obstacles; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 14, 2017 as "Apraxia Awareness Day" in the State of Illinois to bring attention to one of the most severe speech and communication problems in children; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Childhood Apraxia of Speech Association of North America.

HOUSE RESOLUTION 254

Offered by Representative Bellock:

WHEREAS, The Centers for Disease Control and Prevention report that one in three women and one in four men will experience some form of physical violence by an intimate partner in their lifetime; and

WHEREAS, Domestic abuse is a repetitive pattern of behaviors to maintain power and control over an intimate partner; and

WHEREAS, More than three million children witness domestic violence in their homes each year; and

WHEREAS, An estimated one-half of women in abusive relationships in the United States are physically injured by their partner; and

WHEREAS, Domestic violence costs more than \$37 billion a year in law enforcement involvement, legal assistance, medical and mental health treatment, and lost employee productivity; and

WHEREAS, Organizations such as the National Domestic Violence Hotline and the National Coalition Against Domestic Violence have worked to educate, counsel, and help communities affected by domestic violence; and

WHEREAS, Domestic Violence Awareness Month evolved from the "Day of Unity" held in October of 1981, and was conceived by the National Coalition Against Domestic Violence; and

WHEREAS, Since 1989, October has been designated as National Domestic Violence Month; and

WHEREAS, With violence increasing in our schools, on our streets, and in our homes, ending it should be a top priority for everyone; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize National Domestic Violence Awareness Month in October and support and commend the efforts of those people and organizations who work tirelessly to help victims break free of the devastating effects of domestic abuse and work to ameliorate this scourge on society, thereby creating safer communities for all.

HOUSE RESOLUTION 255

Offered by Representative Bellock:

WHEREAS, One in three adolescents in the United States is a victim of physical, emotional, or verbal abuse from a dating partner, a figure far exceeding other types of youth violence; and

WHEREAS, The National Council on Crime and Delinquency points to this issue as being "shockingly common behavior among adolescents"; and

WHEREAS, Violent relationships in adolescence put the victims at higher risk for substance abuse, eating disorders, risky sexual behavior, and further domestic violence; and

WHEREAS, Many youth do not know the difference between a healthy, unhealthy, or abusive relationship - especially when there is no physical abuse present - and are even less aware of how to help peers who are affected by dating violence; and

WHEREAS, Common warning signs of dating abuse can include extreme jealousy, explosive temper, erratic mood swings, constant belittling, and isolation from family and friends; and

WHEREAS, Nearly half of dating college women report experiencing violent and abusive dating behaviors; and

WHEREAS, Teen dating violence is often a difficult subject to discuss for both victims and their families; and

WHEREAS, Organizations such as Break the Cycle and the National Domestic Violence Hotline's "Loveisrespect" project work to raise awareness of teen dating violence and serve as a source of counseling and help for those affected; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize Teen Dating Violence Awareness Month in February of 2017 and 2018 and support and encourage the work of individuals and organizations who provide effective and essential prevention programming for adolescents and offer them resources, tips, and guidance on how to navigate the perils and pitfalls of adolescent dating during this especially critical time in their lives.

HOUSE RESOLUTION 256

Offered by Representative Bellock:

WHEREAS, More than 118,000 people are currently waiting for an organ transplant; 22 people will die each day waiting for an organ, and one person is added to the organ donor waiting list every 10 minutes; and

WHEREAS, One organ donor can save up to eight lives and let up to 79 people receive organ transplants; a single tissue donor can save or heal up to 50 people; and

WHEREAS, More than 24,000 patients saw their lives saved or markedly improved in 2014 thanks to organ transplants; and

WHEREAS, More than 130 million people in the United States are signed up to be organ, eye, and tissue donors, which is approximately 50% of the United States adult population; and

WHEREAS, The citizens of Illinois should be made aware of the need for organ donors and that everyone can become a donor, regardless of age, race, or medical history; and

WHEREAS, National Donate Life Month takes place every year in April and features an entire month of local, regional, and national activities to help encourage Americans to register as organ, eye, and tissue donors and to celebrate those that have saved lives through the gift of donation; and

WHEREAS, The State of Illinois should encourage all residents 18 years and older to register as an organ donor at the same time they apply for or renew a driver's license or ID card; and

WHEREAS, Organ Donor Registration Month in the State of Illinois promotes education and awareness of how citizens can become donors and the importance of being a donor to help save lives; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize April of 2017 as Organ Donor Registration Month in the State of Illinois in honor of those who have lost their lives while waiting on a transplant list, to celebrate the lives of those who have been saved through organ donation, and to thank those who have been donors.

HOUSE RESOLUTION 257

Offered by Representative Bellock:

WHEREAS, It has long been a universal goal to eliminate traffic accidents and traffic fatalities; and

WHEREAS, Data has indicated that many traffic accidents are a direct result of poor peripheral binocular vision and glare from road and car reflections; and

WHEREAS, Correcting vision problems of drivers is an attainable goal; and

WHEREAS, The minimum requirement for visual acuity is 20/40 acuity, with or without corrective lenses; drivers with acuity between 20/41 and 20/70 are limited to daylight driving only; drivers must also have at least 140 degree peripheral vision (the ability to see to the side) to have a license without restrictions; this requirement is with or without corrective lenses; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage all drivers in the State of Illinois to get annual eye exams to insure that they are able to drive safely; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Secretary of State, the Illinois State Police, and the Illinois Department of Transportation.
