WHEREAS, Since its founding, Alpha Phi Alpha has consistently supplied its voice and vision to the struggle of African-Americans, people of color, and issues of civil rights around the world; and

WHEREAS, The aims of Alpha Phi Alpha are manly deeds, scholarship, and love for all mankind; and

WHEREAS, The mission of Alpha Phi Alpha is to develop leaders, promote brotherhood and academic excellence, and provide service and advocacy for communities, as exemplified through its national programs, which include "Go to High School, Go to College", which focuses on the educational achievement of students in elementary, secondary, and post-secondary schools and has given thousands of dollars in scholarship funds to deserving students; "Project Alpha", which teaches teenage pregnancy prevention and sexually transmitted disease prevention to young males, and its "Voteless People is a Hopeless People" campaign, a voter registration and education program, through which thousands of voters have been educated and registered; Alpha Phi Alpha also focuses on providing service through its strategic partnerships with Big Brothers Big Sisters, the Boy Scouts of America, March of Dimes, the American Heart/American Stroke Association, and the American Cancer Society; and

WHEREAS, The centerline of totality for both eclipses will intersect in Jackson County, just a few miles south of Carbondale; and

WHEREAS, Southern Illinois University Carbondale, which is ranked among the top 5% of all United States higher education institutions for research, will host public educational events and activities in cooperation with NASA, the Adler Planetarium, and other top scientists and institutions from around the world, providing an environment for quality outreach, research, and citizen science on the 2017 and 2024 eclipses; and

WHEREAS, Eclipse outreach events and activities at Southern Illinois University Carbondale are aligned with the Federal Science, Technology, Engineering, and Mathematics Strategic Plan, most closely relating to implementation in the areas of: increase and sustain youth and public engagement in STEM, enhance

STEM experience of undergraduate students, better serve groups historically underrepresented in STEM fields; and

WHEREAS, Southern Illinois University Carbondale through the Southern Illinois Eclipse 2017 - 2024 steering committee is providing educational assistance to K-12 school districts in the path of the eclipse; and

WHEREAS, Roughly 250,000 visitors are estimated to travel to areas within a 100-mile radius of the intersection of eclipse totality in Southern Illinois on or about August 21, 2017 and April 8, 2024 to experience the total solar eclipses; and

WHEREAS, The influx of visitors to Southern Illinois to view each eclipse will provide much-needed, long-term economic opportunity for the Southern 16 counties of Illinois; and

WHEREAS, The total solar eclipses on August 21, 2017 and April 8, 2024 will provide unique opportunities to showcase the scenic, natural, historic, recreational, archeological, and cultural resources of Southern Illinois; and

WHEREAS, Due to the anticipated 250,000 visitors to Southern Illinois to view the eclipse, there is an urgent need to direct resources to the region to support entrepreneurship, job creation, hospitality training, heritage tourism, workforce development, infrastructure, and disaster response; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate Southern Illinois as the "Eclipse Crossroads of America" and August 21, 2017 as "Great American Eclipse Day 2017"; and be it further

RESOLVED, That we encourage the development of a marketing plan for regional branding around the solar eclipses and general regional tourism and economic development in Southern Illinois that coordinates and leverages investment by federal, State and local governmental entities, private business, non-profits and non-governmental organizations that support development of a regional organization to ensure sustainable, long-term economic development that balances meeting immediate needs with dedicating resources to strategic and long-term goals.

WHEREAS, In President Trump's proposed budget, funding for the Great Lakes Restoration Initiative was slashed by 97%, from \$300 million to just \$10 million; and

WHEREAS, The funding for this program has helped many critical environmental restoration programs to increase the health and safety of the Great Lakes and improve the lakes for recreation and commerce; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge President Trump and the United States Congress to fully fund the Great Lakes Restoration Initiative, which is vital to our environment and economy; and be it further

HOUSE RESOLUTION 269

Offered by Representative Bellock:

WHEREAS, Autism spectrum disorders can affect all individuals regardless of racial, ethnic, economic, and social groups; and

WHEREAS, The Centers for Disease Control and Prevention (CDC) estimates that one in seven children in the United States have a developmental disability, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy, and autism; and

WHEREAS, Autism spectrum disorders are more common than pediatric cancer, diabetes, and AIDS combined; and

WHEREAS, Studies in Asia, Europe, and North America have identified individuals with an autism spectrum disorder, with an average prevalence of about 1%; a recent study in South Korea reported a prevalence of 2.6%; and

WHEREAS, According to estimates from CDC's Autism and Developmental Disabilities Monitoring Network, about one in 68 children has been identified with an autism spectrum disorder; and

WHEREAS, The cause of autism spectrum disorders is still unknown, but research strongly suggests that it is caused by certain factors that affect brain development; and

WHEREAS, Autism spectrum disorders have increased tenfold in the last decade and now occur in some form in one in 42 boys in the United States; and

WHEREAS, Autism, which is five times more common among boys than girls, usually appears during the first three years of life; and

WHEREAS, Early diagnosis, research, training, education, and therapies are vital to reducing the effects of autism; and

WHEREAS, Current research suspects that there is not a single cause that will ultimately be discovered, but rather a cluster of factors which include genetics, pregnancy/birth complications, viral infections, metabolic disorders, congenital anomaly syndrome (birth defects), and environmental toxins; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April of 2017 and 2018 as "Autism Awareness Month" in the State of Illinois for the purpose of urging both government entities and the citizenry to become aware and educated on the subject of autism spectrum disorders; and be it further

RESOLVED, That a suitable copy of this resolution be presented to The Autism Program of Illinois.

HOUSE RESOLUTION 270

Offered by Representative Bellock:

WHEREAS, Heroin is an illegal and highly addictive drug that is both the most abused and the most rapidly acting of the opiates; and

WHEREAS, Heroin was first synthesized in 1874 from morphine, a naturally occurring substance extracted from the seed pods of certain varieties of poppy plants; and

WHEREAS, Heroin is typically sold as a white or brownish powder or as the black sticky substance known as "black tar heroin"; and

WHEREAS, Although purer heroin is becoming more common, most heroin is "cut" with other drugs or with substances such as sugar, starch, and powdered milk, as well as strychnine or other poisons; and

WHEREAS, Because heroin abusers do not know the actual strength of the drug or its true contents, they are at risk of overdose and death; and

WHEREAS, Heroin also poses special problems because of transmission of HIV and other diseases that can occur from sharing needles or other injection equipment, and because of the medical and social consequences of abuse, including fetal effects, crime, violence, and disruptions to the family, workplace, and educational environments; and

WHEREAS, According to the Illinois Department of Public Health, there are more than 1,700 Illinois citizens per year that overdose on drugs, with 42% of those overdoses directly related to heroin; and

WHEREAS, Notwithstanding the efforts to fight the heroin epidemic, Cook County alone confirmed more than 500 heroin overdose cases in 2016; and

WHEREAS, Despite efforts to combat the use of heroin, DuPage County saw a record 59 confirmed heroin-related deaths in 2013; and

WHEREAS, Heroin has become the second most common drug after alcohol and the most common illegal substance for which individuals enter treatment in Illinois, compared to the fourth most common reason Illinoisans entered publicly-funded treatment in 1998; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the citizens of the State of Illinois, especially the parents of Illinois youth, to become aware of the dangers associated with the use of heroin and the escalating number of accidental deaths due to heroin overdoses; and be it further

RESOLVED, That we find that comprehensive drug education programs, including the Drug Abuse Resistance Education (DARE) program, serve as valuable tools in presenting the facts and dangers related to heroin use to Illinois youth; and be it further

RESOLVED, That we designate the date of November 4 in 2017 and 2018 as Heroin Abuse Awareness Day in the State of Illinois.

HOUSE RESOLUTION 271

Offered by Representative Bellock:

WHEREAS, Someone develops Alzheimer's disease every 66 seconds; and

WHEREAS, Alzheimer's disease is on the rise with 5.4 million Americans currently living with the disease and an estimated 16 million Americans projected to be diagnosed with the disease by 2050; and

WHEREAS, Currently, 220,000 people in Illinois live with the disease; there will be 260,000 in just 10 years; and

WHEREAS, Alzheimer's disease will cost Illinois \$1.53 billion in Medicaid funding in 2016; and

WHEREAS, Alzheimer's disease is the sixth leading cause of death and an unrelenting, progressive condition that destroys brain cells; currently, no cure or even a way to slow the progression of the disease exists; Alzheimer's places significant financial burdens on families and businesses, with businesses losing billions a year in lost productivity and replacement expenses for employees who miss work or quit to care for a relative; and

WHEREAS, In Illinois in 2015, there were 590,000 Illinois family members and friends who provided over 671 million hours of unpaid care, valued at \$8.22 billion, to their loved ones with Alzheimer's and other dementia; and

WHEREAS, The impact of Alzheimer's and other dementia on Illinois families, the health care system, and society as a whole is of great importance; the need for home and community-based services for those with Alzheimer's is on the rise and caregiver stress is at an all-time high; and

WHEREAS, Alzheimer's disease is a looming public health crisis and we call upon all policymakers to join in the efforts to raise awareness and to serve the hundreds of thousands of persons with Alzheimer's and other dementia in Illinois, their families, and caregivers; and

WHEREAS, On April 26, 2017 and 2018, Alzheimer's advocates will speak up for the needs and rights of people with Alzheimer's and their families and ask the Illinois General Assembly to make Alzheimer's disease a priority public health issue in the State of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 26, 2017 and 2018 as the "Annual Alzheimer's Association Advocacy Day" in the State of Illinois; and be it further

HOUSE RESOLUTION 272

Offered by Representative Bellock:

WHEREAS, Direct support professionals are the primary providers of publicly-funded long-term support and services for individuals with intellectual/developmental disabilities; and

WHEREAS, The Congressional Budget Office has found that the demand for direct support professionals will grow rapidly in the coming decade; and

WHEREAS, In recent years, community-based providers serving children and adults with intellectual/developmental disabilities have expressed growing concerns about the inability to recruit and retain direct support professionals despite increasing demand for services; and

WHEREAS, Governor Bruce Rauner, through a proclamation issued on August 24, 2016, acknowledged that there is a documented critical and growing shortage of direct support professionals throughout the United States; and

WHEREAS, The United States Department of Labor's Bureau of Labor Statistics (BLS) is the principal federal agency for measuring labor market activity, working conditions, and price changes in the economy; and

WHEREAS, Policymakers at the federal and State levels make frequent use of BLS data and analytics to identify trends in employment, productivity, price indexes, and compensation; and

WHEREAS, The BLS recently looked at the data it collects for wages, total compensation, and job openings for two direct care occupations: home health aides and personal care aides; this look was organized to better understand wages, total compensation, and job openings for these direct care positions as posited against eight alternative occupations with similar educational level requirements and short-term training requirements; and

WHEREAS, While there is a standard occupational classification for both home health aides and personal care aides, there is not separate standard occupational classification for direct support professionals; and

WHEREAS, As there is overlap with respect to educational and training requirements among home health aides, personal care aides, and direct support professionals, there are clear differences in occupation responsibilities, modalities of employment, and populations served and supported; and

WHEREAS, Factoring direct support professionals in with home health aides and personal care aides does not provide policymakers at both the federal and State levels with accurate data on the key indicators for direct support professionals of wages, total compensation, job openings, and turnover; and

WHEREAS, In August of 2016, a United States Government Accountability Office Report on the Long-Term Care Workforce to the Ranking Member, Subcommittee on Health Care, Benefits, and Administrative Rules, Committee on Government Oversight and Government Reform indicated there are gaps in existing federal data that make it difficult to know what the current workforce numbers are and to predict future trends regarding supply and demand; and

WHEREAS, In the report, it was specifically noted that "According to BLS officials, due to the National Compensation Survey's small sample size, benefits data are limited to direct care workers in all industries and cannot be broken down by occupation or specific industry"; and

WHEREAS, In the same report, it was noted that "Unless the Health Resources and Service Administration (HRSA) takes actions to overcome data limitations in order to make projections of supply and demand, the ability of policymakers and other stakeholders to develop appropriate workforce strategies to ensure a sufficient number of qualified direct care workers will continue to be hampered"; and

WHEREAS, The need to capture accurate data at the federal level to ensure government has the information it needs to build the direct support professional workforce is at its highest need; and

WHEREAS, By designating the Direct Support Professional as its own standard occupational classification, the BLS will be in a position to capture much more precise and accurate data specific to the profession; this in turn will assist federal and State policymakers to inform the public of the current status of the workforce, impact policymaking on direct support professional issues, which will include potential changes by the Centers for Medicare and Medicaid Services and other federal agencies as they recognize the need for focus on this workforce, and potentially impact federal resources legislated by the United States Congress for direct support professional initiatives, and potentially increasing the amount of people employed in the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Department of Labor's Bureau of Labor Statistics to designate the Direct Support Professional as its own standard occupational classification so that more accurate and precise data on this workforce can be captured and analyzed on an ongoing basis; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Secretary of the United States Department of Labor.

WHEREAS, These programs have the opportunity to not only keep seniors in their homes, but also save millions in tax dollars by keeping them out of more costly healthcare settings; and

WHEREAS, In Illinois, the Meals on Wheels Program and Congregate Meals Program both serve over 7.8 million meals to 118,000 seniors in a given year; and

WHEREAS, On March 16, 2017, the Trump Administration presented a budget blueprint that focuses on discretionary spending levels for federal Fiscal Year 2018, and makes deep cuts to discretionary programs, such as Meals on Wheels; and

WHEREAS, The budget blueprint also calls for the elimination of the Community Services Block Grant and Community Development Block Grant, upon which providers of Meals on Wheels programs rely to administer their programs; and

WHEREAS, The budget blueprint also contains a 17.9% cut to the U.S. Department of Health and Human Services budget, placing the programs at even greater risk of being cut; therefore, be it
