At the hour of 1:32 o'clock p.m., the House convened perfunctory session.

**SENATE BILL ON FIRST READING**

Having been reproduced, the following bill was taken up, read by title a first time and placed in the Committee on Rules: SENATE BILL 789 (Fine).

**HOUSE RESOLUTION**

The following resolution was offered and placed in the Committee on Rules.

**HOUSE RESOLUTION 422**

Offered by Representative Currie:

WHEREAS, Section 11 of Article V of the Illinois Constitution authorizes the Governor, by Executive Order, to reassign functions among or reorganize executive agencies that are directly responsible to the Governor; and

WHEREAS, Section 11 of Article V also provides (i) that if an Executive Order proposes a reassignment or reorganization that contravenes a statute, then the Executive Order must be delivered to the General Assembly and (ii) that either house of the General Assembly, by record vote of a majority of the members elected, may disapprove the Executive Order; and

WHEREAS, Section 3.2 of the Executive Reorganization Implementation Act provides that reorganization occurs when, among other circumstances, an Executive Order transfers the whole or any part of any agency or its functions to the jurisdiction and control of another agency; consolidates the functions of an agency; abolishes any agency that does not have or will not have, upon the taking effect of reorganization, any functions; or establishes a new agency to perform all or any part of the functions of an existing agency or agencies; and

WHEREAS, The Governor has issued Executive Order 2017-02, which proposes to consolidate the functions of the Human Rights Commission into the Department of Human Rights; and

WHEREAS, Executive Order 2017-02 qualifies as an executive reorganization order and is subject to Article V, Section 11 of the Illinois Constitution and the Executive Reorganization Implementation Act because it attempts to consolidate, transfer, or abolish entities that are directly responsible to the Governor in contravention of statute, including the Illinois Human Rights Act; and

WHEREAS, Executive Order 2017-02 was delivered in its entirety to the Clerk of the House of Representatives and the Secretary of the Senate on March 31, 2017; and

WHEREAS, No executive reorganization order may take effect until not less than 60 calendar days after its delivery to the General Assembly; and

WHEREAS, The 60-day period for the General Assembly to disapprove Executive Order 2017-02 expires on May 30, 2017; and

WHEREAS, Executive Order 2017-02 contains a severability clause that purports to preserve any portions of the Order not found invalid, thereby relying on the notion that the General Assembly does not have jurisdiction over Executive Order 2017-02 as a whole, but, instead, has the authority only to disapprove the portions that contravene a statute; and

WHEREAS, Section VI of Executive Order 2017-02 states that the Order does not contravene and shall not be construed to contravene any State statute (except as provided in Section IV, which suspends any prior act of the General Assembly that is inconsistent with the Order and therefore expressly contravenes numerous

statutes), regardless of the fact that the Order in its entirety was delivered to the General Assembly and regardless of the fact that the Order in its entirety modifies, changes, or alters the Illinois Human Rights Act so that the Act would have to be substantially amended to conform and be consistent with the change effected in law by the reorganization; and

WHEREAS, The General Assembly has the constitutional and statutory authority to consider each Executive Order that contravenes a statute; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that pursuant to Article V, Section 11 of the Illinois Constitution, the House of Representatives hereby disapproves Executive Order 2017-02 in its entirety; and be it further

RESOLVED, That the Executive Order 2017-02 shall not become effective; and be it further

RESOLVED, That copies of this resolution be delivered to the Governor and the President of the Senate.

### HOUSE RESOLUTION

The following resolution was offered and placed in the Committee on Rules.

#### HOUSE RESOLUTION 418

Offered by Representative Ford:

WHEREAS, The Department of Children and Family Services ("DCFS" or "Department") is responsible for providing child protective services and programs to abused, neglected, and dependent children and their families; and

WHEREAS, The shooting death of 17-year-old Laquan McDonald by a Chicago police officer on October 20, 2014 shed light on the inefficiencies that plague the DCFS foster care program as media reports revealed the instability and abuse Laquan McDonald experienced throughout his youth as he moved through the foster care system; and

WHEREAS, Last month's suspicious death of 16 month-old Semaj Crosby, whose body was found in her family's Joliet home a day and a half after DCFS case workers visited the home to investigate an allegation of child neglect, has elicited sharp criticism on how DCFS investigates reports of child abuse and neglect; and

WHEREAS, Illinois has an interest in ensuring that all reports of child abuse and neglect are thoroughly investigated and that the children of this State have access to adequate and efficient protective services and programs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed in accordance with Section 3-2 of the Illinois State Auditing Act to conduct a performance audit on the Department of Children and Family Services to review and assess the Department's protocols for investigating reports of child abuse and neglect; and be it further

RESOLVED, That the audit include a review of each abuse and neglect investigation conducted by the Department of Children and Family Services within the past 5 years, including, but not limited to, a review of:

- (1) the status of each abuse and neglect investigation;
- (2) the final determination or findings made by the Department for each abuse and neglect investigation;
- (3) the time frame within which the Department completed or closed each abuse and neglect investigation;
- (4) recommendations made by the Department to each family who was the subject of an abuse or neglect investigation, including any services provided by the Department to the child or family; and
- (5) demographic information on each abuse and neglect investigation, including the age, race, and gender of each child who was the subject of the abuse or neglect investigation, and the zip code and county where the abuse or neglect was alleged to have occurred; and be it further

RESOLVED, That, upon completion of the audit, the Auditor General compile a detailed report that lists, by county, the information collected and examined under the audit, including a full summary on the number of lawsuits or other legal actions filed against the Department within the past 5 years that concern an abuse or neglect investigation and the number of lawsuits the Department settled within the past 5 years that concern an abuse or neglect investigation; and be it further

RESOLVED, That the Department of Children and Family Services cooperate fully and promptly with the Auditor General in the conduct of this audit; and be it further

RESOLVED, That the Auditor General is not allowed or authorized to release or disclose in his report any information that is prohibited from public disclosure under the Abused and Neglected Child Reporting Act or under any other State or federal law; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and submit his report, including his findings and recommendations, upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a copy of this resolution be delivered to the Auditor General and the Department of Children and Family Services.
