#### INTRODUCTION AND FIRST READING OF BILLS

#### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 579**

Offered by Representative Stratton:

WHEREAS, The State of Illinois has a waiver from the federal time limit that restricts Supplemental Nutrition Assistance Program (SNAP) eligibility for non-disabled adults without minor children to three out of 36 months unless they are working at least 20 hours per week; that waiver expires on December 31, 2017; and

WHEREAS, Illinois is eligible for this waiver due to continued high labor surplus and unemployment rates; this expiration of the waiver would leave 260,000 low-income Illinoisans without the ability to purchase adequate, nutritious food; and

WHEREAS, Those 260,000 individuals are veterans struggling to find work, men and women experiencing homelessness or living with serious and persistent mental illnesses, displaced workers (coal miners), and mothers and fathers who took time away from the workforce to raise their children; these individuals face significant and often multiple barriers to working at least 20 hours per week, including very low education levels, functional illiteracy, sporadic work histories, and criminal records; and

WHEREAS, The loss of SNAP will leave these men and women without desperately needed resources; their average income is \$283 per month and losing their average \$132 monthly SNAP benefit will put them at risk of severe hunger; and

WHEREAS, Leaders of Illinois food banks have said that their emergency food networks cannot absorb an increase of 260,000 individuals into an already overburdened system; and

WHEREAS, It is in the State's financial interest to extend the waiver; loss of the waiver will result in no savings for the State since SNAP benefits are entirely federally funded; and

WHEREAS, Illinois would lose as much as \$412 million in federal funds, damaging the State's economy and severely impacting businesses in neighborhoods where SNAP recipients are concentrated; and

WHEREAS, Organizations such as the Greater Chicago Food Depository, the Heartland Alliance, the Illinois Hunger Coalition, and the Sargent Shriver National Center on Poverty Law have in the past urged the continuation of the waiver; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Bruce Rauner to intervene on behalf of the 260,000 Illinois residents faced with the termination of their Supplemental Nutrition Assistance Program benefits; and be it further

RESOLVED, That we urge Governor Rauner request a continuing waiver of the federal time limit that restricts eligibility for non-disabled adults without minor children to three out of 36 months unless they are working at least 20 hours per week; and be it further

RESOLVED, That suitable copy of this resolution be delivered to Governor Rauner.

#### **HOUSE RESOLUTION 587**

Offered by Representative Hernandez:

WHEREAS, On September 5, 2017, President Trump and Attorney General Jeff Sessions announced the end the Deferred Action for Childhood Arrivals (DACA) program; and

WHEREAS, In his announcement, Attorney General Sessions misled and mischaracterized those benefiting from the DACA program, as well as immigrant communities in general; and

WHEREAS, Information released on September 5, 2017 from United States Immigration and Customs Enforcements (ICE) states that they expect young people who benefited from DACA to use the remaining time on their work permits to "prepare and arrange for their departure" to return to their countries of birth; and

WHEREAS, Hundreds of community members, educational institutions, political leaders from both parties, and religious and business leaders publicly advocated against the end of DACA; and

WHEREAS, DACA benefited young people who came to the United States before the age of 16, giving them a chance to study or to work if they meet certain criteria; this criteria includes age limits, physical presence in the United States, educational requirements, and no serious criminal convictions; and

WHEREAS, Since 2012, over 800,000 immigrants in the United States and more than 41,000 in Illinois have received work permits and temporary protection from deportation through the DACA program; and

WHEREAS, A 2016 report by the Center for American Progress states that more than 60% of DACA recipients achieved financial independence, and 61% reported helping their families; in addition, DACA recipients reported increased earnings by an average of 42%, and 70% of those in school with DACA are pursuing a bachelor's degree or higher; and

WHEREAS, Ending the DACA program will have life-changing and even tragic life-or-death consequences; and

WHEREAS, The end of DACA is detrimental to individuals, families, and to the interests of residents of the State of Illinois; and

WHEREAS, The State of Illinois values and respects the inherent worth of every person, regardless of immigration status, and welcomes the cultural and economic contributions of DACA recipients and their families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call on President Donald J. Trump and the U.S. Department of Homeland Security to preserve protections under DACA and to uphold the values of the United States and the State of Illinois of providing protection to vulnerable young people who have lived much of their lives in the United States, attended school in the United States, and made the United States their home; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the Majority and Minority Leaders of the United States Senate, the Speaker and Minority Leader of the United States House of Representatives, the Acting Director of the U.S. Department of Homeland Security, the Attorney General of the United States, and all members of the Illinois Congressional Delegation.

#### **HOUSE RESOLUTION 590**

Offered by Representative Kifowit:

WHEREAS, September is designated National Suicide Prevention Awareness Month, a time to come together with collective passion and strength around a difficult topic, to raise awareness, and to promote resources regarding suicide prevention; and

WHEREAS, Suicidal thoughts can affect anyone regardless of age, gender, or background, and although common, should not be considered normal and often indicate more serious issues; suicide is the third leading cause of death among young people; and

WHEREAS, Local and national organizations, like Suicide Prevention Services, are working diligently every day to address an issue that many still refuse to discuss in public; communities have an important role to play in supporting those who are vulnerable; and

WHEREAS, Everyone is encouraged to take the time to inquire as to the wellbeing of their family, friends, and neighbors and to genuinely convey their appreciation for their existence by any gesture they deem appropriate; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of September 2017 as National Suicide Prevention Awareness Month in the State of Illinois; and be it further

RESOLVED, That we encourage individuals, communities, and organizations throughout the State of Illinois to share suicide prevention awareness strategies and to ensure that individuals, friends, and families have access to resources they need to discuss suicide prevention.

#### **HOUSE RESOLUTION 592**

Offered by Representative Ford:

WHEREAS, The State of Illinois finds itself in the midst of a heroin crisis; the epicenter of which is on the West Side of the City of Chicago; and

WHEREAS, According to a recent study, hospitalizations for opioids on the West Side of Chicago account for nearly one in four hospitalizations for the entire State; overdose mortality rates disproportionately impact Chicago's African American population with nine in 100,000 African Americans dying as a result of heroin overdoses, as compared to 5.9 for whites; and

WHEREAS, Most of the attention directed at the heroin crisis is focused on policing rather than treatment, which is an ineffective and expensive way to treat a health crisis such as this; and

WHEREAS, In September of 2015, Illinois adopted the Heroin Crisis Act; this bipartisan and "groundbreaking" legislation is being duplicated in states across the country; shortly before the adoption of the Act, a report was published indicating that Illinois has become the third-worst state in providing treatment for heroin addicts; and

WHEREAS, The Heroin Crisis Act provides for the following: (1) Allows pharmacies to dispense heroin/opiate overdose reversal drugs, such as naloxone, to individuals; (2) Requires all police and fire agencies, and emergency medical technicians, to carry the reversal drugs and be trained to administer, store, and transport it; (3) Permits a school nurse to administer naloxone and requires reporting on it; (4) Upgrades the prescription monitoring program to prevent overprescribing of painkillers, a frequent precursor to heroin addiction; (5) Amends drug court programs to keep users in treatment and out of jail; (6) Establishes drug education programs in schools; (7) Provides insurance coverages for opioid/heroin antidotes; (8) Requires Medicaid to pay for medication-based treatments; (9) Requires coroners, medical examiners, and health care professionals to report to the Department of Public Health all cases of drug overdoses; (10) Requires the Department of Human Services to establish a medication take-back program to collect and dispose of unused medications; (11) Requires State agencies to report to the General Assembly on the impact of the comprehensive efforts addressing opioid/heroin misuse and overdoses; and (12) Mandates for public awareness campaigns on the dangers of unused prescription medications; and

WHEREAS, The Heroin Crisis Act requires funding to be effective and the ongoing budget fight in Illinois has threatened that funding; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Bruce Rauner to declare a state of emergency in Illinois due to the ongoing heroin crisis; and be it further

RESOLVED, That we urge the Director of the Department of Public Health, Nirav Shah, to create a comprehensive plan to combat the heroin crisis that now grips Illinois; and be it further

RESOLVED, That we urge the State of Illinois to fully fund the Heroin Crisis Act; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Bruce Rauner, Speaker of the House Michael Madigan, House Republican Leader Jim Durkin, Senate President John Cullerton, Senate Republican Leader Christine Radogno, and the Director of the Department of Public Health Nirav Shah.

#### **HOUSE RESOLUTION 594**

Offered by Representative Bellock:

WHEREAS, In 1990, Congress designated the first full week in October as Mental Illness Awareness Week in recognition of the efforts by the National Alliance on Mental Illness (NAMI) to raise mental illness awareness; each year the movement grows stronger as people work together to fight stigma, provide support, and advocate for equal care; and

WHEREAS, The lives of millions of Americans are affected daily by mental health conditions; according to NAMI, approximately one in five adults experiences mental illness in a given year, and approximately one in five young people experience a severe mental disorder at some point during life; half of all chronic mental illness begins by age 14; three quarters begins by age 24; despite effective treatment, there are long delays, sometimes decades, between the first appearance of symptoms and when people get help; and

WHEREAS, Each mental illness has its own symptoms, and trying to tell the difference between what expected behaviors are and what might be the signs of a mental illness is not always easy; there is no easy test to diagnose mental illness; common signs in adults and adolescents can include excessive worrying or fear, extreme mood changes, changes in sleeping and eating habits, and difficulty perceiving reality; and

WHEREAS, Individuals living with serious mental illness face an increased risk of having chronic medical conditions; adults in the United States living with serious mental illness die, on average, 25 years earlier than others, largely due to treatable medical conditions; and

WHEREAS, Public policy makes a difference in the lives of both the people living with mental health conditions and the people in their lives; changes in policy can mean better outcomes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of October 1-7, 2017 as Mental Illness Awareness Week in the State of Illinois; and be it further

RESOLVED, That we encourage communities throughout the State to come together and show support for the many people affected by mental illness and for those who advocate for mental health awareness.

#### **HOUSE RESOLUTION 595**

Offered by Representative Bellock:

WHEREAS, World Suicide Prevention Day was first recognized in 2003 as an initiative of the International Association for Suicide Prevention and endorsed by the World Health Organization, to provide worldwide commitment and action to prevent suicides; various activities take place around the world on this day; World Suicide Prevention Day takes place each year on September 10; and

WHEREAS, The International Association for Suicide Prevention reports that every year more than 800,000 people die by suicide, and up to 25 times as many make a suicide attempt; on average, one person in Illinois dies by suicide every six hours, and in this State, nearly twice as many people die by suicide than by homicide, as reported by the American Foundation for Suicide Prevention; behind these statistics are the individual stories of those who have, for many different reasons, questioned the value of their own lives; and

WHEREAS, There is no single cause for suicide; the warning signs of suicide include a change in behavior or the presence of entirely new behaviors; if the new or changed behavior is related to a painful event, loss, or change, it is of utmost concern; and

WHEREAS, Regardless of a person's circumstances, communities have an important role to play in supporting those who are vulnerable; that sentiment is reflected in the 2017 World Suicide Prevention Day theme, "Take a minute, change a life"; as members of communities, it is our responsibility to look out for those who may be struggling, check in with them, and encourage them to tell their stories; broaching the topic of suicide is difficult, but taking a minute to reach out to someone can change the course of a life; and

WHEREAS, People who have lived through a suicide attempt have much to teach about how the words and actions of others are important; almost universally, they say that if someone had taken a minute, the trajectory that they were on could have been interrupted; and

WHEREAS, World Suicide Prevention Day is a time to acknowledge the importance of families and communities working together to achieve the common goal of preventing suicide; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate September 10, 2017 as World Suicide Prevention Day in the State of Illinois; and be it further

RESOLVED, That we encourage communities throughout the State to take a minute to change a life and promote suicide prevention across the State of Illinois.

#### **HOUSE RESOLUTION 602**

Offered by Representative Jimenez:

WHEREAS, Dogs play an important role in the lives of many Illinois citizens by serving as companions, therapy dogs, and assistance dogs; and

WHEREAS, It is recognized that dog-related problems are most often caused by irresponsible owners; and

WHEREAS, Responsible dog ownership is encouraged in Illinois and responsible owners should properly control and provide adequate training for their dogs; and

WHEREAS, Canine Good Citizen programs identify and officially recognize those dogs who behave as members in good standing with the community; and

WHEREAS, The "Canine Good Citizen Program", developed by the American Kennel Club, teaches pet owners that dogs should exhibit "good citizen" behaviors in the presence of other people and animals, in both the home and community; and

WHEREAS, Children and adults of all ages participate in Canine Good Citizen classes to learn the skills involved in responsible dog ownership; and

WHEREAS, With dog bites and animal concerns on the rise, there is a need for dogs to remain well-behaved community members; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we endorse the American Kennel Club's "Canine Good Citizen Program" and support its efforts to promote responsible dog ownership in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the American Kennel Club as a symbol of our respect and esteem.

#### **HOUSE RESOLUTION 605**

Offered by Representative Gabel:

WHEREAS, Direct support professionals build close, respectful, and trusted relationships with the persons they help support and their families; and

WHEREAS, Direct support professionals provide a broad range of individualized support and assistance with tasks such as eating, bathing, administering medication, job and life skills training, money management, meal preparation, and reading, community engagement, and transportation; and

WHEREAS, Over the past several decades, thousands of individuals with developmental disabilities have moved from their family homes, foster homes or state institutions into group homes, where they have been able to achieve more productive and fulfilling lives; and

WHEREAS, There is a documented critical and growing shortage of direct support professionals in Illinois that is directly correlated to low wages that are often below the federal poverty level; and

WHEREAS, This staffing crisis gravely impacts the quality of life and personal safety of persons with disabilities in Illinois; and

WHEREAS, In order to continue to enhance the lives of persons with disabilities and their families who rely on long term supports and services, community providers who employ direct support professionals must obtain the resources to recruit, train and retain a highly qualified and sustainable workforce; and

WHEREAS, Competition is growing for direct support professionals; job opportunities at Walmart, fast food restaurants, retail stores, the new Amazon warehouse, and even at the local donut shop often pay more than what the State pays direct service professionals; in addition, the minimum wage in Chicago is rising well above what the State currently pays direct service professionals; and

WHEREAS, The "They Deserve More" coalition is engaged in a statewide effort to address the staffing crisis affecting services to people with disabilities and their families in Illinois; and

WHEREAS, The only solution to this ever-worsening crisis is to increase state funding to provide a living and competitive wage for direct support professionals; and

WHEREAS, Illinoisans recognize and celebrate the contributions of direct support professionals that help strengthen our communities by fostering greater inclusion for persons with disabilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare September 11-15, 2017 as "Direct Support Professionals Recognition Week" in the State of Illinois; and be it further

RESOLVED, That we honor the dedication and vital role of direct support professionals in enhancing the lives of children and adults with disabilities and their families.

WHEREAS, Most Americans are not aware that what would become our National Anthem contained a verse that was removed before the song became popular; and

WHEREAS, Francis Scott Key held derogatory views towards African Americans and the missing verse was removed because it was feared that it could be misconstrued as racist; and

WHEREAS, The missing verse: "And where is that band who so vauntingly swore, that the havoc of war and the battle's confusion a home and a Country should leave us no more? Their blood has wash'd out their foul footstep's pollution. No refuge could save the hireling and slave from the terror of flight or the gloom of the grave, and the star-spangled banner in triumph doth wave o'er the land of the free and the home of the brave"; and

WHEREAS, Francis Scott Key aggressively worked to repatriate enslaved Africans back to the continent of Africa, because he believed, in agreement with the words of Thomas Jefferson, that Africans could never coexist with white Americans because of the "deep rooted prejudices entertained by the whites; ten thousand recollections, by the blacks of the injuries they have sustained; new provocations; the real distinctions which nature has made; and many other circumstances ... will produce convulsions which will never end but in the extermination of the one or the other race"; and

WHEREAS, The vacancies in the stories told about our collective history must be filled in with every honest and humble effort, so that our citizens are able to face the complex emotions and disturbing facts that feed so much anger and confusion and threats which are obstacles to our advancing in the cause of justice and lasting peace; and

WHEREAS, Public statements from the Trump administration indicate that no action is coming from the federal government on this issue; and

WHEREAS, If we do not act now, the consequences for the country and the State will be devastating and irreversible; therefore, be it

WHEREAS, When Patrolman Roseland reached Gable's Grocery Store on the east side of the street, he discovered the door was open; he entered the store and was confronted by a man with a gun; he had interrupted a robbery in progress by three armed men; and

WHEREAS, Patrolman Roseland was forced at gunpoint to return to his vehicle; when Officer Garrity returned to the squad car, he found that Patrolman Roseland had been shot from behind in cold blood and had died almost instantly; and

WHEREAS, The robbers fled the scene with a female hostage, who they released later near Joliet; the criminals successfully robbed a total of nearly \$60; and

WHEREAS, After several months, the robbers were apprehended and Louis Lutz was charged with the murder of Patrolman Roseland; and

WHEREAS, The murder of Patrolman Roseland was a tragedy that greatly affected the residents of Grundy County for many years to come; he was a great and noble man who was a respected citizen of his community; therefore, be it

WHEREAS, Around midnight, Marshal Hopkins found it necessary to arrest the two drunk men and caught them in a downtown alleyway; as Marshal Hopkins was leading them out of the alley, the men fled on foot; and

WHEREAS, Marshal Hopkins pursued the men when Charles Miller suddenly drew his revolver and fired twice at the officer; Marshal Hopkins was hit by one of the shots and died almost instantly; and

WHEREAS, The funeral for Marshal Hopkins was the largest seen in Morris at the time; he was an honored member of the Masonic Order, a great, noble man, and a respected citizen of the community; therefore, be it

WHEREAS, Captain Joseph Laur mustered into the Union Army on October 19, 1861 as a First Lieutenant in Company K, Illinois Volunteer Infantry Regiment, commanded by Col. W.R. Morrison; and

WHEREAS, Captain Joseph Laur was promoted to Captain on June 10, 1862 and thus earned the nickname "Cap"; he fought at the battles of Fort Donelson, Shiloh, Corinth, the Red River expedition, and the siege of Vicksburg; he was injured in combat and discharged in September of 1865; and

WHEREAS, Captain Joseph Laur was awarded the contract on Star Route 11799 and served each post office from Ashley to Moore's Prairie; and

WHEREAS, Captain Joseph Laur died on June 8, 1895; during his time, Williamsburg became Old Town and was superseded by Waltonville; and

WHEREAS, Captain Joseph Laur's service to the United States and the State of Illinois has greatly benefited the surrounding communities; therefore, be it
