WHEREAS, Senator Shadid listened to his constituents and was always there to offer a helping hand; he prided himself on voting the way he thought was best for his constituency and not along party lines; and

WHEREAS, Senator Shadid always made time for his family throughout his career; he also was known for his interest in encouraging the good in people and channeling that good for a greater purpose; in that process, he felt free to dispense praise or discipline as needed; and

WHEREAS, Senator Shadid was proceeded in death by his son, George Shadid Jr.; and his siblings, Gladys Abraham, Louise Shadid, Joan Petit, Jeannette Harris, Mitchell Shadid, and William Shadid; and

WHEREAS, Senator Shadid is survived by his wife, Lorraine K. Unes; his son, Jim (Jane) Shadid; his daughter-in-law, Mikie Shadid; his grandchildren, James E. (Anne) Shadid, Joseph G. Shadid, Margaret L. Shadid, and Lauren E. Shadid; his sister, Pauline Unes; and his brother, Fred (Jean) Shadid; therefore, be it

### **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 801**

Offered by Representative Riley:

WHEREAS, George N. Leighton is one of the most distinguished citizens of Illinois; he served in the army during the Second World War, became a renowned civil rights lawyer, and earned further respect as a federal judge; and

WHEREAS, George Leighton was born to immigrant parents in Massachusetts, grew up in poverty, worked with his parents in cranberry bogs, and was unable to attend high school; and

WHEREAS, Despite not having graduated high school, George Leighton earned a scholarship to college and attended Howard University, where he studied history; he then earned admission and a scholarship to Harvard Law School; and

WHEREAS, When the United States entered the Second World War, George Leighton entered service as an ROTC Second Lieutenant in the segregated 93rd Infantry Division of the Army, serving as a logistics officer in the Pacific campaign; he earned a Bronze Star and was discharged with the rank of Captain in 1945; and

WHEREAS, Upon returning home after the war, George Leighton returned to Harvard Law, completed his degree, passed the bar, and moved to Chicago in 1946; and

WHEREAS, As a criminal defense lawyer in Chicago, George Leighton took on key civil rights cases in a number of areas, including voting rights, school desegregation, and housing integration; in 1951, he founded a predominantly African American law firm that became one of the largest such firms in the country; in 1952, he became the president of the Chicago branch of the NAACP; and

WHEREAS, George Leighton was elected as a Cook County Circuit Court judge in 1964 and served as one of the few African American judges in the county; he was the first African American judge appointed to the Illinois Appellate Court, and he served ten years as a U.S. District Court judge, retiring at the age of 74; he then continued practicing law; and

WHEREAS, George Leighton, now aged 105, wishes to be buried as a soldier in Arlington National Cemetery; however, Arlington National Cemetery has strict regulations for allowing burial, such that a candidate must have served 20 years active duty, been a prisoner of war, earned a Purple Heart, Silver Star, or higher decoration, or died while on active duty; waivers may be granted by the Secretary of the Army, or, in special cases, the Secretary of Defense or the President of the United States; and

WHEREAS, The Veterans Caucus of the Chicago City Council plans to introduce a resolution urging the federal government to grant George Leighton's request, and Senator Richard Durbin has recently joined this effort by announcing his support and pledging to help in any way he can; and

WHEREAS, George Leighton has honorably served the United States and the State of Illinois as a soldier during the Second World War, a staunch promoter of civil rights, and as a pioneer judge; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support Senator Durbin and the Veterans Caucus of the Chicago City Council in this effort, and we urge the federal government to grant George N. Leighton's request to be buried in Arlington National Cemetery; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Senator Richard Durbin, the Secretary of the Army, the Secretary of Defense, and the President of the United States.

#### HOUSE RESOLUTION 802

Offered by Representative Rita:

WHEREAS, On January 1, 2018, President Donald Trump implemented a \$1.6 billion cut to the 340B Drug Discount Program, a program which requires drug makers to offer large discounts to safety net hospitals for certain drugs prescribed for Medicare patients; and

WHEREAS, In 2018, Medicaid's Disproportionate Share Hospital program, designed to compensate hospitals that provide a significant amount of medical care for which they do not receive reimbursement, is facing a \$2 billion cut to its funding; and

WHEREAS, Safety net hospitals, which provide medical care regardless of an individual's insurance status or ability to pay, are largely dependent on these funds; and

WHEREAS, Illinois receives less federal funds per Medicaid beneficiary than any other state in the U.S and also has one of the lowest Medicaid matching rates in the country; and

WHEREAS, Many Illinois safety net hospitals, which provide essential health services to lower-income individuals who would otherwise lack access to care, will have to scale back services or close entirely due to these program cuts; and

WHEREAS, Safety net hospitals represent almost 20% of all hospitals in Illinois and provide more than 25,000 jobs across the State; and

WHEREAS, These safety net hospitals receive almost 40% of all patients hospitalized for behavioral health conditions such as mental health or substance abuse disorder; and

WHEREAS, Roseland Community Hospital in Chicago is a safety net hospital on the verge of closing due to a lack of federal and State funding; and

WHEREAS, Approximately 24,000 patients visit Roseland's emergency department each year and about 60% of Roseland's total patients are on Medicaid; and

WHEREAS, The closure of Roseland and any other safety net hospital would be damaging to the surrounding communities and to the State of Illinois; and

WHEREAS, Increased access to healthcare leads to better quality of life and lowers financial burdens for both families and communities; and

WHEREAS, The governor, as chief executive officer of the state, has a duty to fight for and protect the rights and health of the citizens he serves; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly urge the federal government, the United States Congress, and the President of the United States to restore the cut funding to the 340B Drug Discount Program and Medicaid's Disproportionate Share Hospital program to protect healthcare for low-income and at-risk populations; and be it further

RESOLVED, That we strongly urge the Governor Rauner to protect the health and rights of his most vulnerable citizens by doing whatever is necessary to increase funding to and ensure the survival of safety net hospitals in Illinois such as Roseland Community Hospital; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Rauner, President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, U.S. Senate Minority Leader Chuck Schumer, U.S. Speaker of the House Paul Ryan, U.S. House of Representatives Minority Leader Nancy Pelosi, and all members of the Illinois Congressional Delegation.



## HOUSE RESOLUTION 803

Offered by Representative Demmer:

WHEREAS, Herpes zoster (shingles) is a disease caused by the same virus (zoster) that causes chickenpox; therefore, any individual who has contracted chickenpox is at risk for shingles, approximately 98% of U.S. adults; and

WHEREAS, Nearly one in three people in the U.S. will contract shingles in their lifetime, corresponding to an estimated one million people annually; and

WHEREAS, The risk of shingles increases with age, with nearly half of those affected over 60 years of age; half of people living until 85 years of age will develop shingles; and

WHEREAS, Shingles is a viral infection that causes a painful rash that can be severe; other symptoms include long-term nerve pain, fever, headache, chills, upset stomach, muscle weakness, skin infection, scarring, and decrease or loss of vision or hearing; and

WHEREAS, As much as 20% of adults who have contracted shingles will develop postherpetic neuralgia, a debilitating complication of shingles that causes severe pain that may interfere with sleep and recreational activities and can be associated with clinical depression; and

WHEREAS, Vaccines have reduced the burden of widespread and often fatal diseases, enabling individuals to lead longer and healthier lives while reducing health care costs; and

WHEREAS, Although much attention has been paid to the importance of childhood vaccinations, there is a general lack of awareness of adult-recommended vaccines and a misperception that immunizations are unnecessary for healthy adults; and

WHEREAS, The United States Centers for Disease Control and Prevention (CDC) and the Advisory Committee on Immunization Practices (ACIP) recommend that healthy adults 50 years and older be vaccinated against shingles to prevent shingles and shingles-related complications; and

WHEREAS, Despite the recommendations of CDC officials and other experts that all healthy adults be vaccinated against shingles, as of 2015 only 30% of eligible adults had received the shingles vaccine; and

WHEREAS, The annual economic burden of shingles in American adults is estimated to be between \$782 million and \$5 billion; and

WHEREAS, The Institute of Medicine (IOM) has stated that one of the six causes of excess costs in the U.S. healthcare system is missed prevention opportunities; and

WHEREAS, Millions of American adults go without routine and recommended vaccinations because our medical system is not set up to ensure that adults receive regular preventive healthcare; and

WHEREAS, The month of August is observed as National Immunization Awareness Month; residents of Illinois should be encouraged to speak with their healthcare provider to ensure that they have been properly vaccinated against shingles according to current CDC and ACIP recommendations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare August of 2018 as "Shingles Awareness and Improvement Month" in the State of Illinois to increase public awareness of the importance of adults receiving vaccines against shingles and to promote outreach and education efforts concerning adult vaccination; and be it further

RESOLVED, That the Department of Public Health is urged to take appropriate action to promote "Shingles Awareness and Improvement Month", including urging health care practitioners to discuss vaccines for shingles with adult patients and adopting appropriate programs and initiatives to raise public awareness of the importance of adult vaccination; and be it further

RESOLVED, That the Department of Public Health is urged to create and disseminate educational resources on shingles and shingles vaccination to educate the residents of Illinois on vaccine-preventable diseases; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Department of Public Health.

## HOUSE RESOLUTION 808

Offered by Representative Hammond:

WHEREAS, The Illinois State Board of Education is charged with setting educational policies and guidelines for public and private schools, preschool through grade 12, as well as vocational education; and

WHEREAS, The State Board of Education analyzes the aims, needs, and requirements of education and recommends legislation to the General Assembly and Governor for the benefit of the school children throughout Illinois; and

WHEREAS, The State Board of Education's stated mission is to "Provide leadership and resources to achieve excellence across all Illinois districts by engaging legislators, school administrators, teachers, students, parents, families, and other stakeholders in formulating and advocating for policies that enhance education, empower districts, and ensure equitable outcomes for all students"; and

WHEREAS, The State of Illinois recently enacted a new school funding formula with a historic amount of dollars dedicated to elementary and secondary education that the State Board of Education has been unable to distribute to schools across the State; and

WHEREAS, Due to years of budget uncertainty and numerous State-mandated regulations, Illinois is also currently facing a devastating statewide teacher shortage that has left schools across the State without qualified teachers in many classrooms; and

WHEREAS, The State Board of Education has recently informed the General Assembly that they have concerns about the cut in State funding that is being provided to it for administrative and employment purposes; and

WHEREAS, The State Board of Education recently posted on its website an advertisement concerning the position of "Storyteller" to serve under the Chief Education Officer; and

WHEREAS, The job description provides that the State Board of Education plans to hire three full-time "Storytellers" at a salary of approximately \$47,400 to work in either its Springfield or Chicago offices; and

WHEREAS, These "Storytellers" will be tasked with, among other duties, connecting real-world practices from schools and districts around Illinois to show the impact of education policy and programs; and

WHEREAS, "Storytellers" are also tasked with creating compelling, persuasive, relevant, and accurate communications content that will increase engagement with programmatic goals and build community support for ISBE programs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we believe this is not the appropriate time for the State Board of Education to hire three public relations professionals to serve as "Storytellers"; and be it further

RESOLVED, That we believe these tax dollars would be of better use in the classroom helping educate the millions of children that rely on a quality public education in this State; and be it further

RESOLVED, That we urge the State Board of Education to focus its resources and energy on distributing evidence-based funding on a timely basis rather than hiring additional employees, in an already cash-strapped State agency, to travel the State of Illinois promoting a public relations campaign; and be it further

RESOLVED, That suitable copies of this resolution be delivered to State Board of Education Chairman James Meeks and State Superintendent of Education Dr. Tony Smith.

#### HOUSE RESOLUTION 809

Offered by Representative Willis:

WHEREAS, The opioid epidemic is the most significant public health and public safety crisis in Illinois; and

WHEREAS, Opioid overdoses have killed nearly 11,000 people since 2008 and have now become the leading cause of death nationwide for people under the age of 50; and

WHEREAS, According to the United States Drug Enforcement Administration (DEA), there has been a dramatic increase in the availability of dangerous synthetic opioids and the drug Fentanyl constitutes a large majority of such synthetic opioids; and

WHEREAS, Fentanyl is a powerful Schedule II narcotic and can cause serious negative health effects, including respiratory depression at very low doses and can even be lethal; and

WHEREAS, According to the DEA, Fentanyl, including its synthetic forms, has similar effects on the human body as morphine but is 50-100 times more potent than morphine; and

WHEREAS, Illicit Fentanyl, Fentanyl-related substances, and other synthetically made opioids resemble powerful drugs, such as heroin or cocaine and can be found as powder, pills, capsules, liquid, and on blotted paper; and

WHEREAS, Fentanyl exposure can occur via injection, oral ingestion, contact with mucous membranes, inhalation, and through the skin; and

WHEREAS, Because of its potency and its affinity for absorption into the human body, synthetic Fentanyl poses a real danger to first responders, public health officials, and law enforcement; and

WHEREAS, The DEA has issued warnings that law enforcement's accidental exposure to synthetic Fentanyl can occur during the execution of search or arrest warrants, the purchase of Fentanyl during undercover operations, the processing of drug evidence containing Fentanyl or Fentanyl-related substances, or the processing of non-drug evidence which could be contaminated with Fentanyl or its analogues; and

WHEREAS, It is imperative that law enforcement, public health officials, and first responders be knowledgeable about the situations in which exposure to Fentanyl or its analogues can occur and how to prevent such exposure; and

WHEREAS, To reduce their exposure to Fentanyl or its analogues, law enforcement, public health officials and first responders must follow their applicable standard safe operating procedures and use personal protective equipment to protect themselves from the dangerous effects of Fentanyl or its analogues; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all first responders, law enforcement, and public health officials to be educated about the dangers of exposure to Fentanyl or its analogues; and be it further

RESOLVED, That we urge all Illinois first responders, law enforcement, and public health officials to take proper precautions to avoid potential overdose of Fentanyl or its analogues.
