WHEREAS, The members of the Illinois House of Representatives are saddened to learn of the death of former Illinois State Representative Thomas B. "Tom" Berns, who passed away on February 19, 2018 at the age of 72; and

WHEREAS, Rep. Berns was born to Henry E. and Phyllis R. (Berglin) Berns on April 8, 1945 and raised in the Illinois communities of Atlanta and Plano; he married his high school sweetheart Jeannie Galvin on August 28, 1965 in Plano and the two enjoyed 52 years of marriage; together they raised two lovely children, Rebecca and Michael; and

WHEREAS, Rep. Berns graduated from the University of Illinois at Urbana-Champaign in 1968 with a bachelor's degree in civil and environmental engineering and began working as an engineer at Danner and Associates, Inc.; in 1975, he and his colleague and friend, Ed Clancy, formed their own business, Berns, Clancy and Associates; in 1979, the firm incorporated and moved to its current location on Main Street in Urbana; today, Berns, Clancy and Associates Inc. is regarded as one of the premier engineering firms in East Central Illinois; and

WHEREAS, Rep. Berns taught surveying for the University of Illinois as an adjunct instructor and around the State for the Engineering Extension Service; he also taught many continuing education classes for the Illinois Professional Land Surveyor's Association, where he served as president in 1976; and

WHEREAS, In 2000, Rep. Berns was appointed to the Illinois House of Representatives to fulfill the unexpired term of former State Rep. Tim Johnson; after completing Rep. Johnson's term, Rep. Berns was reelected and served one full term; and

WHEREAS, During his time in the Illinois House of Representatives, Rep. Berns sponsored or cosponsored 64 House Bills, 20 Senate Bills, and 27 Resolutions; and

WHEREAS, Throughout his career, Rep. Berns received many awards, including the Young Engineer of the Year award in 1975 from the Illinois Society of Professional Engineers, the Distinguished Service Award from the Illinois Professional Land Surveyors Association in 1990, the Chi Epsilon Civil Engineering Honor Society and Tau Beta Pi Engineering Honor Society Awards from the University of Illinois, the Urbana Rotary Vocational Achievement Award in 2007, and the Outstanding Civil Engineer Award from the American Society of Civil Engineers in 2009; and

WHEREAS, Rep. Berns was also a dedicated volunteer and community servant; he was a longtime member of the Urbana Rotary Club and served as the club's president in 1987-1988; he served as president of the Urbana Country Club; he was a team manager and president of the Prairie Little League for four years; he served on the boards of the Champaign County Chamber of Commerce and the Illinois Chamber of Commerce; he was on the board of the Champaign Urbana Schools Foundation from 2005-2011, a member of the Champaign County Bell Tower Committee, and served on the boards of the Champaign County Forest Preserve District Foundation and the Urbana Park District Foundation; he was a member of the board of trustees of the Champaign Urbana Mass Transit district for 11 years and served as its chairman for one term; he was on the board of Clark Lindsey Village in Urbana for 38 years, 35 of those years as chairman; and

WHEREAS, Rep. Berns was a member of St. Patrick's Roman Catholic Congregation in Urbana for over 50 years; he was a lifelong Illini sports fan and enjoyed playing golf and tennis, fly fishing, and spending time with his family and grandchildren; and

WHEREAS, Rep. Berns is survived by his wife, Jeannie; his daughter, Rebecca Berns; his son, Michael (Kelly) Berns; his grandchildren, Brenna, Braden, Breccan, and Briley; and his sister, Mary Ellen Smith; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we mourn the passing of former Illinois State Representative Thomas B. "Tom" Berns, and extend our sincere condolences to his family, friends, and all who knew and loved him; and be it further

HOUSE BILL 5831. Introduced by Representative Scherer, AN ACT concerning appropriations.

HOUSE BILL 5832. Introduced by Representative Stuart, AN ACT concerning transportation.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 887

Offered by Representative Daniel Burke:

WHEREAS, According to the tax documents of the Humane Society of the United States, as well as other independent analyses, the national organization renowned for animal rights donated less than one percent of their \$132 million budget to help care for actual animals in 2016; and

WHEREAS, This information differs from the impression people are given by their late-night commercials, which depict animals in distress and in need of help; the end result is that people who want to help innocent animals are baited into donating their money, which in turn is used to help pay for the six-to-seven figure salaries of executives, and the frivolous law suits of local pet stores, zoos, and hardworking farmers; and

WHEREAS, These financial revelations about the Humane Society of the United States, along with the allegations of sexual assault against their former CEO, bring into question whether the organization is truly living up to its mission, advocating for the rights of animals; and

WHEREAS, Members of this chamber should be encouraging the residents of Illinois to research other local humane societies that are completely unaffiliated with the National organization; residents of Illinois will find that these independent humane societies do not receive many donations and rely primarily on dedicated volunteers to care for the animals; and

WHEREAS, Unlike the Humane Society of the United States, local independent humane societies prioritize assisting animals in our own communities, especially those that are abused and neglected, and ending animal abuse; these local organizations are where we, as residents of Illinois, should donate our time and money; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we admonish the Humane Society of the United States for their disrespectful work culture and lack of commitment to supporting animals; furthermore, we ask anyone who supports animal rights causes to support their local independent humane society instead.

HOUSE RESOLUTION 890

Offered by Representative Drury:

WHEREAS, On November 7, 2017, the Illinois House of Representatives and the Illinois Senate adopted House Joint Resolution 83 which urged action to address the issue of sexual harassment in Springfield and throughout Illinois State government; and

WHEREAS, House Joint Resolution 83 resolved that "those supporting this resolution are committed to saying #IWILL do better and I will work with my colleagues to change the culture that breeds such behavior"; and

WHEREAS, Since the adoption of House Joint Resolution 83, the Illinois General Assembly has not done better; and

WHEREAS, Since the adoption of House Joint Resolution 83, new allegations of sexual harassment and abuse in and around Illinois State government and political campaign organizations continue to be made public on a regular basis, diminishing the integrity of the Illinois General Assembly and the State of Illinois; and

WHEREAS, Since the adoption of House Joint Resolution 83, it has become public that allegations of sexual harassment, abuse and misconduct continue to be mishandled and minimized by the Speaker of the Illinois House of Representatives and his staff and attorneys; and

WHEREAS, Since the adoption of House Joint Resolution 83, there has been a lack of transparency from the Speaker of the Illinois House of Representatives and his staff and attorneys and an apparent effort to use propaganda to divert attention from very serious and troubling allegations of sexual harassment, abuse, and misconduct; and

WHEREAS, Since the adoption of House Joint Resolution 83, it has become clear that the Speaker of the Illinois House of Representatives and his staff and attorneys should not be in charge of investigating allegations of sexual harassment, abuse, and misconduct; and

WHEREAS, Calls have been made for an independent investigation into allegations of sexual harassment, abuse, and misconduct in Illinois State government and political campaign organizations, yet no action has been taken on these calls, and no process is in place to allow for a truly independent investigation; and

WHEREAS, Since the adoption of House Joint Resolution 83, it has become clear that an independent special counsel who is in no way controlled by the Speaker of the Illinois House of Representatives, his staff, his attorneys, or anyone else under the direct control of an Illinois government official is the only way for a truly independent investigation to take place; and

WHEREAS, The time has come for every legislator in the Illinois House of Representatives to stand up for Illinois citizens and demand the immediate appointment of an independent special counsel to investigate and, where necessary, litigate and prosecute, allegations of sexual harassment, abuse, and misconduct; and

WHEREAS, Time is of the essence; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that those supporting this resolution are committed to saying Time's Up and are urging the immediate enactment of whatever legislation is necessary to allow for the appointment of an independent special counsel who is in no way controlled by the Speaker of the Illinois House of Representatives, his staff, his attorneys, or anyone else under the direct control of an Illinois government official, as this is the only way for a truly independent investigation to take place; and be it further

RESOLVED, That the independent special counsel shall have the authority to issue subpoenas, command testimony under oath, open a statewide grand jury, and investigate and, where necessary, litigate and prosecute, allegations of sexual harassment, abuse, and misconduct; and be it further

RESOLVED, That suitable copies of this resolution be presented to every member of the General Assembly.

HOUSE RESOLUTION 891

Offered by Representative McSweeney:

WHEREAS, Illinois' income tax has been levied at a non-graduated rate since its inception in 1969; and WHEREAS, The current flat rate structure is a commitment from the Constitution of the State of Illinois; and

WHEREAS, Illinois' current flat tax rate provides a more predictable, sustainable, and enticing climate for businesses and individuals alike; and

WHEREAS, A graduated income tax is unresponsive to a modern economy, contributing to slower economic growth, less entrepreneurship, and fewer new jobs; and

WHEREAS, States with lower tax burdens, lower marginal tax rates, and less progressivity have more robust economies, with strong incentives to live, work, and start new businesses; and

WHEREAS, A graduated income tax creates an ever-increasing disincentive for work at each "step" in the marginal tax rate; and

WHEREAS, Sound tax policy should reward work effort, saving, investment, risk-taking, and entrepreneurship to promote self-sustaining prosperity; and

WHEREAS, Taxpayers would have no certainty what the final tax rates would be in the event that a constitutional amendment permitting a graduated income tax goes before voters; therefore, be it

HOUSE RESOLUTION 895

Offered by Representative Spain:

WHEREAS, Transportation infrastructure is critical to the economy and future growth of Illinois; and WHEREAS, Local roads comprise over 88% of the State's public road mileage, carrying around 40% of statewide traffic; and

WHEREAS, Transportation projects have traditionally been paid for with user fees, including gas taxes and vehicle registration charges; and

WHEREAS, Among the various grants awarded to local governments is the Needy Township program; and

WHEREAS, The Needy Township program once provided \$10 million annually to townships and road districts that levy the maximum tax rate allowed but still lack adequate revenue to meet a minimum per-mile funding level; the Illinois Department of Transportation determines eligible townships and assistance based on a district's equalized assessed value of all properties, annual average MFT distribution per mile, and average maintenance; and

WHEREAS, The Illinois Department of Transportation reduced the Needy Township allocation by almost half after the FY18 budget was enacted; and

WHEREAS, Other grants to local governments were reduced by almost \$50 million statewide; and

WHEREAS, These reductions follow a decades long trend of reducing funding by the State to local road districts; and

WHEREAS, The deterioration of local roads is contributing to the economic problems of Illinois; and WHEREAS, Local roads generated tax revenue and economic growth for the State of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Transportation to consider that a higher percentage of all new revenues and new transportation investments be distributed for local roads; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Secretary of Transportation, Randall S. Blankenhorn, and to Governor Bruce Rauner.
