CHANGE OF SPONSORSHIP

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 1031

Offered by Representative Butler:

WHEREAS, Ulysses S. Grant became a resident of Illinois in 1860, settling in Galena with his family, a community he called home when elected president in 1868; and

WHEREAS, Grant became the second of now four United States presidents with Illinois roots; and

WHEREAS, The U.S. Grant Home in Galena is an Illinois State Historic Site, a site on the National Register of Historic Places, and has been maintained by the State of Illinois since 1931; and

WHEREAS, Following his service in the United States Army, Grant joined fellow Galena residents who traveled to Springfield in 1861 to volunteer for military service with the Union Army; this led to Grant being named colonel of the 21st Illinois Infantry, thereby beginning his now famous rise up the ranks of the Union Army; and

WHEREAS, President Abraham Lincoln commissioned Grant as lieutenant general in 1864, becoming, at that time, only the second three-star general in United States history; and

WHEREAS, On April 9, 1865, General Grant famously accepted the surrender of Robert E. Lee of the Confederate Army of Northern Virginia at Appomattox Courthouse, thereby effectively ending our nation's civil war; and

WHEREAS, In 1866, General Grant was commissioned as our nation's first-ever four-star general; and

WHEREAS, On May 24, 1868, General Grant accepted the Republican Party nomination for President of the United States; and

WHEREAS, General Grant was elected the 18th President of the United States on November 3, 1868; at the age of 46, he became at that point the youngest-ever president by securing 214 of 294 electoral votes and carrying 26 of 34 states; and

WHEREAS, On November 5, 1872, President Grant was elected to a second term as president, securing 286 of 352 electoral votes and carrying 31 of 37 states; and

WHEREAS, During his time in office, President Grant was a champion for the rights of African Americans by working to protect the civil rights of freed slaves; he fought against the rise of terrorist groups such as the Ku Klux Klan; he enacted the Civil Rights Act of 1875, and he advocated for the passage of the 15th Amendment which was approved during his presidency, thereby granting African-American men the right to vote; and

WHEREAS, President Grant became the first president to discuss the rights of Native Americans during an inaugural address by promising "proper treatment of the original occupants of this land - the Indians"; he also appointed General Ely S. Parker, a member of the Seneca Nation, as the first Native American Commissioner of Indian Affairs; and

WHEREAS, President Grant enacted legislation designating Yellowstone as our first national park, created the Justice Department, instituted civil service reforms reducing the negative effects of patronage, and peacefully settled longstanding disputes with England which cemented our two countries as allies; and

WHEREAS, More than one million people attended President Grant's 1886 funeral in New York, including three U.S. presidents, and both Union and Confederate generals served as pallbearers; and

WHEREAS, During the early 20th Century, President Grant's reputation was systematically sullied by Confederate sympathizers and white supremacists, doing much damage to his legacy of military success and his reputation as a president who did as much to advance the cause of freedom as almost any other American; and

WHEREAS, November 3, 2018 will be the 150th anniversary of U.S. Grant's election as President of the United States; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the tremendous accomplishments of Ulysses S. Grant during his service to the United States as both president and military officer; and be it further

RESOLVED, That we declare November 3, 2018 as President Ulysses S. Grant Day in the State of Illinois in honor of his achievements and in commemoration of the 150th anniversary of his election as president; and be it further

RESOLVED, That we encourage the U.S. Grant Home State Historic Site and the Illinois Department of Natural Resources to plan and carry out appropriate activities to commemorate the sesquicentennial of Grant's election as president.

HOUSE RESOLUTION 1037

Offered by Representative Tabares:

WHEREAS, The Animal Welfare League was founded in 1935 to stop the suffering of animals in Chicagoland; the Animal Welfare League's mission is to prevent cruelty to animals, provide quality homes through adoption, promote respect and compassion for all creatures through humane education, provide shelter and care for homeless and unwanted animals, reduce pet overpopulation through its in-house low-cost spay and neuter clinic, provide veterinary care for low-income pet owners, and relieve the suffering of animals; and

WHEREAS, Recently, a constituent has voiced concerns about the treatment of the animals under the care of the Animal Welfare League in Chicago Ridge; allegations include the mistreatment of animals by employees and terrible living conditions for the animals; and

WHEREAS, Animal cruelty prevention is a major concern for our society, and it is important to put a stop to this silent epidemic in the communities across our State; and

WHEREAS, Illinois has done tremendous work to put policies in place to protect animals across our communities to ensure they are well taken care of; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge an investigation into the treatment of the animals under the care of the Animal Welfare League in Chicago Ridge to ensure they are following the criteria established in their mission statement; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois Department of Agriculture and Chris Dogoda.

HOUSE RESOLUTION 1044

Offered by Representative Durkin:

WHEREAS, As many as 15 million Americans have food allergies; nearly six million are children under the age of 18; and

WHEREAS, Research shows that the prevalence of a food allergy is increasing among children; and

WHEREAS, Eight foods cause the majority of all food allergy reactions in the United States: shellfish, fish, milk, eggs, tree nuts, peanuts, soy, and wheat; symptoms of a food-allergic reaction can include hives, vomiting, diarrhea, respiratory distress, and swelling of the throat; and

WHEREAS, Food allergies result in more than 200,000 Emergency Department visits each year; restrictions typically occur when an individual unknowingly eats a food containing an ingredient to which they are allergic; and

WHEREAS, The number of food allergy reactions requiring emergency treatment has sharply increased over the past decade, with a 377 percent rise in medical procedures associated with anaphylaxis caused by food; and

WHEREAS, Anaphylaxis is a serious allergic reaction that is rapid onset and may cause death; and

WHEREAS, There is no cure for a food allergy, and scientists do not understand why; strict avoidance of the offending food is the only way to prevent an allergic reaction; and

WHEREAS, Food Allergy Research and Education (FARE) is a national, nonprofit organization dedicated to improving the quality of life and the health of individuals with food allergies; the organization also provides hope through the promise of new treatments; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of May 13-19, 2018 as Food Allergy

Awareness Week in the State of Illinois to encourage residents to increase their understanding and awareness of food allergies and anaphylaxis; and be it further

RESOLVED, That a suitable copy of this resolution be presented to FARE in recognition of their commitment to the 15 million Americans with food allergies.

HOUSE RESOLUTION 1046

Offered by Representative Durkin:

WHEREAS, Cystic fibrosis, commonly referred to as "CF", is a genetic disease affecting approximately 30,000 children and adults in the United States and nearly 70,000 children and adults worldwide, 1,035 of whom live in Illinois; and

WHEREAS, A defective gene causes the body to produce an abnormally thick, sticky mucus that clogs the lungs; these secretions produce life-threatening lung infections and obstruct the pancreas, preventing digestive enzymes from reaching the intestines to help break down and absorb food; and

WHEREAS, More than 10 million Americans are symptomless carriers of the defective cystic fibrosis gene; cystic fibrosis occurs in approximately one of every 3,500 live births in the United States; and

WHEREAS, The median age of survival for a person with cystic fibrosis is 41.1 years; and

WHEREAS, With advances in the treatment of cystic fibrosis, the number of adults with cystic fibrosis has steadily grown, and approximately 1,000 new cases of cystic fibrosis are diagnosed each year; and

WHEREAS, Nearly 50% of the cystic fibrosis population is 18 years of age and older; people with cystic fibrosis have a variety of symptoms attributed to the more than 1,800 mutations of the cystic fibrosis gene; and

WHEREAS, Infant blood screening to detect genetic defects is the most reliable and least costly method to identify persons likely to have cystic fibrosis; and

WHEREAS, Early diagnosis of cystic fibrosis permits early treatment and enhances quality of life and longevity; the treatment of cystic fibrosis depends on the stage of the disease and the organs involved; and

WHEREAS, Clearing mucus from the lungs is an important part of the daily cystic fibrosis treatment regimen; other types of treatments include inhaled antibiotics and pancreatic enzymes, among others; and

WHEREAS, There are 15 world-class treatment centers in Illinois that specialize in the diagnosis of cystic fibrosis and the care of persons with cystic fibrosis; and

WHEREAS, A critical component of treating patients with cystic fibrosis includes access to innovative treatments, which can play a crucial role in the lives of patients with cystic fibrosis; and

WHEREAS, Improving the length and quality of life for people with cystic fibrosis starts with awareness; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of May of 2018 as Cystic Fibrosis Awareness Month in the State of Illinois.

Offered by Representative Slaughter:

WHEREAS, Alpha Phi Alpha Fraternity, Incorporated, was founded on December 4, 1906, by 7 college men, respectfully known as the "Seven Jewels", on the campus of Cornell University in Ithaca, New York, becoming the first intercollegiate Greek-letter fraternity established by and for African-Americans; and

WHEREAS, The Seven Jewels of the Fraternity, Henry Arthur Callis, Charles Henry Chapman, Eugene Kinckle Jones, George Biddle Kelley, Nathaniel Allison Murray, Robert Harold Ogle, and Vertner Woodson Tandy, recognized the need for a strong bond of brotherhood among African descendants in this country while stressing academic excellence among its members; the founders recognized the need to help correct the educational, economic, political, and social injustices faced by African-Americans and other people of color; and

WHEREAS, Alpha Phi Alpha initially served as a study and support group for minority students who faced racial prejudice, both educationally and socially, at Cornell University; the Jewel Founders and early leaders of the Fraternity succeeded in laying a firm foundation for Alpha Phi Alpha's principles of scholarship, fellowship, good character, and the uplifting of humanity; and

WHEREAS, Since its founding, Alpha Phi Alpha has consistently supplied its voice and vision to the struggle of African-Americans, people of color, and issues of civil rights around the world; and

WHEREAS, The aims of Alpha Phi Alpha are manly deeds, scholarship, and love for all mankind; and

WHEREAS, The mission of Alpha Phi Alpha is to develop leaders, promote brotherhood and academic excellence, and provide service and advocacy for communities, as exemplified through its national programs, which include "Go to High School, Go to College", which focuses on the educational achievement of students in elementary, secondary, and post-secondary schools and has given thousands of dollars in scholarship funds to deserving students; "Project Alpha", which teaches teenage pregnancy prevention and sexually transmitted disease prevention to young males, and its "A Voteless People is a Hopeless People" campaign, a voter registration and education program, through which thousands of voters have been educated and registered;

Alpha Phi Alpha also focuses on providing service through its strategic partnerships with Big Brothers Big Sisters, the Boy Scouts of America, March of Dimes, the American Heart/American Stroke Association, and the American Cancer Society; and

WHEREAS, For over 109 years, Alpha Phi Alpha has played a fundamental role in the positive development of the character and education of more than 200,000 men around the world; and

WHEREAS, Alpha Phi Alpha has over 700 college and alumni chapters in the United States of America, Africa, Asia, the Caribbean, and Europe; this total includes 141 chapters in the Midwestern Region, including 32 in Illinois; the Midwestern Region includes the states of Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Ohio, Nebraska, West Virginia, Wisconsin, and Canada; Alpha Phi Alpha's presence started in Illinois, with the founding of the first college chapter in Illinois, the Theta Chapter, in 1910, and the first alumni chapter, the Xi Lambda Chapter, in 1924, both in Chicago; and

WHEREAS, Members of Alpha Phi Alpha include many noteworthy leaders in the areas of government, business, entertainment, science, and higher education, including the likes of Dr. Martin Luther King, Jr., Thurgood Marshall, W.E.B. DuBois, John Hope Franklin, John H. WHEREAS, Several Alpha Phi Alpha members have served in the Illinois General Assembly, including: Senator Donne E. Trotter and Representatives Al Riley, Arthur Turner, Jr., Emanuel "Chris" Welch, and Elgie R. Sims, Jr., who also served as the 26th Vice President of the Midwestern Region; and

WHEREAS, Alpha Phi Alpha continues to enrich the lives of its members, who, in turn, provide service and advocacy for the communities they serve with a commitment to service and the uplifting of humanity; therefore, be it

HOUSE RESOLUTION 1050

Offered by Representative Morrison:

WHEREAS, In 1983, President Ronald Reagan designated November as Alzheimer's Awareness Month nationally; and

WHEREAS, Alzheimer's disease is a neurodegenerative disease that causes a person to progressively lose their memory and overall cognitive function over time; Alzheimer's robs a person of their short-term and long-term memory and has a significant effect on their loved ones; and

WHEREAS, Alzheimer's disease is the most common form of dementia, accounting for 60 to 80% of all dementia cases; dementia is a general term to describe a severe decline in mental ability that interferes with daily life; and

WHEREAS, There are currently 5.7 million people living with Alzheimer's in the United States, and the Alzheimer's Association projects that number to grow to 14 million by 2050; and

WHEREAS, Alzheimer's disease is the 6th leading cause of death in the United States and kills more people than breast cancer and prostate cancer combined; according to the Alzheimer's Association, one out of every three seniors dies of Alzheimer's disease; and

WHEREAS, Someone in the United States develops Alzheimer's or some form of dementia every 65 seconds; and

WHEREAS, The Alzheimer's Association estimates that Alzheimer's disease and other forms of dementia will cost people in the United States a combined \$277 billion in 2018; they also state that early and accurate diagnosis of Alzheimer's could save up to \$7.9 trillion in medical costs; and

WHEREAS, No cure is currently available for Alzheimer's disease, and the approximate lifetime cost of care for a person living with Alzheimer's is \$341,840; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare November of 2018 as "Alzheimer's Awareness Month" within the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Alzheimer's Association - Illinois Chapter.

HOUSE JOINT RESOLUTION 125

Offered by Representative Jimenez:

WHEREAS, State Employees Group Insurance provides healthcare coverage for Illinois state employees and dependents; and

WHEREAS, State employees group insurance costs the State nearly \$2 billion annually; and

WHEREAS, It is important to continue to provide adequate care to Illinois employees and their families while also being economically efficient; and

WHEREAS, In 2017, the City of Springfield, in an effort to address the situation of rising healthcare costs, opened an employer sponsored health clinic; and

WHEREAS, Springfield School District 186 and Sangamon County are partnering to launch a similar health clinic option for their employees; and

WHEREAS, An employer-sponsored health clinic is designed to be a clinic where employees are able to receive various services, including lab work and medical care for minor issues with no out-of-pocket costs to the employee and dependents; and

WHEREAS, The issue of controlling health care costs has been a contentious issue for the State of Illinois and its employee unions through the collective bargaining process for many years, with the current contract being tied up in the judicial system; and

WHEREAS, An employer-sponsored health clinic for employees and dependents can see savings by paying a flat contracted rate between the clinic and the employer rather than paying much higher rates at similar clinics under health insurance plans; and

WHEREAS, As the cost of health care in Illinois and across the country continues to rise, it is vital that the State of Illinois look for innovative ways to provide access to care for its employees, dependents, and retirees while at the same time maintaining current levels of care and doing so at a lower overall cost to taxpayers in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the State Sponsored Health Clinic Task Force to study the possibility of implementing a State of Illinois sponsored health clinic for state employees, dependents, and retirees, with the purpose of providing quality care and annual savings to State's overall group insurance costs; and be it further

RESOLVED, That the Task Force shall be composed of the following members, to serve without compensation:

- 1) Two individuals appointed by the Speaker of the House;
- 2) Two individuals appointed by the Minority Leader of the House;
- 3) Two individuals appointed by the President of the Senate;
- 4) Two individuals appointed by the Minority Leader of the Senate;
- 5) One individual appointed by the Governor; and
- 6) One individual appointed by the president/director of a union representing the

largest amount of State employees; and be it further

RESOLVED, That the Department of Central Management services shall provide administrative support for the Task Force; and be it further

RESOLVED, That the Task Force shall submit its final report to the General Assembly no later than December 31, 2018, and upon the filing of its report, the Task Force is dissolved; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Director of Central Management Services, the Speaker of the House, the Minority Leader of the House, the President of the Senate, the Minority Leader of the Senate, the Governor, and the president/director of a union representing the largest amount of State employees.

HOUSE JOINT RESOLUTION 126

Offered by Representative Ford:

WHEREAS, President Dwight D. Eisenhower's ad hoc President's Committee on Civil Rights stated that "In a democratic society, the systematic, critical review of social needs and public policy is a fundamental necessity. This is especially true of a field like civil rights, where problems are enduring, and range widely (and where)...a temporary, sporadic approach can never finally solve these problems"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Illinois Commission on Civil Rights is hereby created; and be it further

RESOLVED, That the Commission is charged with the task of studying alleged discrimination based on race, color, religion, sex, age, disability, and national origin; it also is to study alleged deprivations of voting rights and discrimination in the administration of justice; and be it further

RESOLVED, That the Commission is to consist of 8 members; two appointed by the Speaker of the House of Representatives, two appointed by the President of the Senate, two appointed by the House Minority Leader, and two appointed by the Senate Minority Leader; and be it further

RESOLVED, That those on the Commission shall serve without compensation and shall select a chairperson from its members; and be it further

RESOLVED, That the Commission shall submit a report to the General Assembly no later than January 9, 2019; and be it further

RESOLVED, That the report filed with the General Assembly shall be filed with the Clerk of the House of Representatives and the Secretary of the Senate in electronic form only, in the manner that the Clerk and Secretary shall direct; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker of the House of Representatives, the President of the Senate, the House Minority Leader, and the Senate Minority Leader.

HOUSE JOINT RESOLUTION 127

Offered by Representative Jimenez:

WHEREAS, In the late 1950s and early 1960s, United States military personnel began serving as military advisors to the South Vietnamese military in their conflict with North Vietnam; and

WHEREAS, As the Vietnam War escalated over the subsequent decade; Americans, including many Illinoisans, were called to join the war as the United States implemented a military draft; and

WHEREAS, As the war continued, over 58,000 members of the United States Armed Forces would lose their lives and more than 300,000 were wounded; and

WHEREAS, Nearly 3,000 Illinoisans were killed or listed as missing in action during the Vietnam War; and

WHEREAS, Upon returning home, those who served in Vietnam were met with a vigorous public debate about the involvement of the United States in the war; and

WHEREAS, As these veterans returned home, many of them were not given the credit and support they deserved for dutifully serving their country; many were met with vigorous protests and condemnations and received widespread insults by opponents of the Vietnam War; and

WHEREAS, While service members returning home following World War II and the Korean War were met with homecoming celebrations, veterans returning from Vietnam were met with strong opposition that was directed at them rather than the appropriate decision makers in Washington; and

WHEREAS, Many who returned home from the battlefield were spit on, called killers, and ignored by the American public at a time when they needed the support of their fellow citizens; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we stand united in our strong support of all military personnel who served and sacrificed during the Vietnam War and offer our heartfelt and sincere apology to all Vietnam veterans who were mistreated after returning home from their service; and be it further

RESOLVED, That we declare November 1, 2018 as "Vietnam Veterans Recognition Day" in the State of Illinois; and be it further

RESOLVED, That we urge all Illinoisans to show support and gratitude to all Americans who have worn the uniform of the United States and who put their lives in danger to defend our freedoms; and be it further

RESOLVED, That we urge the Governor and the Secretary of State to instruct that all flags within their purview be lowered to half-mast on November 1, 2018 as a sign of respect to all Vietnam veterans; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Director of the Illinois Department of Veteran's Affairs, the Illinois Vietnam Veterans of America, the Illinois Secretary of State, and the Governor of the State of Illinois.

MESSAGES FROM THE GOVERNOR

April 27, 2018

To the Honorable Members of
The Illinois House of Representatives,
100th General Assembly:

Today I veto House Bill 1273 from the 100th General Assembly, which would have restricted certain placements of security cameras and further outlined the licensure renewal and fee provisions of Senate Bill 1657 had it become law. This bill is moot, as my total veto of the underlying legislation stands.

As a parent, and a grandparent, I can tell you – all anyone wants to know is that their family is safe. Our focus needs to be squarely on substantive public safety policies that accomplish this goal. We need to focus on really moving the needle on critical public safety issues. We need a comprehensive approach including school safety and keeping guns out of the hands of criminals and the mentally ill.

These are bipartisan issues that our Legislative Public Safety Working Group has been discussing over the last several weeks. Together legislators and my office are looking at what legislation is already on the table, and identifying what more we can do to keep people safe in their homes, schools and places of worship.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return House Bill 1273, entitled "AN ACT concerning regulation", with the foregoing objections, vetoed in its entirety.
