### **HOUSE RESOLUTION 1117**

Offered by Representative Cavaletto:

WHEREAS, On November 4, 1943, members of the American Legion met at the Luther B. Easley Post 128 in Salem; at this meeting, the G.I. Bill of Rights (officially known as the Servicemen's Readjustment Act of 1944) was "born" to assist veterans of active service in the U.S. Armed Forces during World War II; and

WHEREAS, The G.I. Bill of Rights was drafted by Omar J. McMackin of Salem, Earl W. Merritt of Salem, former Governor John Stelle of McLeansboro, Dr. Leonard W. Esper of Springfield, George H. Bauer of Effingham, William R. McCauley of Olney, James P. Ringley of Lemont, and A. L. Starshak of Chicago; and

WHEREAS, The plan, originally written down as ideas on napkins in Salem, eventually became legislation passed by the U.S. Senate on June 12, 1944 and the U.S. House of Representatives on June 13, 1944; it was signed into law by President Franklin Delano Roosevelt on June 22, 1944; and

WHEREAS, There were several key components of the G.I. Bill of Rights that included educational opportunity, vocational on-the-job training, readjustment financial allowances, home, farm, and business loans, a review of discharges, adequate health care for veterans, the prompt settlement of disability claims, mustering-out pay (which was removed from the bill after it was enacted separately), effective veteran employment services, and the concentration of all veterans functions in the Veterans Administration; and

WHEREAS, On June 26, 1958, the American Legion - Department of Illinois recognized with a citation stating "That All Men will now recognize the Luther B. Easley Post 128 as the Birthplace of the G.I. Bill of Rights"; and

WHEREAS, This historic piece of legislation is a fine example of things to recognize as being born, built, or grown in Illinois as part of the Illinois bicentennial; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize November 4, 2018 as the 75th anniversary of the "birth" of the G.I. Bill of Rights (officially known as the Servicemen's Readjustment Act of 1944) at the Luther B. Easley Post 128 of the American Legion in Salem; and be it further

RESOLVED, That suitable copies of this resolution be presented to Commander Harold Kocher of the Luther B. Easley Post No. 128, and all other American Legion post commanders with members involved in this historic meeting, as a symbol of our esteem and respect.

### **HOUSE RESOLUTION 1118**

Offered by Representative Brady:

WHEREAS, Peroxisome Biogenesis Disorder - Zellweger Spectrum Disorder (PBD-ZSD or simply PBD) is a rare genetic disorder that affects 1 in 50,000 births within the United States of America; and

WHEREAS, PBD causes life threatening symptoms for most infants and children who have the disease; and

WHEREAS, PBD results in poor muscle tone, hearing loss, vision loss, low bone density, seizures, liver and kidney dysfunction, and developmental delays; and

WHEREAS, PBD causes a mutation in any of the 13 genes termed PEX genes; and

WHEREAS, Max Chapman, born October 17, 2013, a resident of Bloomington, was diagnosed with PBD at the age of 14 months; with his loving heart, his cheerful disposition, and boundless personality, Max has inspired countless family and friends in Central Illinois to spread awareness of this devastating disorder; and

WHEREAS, Max's parents, Corin and Todd Chapman, and his grandparents, Alan and Kathie Chapman and Greg and Patty Garbe, create awareness for PBD by sharing Max and his story unselfishly through blogging, social media, video, and fundraising events; and

WHEREAS, May 18 and 19, 2018 is the third annual Tee it Up! For the GFPD golf outing at Illinois State University's Weibring Golf Club to honor Max and raise funds for The Global Foundation for Peroxisomal Disorders (GFPD) in support of their mission to advocate for awareness of PBD and support new avenues for medical research in the development of treatments and cures; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge awareness of peroxisomal disorders and encourage support for medical research in the development of new treatments and cures; and be it further

RESOLVED, That suitable copies of this resolution be presented to The Global Foundation for Peroxisomal Disorders, Max Chapman, Max's parents, and Max's grandparents.

### **HOUSE RESOLUTION 1120**

Offered by Representative Butler:

WHEREAS, It is public policy of the State of Illinois to provide and maintain a healthful environment for the benefit of this and future generations; and

WHEREAS, It is the duty of the Illinois General Assembly to implement and enforce this constitutionally mandated right of the citizens of Illinois to a healthful environment; and

WHEREAS, The citizens of Illinois need clean waterways as a source of drinking water, for agricultural and industrial uses, as a healthful habitat for aquatic species, and for the enjoyment of recreational activities, including fishing, swimming, paddling, and boating; and

WHEREAS, Excessive levels of nutrients are degrading the quality of streams, rivers, and lakes within the State of Illinois and contributing to the dead zone in the Gulf of Mexico; and

WHEREAS, The 2008 Gulf Hypoxia Action Plan called on the State of Illinois to produce a plan to reduce the amount of phosphorus and nitrogen carried in rivers throughout the State and to the Gulf of Mexico; and

WHEREAS, The State's Environmental Protection Agency and Department of Agriculture collaborated with a Policy Working Group of academia, environmental non-profits, representatives of federal, state, and local agencies, wastewater treatment professionals, and the agricultural community to develop the Illinois Nutrient Loss Reduction Strategy in 2015; and

WHEREAS, The Strategy's Policy Working Group released its first biennial report on the implementation of the Strategy in 2017, documenting the substantial financial and staff resource efforts to educate all citizens of Illinois about nutrient loss, including through in-person meetings, workshops, and field days, as well as communication platforms to reach all stakeholders in Illinois; and

WHEREAS, The Strategy's biennial report also documented significant collaborative efforts to implement the Strategy, including through impressive resource investments in research, the installation of agricultural conservation practices across the State, and adoption of new technology to reduce nutrient levels in our waterways from wastewater discharges and runoff from agricultural and urban lands; and

WHEREAS, The Strategy's biennial report found a ten percent reduction in nitrogen loads, but a 17 percent increase in phosphorus loads; and

WHEREAS, The Strategy sets a milestone to reduce nitrogen loads by 15 percent and phosphorus loads by 25 percent by 2025 from baseline levels (1980-1996); and

WHEREAS, The Strategy's goal is to reduce both nitrogen and phosphorus loads by 45 percent by 2035; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the Nutrient Loss Reduction Strategy and the

work of stakeholders on the continued implementation of the Strategy as the State of Illinois and its citizens move forward in this important effort; and be it further

RESOLVED, That we encourage the agencies and their partners in implementing the Strategy to regularly communicate with the General Assembly and seek their support on activities and long-term programs that would help further their work and attain the Strategy's goals.
