HOUSE RESOLUTION 1126

Offered by Representative Mussman:

WHEREAS, The health and well-being of women in the State of Illinois is a top priority; the health and education of women is directly linked to improved social well-being for the entire community; and

WHEREAS, The reproductive rights of women and their ability to make their own decisions about how to take care of their own bodies should be protected; access to education and medical services regarding sexual health is one of those rights; and

WHEREAS, The Trump administration will reportedly propose a rule that prohibits Title X funding from going to organizations that perform or support abortions in addition to the other services they provide; and

WHEREAS, Federal funds already cannot be spent directly on abortions because of the 1976 Hyde Amendment, and any federal money that organizations like Planned Parenthood receive is instead used for other women's health services, such as contraception services, STD testing, breast cancer screenings, and other, potentially life-saving services; and

WHEREAS, The Trump administration's new rule would take the Hyde Amendment a step further and prohibit women, especially those from low-income backgrounds, from having access to basic healthcare services; and

WHEREAS, The Trump administration has already attempted to limit access to essential services by requiring Title X grant applicants to support an abstinence-only sex education and natural family planning methods, neither of which are recommended by health experts as effective ways to improve public health nor reduce teen pregnancy; and

WHEREAS, Funding Title X has received bi-partisan support since signed into law to help reduce unplanned pregnancies as well as provide all women, regardless of income level, with basic healthcare services; and

WHEREAS, The Trump Administration's new rule could result in increased levels of teen and unplanned pregnancies since access to contraception services would be cut off to communities that rely upon Title X funding; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that cutting funds to these services could result in the closure of organizations that service urban, suburban, and rural communities, putting the lives of women across the nation in jeopardy; and be it further

RESOLVED, That we urge the three branches of the federal government to continue funding Planned Parenthood and other similar organizations that provide basic healthcare to women, and to keep the Obama Era Title X guidelines; and be it further

RESOLVED, That we call on Governor Rauner to stand up to and urge the Trump administration to maintain the original Title X guidelines so that women in Illinois and throughout the country are able to receive essential healthcare services; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, Senate Majority Leader Mitch McConnell, Senate Minority Leader Chuck Schumer, Speaker of the House Paul Ryan, House of Representatives Minority Leader Nancy Pelosi, all members of the Illinois Congressional Delegation, and Governor Rauner.

HOUSE RESOLUTION 1127

Offered by Representative Connor:

WHEREAS, Gun violence continues to plague the United States and devastate families, schools, workplaces, and communities; in 2016, 38,658 people died by firearms in the U.S., including 1,490 in Illinois; and

WHEREAS, 4,349 people were shot in Chicago in 2016, and 3,457 were shot in 2017, 625 of who were killed; and

WHEREAS, The recent sustained surge in mass shootings has further revealed the depth of the gun problem in the U.S.; since the Sandy Hook Elementary shooting, over 400 people have been shot in over 200 school shootings nationwide; 2017 saw the most deadly mass shooting in U.S. history when 58 people were killed at a Las Vegas music festival; and

WHEREAS, In addition to efforts to enact gun control legislation at the local and federal levels, the private sector can also contribute to the effort to reduce gun violence in the United States; and

WHEREAS, In the wake of the Parkland shooting, a number of companies have taken steps to restrict gun sales: Dick's Sporting Goods raised the minimum age for gun sales to 21 and ceased sale of all assault-style riles; Walmart also raised its minimum age for gun sales to 21; and

WHEREAS, In New York State, the Comptroller has encouraged credit card and banking companies to consider reclassifying gun sales as high-risk sales, handling them as they would pornography or illicit drug purchases; this is yet another way that private companies can work to reduce the number of gun sales in Illinois and the United States; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Visa, American Express, MasterCard, Bank of America, and J.P. Morgan Chase to reclassify gun sales as high-risk and implement the appropriate precautions; and be it further

RESOLVED, That suitable copies of this resolution be sent to the Governor, and to the CEOs of Visa, American Express, MasterCard, Bank of America, and J.P. Morgan Chase.

HOUSE RESOLUTION 1128

Offered by Representative Durkin:

WHEREAS, Methicillin-resistant Staphylococcus aureus (MRSA) is a type of bacteria that is resistant to treatment with the usual antibiotics and is the most common pathogen that causes Healthcare-Associated infections (HAIs) in the United States and around the world; and

WHEREAS, According to the U.S. Centers for Disease Control and Prevention (CDC), there were 80,400 invasive MRSA infections in 2011, and MRSA invasive infection rates do not include MRSA surgical site infections, which are 90% of all MRSA infections; including MRSA surgical site infection rates, the total number of MRSA healthcare-associated infections is 723,600; and

WHEREAS, The U.S. Centers for Disease Control and Prevention (CDC) lists MRSA as a serious threat that requires prompt and sustained action to prevent the spread of MRSA which can cause severe problems such as blood stream, surgical site, central-line, and pneumonia infections; severe cases can cause sepsis and death; and

WHEREAS, In 2015, the World Health Organization (WHO) warned that the overuse of antibiotics is fueling dangerously high resistant levels; the former global director of the WHO has stated that "The rise of antibiotic resistance is a global crisis", and "antimicrobial resistance (AMR) is on the rise in every region of the world"; and

WHEREAS, According to the Illinois Department of Health's (IDPH) 2015 data, there were 17,578 healthcare-associated MRSA (HA-MRSA) cases from Illinois hospitals, and Illinois continues to have an ongoing MRSA epidemic; 75% of the patients infected with MRSA were 50 years of age or older with higher mortality rates; community-associated MRSA (CA-MRSA) infection rates continue still to be an unreported disease; and

WHEREAS, The U.S. Veterans Administration (VA) has been universally screening all patients upon admission for MRSA in all of their 150 facilities since 2007 and has reduced their MRSA hospital infection rates by over 80%, with 49.4% in long-term care facilities; and

WHEREAS, Individuals infected with MRSA are most likely to have longer and more expensive hospital stays, with the average cost between \$35,000 to \$120,000; and

WHEREAS, MRSA is a major factor in the annual price tag for treating healthcare-associated infections in the United States; and

WHEREAS, Anyone, not just infected patients but also MRSA colonized carriers, can be a vehicle for transmission of MRSA through skin-to-skin or object contact; and

WHEREAS, MRSA is a preventable disease with appropriate contact precautions, including strict adherence to hand hygiene and the decontamination of surfaces and the environment, along with a good antibiotic stewardship program in healthcare facilities; and

WHEREAS, Raising awareness of MRSA is important to the prevention of MRSA infections; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the work of patient advocates and organizations such as the MRSA Survivors Network in educating, supporting, and providing hope for individuals and their families affected by community and healthcare-associated infections; and be it further

RESOLVED, That we acknowledge the 10th anniversary of World MRSA Day, October 2, and the 10th anniversary of World MRSA Awareness Month in October; and be it further

RESOLVED, That we declare October 2, 2018 as "MRSA Day" in the State of Illinois; and be it further RESOLVED, That a suitable copy of this resolution be presented to the MRSA Survivors Network as a symbol of our respect and esteem.
