HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 1129

Offered by Representative Jones:

WHEREAS, The areas in and around a casino can sometimes be unstable; the housing market can be volatile, the residents often face high taxes, and there is frequently a proliferation of video gaming establishments; and

WHEREAS, When a casino is placed within a border community or a low-income community, it is expected that the casino will generate enough income to sustain itself and stabilize the surrounding housing market, reduce taxes, and encourage small business investment; and

WHEREAS, Small businesses are barely surviving in the south suburbs, and with potential casinos comes the need for new measures to spur the economy and provide new jobs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge COGFA and the Illinois Gaming Board to conduct a study on the impact of placing a casino in the south suburbs, specifically on what the casino's impact would be on the local housing market, taxes, and minority-owned and small businesses; and be it further

HOUSE RESOLUTION 1132

Offered by Representative Jones:

WHEREAS, Taxes in the south suburbs are at an all-time high; and

WHEREAS, The south suburbs have failed to produce on three solid economic restoration projects, including the third airport, the Metra revitalization, and the I-57 corridor project; and

WHEREAS, Many local economies are barely surviving, and taxes are driving residents out of the area; schools are relying on increased taxes to fund programs, and many programs are being cancelled; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to grant a five-year special tax for the south suburbs, which allows flat-rate taxes for alternating years for homeowners and businesses; homeowners would pay a flat rate of \$4,500 per year if they have lived in their homes for seven or more years; the next year, any commercial business would pay a flat rate of \$65,000 if they have been in business for seven or more years; new or existing businesses that employ more than fifteen to 25 people would only pay a flat rate in the year of the flat-rate tax system; and be it further

RESOLVED, That the special tax goes into effect providing that each community passes an ordinance or corresponding resolution accepting the flat tax rate, and that each municipality submits a three to five year redevelopment plan that addresses the creation of new businesses, housing market stabilization, black and Hispanic contracting goals, and a youth employment plan.

HOUSE RESOLUTION 1134

Offered by Representative Carroll:

WHEREAS, Suicide is a major public health problem and a leading cause of death in the United States that can have lasting effects on the family, friends, and communities of the person who acts to take his or her life; and

WHEREAS, Suicide is the 10th leading cause of death in the United States, and in 2015, was responsible for 44,193 deaths, or approximately one suicide death every 12 minutes; more than 1,000 Illinoisans die each year by suicide; Illinois death by suicide averages 2.9 every day, and suicide attempts average 16.7 every day; individuals ages 15 to 19 have the highest suicide attempt rate for any age group in Illinois; and

WHEREAS, Goal 1 of the Illinois Department of Public Health's Suicide Prevention Strategic Plan is to "... increase awareness, knowledge, and competency in suicide prevention, assessment and treatment for first responders and health care, social service, clergy, law enforcement and school personnel"; and

WHEREAS, Following the tragic loss of their 27-year old son, Stephen, the fifth of their eight children, to suicide on June 13. 1987, Stephen's parents, Edward and Mary Alice Sexton, decided to make their son's death a motivation for furthering life; and

WHEREAS, To realize that goal, the Sextons founded the Stephen Sexton Memorial Foundation in 1987 to raise funds for programs focused on the unmet need they discovered for suicide prevention, awareness, and research programs in Illinois; and

WHEREAS, Since its founding, the foundation has raised over \$1 million in funding for these programs, almost exclusively through the grassroots fundraising efforts of members of the Sexton Family and their friends; these programs include, among others, Maryville Academy's Stephen Sexton Training Institute and the Glenview Youth Service; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in light of the critical importance of expanding suicide prevention and awareness in Illinois, and in recognition of the commitment and pioneering efforts of the Sexton Family over more than 30 years to fund prevention and awareness programs in Illinois in honor of

the life of their son, Stephen T. Sexton, that we declare June 13, 2018 as Suicide Awareness Day in Illinois; and be it further

RESOLVED, That we encourage the sharing of suicide awareness and prevention strategies among individuals, communities and organizations so that all Illinoisans have access to the resources they need to discuss suicide awareness and prevention and dispel the myths, stigma, and shame surrounding suicide that hinders efforts to prevent it; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Sexton family, the Maryville Academy, and the Glenview Youth Service.

HOUSE RESOLUTION 1138

Offered by Representative Phillips:

WHEREAS, The State of Illinois is often regarded as having two distinct regions, the City of Chicago and downstate Illinois; and

WHEREAS, Even communities north of Chicago are considered "downstate" because they have more in common with rural southern and central Illinois counties than they do with the City of Chicago; and

WHEREAS, The divide between the City of Chicago and downstate Illinois is frequently manifested in electoral results such as the 2010 gubernatorial election in which the Democrat candidate won the election despite only carrying four counties out of 102 counties, and in fact, did not need to carry any other counties to win because of the margin of victory in Chicago and Cook County; and

WHEREAS, The City of Chicago is frequently treated as a separate region of the State and has often been exempted from major legislative initiatives the General Assembly enacts in law because of this fact; and

WHEREAS, The City of Chicago is often bailed out by taxpayers in the rest of the State such as the \$221 million bailout for the CPS pension system that was signed into law last year; and

WHEREAS, Numerous counties in the southern and central parts of Illinois are approving resolutions to become sanctuary counties for gun owners, while the City of Chicago has some of the strictest gun laws in the country; and

WHEREAS, The majority of residents in downstate Illinois disagree with City of Chicago residents on key issues such as gun ownership, abortion, immigration, and other policy issues; and

WHEREAS, The dissension between downstate Illinois and the City of Chicago spans the nearly 200year history of the State, and there have been several attempts in the past to divide Illinois into two states; and

WHEREAS, The City of Chicago passed a resolution in 1925 to form the State of Chicago; and

WHEREAS, Western Illinoisans declared their region as the "Republic of Forgottonia"; and

WHEREAS, In 1981, State Senator Howard Carroll passed a Cook County succession bill through both chambers of the State Legislature; and

WHEREAS, There continue to be organizations pushing for separation between the City of Chicago and downstate Illinois such as the "Southern Illinois Secession Movement"; and

WHEREAS, Separation of states continues to be a focus in the news media as there is a movement in California to divide that state into multiple states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Congress to take action to declare the City of Chicago the 51st state of the United States of America and separate it from the rest of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

HOUSE RESOLUTION 1139

Offered by Representative Bristow:

WHEREAS, Steel has always been a core part of the industry and manufacturing sector of the United States; in Illinois, the steel industry employs over 9,000 workers and supports approximately 64,000 jobs; and

WHEREAS, At its height in the 1940s and 1950s, American steel accounted for about 40% of production worldwide, and the industry employed over 650,000 workers; today, China has taken over the steel market, producing 49% of the 1.7 billion metric tons produced globally in 2017, while the United States ranked fifth with 5% of production; and

WHEREAS, China's overwhelming grip on the industry has forced prices down and pushed American companies out of business, leading to the layoff of thousands of American workers; and

WHEREAS, Currently, there are approximately 140,000 Americans working in the steel industry, a decline of over 500,000 from the industry's peak; and

WHEREAS, The U.S. is the world's top importer of steel; in 2017, we imported 36 million metric tons of steel, while only producing 10.1 million metric tons; and

WHEREAS, The total U.S. trade deficit with China was \$375 billion in 2017; and

WHEREAS, Despite these troubling trends, public contracts continue to be awarded to Chinese companies that have undercut our market with predatory prices; the Chicago Transit Authority recently awarded a \$1.3 billion contract for new rail cars to the Chinese CRRC Corporation, further undermining U.S. steel; and

WHEREAS, American tax dollars should be used to back American companies, support American jobs, build up our infrastructure and encourage long term growth in our industry and manufacturing sector; and

WHEREAS, Illinois should implement a "Buy America" policy which would give preference to American companies for publicly funded infrastructure projects; such a policy would improve our infrastructure, create jobs, and give Illinois a tool to use against unfair pricing from foreign companies; and

WHEREAS, Illinois should also institute a "Buy Illinois" policy, which would give further preference to companies located in Illinois; both such policies have been introduced in the House by Representative Jay Hoffman as HB 4574 and HB 4575; and

WHEREAS, It is within our power to fight back against Chinese control of the steel market by using taxpayer dollars to support American jobs, families, and communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the importance of steel to manufacturing base of the United States, and we support American steel workers and American steel companies; and be it further

RESOLVED, That the State of Illinois should implement a "Buy America" and a "Buy Illinois" policy, which would help grow the steel industry, create jobs, build the middle class, and protect American companies and workers.

HOUSE JOINT RESOLUTION 136

Offered by Representative Jones:

WHEREAS, There is an unbalanced approach concerning how taxes are assessed on commercial real estate in the south suburbs, which may be draining those businesses and driving them away; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the South Suburban Commercial Real Estate Tax Assessment Task Force is created; and be it further

RESOLED, That the Task Force should look at the following issues:

- (1) If proximity to Indiana is impacting business closing;
- (2) How many businesses have left Illinois for Indiana; and
- (3) If implementing a five-year pilot program for a flat tax rate system would stabilize the area; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) Two members of the House of Representatives, one from each party, appointed by the Speaker of the House and the House Minority Leader respectively;
- (2) Two members of the Senate, one from each party, appointed by the Senate President and the Senate Minority Leader respectively; and
 - (3) Two south suburban businessmen, one each appointed by the Speaker of the House and

Senate President respectively; and be it further

RESOLVED, That the Department of Revenue shall provide administrative support; and be it further RESOLVED, That the Task Force shall meet at least three times and submit their final report no later than December 31, 2018, and upon the filing of its report, the Task Force is dissolved; and be it further

RESOLVED, That the report filed with the General Assembly shall be filed with the Clerk of the House of Representatives and the Secretary of the Senate in electronic form only, in the manner that the Clerk and Secretary shall direct; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker of the House, the House Minority Leader, the Senate President, the Senate Minority Leader, and the Director of Revenue.
