WHEREAS, In response to this hateful attack on service members by our country's very own commander-in-chief and the nation's highest court, United States Senator Tammy Duckworth, an Illinois hero, responded by stating that when she was bleeding to death in her Black Hawk helicopter on a dusty field in Iraq, she didn't care if the American troops risking their lives to help save her were gay, straight, transgender, black, white, male, or female; and

WHEREAS, Since taking office, Donald Trump and his extremist allies have worked to deny basic human rights to LGBTQ+ Americans; and

WHEREAS, Not only has Donald Trump's administration banned LGBTQ+ Americans from honorably serving our country, they have argued against people qualifying for Title VII protection under civil rights legislation, which would allow people to be fired for their sexual orientation with no grounds for legal recourse; and

WHEREAS, Donald Trump's administration has revoked guidelines that protected LGBTQ+ youth in their schools; and

WHEREAS, Donald Trump's administration has halted or rolled back regulations intended to protect LGBTQ+ Americans from discrimination in health care settings; and

WHEREAS, These attacks on our fellow Americans are an affront to the founding principles of our nation; and

WHEREAS, In a time of dangerous, anti-democratic rhetoric on the rise across the world, Donald Trump's actions hinder our country's standing in the world as a leader of justice and equality; and

WHEREAS, The State of Illinois values and respects the inherent worth of every person, regardless of gender identity and sexual orientation; and

WHEREAS, The State of Illinois will continue fighting for every one of its citizens by continuing to enact state-level protections that support the LGBTQ+ community; and

WHEREAS, People throughout the State of Illinois have gone to great lengths to be allies and support our fellow LGBTQ+ residents by planning pride festivities in communities like Chicago, Carbondale, Aurora, and Buffalo Grove; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn Donald Trump's blatant bigotry and discriminatory policies against the LGBTQ+ community, whose perseverance and battle for justice embody the true spirit of our union, a spirit which calls on us to perfect our union by correcting the wrongs in society until we are all truly equal; and be it further

RESOLVED, That a suitable copy of this resolution be presented to BG Pride, Mundelein LGBT Alliance and Allies, and to all members of the Illinois Congressional Delegation.

#### HOUSE RESOLUTION 87

Offered by Representative Hernandez:

WHEREAS, High-quality, early childhood care and education have been shown by decades of respected research to play a positive role in the learning and development of young children, including greater chances of entering school prepared to succeed academically and behaviorally, graduate high school on time, and avoid criminal trouble; and

WHEREAS, Early learning is essential for reaching the State of Illinois' overarching objectives for improving education and its outcomes, including the goal of at least 60 percent of residents holding a post-secondary education degree by the year 2025; and

WHEREAS, In 2006, the State of Illinois adopted in statute the "Preschool for All" goal of increasing young children's access to voluntary, high-quality, early learning programs, over time and as resources allow, with priority attention focused on children who struggle the most; and

WHEREAS, The State of Illinois has accordingly and wisely increased its investments in early learning over the course of several years, gradually strengthening access to preschool and birth-to-3 services for communities statewide; and

WHEREAS, Tens of thousands of young children still lack access to the high-quality early learning programs that their parents seek for them; and

WHEREAS, Too many low-income, working parents still struggle to find affordable, reliable, high-quality options for ensuring their children are in good child care settings during the hours when parents are on the job; and

WHEREAS, The quality of early childhood services depends in large part on solid program infrastructure, ranging from well-qualified teachers and support personnel to supportive data systems; and

WHEREAS, Infrastructure also includes safe, developmentally appropriate classrooms and related physical space for young children to learn; and

WHEREAS, High-quality, early childhood facilities have been shown to help children grow by improving play interaction, lessening conflicts, and advancing their school readiness, as characterized by Temple University's Family and Children's Policy Initiative; and

WHEREAS, The national Bipartisan Policy Center recently declared that "safe and developmentally appropriate early care and learning programs are an essential component of building healthy and economically sustainable communities in which families and young children thrive", and that "early learning programs are critical to the health and success of local communities and the national economy"; and

WHEREAS, The Bipartisan Policy Center adds that "investments in early care and learning facilities should be an element of federal, state, and local economic-development strategies"; and

WHEREAS, Illinois policymakers responded to communities' brick-and-mortar early learning needs and set a sensible precedent in their 2009 capital plan by including a \$45 million appropriation from the Build Illinois Bond Fund for this State's first Early Childhood Construction Grant program; and

WHEREAS, The Capital Development Board received 227 applications totaling more than \$539 million in requests for these construction and renovation resources, or about 12 times the amount of grant funding available, illustrating the enormous scope of communities' early childhood capital needs; and

WHEREAS, Funding limitations in 2011 restricted resulting grant awards to only 6 percent of the project applicants from school districts and not for profit providers in communities with particularly underserved populations of children under age 5; and

WHEREAS, Funding delays, exacerbated by the State's recent budget impasse, prevented some of this funding from ever being delivered to approved grantees for desperately needed early childhood projects; and

WHEREAS, The urgent demand for such assistance remains, as demonstrated in the 2018 Capital Needs Assessment Survey of Schools conducted by the Illinois State Board of Education, which reveals the need for over 200 additional preK classrooms statewide; and

WHEREAS, Those ISBE survey results reflect only the needs of the 350 school districts that responded to the board's query and do not include the needs of still other school systems; and

WHEREAS, Those ISBE survey results also exclude the needs of the hundreds of non-school, community-based providers of early childhood services that help relieve capacity pressure on maxed-out schools, while also meeting the needs and choices of parents in their own neighborhoods and localities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that one of the most urgently required, realistic, and important ways to accommodate the early childhood program needs of today and to accommodate growth for meeting their future needs is to provide stronger support for such programs' physical infrastructure; and be it further

RESOLVED, That the next state capital program to meet Illinois' physical infrastructure needs should reflect that reality, upholding the important precedent set in the 2009 Early Childhood Construction Grant Program; and be it further

RESOLVED, That Illinois is urged to dedicate a minimum of \$250 million from state bond sources for the purpose of supporting critical, early childhood building and renovation projects for approved grant applicants from school districts and community-based service providers; and be it further

RESOLVED, That our State should prioritize such help for applicants from communities with particularly underserved populations of children under the age of 5 years of age; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the offices of the Governor, the Capital Development Board, the Illinois State Board of Education, and the Illinois Department of Human Services.

## HOUSE RESOLUTION 88

Offered by Representative Hernandez:

WHEREAS, The State of Illinois has a significant population for whom English is their second language; and

WHEREAS, A proportion of their children have been or will be identified as eligible for special education services; and

WHEREAS, Parents of children with disabilities have a right and an obligation to actively participate in Individualized Education Program (IEP) meetings; and

WHEREAS, Parents who are not proficient in English are effectively foreclosed from meaningful participation at IEP meetings due to their inability to fully comprehend vital information provided to them only in English; and

WHEREAS, The State of Illinois has established qualifications and standards of competency for interpreters for the deaf and hard of hearing; and

WHEREAS, The State of Illinois has not established comparable qualifications and standards of competency for language interpreters for, in this instance, parents with limited English proficiency; and

WHEREAS, Language interpretation services for parents of limited English proficiency at IEP meetings vary widely throughout the State; when services are provided by individuals with unknown levels of proficiency in two languages, without interpreter training, without knowledge of special education terminology, or without an understanding of ethical and cultural considerations, the opportunity to arrange the best possible support for a child with special needs will be limited; and

WHEREAS, It is incumbent upon the State of Illinois that all parents, including parents of children with disabilities, and, in this instance, parents of limited English proficiency with children receiving special education services, be afforded the same opportunities to comprehend and effectively participate in IEP meetings on the same footing as similar parents who are English speaking and parents who are deaf or hard

of hearing who are provided required, competent interpretation services for the deaf and hard of hearing; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to enact legislation to amend The School Code of Illinois, requiring the Illinois State Board of Education to establish criteria, standards, and competencies required of bilingual language interpreters for parents of limited English proficiency who are participating in IEP meetings.

#### HOUSE RESOLUTION 89

Offered by Representative Mason:

WHEREAS, Nearly all domestic violence victims also face financial abuse, and there is a new push to shine a light on this invisible form of abuse; and

WHEREAS, Intimate partner violence costs the country an estimated \$8.3 billion each year in mental health and medical care and lost productivity from paid and household work; victims of domestic violence bear tremendous additional costs over their lifetimes from dealing with the criminal justice system and incurring losses related to health problems and work productivity; some studies estimate those costs at more than \$100,000 for women and \$23,000 for men; and

WHEREAS, An abuser might destroy the victim's credit by taking out cards in the partner's name and racking up debt, ruining the victim's ability to get an apartment or a car; an abuser might empty joint bank accounts; the abuser often micromanages the family's money, allotting the victim an allowance and demanding approval of every purchase; other abusers sabotage victims' employment by refusing to let them use the car or disrupting them at the workplace; and

WHEREAS, Financial abuse has few specific programs or laws to address it in the U.S. but new financial abuse legislation in the U.K. and Australia could serve as models for change here; advocacy groups and foundations in the U.S. have recently launched campaigns aimed at raising awareness about this little-known aspect of domestic violence; and

WHEREAS, The United States is far behind when it comes to recognizing financial abuse; we need to understand that other forms of abuse, not just physical harm, are significant and should be criminal; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge more attention be directed to the financial aspect of domestic abuse, and that laws and policies be crafted to help those victims of financial abuse.

WHEREAS, The State of Illinois is committed to the value of religious diversity, tolerance grounded in the First Amendment principles, a culture of mutual understanding, the diminution of violence, and educating citizens about the world's religions; and

WHEREAS, The State of Illinois seeks to further the diversity of its community and afford all residents the opportunity to better understand, recognize, and appreciate the rich history and shared experiences of Sikh Americans; and

WHEREAS, The State of Illinois honors the many ways that Sikh Americans have influenced American History, achievement, culture, and innovation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of April 2019 as Sikh Awareness and Appreciation Month in Illinois; and be it further

(6) What current manufacturing assets and capital needs exist to support life science innovation, incubators, and existing companies; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

(1) Five members of the House of Representatives appointed by the Speaker of the House;

(2) Five members of the House of Representatives appointed by the Minority Leader of the House;

(3) One member representing a state healthcare agency appointed by the State Representatives who have been appointed to the board;

(4) One member representing the private healthcare industry appointed by the State Representatives who have been appointed to the board;

(5) One member representing the transportation industry appointed by the State Representatives who have been appointed to the board;

(6) One member representing the labor industry appointed by the State Representatives who have been appointed to the board;

(7) One member representing a state university appointed by the State Representatives who have been appointed to the board;

(8) One member representing a state community college appointed by the State Representatives who have been appointed to the board; and

(9) Two members representing the private sector in medical research appointed by the State Representatives who have been appointed to the board; and be it further

RESOLVED, That the Task Force shall meet for the first time at the call of the legislative leaders and shall elect amongst themselves a chairperson at the first meeting; and be it further

RESOLVED, That the Task Force shall meet no less than once a month for the 12 months following the first meeting; and be it further

RESOLVED, That the Illinois Department of Health and the Illinois Department on Healthcare and Family Services shall provide administrative support to the Task Force; and be it further

RESOLVED, That the Task Force shall present its findings and recommendations to the Governor and the General Assembly no later than November 1, 2020, and, upon the filing of its report, is dissolved.

WHEREAS, The DACA program has allowed over 800,000 young people, of which 42,376 are Illinois residents, the ability to fundamentally enrich the social and cultural character of the State of Illinois and, thus, of our nation; and

WHEREAS, A 2016 report by the Center for American Progress found that more than 60% of DACA recipients achieved financial independence, and 61% reported helping their families; in addition, DACA recipients reported increased earnings by an average of 42%, and 70% of those in school with DACA are pursuing a bachelor's degree or higher; and

WHEREAS, Despite these contributions to our society, on September 5, 2017, President Donald Trump and Attorney General Jeff Sessions announced the end of the Deferred Action for Childhood Arrivals (DACA) program; and

WHEREAS, Although the 9th U.S. Circuit Court of Appeals has since blocked the Trump Administration's immoral decision to end the DACA program, it is imperative that Congress acts to protect the inherent worth of each of the 800,000 talented young Americans whose livelihood hangs by a thread; and
