Dear Clerk Hollman:

The Illinois House of Representatives considered Senate Bill 1 on February 14, 2019. The legislative measure passed by a vote of 69-47. Unfortunately, I was unable to vote on this important legislation as I had a previous legal commitment for a client. My intentions were to vote ("No") on Senate Bill 1.

It is my belief that Senate Bill 1, which increases the minimum wage, will be detrimental to Illinois. I understand the sentiment behind raising the minimum wage. However, as written, SB1 will only hurt those it intends to help. The constituents, non-profits, government entities, and business community of the 47<sup>th</sup> district are standing in unison and are overwhelming opposed to this legislation.

The way in which to get Illinoisans a raise is for the legislature to promote a strong economy and a tight labor market. SB1 will hurt the people the people who are currently making minimum wage by eliminating many of their jobs. Those who have worked hard to move beyond the minimum wage jobs will be devalued; they have worked hard and made sacrifices to move up. Less experienced, less skilled workers will now have wages on par with them. Students looking to break into their field, women trying to afford childcare, and people whose jobs become automated will be impacted negatively once this bill becomes law.

I respectfully request that this letter be included in the House Journal.

At the hour of 4:48 o'clock p.m., the House convened perfunctory session.

**HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

**HOUSE RESOLUTION 106**

Offered by Representative Sosnowski:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 101st General Assembly are amended by changing Rule 37 as follows:

(House Rule 37)

37. Bills.

(a) A bill may be introduced in the House by sponsorship of one or more members of the House, whose names shall be on the reproduced copies of the bills, in the House Journal, and in the Legislative Digest. The Principal Sponsor shall be the first name to appear on the bill and may be joined by no more than 4 chief co-sponsors with the approval of the Principal Sponsor; other co-sponsors shall be separated from the Principal Sponsor and any chief co-sponsors by a comma. The Principal Sponsor may change the sponsorship of a bill to that of one or more other Representatives, or to that of the standing committee or special committee to which the bill was referred or from which the bill was reported. Such change may be made at any time the bill is pending before the House or any of its committees by filing a notice with the Clerk, provided that the addition of any member as a Principal Sponsor, chief co-sponsor, or co-sponsor must be with that member's consent. When the Principal Sponsor ceases to be a Representative during the term, the chief sponsorship of any of his or her pending legislative measures may be changed to another Representative upon approval by the Speaker or Minority Leader, whichever served as the Representative's caucus leader. If a bill is amended to replace everything after the enacting clause with language differing in substance or subject matter from the bill as introduced, upon adoption of such an amendment, the Clerk shall remove the Principal Sponsor, chief co-sponsors, and co-sponsors from the bill and the Principal Sponsor of that amendment shall become the Principal Sponsor of the bill. This subsection may not be suspended.

(b) The Principal Sponsor of a bill controls that bill. A committee-sponsored bill is controlled by the Chairperson, or if Co-Chairpersons have been appointed, by the Co-Chairperson from the majority caucus, who for purposes of these Rules is deemed the Principal Sponsor. Committee-sponsored bills may not have individual co-sponsors.

(c) The Senate sponsor of a bill originating in the Senate may request substitute House sponsorship of that bill by filing a notice with the Clerk. Such notice is automatically referred to the Rules Committee. The notice shall include the bill number, signature of the Senate sponsor, signature of the substitute House sponsor, and a statement that the original House sponsor was provided with notice of intent to request a substitute House sponsor. A notice that satisfies the requirements of this subsection shall be approved by the Rules Committee. If the Rules Committee does not act on a notice that satisfies the requirements of this subsection within 3 legislative days after its referral, then the notice is deemed approved and the Clerk shall substitute sponsorship. This subsection shall be in effect if, and only for so long as, the Rules of the Senate include a reciprocal privilege for House sponsors and the Senate complies with the rule. This subsection may not be suspended.

(d) All bills introduced in the House shall be read by title a first time and automatically referred to the Rules Committee in accordance with Rule 18. After a Senate Bill is received and a House member has submitted notification to the Clerk of sponsorship of that bill, it shall be read by title and automatically referred to the Rules Committee in accordance with Rule 18.



(e) All bills introduced into the House shall be accompanied by 1 copy. Any bill that amends a statute shall indicate the particular changes in the following manner:

(1) All new matter shall be underscored.

(2) All matter that is to be omitted or superseded shall be shown crossed with a line.

(f) No bill shall be passed by the House except on a record vote of a majority of those elected, subject to Rule 69. A bill that has lost on Third Reading and has not been reconsidered may not thereafter be revived. If a motion for the adoption of a first conference committee report fails and the motion is not reconsidered, then a second conference committee may be appointed as provided in Rule 76(c). If a motion for the adoption of a second conference committee report fails and is not reconsidered, then the bill may not thereafter be revived.

WHEREAS, The permanent establishment of Food Pantry Donation Month will serve to educate the residents of Illinois about the importance of food banks and food pantries in the effort to reduce food insecurity and to encourage communities throughout the State to support local charitable food organizations in their efforts to establish a safety net for those who are unable to provide for their own nutritional needs or those of their families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the Month of November 2019 as Food Pantry Donation Month in order to raise a greater public awareness of food insecurity and the impact food insecurity has on the residents of Illinois.

#### HOUSE RESOLUTION 110

Offered by Representative Flowers:

WHEREAS, This year will mark the 31st anniversary of the establishment and recognition of National Black Nurses' Day by the 101st United States Congress; and

WHEREAS, Blacks have long been active in the nursing field; currently, they comprise five percent of the total nursing population and practice in a variety of areas, including clinical, education, administrative, research, government, and private enterprise; and

WHEREAS, Black nurses have made significant contributions to the nursing profession; as attention to the health care problems of minorities and the poor increases, black nurses can be credited for establishing an environment of quality, service, and skill that patients have come to expect from health care practitioners; and

WHEREAS, Since February honors the contributions made to this country by black Americans, it is fitting that black nurses be recognized and honored for their outstanding contributions to our communities and our country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 2019 as Black Nurses Month in Illinois; and be it further

RESOLVED, That we urge all citizens of Illinois to acknowledge the tireless efforts and selfless service contributed by African American nurses every day.

#### HOUSE RESOLUTION 111

Offered by Representative Butler:

WHEREAS, One in nine men will be diagnosed with prostate cancer; and

WHEREAS, Prostate cancer is the second leading cause of cancer death among American men and the most commonly diagnosed; and

WHEREAS, In 2019, there are expected to be approximately 174,650 new cases of prostate cancer and nearly 31,620 deaths from the disease in the United States; in Illinois, it is estimated that 6,690 men will be diagnosed with prostate cancer in 2019; and

WHEREAS, Prostate cancer affects all races and socioeconomic classes; however, compared to white men and other men of color, African American men are at an increased risk for developing prostate cancer; one in six African American men will develop prostate cancer; overall, African American men are 1.7 times more likely to be diagnosed with, and 2.3 times more likely to die from, prostate cancer than white men; African American men are also slightly more likely than white men to be diagnosed with advanced stages of the disease; and

WHEREAS, Finding prostate cancer when it is still at an early stage offers the best hope for effective treatment and a cancer-free life; and

WHEREAS, If the disease progresses to metastatic castration-resistant prostate cancer (CRPC), the prognosis is poor, with a median survival of approximately three years; the patient, family, health, and economic burdens of prostate cancer, particularly of advanced-stage cancer, are large; and

WHEREAS, Improved awareness of prostate cancer, an understanding of increased risks for developing the disease, as well as access to recent medical advances that may extend the time a patient lives without his cancer spreading are important to improve the patient's outcome; and

WHEREAS, Shared decision making between the patient, his family and other caregivers, and a physician is important to support the appropriate care for an individual's clinical situation; and

WHEREAS, Patients should consult their physicians regarding individual risk for developing prostate cancer, to determine when screening and other tests for early detection of prostate cancer are needed, and to understand the risks and possible benefits of screening; and

WHEREAS, Individuals who are diagnosed with prostate cancer can speak with their physician and other health care providers to learn more about the disease; they can also find support groups and services in their community or online; and

WHEREAS, Additional focus is needed on the personal and social burdens of prostate cancer to anticipate the needs and provide support to the patient, his family, and other caregivers; and

WHEREAS, Additional research on prostate cancer is needed, so new and more effective treatments can be developed, as well as a push for critical research and advanced treatments for prostate cancer; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare September 2019 as Prostate Cancer Awareness Month in the State of Illinois, and we ask the citizens of Illinois to become aware of prostate cancer, so they can have an informed conversation with their health care provider regarding possible screening and diagnostic methods and, if necessary, treatments to improve the outcomes and the psychosocial support for people affected by the disease.

Offered by Representative Cassidy:

WHEREAS, The State of Illinois traditionally exercises its police powers to reflect local values and needs when determining appropriate law enforcement policies; and

WHEREAS, Illinois, as with many other states across the United States, has acted upon the issues of cannabis decriminalization by adopting a variety of policies for regulating the use of cannabis; and

WHEREAS, Thirty-three states and the District of Columbia allow for the medicinal use of cannabis; and

WHEREAS, Ten states and the District of Columbia have passed legislation to legalize the use of recreational cannabis; and

WHEREAS, In the enactment of legislation allowing for the use of cannabis for medicinal or recreational purposes, states have provided for the regulation and taxation of the use of cannabis; and

WHEREAS, Cannabis remains a Schedule I Drug under the federal Controlled Substances Act, classifying it among the most dangerous drugs in the Act; and

WHEREAS, This creates a problem for cannabis-related businesses that are legally operating pursuant to state law and makes it more difficult for consumers or businesses who are authorized to grow, sell, or purchase cannabis products under state law; and

WHEREAS, Many financial institutions have been unable to do business with cannabis-related businesses because of existing federal law and policies; and

WHEREAS, Many cannabis-related businesses rely upon cash transactions, which increases the risk of various crimes and impairs the ability of states to collect taxes; and

WHEREAS, In the interest of promoting efficient business practices, financial institutions should be confident in serving businesses legally operating in the State of Illinois under state law so long as safety and soundness requirements are met; and

WHEREAS, Legislation has been introduced in Congress to provide specific regulatory protection and immunity from federal prosecution for depository institutions providing financial services to cannabis-related businesses acting under applicable state law; and

WHEREAS, Maintaining a business relationship with financial institutions will allow for greater access to loans, as well as debit and credit transactions for businesses serving the cannabis industry, their employees, and for consumers purchasing cannabis legally under state law; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge Congress to amend federal law to provide immunity from federal prosecution and regulatory protections for financial institutions legally providing services to cannabis-related businesses, licensees, and consumers pursuant to applicable state law; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, U.S. Senate Minority Leader Chuck Schumer, U.S. Speaker of the House Nancy Pelosi, U.S. House of Representatives Minority Leader Kevin McCarthy, and all members of the Illinois Congressional Delegation.

**HOUSE JOINT RESOLUTION  
CONSTITUTIONAL AMENDMENT 23**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that

there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V  
THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, ~~Comptroller~~ and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, ~~Comptroller~~ or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, ~~Comptroller~~ or Treasurer fails to qualify or if ~~the his~~ office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if ~~the his~~ office becomes vacant, it shall remain vacant until the end of the term.

SECTION 17. COMPTROLLER - DUTIES (REPEALED)

~~The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.~~

SECTION 18. TREASURER - DUTIES

The Treasurer, in accordance with law, shall (i) maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her, (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law of the Comptroller.

SCHEDULE

A Comptroller shall not be elected in 2022 and thereafter. This Constitutional Amendment otherwise takes effect upon the conclusion of the term of the Comptroller elected in 2018.
