Perfunctory Session

WEDNESDAY, MARCH 20, 2019

At the hour of 2:57 o'clock p.m., the House convened perfunctory session.

SENATE BILL ON FIRST READING

Having been reproduced, the following bill was taken up, read by title a first time and placed in the Committee on Rules: SENATE BILL 1273(Martwick).

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 203

Offered by Representative DeLuca:

WHEREAS, Our nation's future and well-being rely on a high-quality public education system that prepares all students for college, careers, citizenship, and lifelong learning; and

WHEREAS, Youth safety is of the utmost importance in schools and communities; and

WHEREAS, The academic success of students is affected by events that occur within and outside of school; and

WHEREAS, There is a growing concern regarding youth violence and safety within our schools and communities, including a most urgent and very present concern regarding gun violence in the south suburban area, with all three school districts in the south suburban area being affected by recent gun violence and gang behavior; and

WHEREAS, Schools serve as portals for opportunities to learn life skills, appropriate behavior, and how to make positive choices; and

WHEREAS, Educational personnel are often the primary sources of support, resources, and information that help students and families, including assistance with mental, emotional, and physical health; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the creation of a South Suburban Youth Coalition and Violence Prevention Task Force in collaboration with stakeholders from the represented communities as a concrete means of helping to address the growing concern of youth violence affecting the south suburban communities and schools connected with Bloom Township High School District 206, Crete-Monee Community Unit School District 201U, and Rich Township High School District 227; the school districts served by this coalition shall include Bloom Township High School District 206, Brookwood School District 167, Community Consolidated Schools District 168, Ford Heights School District 169, Chicago Heights School District 170, Steger School District 194, Cree-Monee Community Unit School District 201U, Rich Township High School District 227, Elementary School District 159, Country Club Hills School District 160, Matteson School District 162, and Park Forest-Chicago Heights School District 163; and be it further

RESOLVED, That each district is strongly urged to provide education on the adverse and detrimental effects of student violence in our schools and communities by using existing resources and staff, including teachers, deans, social workers, and psychologists; and be it further

RESOLVED, That each district is strongly urged to create a proactive school district policy that addresses the growing issue of youth violence and focuses on problem-solving skills and conflict and dispute resolution skills for students in grades Pre-K through 12 and implements programs and strategies that encourage character building and are in alignment with the Illinois State Social and Emotional Learning Standards; the policy should provide for the professional development of teachers, administrators, support staff, board

members, and parents concerning student violence within school, youth violence in the community, conflict and dispute resolution, and de-escalation tactics; and be it further

RESOLVED, That each district is urged to create proactive solutions to student violence within schools, including the use of peer mediation, school counseling, incident reporting, and school assemblies that address student-to-student violence, gun violence, and overall school safety; and be it further

RESOLVED, That each district is urged to partner with the South Suburban Youth Coalition and Violence Prevention Task Force and applicable stakeholders, including law enforcement agencies, municipal leaders, and youth organizations, to develop solutions to eliminate youth violence in schools and communities; and be it further

RESOLVED, That each district is urged to post this resolution on every school site, distribute it to district staff, students, and parents, and have it read and voted upon at the most immediately available school board meeting and be translated into all languages currently spoken by students and parents within the south suburban area; and be it further

RESOLVED, That suitable copies of this resolution be presented to the superintendent of Bloom Township High School District 206, the superintendent of Crete-Monee Community Unit School District 201U, the superintendent of Rich Township High School District 227, the superintendent of Brookwood School District 167, the superintendent of Community Consolidated Schools District 168, the superintendent of Ford Heights School District 169, the superintendent of Chicago Heights School District 170, the superintendent of Steger School District 194, the superintendent of Elementary School District 159, the superintendent of County Club Hills School District 160, the superintendent of Matteson School District 162, and the superintendent of Park Forest-Chicago Heights School District 163.

HOUSE RESOLUTION 204

Offered by Representative Costa Howard:

WHEREAS, The health and well-being of women in the State of Illinois is a top priority; the health and education of women is directly linked to improved social well-being for the entire community; and

WHEREAS, Reproductive rights are not synonymous with abortion services, and Title X funds cannot be used to fund abortion services due to the Hyde Amendment of 1976, which does not allow federal funds to be used for abortion services; and

WHEREAS, Title X funding is directly linked with the prevention of sexually transmitted infections (STIs), early screening for cervical cancer, and other family-planning services; and

WHEREAS, Defunding clinics that perform abortion services that use Title X funding for other family-planning functions will have a direct effect on the most impoverished communities, which include the unemployed, the underemployed, and women of color, as they are the most likely recipients of Title X funding; and

WHEREAS, The Title X gag order prevents healthcare providers from discussing abortion referrals; this action limits the doctor-patient relationship and will force the closure of clinics that allow patients and doctors to discuss options and choose the most effective healthcare treatment for their individual need; and

WHEREAS, The Title X gag order will help to dismantle progress the United States has made in lowering the rate of teen pregnancy, since teens are more likely to seek clinics that use Title X funding to grant services on a sliding scale; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Health and Human Services to overturn 84 FR 7714, which would render the clinics that perform abortion services to be ineligible for any Title X funding and would not allow doctors to give referrals for abortion services; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, the Office of the Assistant Secretary of Health, the Office of the Secretary, HHS, the Department of Health and Human Services, and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 205

Offered by Representative Elizabeth Hernandez:

WHEREAS, The Constitution of the State of Illinois of 1970 Article 1 Section 2 protects the rights of due process of individuals in Illinois; SECTION 2. DUE PROCESS AND EQUAL PROTECTION "No person shall be deprived of life, liberty or property without due process of law nor be denied the equal protection of the laws."; and

WHEREAS, The Constitution of Illinois Article 1 Section 2 does not contradict the U.S. Constitution protections afforded to all Americans by the Fifth and Fourteenth amendments; and

WHEREAS, The Supreme Court has held that the Due Process Clause applies to all noncitizens in the United States Constitution; "Aliens, even Aliens whose presence in this country is unlawful, have long been recognized as 'persons' guaranteed due process of law by the Fifth and Fourteenth Amendments" Pyler v. Doe, U.S. 202, 210 (1982); and

WHEREAS, The Supreme Court has recognized family unity as a necessary protected interest by the United States Constitution; "There is a fundamental liberty interest of natural parents in the care, custody and management of their child"; Santosky v. Kramer, 455 U.S. 745, 753 (1982); and

WHEREAS, Illinois serves as the third largest recipient of federal grants for detention centers in the United States; and

WHEREAS, "Illinois agencies received nearly \$90 million in federal grants in the last two fiscal years to help resettle unaccompanied minors coming to the U.S." as reported by ABC 7 News Chicago; and

WHEREAS, "In 2017, the American Pediatric Association released a statement, "Immigrant children seeking safe haven in the United States should never be placed in detention facilities. Studies of detained immigrants have shown that children and parents may suffer negative physical and emotional symptoms from detention, including anxiety, depression and posttraumatic stress disorder. Conditions in U.S. detention facilities, which include forcing children to sleep on cement floors, open toilets, constant light exposure, insufficient food and water, no bathing facilities, and extremely cold temperatures, are traumatizing for children. No child should ever have to endure these conditions."; and

WHEREAS, Currently, Illinois participates in detaining children under the federal government's Zero Tolerance Policy by way of providing facilities for detention funded by federal grants; and

WHEREAS, ICE (U.S. Immigration and Customs Enforcement) is an agency created in 2003 by the Department of Homeland Security, through the Homeland Security Act of 2002; and

WHEREAS, The Homeland Security Act is a Congressional legislation, and the creation of ICE is administrative creation for enforcement; and

WHEREAS, ICE is the official enforcement arm of the Custom Border Patrol under Homeland Security that identifies and separates children and places them in Illinois detention centers; and

WHEREAS, ICE has protocols titled the Parental Directive to aid in communication between child detainees and their parents, but they have not been followed, resulting in numerous children in Illinois unable to be reunified with families or communicate in a timely manner; and

WHEREAS, ICE has contracts of interservice agreements/contracts with Illinois local agencies such as the Illinois State Police and the DMV to share information, yielding names of individuals who may be detained and separated from their children while held in detention centers; and

WHEREAS, In Manigault v. Springs, the Supreme Court said, It is the settled law of this court that the interdiction of statutes impairing the obligation of contracts does not prevent the State from exercising such powers as are vested in it for the promotion of the common weal, or are necessary for the general good of the public, though contracts previously entered into between individuals may thereby be affected. This power, which in its various ramifications is known as the police power, is an exercise of the sovereign right of the Government to protect the lives, health, morals, comfort and general welfare of the people, and is paramount to any rights under contracts between individuals. 480. 34. 290 U.S. at 438; and

WHEREAS, The Supreme Court further cited Home Building & Loan Association v. Blaisdell 290 U.S. 398 (1934); in upholding the legislation, the Court established new standards by which to evaluate the validity of legislation impairing the obligations of contracts; the inquiry is not simply whether an obligation is impaired, but rather "whether the legislation is addressed to a legitimate end, and the measures taken are reasonable and appropriate to that end." This flexible standard allows the Court to construe the contract; The legitimacy of the ends and the reasonableness of the means were judged by the following five factors: (1) an emergency must exist that furnishes a "proper occasion for the exercise of the reserved power of the State to protect the vital interests of the community, (2) the legislation must be for the protection of a basic interest of society, not for the mere advantage of particular individuals, (3) the relief must be appropriate to the character of the emergency that existed, (4) the conditions of the legislation must be reasonable, and (5) the legislation must be temporary and limited to the exigency that called it forth; and

WHEREAS, The State of Illinois has a right to review contracts and operations of detention centers that are causing harm to Illinois youth on Illinois soil; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the ICE Monitoring Task Force whose purpose is the following:

- (1) Review ICE practices and procedures within the State;
- (2) Review the use and condition of detention centers in Illinois; and
- (3) Review all ICE contracts in Illinois, including those with Private Detention

Centers, the Illinois State Police, and the Department of Motor Vehicles; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) Two members nominated by the Latino Policy Forum and appointed by the Speaker of the House, one of whom shall serve as co-chair;
- (2) Two members nominated by the Loyola Civitas Child Law Center and appointed by the Minority Leader of the House, one of whom shall serve as co-chair;
 - (3) Two members nominated by the ACLU and appointed by the Senate President;
- (4) One member nominated by Arab American Family Services and appointed by the Senate Minority Leader;
- (5) One member nominated by the National Immigration Law and Justice Center and appointed by the Speaker of the House; and
- (6) One member nominated by the Illinois Coalition for Immigrants and Refugee Rights and appointed by the Minority Leader of the House; and be it further

RESOLVED, That the Task Force shall meet for the first time at the call of the co-chairs; and be it further RESOLVED, That the Illinois Department of Human Rights shall provide administrative support; and be it further

RESOLVED, That the Task Force shall submit its final report to the General Assembly and the Governor no later than December 31, 2019, and, upon the filing of its report, is dissolved.
