THURSDAY, MARCH 28, 2019

At the hour of 4:59 o'clock p.m., the House convened perfunctory session.

SENATE BILL ON SECOND READING

Having been reproduced, the following bill was taken up, read by title a second time and held on the order of Second Reading: SENATE BILL 1474.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 227

Offered by Representative Ford:

WHEREAS, Once a decade, America comes together to count every resident in the United States, creating national awareness of the importance of the census and its valuable statistics; the decennial census was first taken in 1790, as mandated by the Constitution; it counts our population and households, providing the basis for reapportioning congressional seats, redistricting, and distributing more than \$675 billion in federal funds annually to support states, counties, and communities' vital programs - impacting housing, education, transportation, employment, health care, and public policy; and

WHEREAS, The next census is coming in 2020; counting an increasingly diverse and growing population is a massive undertaking; it requires years of planning and the support of thousands of people; and

WHEREAS, Ultimately, the success of the census depends on everyone's participation; the Census Bureau depends on cross-sector collaborations with organizations and individuals to get people to participate; and

WHEREAS, The 2020 Census is important to Illinois; the census affects our State's voice in government, how much funding our communities receive, and how our communities will plan for the future; and

WHEREAS, The census is about fair representation; every ten years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets; and

WHEREAS, The census is part of every individual's civic duty; it is a way to participate in our democracy; and

WHEREAS, The census is about redistricting; state officials use the results to redraw the boundaries of their congressional and state legislative districts, adapting to population shifts; and

WHEREAS, Data collected is confidential; federal law protects census responses, and answers can only be used to produce statistics; information cannot be shared with immigration enforcement agencies, law enforcement agencies, or any agency that determines eligibility for government benefits; and

WHEREAS, In addition, the census benefits each of our communities; federal funds, grants, and support to states, counties, and communities are based on population totals and breakdowns by sex, age, race, and other factors; our communities benefit the most when the census counts everyone; and

WHEREAS, Census data is used in all kinds of ways; residents use the census to support community initiatives involving legislation, quality-of-life, and consumer advocacy; businesses use Census Bureau data to decide where to build factories, offices, and stores, and these create jobs; local government officials use the census to ensure public safety and plan new schools and hospitals; real estate developers and city planners use the census to plan new homes and improve neighborhoods; and

WHEREAS, There are a variety of reasons people do not participate in the decennial census; they might think it will not have an impact on their life, or they might be afraid of sharing information with the government; they might have trouble completing a census form or feel they do not have the time to commit to completing the form; and

WHEREAS, Every citizen of Illinois can help with the efforts to obtain an accurate census by making sure people know what the census is and how census data are used, and by encouraging everyone to participate; and

WHEREAS, The U.S. Census Bureau will host a live operational press briefing to mark the one year out milestone from the 2020 Census; on April 1, 2019, Census Bureau Director Dr. Steven Dillingham and Census Bureau leadership will brief the public on the status of operations and provide updates on the success of the integrated partnership and communication campaign; the Census Bureau will also be joined on stage by several organizations that highlight a handful of the partnerships that are key to ensuring a successful 2020 Census; and

WHEREAS, Additionally, Census Bureau leaders will be available to discuss national hiring efforts and highlight what partners and other stakeholders can do to ensure complete and accurate counts in communities across the country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage every citizen in the State to support efforts to insure an accurate census in 2020; and be it further

RESOLVED, That we declare April 1, 2019 as "Census Day in Illinois", the one year mark until the 2020 Census kicks off.

HOUSE RESOLUTION 229

Offered by Representative McSweeney:

WHEREAS, Jussie Smollett, a professional actor and celebrity, reported to law enforcement on January 29, 2019 that he had, earlier on that day, been assaulted on a Chicago street by two men; in the alleged incident, Smollett told law enforcement that he had been subjected to assault, battery, and acts that could be characterized as life-threatening, accompanied by racial, homophobic, and political slurs; and

WHEREAS, Jussie Smollett's report of the alleged January 29 crime against him created a sensational media story, with Smollett frequently repeating his story for the press, especially 24-hour cable news; the repeated story was accompanied by repeated commentary, delivered by alleged experts, on the dangers of the streets of Chicago and the purported significance of the alleged incident to the overall climate of racial relations in the United States; and

WHEREAS, Questions began to be raised about Jussie Smollett's story and the veracity of the alleged incident; and

WHEREAS, On February 19, 2019, Cook County State's Attorney Kim Foxx announced that she had recused herself from the investigation, due to what she described as her familiarity with potential witnesses in the case; and

WHEREAS, On February 20, 2019 Jussie Smollett was charged with a Class 4 felony for filing a false police report; the actor was booked and taken into custody on the same day, and the Chicago Police Department released extensive information on what they described as a hoax crime, an incident where a purported victim falsely claims to have been victimized in order to grasp fame, grab attention, make political points, or some combination of all of the above; and

WHEREAS, On February 21, 2019, Jussie Smollett was released from custody, it being described that a friend of the actor had posted \$10,000 bond to gain his release; and

WHEREAS, Heavy press coverage of the alleged incident continued, with severe criticisms being leveled against Jussie Smollett and Cook County State's Attorney Kim Foxx; and

WHEREAS, On March 8, 2019, Jussie Smollett was indicted on 16 separate felony counts of "false report of offense" arising from the incident, the separate counts being related to separate elements of the statements Smollett had made to law enforcement; and

WHEREAS, In the days following this indictment, widespread reports were spread by cable news to the effect that Jussie Smollett and his attorneys were trying to wield political clout to get the charges against him negotiated, pled down, or dropped; and

WHEREAS, On March 26, 2018, a dramatic announcement altered the terrain of the Jussie Smollett case; it was announced that Smollett would perform unspecified community service and forfeit the bond allegedly posted by his friend on February 21, and in return, all felony charges would be dropped and the court file of the incident would be sealed; and

WHEREAS, The announcement of this court proceeding and sealing was publicly criticized by Eddie Johnson, the superintendent of the Chicago Police Department, who stated that 'justice was not served'; and

WHEREAS, This announcement left unanswered questions as to the roles of actor Jussie Smollett, Cook County State's Attorney Kim Foxx, First Assistant Cook County State's Attorney Joseph Magats (the prosecutor of record subsequent to State's Attorney Foxx's recusal), and other political figures who may have been involved in the case; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we request that the Attorney General of Illinois conduct a full, prompt, and comprehensive examination of the Jussie Smollett case and the decision by the Office of the Cook County State's Attorney not to pursue charges against Jussie Smollett; and be it further

RESOLVED, That the results of this examination be fully reported as a public document, so as to answer the unanswered questions surrounding the Jussie Smollett incident; and be it further

RESOLVED, That a copy of this resolution be delivered to Kwame Raoul, the Attorney General of the State of Illinois.
