At the hour of 10:16 o'clock a.m., the House convened perfunctory session.

WHEREAS, Lt. Col. Stein grew up in the Macomb area and moved away in 1983; he graduated from the Rochester Institute of Technology in 1985; he received his master's degree from the University of Maryland; and

WHEREAS, Lt. Col. Stein was commissioned into the United States Army and transferred to the United States Air Force; during his military career, he flew 3,901 hours; he volunteered for the rescue mission he was flying when he was killed in Afghanistan on March 23, 2003; and

WHEREAS, During his military career, Lt. Col. Stein received a Meritorious Service Medal, an Air Medal, an Aerial Achievement Medal, an Air Force Commendation Medal, an Army Commendation Medal, and an Army Achievement Medal; and

WHEREAS, Lt. Col. Stein's passing has been deeply felt by many, especially his wife, Barbara Nelson Stein; his father, Jay W. Stein; his mother, Hazel Henry; his two sons, Doug and Tim Stein; his daughter, Erin Stein Jones; his sisters, Holly Stein, Navida (James McLaughlin) Stein, and April Stein; his six nieces; and his two nephews; and

WHEREAS, Lt. Col. Stein was preceded in death by his grandparents; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the portion of Old Highway 136 from E. 950th St. to E. 750th St. between Macomb and Colchester as the "Lt. Col. John Stein Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of "Lt. Col. John Stein Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Secretary of Transportation and the family of Lt. Col. Stein.

### **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 371**

Offered by Representative Crespo:

WHEREAS, Career and Technical Education (CTE) links academic learning directly to workplace competencies through hands-on learning, career exploration, on-site instruction, and credentialing to give students a jump start on their postsecondary education or meaningful career; and

WHEREAS, Students who take more than two CTE courses in a sequence have a 90% graduation rate and are as likely as non-CTE students to enroll in college; and

WHEREAS, The federal Strengthening Career and Technical Education for the 21st Century Act, which amended the Carl D. Perkins Career and Technical Education Act, was signed into law on July 31, 2018; and

WHEREAS, The Perkins re-authorization provides renewed opportunities to improve CTE and enables more flexibility for states to meet the unique needs of their learners, educators, and employers; and

WHEREAS, The Illinois State Board of Education (ISBE) and the Illinois Community College Board (ICCB) convened a broad group of stakeholders to provide input as the agency drafts its plan and have continued this feedback loop with stakeholders through committees (Equity and Access, Transitions and Alignment, Data and Accountability, Employer Engagement, Teacher Pipeline and Professional Development, and Innovation); and

WHEREAS, CTE funding in Illinois has been largely stagnant since 2004 while surrounding states continue to invest heavily in workforce development programs that encourage industry-partnerships and emphasize credentialing; and

WHEREAS, The Department of Commerce and Economic Opportunity's (DCEO) related Workforce Investment Opportunity Act (WIOA) plan is due to the federal government on the same timeline as the Perkins Plan, allowing an unprecedented opportunity for alignment between the two plans; and

WHEREAS, The Illinois General Assembly has established a set of strategies for a robust and coordinated postsecondary education and career readiness system through the enactment of the Postsecondary and Workforce Readiness Act; and

WHEREAS, This year presents a unique chance for Illinois to consider its CTE funding methodology, alignment with priority occupational areas, modernization of course catalog codes, development of pathways sequences, alignment to the Postsecondary and Workforce Readiness Act, and state supports needed to effectively enable high-quality local CTE programs; therefore, be it

**RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS**, that we encourage ISBE and ICCB to include within the State's Perkins plan:

- (1) A funding methodology that incentivizes completion of aligned course sequences, early college credit, and work-based learning as part of college and career pathway systems extending from high school into postsecondary education;
- (2) A plan to expand equitable access to high quality college and career pathway systems to students across Illinois;
- (3) Program quality indicators for secondary education that address both dual credit and work-based learning;
- (4) Incentivization for innovative regional career pathway models that incorporate the

Postsecondary and Workforce Readiness Act's College and Career Pathways Endorsements through Perkins Reserve funding; and

(5) Definitions and systems aligned with the Postsecondary and Workforce Readiness Act and the State's career pathways definitions; and be it further

RESOLVED, That ISBE, ICCB, and DCEO are encouraged to work collaboratively with each other and with school districts, community colleges, business and industry, and other organizations to ensure alignment among the Perkins and WIOA plans and priority occupational areas; and be it further

RESOLVED, That as the applicable agencies step back to rethink and improve allocation of Perkins and WIOA funding, the agencies are encouraged to assess their administrative capacity to effectively support local programs, maintain accurate and accessible data, and modernize course coding frameworks and other administrative structures to better enable local innovation and to propose, within their Perkins and WIOA Plans, funding or structural mechanisms necessary to provide that support; and be it further

RESOLVED, That ISBE, ICCB, and DCEO shall report to the General Assembly and the P-20 Council on or before October 1, 2019 on how the State's draft versions of Perkins and WIOA plans address the foregoing recommendations, and the P-20 Council shall subsequently review the draft Perkins and WIOA plans and make recommendations to ISBE, ICCB, DCEO, and the General Assembly on or before December 31, 2019 on how to strengthen the plans and any other aspect of law or policy to better address the foregoing recommendations.

#### HOUSE RESOLUTION 378

Offered by Representative Thapedi:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we direct the Illinois Gaming Board to conduct a disparity study on whether minority-owned businesses face any barriers that prevent their equitable participation in the business of legalized sports wagering; and be it further

RESOLVED, That the study should include, but not be limited to, the following:

- (1) Evidence of past and present racial discrimination by the government in gaming;
- (2) Annual income and access to capital of those seeking to enter the field; and
- (3) The process for obtaining sports wagering permits and licensing; and be it further

RESOLVED, That the Illinois Gaming Board and the General Assembly should use the results of this study to address the inequality within the business of legalized sports wagering and develop clear guidelines to prevent it, alternate remedies to prevent it, flexibility and duration of the relief, the relationship of the numerical goals to the relevant labor market, and the impact on third parties; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Gaming Board.

#### HOUSE RESOLUTION 379

Offered by Representative Thapedi:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we direct the Department of Agriculture and the Department of Financial & Professional Regulation to each conduct a disparity study on whether minority-owned businesses face any barriers that prevent the equitable participation in the business of cultivating, manufacturing, delivering, distributing, testing, transporting, and other avenues within the business of legalized cannabis in Illinois; and be it further

RESOLVED, That the study should include, but not be limited to, the following:

- (1) Evidence of past and present racial discrimination by the government in the businesses of agriculture (non-livestock), its delivery, its distribution, its testing, and its transportation;
- (2) Annual income, access to capital, cannabis convictions, communities with a disproportionately high amount of law enforcement with respect to cannabis of those seeking to enter the field; and
- (3) The process for obtaining recreational and medical permits and licensing; and be it further



RESOLVED, That the Department of Agriculture, the Department of Financial & Professional Regulation, and the General Assembly should use the results of this study to address the inequality within the business of legalized cannabis and develop clear guidelines to prevent it, alternative remedies to prevent it, flexibility and duration of the relief, relationship of the numerical goals in the relevant labor market, and impact on third parties; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Department of Agriculture and the Department of Financial & Professional Regulation.

#### HOUSE JOINT RESOLUTION 74

Offered by Representative Mah:

WHEREAS, It is right and appropriate to celebrate a diversity of cultures and heritages; this celebration serves as a reminder that despite our differing backgrounds, everyone in Illinois is bound by a common hope for a better and more inclusive future for our children; and

WHEREAS, Asian Americans and Pacific Islanders are among the fastest growing ethnic groups in Illinois; Asian Americans and Pacific Islanders make up more than 5% of the population of the State; the community grew by over 40% between 2000 and 2010; and

WHEREAS, The Asian American and Pacific Islander community has a long and integral history in the United States; in recognition and celebration of that history, the United States Congress established Asian/Pacific American Heritage Week in 1978; that week was extended to the full month of May in 1990; and

WHEREAS, May is an appropriate month for the observation of Asian American Pacific Islander Heritage, since May 7, 1843 marked the arrival date of the first Japanese immigrant to the United States; May 10, 1869 is the date that America was united coast to coast by the Transcontinental Railroad with the placement of the "Golden Spike"; the railroad was made possible by the herculean efforts of the mostly Chinese immigrant workers; May 6, 1882 marks the passage of the Chinese Exclusion Act, which shaped the course of Asian immigration for almost a century to come; and

WHEREAS, The Asian American community played a heroic role in the Second World War; the 442nd Infantry regiment, comprised mostly of Japanese Americans, fought for the United States while their families at home were facing harsh discrimination and internment; the 442nd became one of the most decorated units for its size, earning almost 10,000 Purple Hearts; and

WHEREAS, Despite the contributions of Asian Americans and immigrants, the Asian American community has faced challenges and discrimination in the United States; many of the Chinese laborers were treated extremely poorly during the construction of the Transcontinental Railroad, and none of the Chinese Americans were allowed in the famous picture of the "Golden Spike"; Asian immigrants faced xenophobia and outright violence throughout periods of the 19th and 20th centuries; and

WHEREAS, Despite this inequity, brilliant leaders from different Asian American communities have contributed to the history of our country; Dalip Singh Saund was the first Asian American elected to Congress; Fred T. Korematsu was a champion of civil liberties and of the Japanese Americans interned during the Second World War; Larry Dulay Itliong was a hero for the labor movement; Grace Lee Boggs and Patsy Mink were both a transformative force for Title IX; whether as soldiers, laborers, business owners, advocates, or community leaders, those in the Asian American and Pacific Islander community continue to rise to the challenges they face and serve as a force for good in the State of Illinois and the United States; and

WHEREAS, Illinoisans and Americans of all walks of life are encouraged to learn about the deep history of Asian and Pacific Islander Americans and their contributions to our State and country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we declare May of 2019 as Asian American and Pacific Islander Heritage Month in the State of Illinois in honor of the people in these communities in the State and the nation; and be it further

RESOLVED, That we welcome everyone to Asian American Action Day on May 15, 2019, where community organizations and people of all creeds across Illinois advocate in the Capitol for legislation that is more inclusive of Asian and Pacific Islander Americans.

#### HOUSE JOINT RESOLUTION 75

Offered by Representative Sosnowski:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and, in doing so, have gone above and beyond the call of duty to make the ultimate sacrifice for our nation; and

WHEREAS, Specialist Brandon Jacob Rowe was killed in action during the War in Iraq near the city of Al Hillah on March 31, 2003; he was a member of the 101st Airborne Division (Air Assault) of the United States Army and was based at Fort Campbell, Kentucky; he was the first Infantryman of the 101st to be killed in combat in Operation Iraqi Freedom and the first from the Northern Illinois Area to be killed in that war; and

WHEREAS, Specialist Rowe's last act of kindness was toward one of his "brothers," the Medic serving with his unit; when Specialist Rowe saw that his friend was uncomfortable where he was seated on the tank, he offered to change places with him, thereby putting himself in the front of the tank; and

WHEREAS, Specialist Rowe's death was the catalyst that led the leader of his unit to get the men to safety, off of their assigned tanks, and to find cover; against great odds, the unit continued to fight for eight hours that day, in spite of the fact that information had been offered that there would be little resistance by the Republican Guard Soldiers; no other lives were lost in the battle, making the mission a success; and

WHEREAS, Specialist Rowe was posthumously awarded many medals, including the Bronze Star Medal, the Purple Heart Medal, and the Global War on Terrorism Medal; he earned many other awards and recognitions throughout his military career; and

WHEREAS, Specialist Rowe was born in Rockford on April 14, 1982; he graduated from Hononegah High School in 2000; during high school, he worked at DiGiovanni's Restaurant and Highlander Supermarket in Roscoe; he attended Rock Valley College before enlisting in the United States Army in 2001; he planned to continue studying computers after his military service; and

WHEREAS, Specialist Rowe is survived by his maternal grandfather, George Scheidegger; his paternal grandmother, Tennessee Sanders; his mother, Wendy Borowski; his stepfather, Rick Borowski; his father, Milton Rowe; his stepmother, Debbie Rowe; his sister, Leah Yates; his brothers, Brent and Kevin Rowe; his stepsisters, Heidi and Heather Schultz; his nephews, Devon Yates and Jake and Aiden Rowe; and his niece, Grace Yates; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the section of Illinois Route 251 from Bridge Street in Roscoe to Rockton Road in Roscoe as the Specialist Brandon Jacob Rowe Memorial Highway; and be it further

RESOLVED, That the Illinois Tollway is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of "Specialist Brandon Jacob Rowe Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Specialist Brandon Jacob Rowe and the Secretary of the Department of Transportation.
