Perfunctory Session

TUESDAY, NOVEMBER 12, 2019

At the hour of 11:18 o'clock a.m., the House convened perfunctory session.

HOUSE RESOLUTION

The following resolution was offered and placed in the Committee on Rules.

HOUSE RESOLUTION 603

Offered by Representative Robinson:

WHEREAS, The Illinois Department of Public Health has determined that African American and Latinx at-risk populations are among the five demographics selected for funding beginning early 2019 in support of Community Development initiatives; it is imperative that the voices of those most imminently affected by this crucial health issue be heard before any funding is considered; and

WHEREAS, The most recent and available statistics place HIV disease as one of the top five leading causes of death in African American women between the ages of 35 to 44 and the seventh ranking cause in African American women between the ages of 20 to 34; and

WHEREAS, According to the Chicago Department of Public Health, this city's African Americans are afflicted with more than half of the newly diagnosed HIV and AIDS cases; non-Hispanic African Americans were the most frequently diagnosed population, representing 58.5% of new HIV diagnoses, 56.4% of AIDS diagnoses, and 55.2% of late diagnoses; and

WHEREAS, In 2016, the highest rates of new individual HIV infection diagnoses occurred in the predominantly African American neighborhoods of Douglas, Grand Boulevard, Kenwood, North Lawndale, Washington Park, and West Garfield Park; and

WHEREAS, It is imperative that action be taken to halt new HIV infections among these demonstrably atrisk African American men and women, which continue at an alarming rate that exceeds 80% while new cases of infections among the corresponding at-risk Caucasian demographic have dramatically decreased to a current rate of less than 20%; and

WHEREAS, Hispanics/Latinos recently accounted for about one quarter of all new diagnoses of HIV in the United States, despite representing about 18% of the total U.S. population; and

WHEREAS, More than 20% of people living with HIV in the City of Chicago identify as Latinx, with the highest risk and most marginalized subpopulations (injection drug users, sexual and gender minorities, etc.) exclusively depending on indigenous-led and staffed organizations for services; and

WHEREAS, Young men ages 20 to 29, especially Black and Latino men who have sexual contact with men, also continue to make up the majority of new diagnoses, while transgender women, particularly those of color, also are disproportionately affected; the City of Chicago stated that these populations, as well as Chicagoans in some southern, western, and northern community areas, continue to be "priority populations" for HIV prevention efforts; and

WHEREAS, Gay and bisexual men accounted for 85% (7,271) of the HIV diagnoses among Hispanic/Latino men in 2015, with indigenous-led organizations on the South and West sides of Chicago leading efforts for outreach and engagement with the highest risk individuals; and

WHEREAS, According to reporting by the Chicago Department of Public Health in 2016, gay, bisexual, and other men who have sex with men, particularly Latino men, bear a disproportionate burden of HIV; and

WHEREAS, Significant gaps in knowledge exist concerning HIV incidence and prevalence in the Latinx community, especially given the influx of evacuees into the city from Puerto Rico after Hurricane Maria; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the Director of the Illinois Department of Public Health to expeditiously participate in legislative public hearings, as well as hearings

within the communities so affected, in order to provide expert and public testimony concerning the amelioration of this disturbing and reversible public health threat; and be it further

RESOLVED, That we urge additional appropriations in State funding, along with any available federal dollars, to provide necessary preventative diagnostic and treatment services to mitigate the harmful effects of HIV among at-risk African American and Latinx populations; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Director of the Illinois Department of Public Health.

HOUSE RESOLUTION 588

Offered by Representative Durkin:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 101st General Assembly are amended by adding Rule 18.5 as follows:

(House Rule 18.5 new)

18.5. Bipartisan Bills. Notwithstanding any other provision of these Rules, any bill pending before the Rules Committee shall be immediately discharged and referred to a standing committee or special committee, as provided in Rule 18, if the Principal Sponsor of the bill notifies the Clerk in writing that the bill has, in addition to the Principal Sponsor, 5 or more chief co-sponsors or co-sponsors from the majority caucus and 5 or more chief co-sponsors or co-sponsors from the minority caucus. The written notice shall specify the standing committee or special committee to which the bill shall be referred. Such a bill must be heard before the standing committee or special committee to which it is referred under this Rule, and must be called for a vote in that standing committee or special committee.

HOUSE RESOLUTION 595

Offered by Representative Welch:

WHEREAS, The boards of trustees of the University of Illinois and The John Marshall Law School have voted to approve the acquisition of The John Marshall Law School by the University of Illinois at Chicago, and the first entering class of the new UIC John Marshall Law School is expected to matriculate in fall 2019; and

WHEREAS, The UIC John Marshall Law School will be the only public law school located in Chicago; and

WHEREAS, The University of Illinois at Chicago is the city's only public research university, is one of the most diverse research universities in the country, and is an integral part of Chicago's educational, technological, and cultural fabric; and

WHEREAS, The John Marshall Law School, founded in 1899, has been a pioneer in legal education with top-ranked programs in lawyering skills, trial advocacy, and intellectual property; it is one of the most diverse law schools in the country and has a long history of giving back to the community by providing pro bono legal services; and

WHEREAS, Both the University of Illinois at Chicago and The John Marshall Law School have track records of excellence in research and scholarship, access for underserved students, and service to Chicago and its people; and

WHEREAS, The acquisition will create opportunities for interdisciplinary courses and new joint and dualdegree programs aligned with UIC strengths in multiple disciplines, such as the health sciences, engineering and technology, urban planning and public administration, social sciences, and business; and

WHEREAS, University of Illinois at Chicago students will benefit from expanded research and program offerings, such as access to law courses and opportunities to take classes jointly taught by law school and other UIC faculty; and

WHEREAS, The acquisition will provide current and prospective Illinois law students with a more affordable legal education and enhanced student services, including access to health care services, recreational facilities, residence halls, and college athletics; and

WHEREAS, The establishment of the UIC John Marshall Law School complements other university efforts to advance innovation and opportunity in higher education, such as the recent openings of UIC's Engineering Innovation Building and Academic and Residential Complex to address UIC's continued growth and record enrollment gains; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the establishment of Chicago's public law school, the UIC John Marshall Law School; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the UIC John Marshall Law School.

HOUSE RESOLUTION 598

Offered by Representative Tarver:

WHEREAS, The members of the Illinois House of Representatives recognize that the sequencing of the human genome is one of the most significant scientific accomplishments of the past hundred years and expresses support for genetic counselors, who are using this research to improve the lives of many throughout the State; and

WHEREAS, Genetic counselors empower patients and their families with vital healthcare information, guidance, and emotional support to help them understand their family history, evaluate genetic testing options, and make informed choices based on test results; and

WHEREAS, There are over 150 certified genetic counselors in Illinois working in prenatal, fertility, pediatrics, metabolic, cardiovascular, neurology, and cancer care; and

WHEREAS, Many people benefit from increased genetic sequencing research and genetic counseling, including anyone with a condition linked to a specific gene or anyone who has a family history of an inherited disease; and

WHEREAS, The 5,000 genetic counselors across the country streamline the healthcare industry by ensuring the right tests are being ordered, avoiding costly and unnecessary costs and tests, by helping patients and providers understand complex test results and how to best use this information, by helping consult with potential parents on the intimidating potential of passing on inherited diseases, by sharing information with family members, and by providing recommendations for community support services; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare November 14, 2019 as "Genetic Counselor Awareness Day" in the State of Illinois.

HOUSE JOINT RESOLUTION 92

Offered by Representative Kifowit:

WHEREAS, S. 1573 of the 116th Congress, introduced by Sen. Tammy Duckworth, and its companion bill H.R. 3932, introduced by Cong. Lauren Underwood, would eliminate co-pays for preventive procedures and medication for patients treated through the Veterans Administration (VA); and

WHEREAS, Private insurance companies waive co-pays for preventive care because they realize that the amount they would spend on preventive care is far less than what they would have to spend on the treatment for preventable diseases; and

WHEREAS, When the VA instituted co-pays, it told veterans that co-pays actually benefited them because it would mean that the VA would have more money to spend on their treatment; this was an insult to the

intelligence of veterans because no outside healthcare provider would ever insult the intelligence of its patients by telling them that paying or paying more for their care would be good for them; and

WHEREAS, Veterans should not be the only Americans who are required to make co-pays for preventive care; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the passage of the legislation before the 116th U.S. Congress that would eliminate co-pays for preventive procedures and medication for those treated through the Veterans Administration; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.

HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

Representative Durkin introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 36

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IV of the Illinois Constitution by changing Section 2 as follows:

ARTICLE IV THE LEGISLATURE

SECTION 2. LEGISLATIVE COMPOSITION

- (a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.
- (b) Each Legislative District shall be divided into two Representative Districts. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years.
- (c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.
- (d) When a vacancy occurs, it shall be filled by a special election held no earlier than 45 days but no more than 90 days after the vacancy. However, if the vacancy occurs within 120 days before a general election or general primary election, the vacancy shall be filled by that general election or general primary election. The candidates to fill the vacancy shall be members of the same political party as the person that vacated the seat. Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty-eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.

(e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term.
