# **MESSAGES FROM THE GOVERNOR**

November 25, 2019

To the Honorable Members of The Illinois House, 101st General Assembly:

Today, I veto House Bill 3902 from the 101st General Assembly, which would have amended the Use Tax Act, the Service Use Tax Act, the Service Occupation Tax Act, and the Retailers' Occupation Tax Act and applied a sales tax exemption for materials, parts, equipment, components, and furnishings incorporated into or upon an aircraft as part of the modification, refurbishment, completion, replacement, repair, or maintenance of a private aircraft continuously from January 1, 2010 through December 31, 2024.

My administration appreciates the hard work of the sponsors of this legislation in the House and Senate. However, I am opposed to providing a sales tax exemption to private aircraft companies. The delinquent taxes owed from Illinois' private jet companies amounts to roughly \$50 million, including interest and penalties, and if House Bill 3902 became law, the state would be allowing an additional \$10 million per year in tax credits through 2024.

Giving private aircraft companies tens of millions of dollars in past due tax forgiveness is not the right fiscal decision for our state as we face billions in debt associated with unpaid bills, a multi-billion-dollar structural deficit, and critical needs in schools and public safety services.

My administration is committed to growing Illinois' economy, spurring competition, and creating jobs in every region of the state. I've taken several steps to accomplish this objective, with the strong bipartisan support of the General Assembly in efforts that extend beyond any single industry.

 $\cdot$  Together, we enacted the historic \$45 billion Rebuild Illinois plan, which will support and create hundreds of thousands of jobs, fix our long-neglected roads and bridges, invest in higher education and bring broadband to every part of the state.

 $\cdot$  We also extended the Research and Development Tax Credit, helping manufacturers who are seeking certainty in the long-term.

 $\cdot$  We expanded and made permanent the Manufacturers' Purchase Credit, allowing companies to receive a sales tax exemption for machinery or equipment used to manufacture personal property for retail sale or lease.

• We eliminated the Corporate Franchise Tax, which affects every business operating in the state of Illinois – small businesses most of all.

 $\cdot$  We created a new apprenticeship tax credit, which will cover up to \$3,500 of qualified education expenses incurred by employers on behalf of a qualifying apprentice.

 $\cdot$  We expanded a set of tax credits for relocating and expanding businesses through the Blue Collar Jobs Act.

Most importantly, we are working to balance our budget and to provide a stable fiscal environment upon which to build a thriving economy. Allowing this past due tax forgiveness to the private jet industry at this time is not in line with this vision.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return House Bill 3902, entitled "AN ACT concerning revenue," with the forgoing objections, vetoed in its entirety.

WHEREAS, Grain bin accidents are serious incidents that affect farmers across the country; and

WHEREAS, More than 900 cases of grain bin entrapments have been reported with a fatality rate of 62% in the past 50 years; and

WHEREAS, In 2015, over 24 grain bin entrapments occurred with at least 14 fatalities, and in 2014, 38 reported grain bin entrapments resulted in 17 fatalities, which are the highest numbers since 2010 when 59 entrapments claimed 26 lives; and

WHEREAS, The actual number of grain bin related accidents may be higher than the documented numbers; and

WHEREAS, Grain bin accidents can tragically affect individuals, families, and communities; and

WHEREAS, Through education and awareness of hazards and safe-work practices and procedures, the number of preventable injuries and deaths associated with grain handling and storage may be reduced; and

WHEREAS, Grain Bin Safety Week is a collaborative effort by industry leaders and agricultural professionals working together; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 16 to February 22, 2020 as Grain Bin Safety Week in the State of Illinois; and be it further

RESOLVED, That we recognize the involvement of Nationwide Mutual Insurance Company, Specialty Risk Insurance, KC Supply Co. #### HOUSE RESOLUTION 636

Offered by Representative Greenwood:

WHEREAS, Parkinson's disease is a progressive nervous system disorder that affects movement; symptoms start gradually, sometimes starting with a barely noticeable tremor in just one hand; additional symptoms may include slowed movement, rigid muscles, impaired posture and balance, loss of automatic movements, speech changes, and writing changes; and

WHEREAS, The signs and symptoms of Parkinson's disease can be different for everyone; early signs may be mild and go unnoticed; and

WHEREAS, The cause of Parkinson's disease is unknown, and therefore, proven ways to prevent the disease also remain a mystery; and

WHEREAS, Approximately 60,000 Americans are diagnosed with Parkinson's disease each year, and an estimated 7 to 10 million people are living with the disease worldwide; and

WHEREAS, Although Parkinson's disease cannot be cured, medications might significantly improve one's symptoms; early detection is key; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 2020 as "Parkinson's Disease Awareness Month" in the State of Illinois to bring attention to those battling Parkinson's and to the importance of early detection and treatments.

#### HOUSE RESOLUTION 640

Offered by Representative Villa:

WHEREAS, On January 1, 2016, Silver Search legislation was passed by the Illinois General Assembly; and

WHEREAS, The Silver Search Task Force was created to bring agencies and organizations together with the common goal of creating a Silver Search program and toolkit to assist in missing person cases involving those with Alzheimer's or dementia; and

WHEREAS, The Silver Search program brings to light the increasing incidence of people with Alzheimer's or dementia that get lost and the ways in which the public can help law enforcement return them home safely; and

WHEREAS, Silver Search utilizes an Endangered Missing Person Advisory when a person with Alzheimer's or dementia goes missing; the purpose of the advisory is to get as many eyes looking for a missing person as possible; emails, faxes, radio and television broadcasts, text messages, and law enforcement bulletins are all means to disseminate the information about a missing person; and

WHEREAS, Because of the partnership with the Illinois Department of Transportation and the Illinois Tollway Authority, the dynamic message signs on the interstates and tollways can now be utilized during advisories when a person is missing while driving a vehicle; and

WHEREAS, Of the 121 Silver Alerts that have been issued since the creation of the Silver Search program, all but one person has been found; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge county authorities throughout the State to utilize the Silver Search program more frequently.

WHEREAS, The current high school graduation rate is 86%; and

WHEREAS, SAT Math scores for 11th graders who achieve "meets or exceeds" are at only 35%; and

WHEREAS, SAT English/Language Arts scores for 11th graders who achieve "meets or exceeds" are at only 37%; and

WHEREAS, In science, only 49% of all students in all grades are testing at the proficient level; and

WHEREAS, Only 73% of high school seniors enroll in a college program within 12 months of graduation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 2020 as "Illinois Whole Child Month" to recognize the value of assuring that each student is challenged, supported, healthy, safe, and engaged; and be it further

RESOLVED, That we urge parents, educators, and community members to support a whole child approach to education for each student; and be it further

RESOLVED, That we urge every school in Illinois to celebrate Whole Child Month by adopting at least one of the whole child tenets to promote and encourage throughout the month; and be it further

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 2020 Ambucs Appreciation Month in the State of Illinois to honor the accomplishments, unequaled charitable giving, and selfless contributions of the individual Ambucs and Ambuc Chapters throughout the State.

#### HOUSE RESOLUTION 646

Offered by Representative Spain:

WHEREAS, The State of Illinois has seen a decline in the number of residents with college degrees that would serve as a basis for improving the economic conditions and subsequent quality of life improvements for the State; and

WHEREAS, This has led to a loss of overall population in the State and a skills gap that has not been addressed as a top priority, leading to increasing burdens on State and local government to meet the needs of the residents; and

WHEREAS, Executive Order 2019-03, An Action Agenda for Workforce Development and Job Creation, signed by Gov. JB Pritzker, directs Illinois' state agencies to review current and potential industries targeted for economic growth and recommend how workforce resources for disenfranchised populations may be improved in communities throughout Illinois; and

WHEREAS, The four Illinois state agencies involved in implementing the federal Workforce Innovation and Opportunity Act, the Departments of Commerce & Economic Opportunity, Employment Security, and Human Services and the Illinois Community College Board, and representatives of the Illinois Workforce Innovation Board have prepared an agenda that will create opportunities for all Illinoisans; and

WHEREAS, Those agencies presented a report, An Action Agenda for Workforce Development and Job Creation, that includes evidence-based practices, promising innovations, and collaborative input from leaders across the State; its goal is to ensure that businesses, individuals, and communities have the opportunity to prosper and contribute to the State's economic growth, specifically attracting and retaining young people to Illinois; and

WHEREAS, The U.S. Census Bureau asserts that 93 of 102 counties in Illinois have lost populations since 2010; and

WHEREAS, Since the end of the Great Recession in 2011, the prime working-age population in Illinois has declined five percent while the U.S. prime working-age population has grown 1.4 percent; and

WHEREAS, In collaboration with the State of Illinois, Community Foundations of Illinois have focused their efforts on increasing talent retention and regional prosperity and combatting deteriorating and financially distressed communities by creating a new scholarship that will lessen the burdens of government by preventing further erosion of the State's economic base by recruiting and retaining college educated employees to live and work in the State; and

WHEREAS, With this new scholarship, the Community Foundations of Illinois seek to lessen the burdens of government and improve the quality of life and economic conditions of the residents of the State, which is consistent with the goals of Executive Order 2019-03; it will be a vital part of the State's effort to expand talent retention, stimulate greater investments in our communities, and improve our economic outlook; and

WHEREAS, The new scholarship will support the efforts of local partners to attract young professionals with expertise in Illinois trades, such as agribusiness and food processing, biotechnology, energy, healthcare, professional services, information technology, financial activities, leisure, hospitality, and transportation, distribution, and logistics; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Community Foundations of Illinois to enter into a joint effort with the State of Illinois to administer post-graduation scholarship programs, which are designed to lessen the burdens of government by improving income levels, decreasing unemployment rates, increasing household incomes, and increasing the percentage of residents with college degrees living and working in financially distressed areas in the State in accordance with the rules and regulations of the individual Community Foundations and Executive Order 2019-03.

Offered by Representative West:

WHEREAS, Research over the last two decades in the evolving fields of neuroscience, brain science, molecular biology, public health, genomics, and epigenetics reveals that experiences in the first few years of life build changes into the biology of the human body, including the architecture of the brain; and

WHEREAS, Brain growth occurs rapidly in the first three years of a child's life and accelerates over the next ten years, slowing during the early twenties; a child's brain and body development can be impaired by certain environmental conditions, influencing the person's physical and mental health and social outcomes over their lifespan; and

WHEREAS, Adverse childhood experiences, or ACEs, are traumatic experiences occurring during childhood that have been found to have a profound effect on a child's developing brain structure and body and may result in poor health during the person's adulthood; ACEs can be physical, emotional, or sexual abuse, neglect, household dysfunction, including caregiver substance abuse, untreated mental illness or incarceration, domestic violence, or separation or divorce involving household members; and

WHEREAS, Experiencing ACEs as well as experiencing intense and prolonged stress, like community violence, without positive influences or nurturing relationships during childhood can become known as toxic stress, further affecting a child's brain development and function and leading to long-term cognitive and health impairments; and

WHEREAS, ACEs studies have also found a strong correlation between the number of ACEs and a person's risk for disease and negative health behaviors, including suicide, depression, cancer, stroke, ischemic heart disease, diabetes, autoimmune disease, smoking, substance abuse, interpersonal violence, obesity, unplanned pregnancies, lower educational achievement, workplace absenteeism, and lower wages; and

WHEREAS, Findings from the Illinois 2013 Behavioral Risk Factor Surveillance Survey (BRFSS) Illinois ACEs Response Collaborative found that almost 60% of non-institutionalized adult Illinoisans reported having at least one ACE; this number equates to almost 5 million Illinois residents; 14.2% of Illinois adults reported four or more ACEs; and

WHEREAS, BRFSS data also showed that approximately 20% of African American and Hispanic adults in Illinois reported four or more ACEs, compared to 13% of non-Hispanic whites; and

WHEREAS, The Illinois 2013 BRFSS also found that 43% of women and 48% of men reported having one to three ACEs; 15% of women and 13% of men reported experiencing four or more ACEs; and

WHEREAS, BRFSS data showed that individuals with between 1 and 3 ACEs reported their physical health was not good 12% more often and their mental health was not good 44% more often than individuals with no ACEs, and individuals with more than 4 ACEs reported their physical health was not good 65% more often and their mental health was not good 176% more often than individuals with no ACEs; and

WHEREAS, Individuals with six or more ACEs were found, on average, to live 20 years less than those individuals with zero ACEs; and

WHEREAS, Among those who misuse opioids, the individuals most likely to experience problems with addiction are those who suffered ACEs; general population surveys have estimated that 75% of individuals with substance use disorders have experienced trauma early in their lives; rates are even higher among populations seeking treatment for opioid addiction; and

WHEREAS, ACEs appear to be a root cause of many of our most challenging health and social problems; without adequate family intervention and support, they appear to be transmitted from one generation to the next, further exacerbating the poor outcomes from ACEs and toxic stress; and

WHEREAS, It is less disruptive to well-being, less costly, and more effective to positively influence the development of a child's brain than to intervene and correct negative experiences and outcomes later in life; and

WHEREAS, Trauma-informed care is an approach that can bring greater understanding and more effective ways to prevent, identify, and support and serve children, adults, families, and communities affected by ACEs, trauma, adversity, and toxic stress; and

WHEREAS, Trauma-informed care is not a therapy or an intervention but is a principle-based culture change process aimed at recognizing strengths and resiliency and helping people who have experienced trauma to overcome those issues in order to achieve personal and economic well-being; and

WHEREAS, The Substance Abuse and Mental Health Services Administration and many other agencies and organizations provide substantial resources to better engage individuals, community based organizations, and communities across the United States in order to implement trauma-informed care; and

WHEREAS, A trauma-informed Illinois enhances the ability of children and adults to adapt, cope, and thrive despite difficult experiences, supporting the mental well-being of everyone in our State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we acknowledge that toxic stress and adverse childhood experiences can have significantly negative short-term, long-term, and generational impacts and that early interventions through trauma-informed care is the most efficient and cost effective way to combat these impacts; and be it further

RESOLVED, That the Illinois State Legislature is urged to seek opportunities to enhance legislation through the science of resiliency and a trauma-informed lens and to seek funding around early intervention services for children and families that centers the principles of brain development, the intimate connection between mental and physical health, and the concepts of toxic stress and adverse childhood experiences; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker, House Speaker Michael Madigan, Senate President John Cullerton, House Majority Leader Greg Harris, Senate Minority Leader Bill Brady, and the Illinois interagency Council on Early Intervention.

#### HOUSE RESOLUTION 660

Offered by Representative Mussman:

WHEREAS, The Sexuality Information and Education Council of the United States reports that Illinois teens experience higher percentages of forced sexual intercourse, dating violence, and physical or sexual violence compared to the national average; and

WHEREAS, The Center for Disease Control reports 1 in 3 women and 1 in 4 men have experienced sexual violence involving sexual contact; and

WHEREAS, 1 in 9 females and 1 in 36 male high school students reported experiencing sexual dating violence in the last year; and

WHEREAS, Members of the LGBTQ+ community face greater rates of sexual violence compared to heterosexual individuals; and

WHEREAS, Around half of transgender people are sexually assaulted in their lifetime; and

WHEREAS, Approximately 1.8 million cases of Chlamydia and over 500,000 cases of Gonorrhea were reported to the CDC in 2018; and

WHEREAS, In 2017, Illinois ranked 10th for the rate of Chlamydia and Syphilis cases and was ranked 17th for the rate of Gonorrhea cases; and

WHEREAS, Sexually transmitted diseases cost the U.S. healthcare system \$16 billion annually; and

WHEREAS, Comprehensive sex education means that the sex education curriculum fully meets the seven topics of the National Sexuality Education Standards: Anatomy and Physiology, Puberty and Adolescent Development, Identity, Pregnancy and Reproduction, Sexually Transmitted Disease and HIV, Healthy Relationships (which includes consent education), and Personal Safety; and

WHEREAS, Comprehensive sex education has been proven to reduce teen pregnancy and STD rates as well as to increase contraceptive use and help young people have healthy relationships; and

WHEREAS, the CDC found a 12% reduction in sexual risk-taking among students who had comprehensive sex education; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize every student has the right to comprehensive sex education, and we support organizations and schools that are providing comprehensive sex education; and be it further

RESOLVED, That comprehensive sex education is necessary to aid in the reduction of the high rates of sexual violence and STDs.

#### HOUSE RESOLUTION 666

Offered by Representative Mason:

WHEREAS, Approximately 32 million people in the United States have food allergies; Results from a 2015 to 2016 survey of more than 38,000 children indicated that 5.6 million children, or nearly 8%, have food allergies; that is one in 13 children, or roughly two in every classroom; and

WHEREAS, Children with food allergies are two to four times more likely to have other related conditions such as asthma and other allergies, compared with children without food allergies; this is of great importance as children with a coexisting food allergy and asthma may be more likely to experience anaphylactic reactions to foods and be at high risk of death; and WHEREAS, Food allergy is a potentially serious immune response to eating specific foods or food additives; eight types of food (milk, eggs, peanuts, tree nuts, fish, shellfish, soy, and wheat) account for over 90% of allergic reactions in affected individuals; and

WHEREAS, Reactions to these foods by an allergic person can range from a tingling sensation around the mouth and lips or hives to death, depending on the severity of the allergy; every three minutes a food allergy reaction sends someone to the emergency room; each year in the U.S., 200,000 people require emergency medical care for allergic reactions to food; between 2007 and 2016, medical procedures to treat anaphylaxis resulting from food increased by 377%; more than 40% of children with food allergies have experienced a severe allergic reaction such as anaphylaxis; and

WHEREAS, The mechanisms by which a person develops an allergy to specific foods are largely unknown; food allergies are more prevalent in children than adults, and a majority of affected children will outgrow food allergies with age; children under age 5 years had higher rates of reported food allergy compared with children at 5 to 17 years of age; boys and girls had similar rates of food allergy; and

WHEREAS, A food allergy can sometimes become a lifelong concern; food allergies can greatly affect children and their families' well-being; annually, caring for children with food allergies costs U.S. families nearly \$25 billion; there are some indications that the prevalence of food allergies may be increasing in the United States and in other countries; and

WHEREAS, A food allergy is an impairment that limits a major life activity and may qualify an individual for protection under the Americans with Disabilities Act of 1990 (ADA) and Section 504 of the Rehabilitation Act of 1973; and

WHEREAS, Increased food allergy awareness will lead to greater public understanding of these health problems and will lead to more life-saving research on the subject; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May Food Allergy Awareness Month.

#### HOUSE RESOLUTION 668

Offered by Representative Marron:

WHEREAS, Light pollution is defined as the brightening of the night sky caused by street lights and other man-made sources; it has a disruptive effect on the natural cycles and inhibits the observation of stars and planets near urban localities and industrial districts; and

WHEREAS, Counter to "ambient" or "natural" light, light pollution results from amplified use of artificial electrical light; and

WHEREAS, Too much light pollution has adverse consequences, such as washing out starlight in the night sky, interfering with astronomical research, disrupting ecosystems, poor health effects, and wasting energy; and

WHEREAS, Though light pollution affects Illinoisians across the state, it is most prominent in urban localities and industrial districts; and

WHEREAS, The luminous glow of light pollution prevents nearly eighty percent of people in North America from seeing our Milky Way Galaxy in the night sky; more than ninety-nine percent of people living in the United States and Europe witness light pollution skies on a nightly basis; and

WHEREAS, Meanwhile, there are countries, such as Chad and Madagascar, where the majority of people live under crisp black-sky conditions; and

WHEREAS, Light pollution affects more than simply the aesthetic view of the evening landscape; the circadian rhythm of an individual exposed to especially damaging light pollution can be thrown into disarray, resulting in sleep disorders which can impact the individual's personal, physical, and emotional well-being; and

WHEREAS, Light pollution can confuse the migratory patterns of animals, alter competitive interactions of animals, change predator-prey relations, and cause physiological harm to numerous wildlife species; and

WHEREAS, Such light pollution can be curtailed by light fixture and bulb selection and the proper shielding of urban lighting; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage awareness about the impact and possible prevention of light pollution within the State of Illinois.

#### HOUSE RESOLUTION 671

Offered by Representative Kifowit:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 101st General Assembly are amended by adding Rule 9.5 as follows:

(House Rule 9.5 new)

9.5. Memorial Day.

(a) Notwithstanding any provision of these Rules to the contrary, the Speaker shall not convene the House in regular or perfunctory session after 4:00 p.m. on the day before Memorial Day or before 4:00 p.m. on Memorial Day.

(b) On a regular session day reasonably close to Memorial Day, the Speaker shall include in the business on the Daily Calendar for that session a remembrance ceremony for Memorial Day to honor those who gave the ultimate sacrifice in defense of our nation.

(c) This Rule may not be suspended.

#### HOUSE RESOLUTION 672

WHEREAS, By law, the U.S. government is required to count the number of people living in the United States every ten years; engaging the participation of all individuals in order to get an accurate count is of crucial importance because census numbers impact all individuals and all organizations in the United States in many ways; and

WHEREAS, The federal government uses census numbers to allocate more than \$675 billion in federal funds annually for community programs and services, such as education programs, housing and community development, health care services, grants, and a variety of special projects; and

WHEREAS, The census also plays a vital role in our nation's system of government by determining how many representatives will be sent to Congress from each state to convey our concerns and work towards a better future; the information is then used by lawmakers to prioritize allocations to the communities schools, hospitals, and infrastructures in the most need; and

WHEREAS, State, local, and tribal governments use census information for planning and allocating funds for new schools, libraries, public transportation systems, new roads and bridges, and for help in determining zoning locations for police, fire, and other first responders; and

WHEREAS, Communities and small businesses use census information to develop social service programs, community action, and outreach projects; census numbers help determine where to locate factories, shopping centers, movie theaters, banks, and offices, which all have the potential to lead to new jobs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the importance of prioritizing census participation and urge state agencies to post clear and easy to access information regarding census procedures in English and Spanish so that all individuals have an equal opportunity for civic duty engagement; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor's Office and all members of the Illinois General Assembly.

Offered by Representative Marron:

WHEREAS, Military service members of Illinois and across the United States have sworn an oath to protect our nation's freedoms, even if it means the cost of their own life; and

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

# HOUSE RESOLUTION 676

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the U.S. government to embrace the U.N. Treaty on the Prohibition of Nuclear Weapons and make global nuclear disarmament the centerpiece of its national security policy; and be it further

RESOLVED, That we call upon the U.S. government to spearhead a global effort to prevent nuclear war by:

(1) Renouncing the option of using nuclear weapons first;

(2) Ending the sole, unchecked authority of any president to launch a nuclear attack;

(3) Taking U.S. nuclear weapons off hair-trigger alert;

(4) Cancelling the plan to replace its entire arsenal with enhanced weapons; and

(5) Actively pursuing a verifiable agreement among nuclear-armed states to eliminate their nuclear arsenals; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.

WHEREAS, During the month of January, members of the Tamil community celebrate Pongal, a harvest festival spanning four days; Tamil Language and Culture Week provides an opportunity to share the culture of the Tamil community with Illinois citizens and to recognize centuries of Tamil traditions; therefore, be it

WHEREAS, Bullying is a prevalent issue among youth ages 12 to 18 years old, with 35% and 15% of that age group reporting involvement in traditional bullying and cyberbullying, respectively; and

WHEREAS, Suicide is the second leading cause of death among people aged 10 to 34 and the 10th leading cause of death in the United States; and

WHEREAS, The University of Illinois' 2018 Illinois Youth Survey found that 58% of 12th grade students used alcohol, tobacco, inhalants, or marijuana in the past year; and

WHEREAS, Interactions with their peers is a major component of a student's daily life; school days last for an average of 6.5 hours, and Illinois requires a minimum of 176 school attendance days each school year; therefore, students are exposed to their peers for a minimum of 1,144 hours each year; and

WHEREAS, Schools are the most effective and efficient places to teach youths to identify, understand, and respond to signs of substance use and mental health disorders in themselves and among their peers; schools can provide meaningful instruction to students on how to help someone who is developing a mental health problem or experiencing a mental health crisis; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge Illinois schools to provide education for all students in grades six to 12 on how to identify, understand, and respond to signs of addictions and mental illnesses, as well as provide instruction on how to help someone who is developing a mental health problem or experiencing a mental health crisis; and be it further

WHEREAS, The State of Illinois has an interest in ensuring that students who are eligible for federal, state, or institutional aid are receiving that aid to help them attain a degree or credential; and

WHEREAS, The award of student financial aid from federal, state, and institutional sources is subject to federal and state laws and regulations as well as institutional policies and procedures; and

WHEREAS, The Illinois Student Assistance Commission conducts compliance reviews of financial aid offices participating in ISAC-administered financial aid programs; the agency also offers training for financial aid administrators; and

WHEREAS, Institutions must act within federal and state regulations but may also adopt different approaches to complying with federal and state mandates; and

WHEREAS, Compliance with those mandates is meant to ensure the appropriate delivery of assistance while remaining within the scope and responsibilities of the institution; and

WHEREAS, Federal programs sometimes include constraints, such as a suspension of federal student aid eligibility for students convicted of drug crimes that occurred while receiving federal student aid, that exceed the constraints on state programs and should not be applied to state programs; therefore, be it

RESOLVED, That the working group shall consist of the following, convened by the Executive Director of the Illinois Student Assistance Commission or his designee, with staff support from the Commission:

(1) The president of a statewide professional organization of student financial aid administrators, or that person's designee;

(2) Additional financial aid administrators representing the diversity of Illinois postsecondary institutions; and

(3) The president of a statewide organization of professionals involved in college admission counseling, or that person's designee; and be it further

RESOLVED, That the Commission, at the discretion of the executive director, may include additional experts on college access, federal student aid, disparities in higher education, immigration law, tax law, or any other topics relevant to the tasks outlined above, and be it further

RESOLVED, That the Commission shall use its best efforts in assuring that the working group is representative of the geographic, racial, and ethnic diversity of this state, and be it further

RESOLVED, That working group members shall serve without compensation but may be reimbursed for travel expenses from appropriations made to the Commission and available for this purpose.
