WHEREAS, This year will mark the 32nd anniversary of the establishment and recognition of National Black Nurses' Day by the 101st United States Congress; and

WHEREAS, Blacks have long been active in the nursing field; currently, they comprise five percent of the total nursing population and practice in a variety of areas, including clinical, education, administrative, research, government, and private enterprise; and

WHEREAS, Black nurses have made significant contributions to the nursing profession; as attention to the health care problems of minorities and the poor increases, black nurses can be credited for establishing an environment of quality, service, and skill that patients have come to expect from health care practitioners; and

WHEREAS, Since February honors the contributions made to this country by black Americans, it is fitting that black nurses be recognized and honored for their outstanding contributions to our communities and our country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 2020 as Black Nurses Month in Illinois; and be it further

RESOLVED, That we urge all citizens of Illinois to acknowledge the tireless efforts and selfless service contributed by African American nurses every day.

## **HOUSE RESOLUTION 716**

Offered by Representative Ammons:

WHEREAS, Cholangiocarcinoma (bile duct cancer) is a rare form of cancer that originates from the cells lining the bile ducts that play a key role in digestion; there are three types, Intrahepatic, extrahepatic, and perihilar; and

WHEREAS, There are approximately 12,000 Americans diagnosed each year in the United States, with numbers increasing yearly; the mortality rate has increased dramatically in the last decade; and

WHEREAS, Patients are typically diagnosed at a late stage due to no validated early method of detection; symptoms of jaundice, abdominal pain, itchy skin, and weight loss are symptoms that do not usually present till advanced disease progression; and

WHEREAS, Cholangiocarcinoma is a rare cancer; of the top eight deadliest cancers, seven are rare; rare cancers have a five-year survival rate under 50%, with the cholangiocarcinoma five-year survival rate being approximately 20%; and

WHEREAS, There is currently no cure for cholangiocarcinoma/bile duct cancer; and

WHEREAS, Kelly green is the color representing cholangiocarcinoma/bile duct cancer awareness; and WHEREAS, Foundations, research and teaching hospitals, rare cancer advocate groups, and patient advocate groups from around the globe have joined together to recognize February 12, 2020 as World Cholangiocarcinoma Day; and

WHEREAS, Increased cholangiocarcinoma advocacy, awareness, research, and education will bring improved outcomes for patients in earlier detection and treatment and potential curative methods; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize February 12, 2020 as being World Cholangiocarcinoma Day.

# **HOUSE RESOLUTION 719**

WHEREAS, Through the Community Services Block Grant Program (CSBG), Community Action Agencies (CAAs) offer a variety of services to assist individuals and families in moving towards self-sufficiency; federal funding is provided to Illinois' 36 CAAs to deliver locally designed programs and services for low-income individuals and families; and

WHEREAS, The Participation Loan Program (PLP) delivers participation loans through pre-approved Illinois financial institutions to accelerate investments and ease traditional credit underwriting standards for small businesses that may not otherwise qualify for traditional bank financing; and

WHEREAS, Important parts of the Governor's economic plan for Illinois include investing in transportation, broadband, and small business development, bringing down barriers to accessing the job market and capital in communities of color, and fostering collaboration by developing regional economic hubs, which can be accomplished by having clear communication among key economic actors in Illinois including state and local governments, industry, unions, universities, and non-profits; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage companies to bring pre-training and pre-hiring placement centers to underresourced and underserved communities; and be it further

RESOLVED, That we encourage the Department of Commerce and Economic Opportunity and the State of Illinois to explore creating a pilot program or grant program for these companies.

WHEREAS, The idea for an International Day of Women and Girls in Science was generated during the 2015 Inaugural High-Level World Women's Health and Development Forum organized by the Royal Academy of Science International Trust (RASIT) and the United Nations Department of Economic and Social Affairs (DES); and

WHEREAS, This Forum was held at the United Nations Headquarters, with the participation of government Ministers and representatives, UNESCO, UN-Women, WHO, UNRWA, UNICEF, UNFPA, the Every Woman Every Child Initiative, and others; most of the distinguished guests and speakers at the Inaugural Forum, whether at ministerial, intergovernmental, diplomatic, academic or professional levels, were women in science; and

WHEREAS, Despite progress in ensuring opportunities for women in science, technology, engineering, and mathematics (STEM) fields, women and girls continue to be systematically underrepresented as users and leaders in these areas; in order to achieve sustainable development goals, we need to ensure full and equal access to and participation in science for women and girls; and

WHEREAS, Recent studies suggest that 65 percent of children entering primary school today will have jobs that do not yet exist; while more girls are attending school than before, girls are significantly under-represented in STEM subjects in many settings, and they appear to lose interest in STEM subjects as they reach adolescence; and

WHEREAS, Debunking the myths that girls do not like the sciences and other gender stereotypes, along with investment in teacher trainings, gender-responsive technology, and innovation, can reverse these trends; and

WHEREAS, Less than 30 percent of researchers worldwide are women; with too few women in decision making roles and higher-paying STEM jobs, the gender gap in STEM has deep implications for the future of global economy; women stand to gain only one new STEM job for every 20 lost, in stark contrast to men, who gain one new STEM job for every four lost; and

WHEREAS, Women still have less than two-thirds of the economic opportunity that men have; the jobs of the future will be driven by technology and innovation, and if the gender divide in Science Technology Engineering and Mathematics (STEM) is not bridged soon, the overall gender gap is likely to widen; and

WHEREAS, Improved recruitment, retention, and promotion policies, as well as continuous learning and skills development for women, can go a long way towards closing this gap; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 11, 2020 as Women and Girls in Science Day.

#### **HOUSE RESOLUTION 721**

Offered by Representative Hernandez, Barbara:

WHEREAS, On February 15, 2019, a disgruntled former employee of the Henry Pratt Company in Aurora opened fire inside the company warehouse, killing five fellow employees and wounding another; five police officers were also shot and wounded while responding to the incident, before the gunman was killed in a shootout with law enforcement; and

WHEREAS, The gunman responsible for this heinous act of terror was able to obtain the gun he used to wound and kill innocent victims through a loophole in our Firearm Owners Identification (FOID) system; despite being convicted of a felony aggravated assault in 1995 in the state of Mississippi, the gunman obtained a FOID card in January 2014, and when the gunman applied for a concealed carry license in March 2014, only then did State Police revoke his FOID card and send him a notice to surrender his firearms and submit a Firearm Disposition Record; the gunman failed to surrender his weapons and submit the Firearm Disposition Record, and the State Police did not follow up; this tragic shooting brought to light dangerous gaps in State law that allowed the shooter easy access to guns; and

WHEREAS, We must remember the victims of this senseless act of violence: Clayton Parks of Elgin, age 32, Trevor Wehner of DeKalb, age 21, Russell Beyer of Yorkville, age 47, Vicente Juarez of Oswego, age 54, and Josh Pinkard of Oswego, age 37, and Timothy Williams, who was wounded by the gunman while running to warn other employees of the shooting; and

WHEREAS, Senate Bill 1966 would address many of these gaps, strengthen the FOID system, and help ensure that people with violent criminal histories who are prohibited from gun possession are not able to easily evade the law and arm themselves; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the one year anniversary of the mass shooting that took place at the Henry Pratt Company in Aurora on February 15, 2019, and we honor the victims of this senseless act of violence; and be it further

RESOLVED, That we urge the passage of Senate Bill 1966 to close the loopholes that have allowed violent criminals to obtain a FOID card and to streamline the revocation process for law enforcement to remove firearms from dangerous individuals.

# **HOUSE RESOLUTION 725**

Offered by Representative Williams, Ann:

WHEREAS, Strides for Peace was founded in response to the high incidence of gun violence occurring in Chicago; and

WHEREAS, The mission of Strides for Peace is to increase the collective impact of community organizations working to stop gun violence, save lives, and build a stronger Chicago; and

WHEREAS, The Race Against Gun Violence was launched by Strides for Peace in 2014 to bring the community together and show the world that Chicago can come together to address the problem of gun violence and save lives; and

WHEREAS, The race is a rallying point to raise funds for and awareness of what is being done to end gun violence and build a Chicago where all can thrive; and

WHEREAS, The date for this race was chosen to recognize National Gun Violence Awareness Month and the urgent need to prevent gun violence, especially during the summer months, and to provide a platform for members of the Chicagoland community to come together to be part of the solution to this problem; and

WHEREAS, Strides for Peace is hosting the Race Against Gun Violence on the evening of June 4, 2020 at 6:00 PM at Grant Park in Chicago; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize and support the Race Against Gun Violence hosted by Strides for Peace and the larger effort to address and prevent gun violence in the City of Chicago; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Strides for Peace as a symbol of our respect and esteem.

#### **HOUSE RESOLUTION 726**

Offered by Representative Keicher:

WHEREAS, The Illinois State Board of Education is required to collect vast amounts of school and student data from public school districts across the State; and

WHEREAS, The data collected is required by State-mandated regulations through the Illinois School Code, the Illinois Administrative Code, or by numerous federal requirements; and

WHEREAS, Reporting local school and student data is oftentimes burdensome, costly, redundant, and time-consuming for school districts and school staff; and

WHEREAS, With various State and federal mandates, school districts may be reporting the same data to meet different requirements; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois State Board of Education to review existing data reporting mandates, both State and federal, in an effort to streamline the reporting system and remove redundant data collection; and be it further

RESOLVED, That the State Board of Education study the following:

- (1) Areas in which data collecting may be streamlined to eliminate inefficiencies in the data reporting system for local school districts;
- (2) Areas in which data collecting may be streamlined so that school districts are not required to report the same data multiple times to meet different State and federal requirements; and
- (3) Areas in which data collecting is not required by State or federal mandates so that school districts are not required to report data that is not used to improve the educational outcomes of students and schools; and be it further

RESOLVED, That the State Board of Education is urged to submit a report to the General Assembly by December 31, 2020 with information on the reviewed areas and recommendations on how to streamline the school data reporting and collecting system of the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the State Superintendent of Education.

#### **HOUSE RESOLUTION 727**

Offered by Representative Sosnowski:

WHEREAS, The Illinois General Assembly has been asked to consider the imposition of a privilege tax on the transfer of financial assets when this transfer takes place on a market platform that is domiciled within the State of Illinois; and

WHEREAS, Transactions on market platforms domiciled in Illinois play an essential role in creating and stabilizing a global market and global market prices for debt securities and interest, financial instruments, currencies, and essential commodities of all sorts, including foodstuffs, motor fuel, and energy; and

WHEREAS, The financial securities that are traded in Illinois-based financial transaction platforms or enjoy market value based upon those platforms are used by millions of Illinois workers to save for pensions and retirement; and

WHEREAS, The CME Group, a market platform domiciled in Chicago, and the transactions carried out on its financial exchanges would be affected by this tax; and

WHEREAS, The CME Group, as a direct entity, pays \$50 million in annual taxes to Illinois, prior to and independently of the taxes paid by and on behalf of the thousands of professionals and workers whose jobs are tied to the financial trading markets of Illinois; and

WHEREAS, The estimated 100,000 jobs connected directly or indirectly to Illinois financial markets create income tax revenue from wage taxes withheld, sales tax revenue from goods purchased, and other tax and fee revenues essential to the budget of the State of Illinois and its local governments; and

WHEREAS, While an overwhelming subset of the people who hold these jobs are men and women who live and pay taxes in Illinois, the market platforms themselves are electronic ones, and the great majority of the transactions that take place on these platforms can take place anywhere within the United States or anywhere within any of the other nations governed by a financial Rule of Law, with a speed determined by the excellence of electrical engineering; and

WHEREAS, The State of Illinois should protect these platforms and keep these jobs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the continued health and operation of the financial transaction markets of Illinois and oppose the concept of a privilege tax on financial transactions; and be it further

RESOLVED, That any tax of this type will be passed on to burden the savings activities of people all over the world, including Illinois workers saving for retirement; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker of the House of Representatives, the Minority Leader of the House of Representatives, the President of the Senate, the Minority Leader of the Senate, the Mayor of the City of Chicago, and the chief executive officer of the CME Group.

## **HOUSE RESOLUTION 740**

Offered by Representative Sommer:

WHEREAS, The mission of the Illinois Department of Children and Family Services (DCFS) is to promote prevention, child safety, permanency, and well-being; and

WHEREAS, As of June 30, 2018, DCFS had approximately 17,481 children under its service umbrella; and

WHEREAS, Governor Pritzker and the General Assembly budgeted an additional \$128.2 million for DCFS for Fiscal Year 2020 and authorized the hiring of an additional 300 employees; and

WHEREAS, DCFS has the primary responsibility of protecting children through the investigation of suspected abuse and neglect by parents and other caregivers in a position of trust or authority over the child; and

WHEREAS, The Office of Inspector General of DCFS has recommended changes within DCFS in its annual report; and

WHEREAS, 123 children who are, or who have been, under the DCFS service umbrella died between July 1, 2018 and June 30, 2019; and

WHEREAS, The Adoption and Child Welfare Committee of the Illinois House of Representatives is a bi-partisan group of legislators committed to working together to better protect children under the purview of DCFS; and

WHEREAS, Input from the medical community is important to this endeavor; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Illinois' medical community to work with the General Assembly and other stakeholders to develop the best practices and resources to assist them in their role as mandated reporters of suspected child abuse and neglect.

# **HOUSE RESOLUTION 745**

Offered by Representative LaPointe:

WHEREAS, Many Illinoisans with developmental disabilities encounter obstacles in their lives that can be overcome with technology; and

WHEREAS, Innovative supportive technology positively impacts the lives of Illinoisans with developmental disabilities at home and in their communities; and

WHEREAS, "Supportive technology" includes any product, device, or equipment that may be used to maintain, increase, or improve the functional capabilities of individuals with disabilities; and

WHEREAS, With continuing technological advancements, Illinoisans with developmental disabilities increasingly have more opportunities to access innovative supportive technology that lowers barriers that people with disabilities encounter in their daily lives and promotes their independence, confidence, and abilities: and

WHEREAS, Illinoisans recognize that supportive technology in the workplace can enable individuals with disabilities to perform jobs and tasks in order to seek or maintain employment to achieve independence; and

WHEREAS, The demand for direct support staff who assist people with developmental disabilities is projected to increase, and technology is one tool that can help supplement and assist those who do the important work of supporting individuals with disabilities; and

WHEREAS, While Illinois recognizes that human relationships are an essential part of all of our lives, supportive technology can connect people with disabilities with additional assistance to supplement and enhance the support they receive; and

WHEREAS, Illinois aims to ensure supportive technology solutions are considered when determining the appropriate services and supports to be provided for people with developmental disabilities; and

WHEREAS, Illinois should commit to a statewide initiative to expand access to supportive technology designed to improve the lives of people with developmental disabilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor and the State of Illinois to adopt the principles of Technology First, a commitment that citizens with development disabilities be afforded opportunities to improve their lives through supportive technology and that supportive technology be prioritized when considering services and support needs; and be it further

RESOLVED, That the Illinois Technology First Council is created to study ways to expand the use of supportive technology for Illinoisans with developmental disabilities; and be it further

RESOLVED, That the Council shall consist of the following members, who shall serve without compensation:

- (1) The Director of the Illinois Department of Human Services Division of Developmental Disabilities or his or her designee, who shall serve as chair;
  - (2) The Director of the Illinois Council of Developmental Disabilities or his or her designee; and
- (3) The following members who shall be appointed by the Director of the Illinois Department of Human Services Division of Developmental Disabilities:

- (a) One member who represents an organization that works with or advocates on behalf of persons with autism and related conditions;
- (b) One member who represents an Independent Service Coordination Agency in the State of Illinois:
- (c) Two members who represent an intellectual or developmental disability advocacy organization;
- (d) One member who is familiar with supportive technology research and who represents an institute of higher learning;
- (e) Two members representing existing service providers who have significant experience using supportive technology to provide services to people with developmental disabilities;
- (f) One member who is the parent or guardian of an individual with a developmental disability who has significant experience with the use of supportive technology; and
- (g) One member who is a person with a developmental disability and who has significant experience with the use of supportive technology; and be it further

RESOLVED, That the Illinois Department of Human Services Division of Developmental Disabilities shall provide administrative support to the Council; and

RESOLVED, That the Council is charged with the following tasks:

- (1) Develop state policy to encourage the use of supportive technology and to align Illinois Administrative Code waiver service rules with that policy;
- (2) Identify and address areas where sufficient support is not currently available or where additional options may be needed to assist those with developmental disabilities to gain access to supportive technology;
- (3) Identify best practices, effective partnerships, and opportunities for shared services among existing providers of developmental disabilities to increase supportive technology opportunities for those with developmental disabilities;
- (4) Recommend ways to integrate supportive technology into existing programs to move with school aged youth as they transition into adult services;
- (5) Develop recommendations on ways to expand the Discovery and Personal Plan to include supportive technology in the person-centered planning process; and
- (6) Recommend system-level benchmarks for monitoring use of supportive technology and person-centered outcomes that demonstrate increased quality of life for persons with developmental disabilities; and be it further

RESOLVED, That the council shall submit its final report to the Governor and the Illinois General Assembly no later than January 1, 2021, and is dissolved upon the filing of its report; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Director of the Illinois Department of Human Services Division of Developmental Disabilities and the Governor.

#### **HOUSE RESOLUTION 746**

Offered by Representative Marron:

WHEREAS, It has recently come to light that there may have been a sexual assault purposefully prevented from being reported in Champaign; and

WHEREAS, The Champaign County State's Attorney stated that she was initially hesitant to investigate the sexual assault because her budget did not provide for the convening of a grand jury; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State's Attorney Proper Funding Task Force is established to:

- (1) Study the current funding levels of state's attorneys' offices in Illinois and their ability to effectively represent the State's interests and protect the people in this State at the current funding levels;
  - (2) Study the optimal funding for state's attorneys' offices in the State; and
- (3) Make recommendations to improve the funding to state's attorneys' offices across the State; and be it further

RESOLVED, That the Task Force shall consist of the following members appointed by the Governor no later than 30 days after the adoption of this resolution:

- (1) Two members who are assistant state's attorneys from the Cook County State's Attorney's Office;
- (2) Five members who are state's attorneys or assistant state's attorneys from five counties other than Cook County;
  - (3) One Cook County circuit judge experienced in the litigation of criminal law matters;
- (4) One circuit judge from outside of Cook County experienced in the litigation of criminal law matters; and
- (5) One representative from the Office of the State's Attorney Appellate Prosecutor; and be it further

RESOLVED, That Task Force members shall serve without compensation but may be reimbursed for their expenses incurred in performing their duties; if a vacancy occurs in the Task Force membership, the vacancy shall be filled in the same manner as the original appointment for the remainder of the Task Force; and be it further

RESOLVED, That The Task Force shall hold a minimum of one public hearing per month; at the public hearings, the Task Force shall take testimony from state's attorneys, victims of crimes prosecuted by state's attorneys, and any other person the Task Force believes would aid the Task Force's examination and recommendations; the Task Force may meet at such other times as it deems appropriate; and be it further

RESOLVED, That the Office of the State's Attorney Appellate Prosecutor shall provide administrative and other support to the Task Force; and be it further

RESOLVED, That the Task Force shall prepare a report that summarizes its work and makes recommendations; the Task Force shall submit its report to the Governor and the General Assembly no later than December 31, 2020 and is dissolved upon the filing of its report.

#### **HOUSE RESOLUTION 750**

Offered by Representative Sosnowski:

WHEREAS, Daylight Saving time began in Germany during World War I as an effort to conserve fuel; and

WHEREAS, Daylight Saving Time was instituted in the United States in 1918 under the title of "War time" and proved so unpopular that Congress abolished it when the war was over; and

WHEREAS, Local jurisdictions then had control over their clocks until the Uniform Time Act of 1966, which mandated standard time within time zones and instituted the practice of advancing clocks one hour in the spring and turning them back one hour in the fall; and

WHEREAS, In 1986, Congress amended the Uniform Time Act, moving the beginning of Daylight Saving Time from the last Sunday in April to the first Sunday in April; and

WHEREAS, Congress, as part of the Energy Policy Act of 2005, moved the beginning of Daylight Saving Time to the second Sunday in March and the end to the first Sunday of November; and

WHEREAS, States were allowed to exempt themselves from Daylight Saving Time, resulting in a patchwork of time differences throughout the nation, especially in states with multiple time zones, such as Indiana; and

WHEREAS, Uniformity of time among the states is essential for interstate commerce; and

WHEREAS, Numerous studies indicate that the biannual time change interferes with the body's circadian rhythm, affecting sleep cycles, stress levels, and drowsiness during the day; and

WHEREAS, A 2009 study in the Sleep Medicine journal indicated that it may take some people up to three weeks to adjust to the time change; and

WHEREAS, According to the American Journal of Cardiology, there is a ten percent increase in the number of heart attacks on the Monday following the time change; and

WHEREAS, A 2004 study in the Accident Analysis and Prevention journal estimated that instituting Daylight Saving Time permanently could save up to 366 lives due to a reduction in automotive accidents; and

WHEREAS, The rationale for switching clocks twice per year to aid in the war effort was laudable over 100 years ago, but modern and scientific research now clearly favors the institution of Daylight Saving

Time year round, eliminating the stress and negative health effects caused by changing clocks; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we believe that the United States should move away from biannual time change, instead instituting Daylight Saving Time permanently; and be it further

RESOLVED, That we urge the Congress of the United States of American to enact permanent Daylight Saving Time to minimize confusion and disruption to people's lives, wellness, transportation, and commerce; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the President of the United States, the Secretary of the United States Department of Energy, and the Congressional Delegation of the State of Illinois.

# **HOUSE RESOLUTION 751**

Offered by Representative Halpin:

WHEREAS, The U.S. Congress created Amtrak under the Rail Passenger Service Act of 1970 (Public Law 91–158), and Amtrak began serving customers on May 1, 1971, taking over the operation of most intercity passenger trains in exchange for access to the national rail network; and

WHEREAS, Congress passed the Amtrak Improvement Act of 1973 (Public Law 93–146), which gives intercity and commuter rail passenger transportation preference over freight transportation in using a rail line, junction, or crossing, a right codified as section 24308(c) of title 49, United States Code; and

WHEREAS, U.S.C. Sec. 24308(c) of Title 49 states, "Except in an emergency, intercity and commuter rail passenger transportation provided by or for Amtrak has preference over freight transportation in using a rail line, junction, or crossing unless the [Surface Transportation] Board orders otherwise under this subsection. A rail carrier affected by this subsection may apply to the Board for relief. If the Board, after an opportunity for a hearing under section 553 of title 5, decides that preference for intercity and commuter rail passenger transportation materially will lessen the quality of freight transportation provided to shippers, the Board shall establish the rights of the carrier and Amtrak on reasonable terms"; and

WHEREAS, Many host railroads have ignored the law by refusing to give passenger rail the priority to which it is statutorily entitled, resulting in poor and declining on-time performance by Amtrak on most host railroads; according to Amtrak during fiscal year 2019 alone, this caused 6.5 million customers on state-supported and long-distance trains to arrive at their destination late; and

WHEREAS, Amtrak's Office of Inspector General, in a 2019 report, showed poor on-time performance wastes taxpayer dollars to the extent that a mere five percent improvement on all Amtrak routes would result in \$12.1 million in cost savings to Amtrak in the first year; if on-time performance on long-distance routes reached 75 percent for a year, Amtrak would realize an estimated \$41.9 million in operating cost savings along with a one-time savings of \$336 million due to a reduction in equipment replacement needs; and

WHEREAS, On-time passenger rail performance on host railroads has historically been driven by the existence of an effective means to enforce Amtrak's preference rights as shown historically by:

- (1) Enactment of the Passenger Rail Investment and Improvement Act (PRIIA) of 2008 (division B of Public Law 110–432), which included provisions for the enforcement of these preference rights:
- (a) Two months afterward, the on-time performance of long-distance trains improved from 56 percent to 77 percent and Class I freight train interference delays across all routes declined by 40 percent; and
- (b) One year after enactment of PRIIA, freight train interference delays had declined by 54 percent, and the on-time performance of long-distance trains reached 85 percent; and
- (2) Removal in 2014 of some of those provisions after being ruled unconstitutional by a Washington, D.C., Circuit Court: long-distance train on-time performance declined from 72 percent to 50 percent, and freight train interference delays increased 59 percent; and

WHEREAS, As a result of violations of Amtrak's right to preference, Amtrak has been consistently unable on host railroad networks to meet its Congressionally-mandated mission and goals and does not have an effective mechanism to enforce its statutory preference right in order to fulfill its mission and goals; and

WHEREAS, Only the United States Attorney General can bring a civil action for equitable relief in a district court of the United States to enforce Amtrak's preference rights but has done so just once in Amtrak's entire history, against the Southern Pacific Transportation Company in 1979; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support a strong intercity passenger rail network and support the passage of U.S. S.2922, the proposed "Rail Passenger Fairness Act", providing Amtrak the ability to enforce its preference rights by bringing a civil action before a federal district court (the so-called "private right of action"); and be it further

RESOLVED, That we urge the Illinois Congressional Delegation to support S.2922; and be it further RESOLVED, That suitable copies of this resolution be delivered to each member of the Illinois Congressional Delegation.

#### **HOUSE RESOLUTION 753**

Offered by Representative LaPointe:

WHEREAS, Little Italy, sometimes combined with University Village, is one of Chicago's most vibrant communities; and

WHEREAS, The community was once predominantly Italian immigrants but now consists of diverse ethnic and socio-economic backgrounds; and

WHEREAS, Other ethnicities have always been present in the area; nonetheless, the neighborhood was given its name due to the strong influence of Italians and Italian culture on the neighborhood throughout the 19th and 20th century; and

WHEREAS, The area's Italian-American heritage is primarily evident in the Italian-American restaurants that once lined Taylor Street; the neighborhood is home to the National Italian American Sports Hall of Fame and the historic Roman Catholic churches Our Lady of Pompeii, Notre Dame de Chicago, and Holy Family; and

WHEREAS, The recent history of the neighborhood is that of urban renewal, starting with the construction of expressways in the 1950s, the development of the University of Illinois at Chicago in the 1960s, the demolition of public housing in the 1990s and 2000s, and the redevelopment of Maxwell Street in the 2000s; and

WHEREAS, Perhaps the largest concentration of Italian businesses and residents in present-day Chicago is located along Harlem Avenue on the Northwest Side and neighboring Elmwood Park; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the City of Chicago to honorarily rename the section of Harlem Avenue from Foster Avenue to Grand Avenue as "Via Italia"; and be it further RESOLVED, That a suitable copy of this resolution be delivered to the Chicago City Council.

# **HOUSE RESOLUTION 754**

Offered by Representative Edly-Allen:

WHEREAS, the State of Illinois ensures the right to use sick leave benefits provided by employers for absences due to illness, injury, or appointment of an employee or their family; and

WHEREAS, the Federal Railway Labor Act was passed in 1926 and amended in 1936 to include airplane employees; the Act was designed to prevent disruptive strikes by facilitating a system of bargaining and arbitration to resolve Major and Minor disputes between rail and plane employees and their employers; and

WHEREAS, the Federal Railway Labor Act limits the State of Illinois by excluding rail and plane employees from receiving the same benefits for family sick leave as those employed across Illinois; and

WHEREAS, the right to use earned sick days for family emergencies is protected by law in the State of Illinois and by the Federal Family and Medical Leave Act, and the exclusion of rail and plane employees is detrimental to their well-being and the safety of their families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State of Illinois urges the federal government to remedy the situation by encouraging dialogue between employers and unions in order to guarantee the same family sick leave rights to rail and plane employees that are available to employees across the state; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Illinois Congressional Delegation.

#### **HOUSE RESOLUTION 755**

Offered by Representative Stuart:

WHEREAS, Research shows that early childhood teacher effectiveness is a predictor for positive developmental and academic outcomes for children; and

WHEREAS, Continuity in early relationships with teachers and caregivers results in safe, stable, and trusting environments that allow young children the opportunity to explore and learn; and

WHEREAS, The work of early childhood educators is sophisticated and central to the healthy learning and development of young children and takes place in a range of settings, including schools, community-based centers, and homes; and

WHEREAS, Early childhood educators include home visitors and Early Intervention professionals as well as educators in schools, child care centers, and family child care homes; and

WHEREAS, Research shows that having children see their own identities reflected in their teachers can improve students' perceptions of and actual performance in school, and that it is critical for early childhood programs to have educators that reflect the families and communities they serve; and

WHEREAS, Nearly half of all lead early childhood educators hold a bachelor's degree or higher, nearly three-quarters have secured an associate's degree or higher, many hold state-recognized credentials, all must fulfill scheduled training requirements, and many have years of experience in the field; and

WHEREAS, The early childhood workforce is almost exclusively female and more racially diverse than the K-12 workforce; and

WHEREAS, The current early childhood education system functions because early childhood professionals, particularly those working in community-based settings and those working with infants and toddlers, often forgo a living wage aligned to the sophistication of their work and level of education; and

WHEREAS, The early childhood workforce, particularly in community and home based settings, earns wages in the second percentile of annual earnings; many early childhood workers lack access to workplace benefits and must rely on public benefits to meet the needs of their own families; and

WHEREAS, These low wages have contributed to significant shortages in qualified staff in early childhood programs and will be a barrier to further expansion of services; and

WHEREAS, Adequate compensation is the foundation of a quality early childhood workforce; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to increase its investments in Early Childhood Education, the Child Care Assistance Program, Early Intervention, Healthy Families, and Parents Too Soon not only to expand access to high-quality services for children and families but also to enable Illinois to pay its early childhood workforce the wages needed to attract and retain qualified professionals; and be it further

RESOLVED, That we urge the Illinois State Board of Education and the Department of Human Services to implement policies and strategies to ensure that any new funding is directed toward improving the compensation levels of early childhood professionals to reflect more closely other professions with similar qualifications and educational levels.

#### **HOUSE RESOLUTION 756**

Offered by Representative Villa:

WHEREAS, The month of May is nationally recognized as Hepatitis Awareness Month thanks to the Know More Hepatitis campaign initiative developed by the U.S. Centers for Disease Control and Prevention's (CDC) Division of Viral Hepatitis; the campaign was designed to increase awareness about the hidden epidemic that affects the lives of so many; and

WHEREAS, Anyone can contract Hepatitis C, and baby boomers are five times more susceptible to the virus; Hepatitis is particularly dangerous because the symptoms do not manifest upon contraction or, in some cases, in more advanced stages; this unfortunately leads to individuals being unaware of their infection; and

WHEREAS, According to the Illinois Department of Public Health, there were 80,068 cases of chronic or resolved Hepatitis C virus infections reported from 2005 to 2015, with 171 other cases reported to be acute forms of the infection; of those infected in Illinois, over half were between the ages of 46 and 60; and

WHEREAS, Various private and public organizations, such as the American Liver Foundation, the Illinois State Medical Society, the Chicago Department of Public Health, the Illinois Department of Public Health, and the CDC, have championed efforts to raise awareness and to find solutions to the problems resulting from the Hepatitis C virus in Illinois and across the country; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 19, 2020 as "Hepatitis C Screening Day" in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, all Illinois constitutional officers, and all members of the Illinois General Assembly in order to bring further awareness of the prevalence of the Hepatitis C virus in our State and around the country.

#### **HOUSE JOINT RESOLUTION 104**

Offered by Representative West:

WHEREAS, All children in Illinois are entitled to the facilities and resources needed for a high-quality education; and

WHEREAS, Many charter schools are in older, sometimes dilapidated buildings that require repair, such as tuckpointing, new roofs, or boilers; and

WHEREAS, Most children in existing charter schools do not have the necessary access to special education resource space, to adequate space for physical education and athletics, and/or to dining facilities; and

WHEREAS, Thirty-one jurisdictions, including Arizona, California, Colorado, Florida, Massachusetts, Minnesota, New Mexico, Pennsylvania, Tennessee, Utah, and Washington D.C. currently offer facilities support for existing charter public schools through varying resources and can offer expertise on best practices; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the Task Force on Charter Public School Facilities to examine charter public school facilities issues and provide the following:

- (1) An analysis of the current capital funds and facilities provisions in the Illinois Charter Schools Law for the purpose of ensuring equitable access;
- (2) A comparative analysis of charter public school facilities funding and access across the United States; and
- (3) Recommendations for ensuring that charter public schools have equitable access to safe and appropriate facilities; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) Two members appointed by the Speaker of the House of Representatives;
- (2) Two members appointed by the Minority Leader of the House of Representatives;
- (3) Two members appointed by the President of the Senate;
- (4) Two members appointed by the Minority Leader of the Senate;
- (5) The State Superintendent of Education or his or her designee;

- (6) The chief executive officer of a school district in a city having a population exceeding 500,000 or his or her designee appointed by the State Superintendent of Education;
- (7) One member appointed by the Speaker of the House of Representatives, upon recommendation of an organization representing teachers in a school district in a city having a population exceeding 500,000;
- (8) One member appointed by the President of the Senate, upon recommendation of an organization representing teachers in a school district in a city having a population exceeding 500,000;
- (9) One member appointed by the Governor, upon recommendation of a statewide organization representing charter public schools in this State;
- (10) A principal of a currently operating, high-performing charter public school in this State, appointed by the State Superintendent of Education;
- (11) One member appointed by the Governor who is a representative of a community organization that operates charter public schools, upon recommendation of that community organization;
- (12) One member appointed by the Minority Leader of the House of Representatives, upon recommendation of an organization representing the business community in this State;
- (13) One member appointed by the Minority Leader of the Senate, upon recommendation of an organization representing the business community in this State;
- (14) One member appointed by the Governor, upon recommendation of an education advocacy group that organizes parents and supports high-quality public-school options, including high-quality public charter schools;
- (15) One member appointed by the state superintendent representing one of the ten currently operating Commission-approved charter public schools in this State, upon recommendation of the leadership of the Commission-approved charter public schools;
- (16) One member appointed by the Governor, upon recommendation of a large, non-profit community development financial institution (CDFI) in Illinois that provides or has provided specialized loans, real estate development, and additional forms of financial assistance to charter public schools in this State; and
- (17) One member appointed by the state superintendent who represents a charter school outside of the City of Chicago; and be it further

RESOLVED, That the members of the Task Force shall elect a chairperson from among their membership, and the Illinois State Board of Education shall provide administrative support; and be it further

RESOLVED, That the members of the Task Force shall be appointed within 30 days after the adoption of this resolution and shall begin meeting no later than 30 days after the appointments are finalized; in the event the appointments by the Governor are not made within 30 days after the adoption of this resolution, the State Superintendent shall make such appointments within 15 days of the appointment deadline; and be it further

RESOLVED, That the Task Force shall issue a report making recommendations on any changes to State laws with regard to charter public school facilities access on or before January 1, 2021, and that the Task Force shall be dissolved upon issuance of this report; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the State Superintendent of Education, the Illinois State Board of Education, and the Chief Executive Officer of the City of Chicago School District 299.

#### **HOUSE JOINT RESOLUTION 105**

Offered by Representative Ortiz:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Medicaid Buy-In Task Force is created to:

- (1) Determine how many people are currently uninsured compared to how many people have health care through their employer, the exchanges and Medicaid;
- (2) Evaluate current health care plan costs for private insurance compared to Medicaid managed care plans;

- (3) Estimate how many uninsured citizens in Illinois would take advantage of this program if created;
- (4) Estimate the federal financial subsidies the State would be able to take advantage of if this program were created; and
- (5) Estimate the total cost to the State of creating a Medicaid buy-in coverage option, which would include administrative costs for administering the program and costs for expanding Medicaid to that estimated population; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) The Director of the Department of Healthcare and Family Services, or his or her designee, who shall serve as chair;
  - (2) Two members of the House of Representatives, appointed by the Speaker of the House;
  - (3) Two members of the House of Representatives, appointed by the House Minority Leader;
  - (4) Two members of the Illinois Senate, appointed by the Senate President;
  - (5) Two members of the Illinois Senate, appointed by the Senate Minority Leader; and
  - (6) 8 members appointed by the Governor who represent the following:
    - (a) Organizations that advocate for Medicaid recipients;
    - (b) Organizations that provide Medicaid services or represent Medicaid health plans; and
- (c) Organizations that represent health care providers involved in delivering services to Medicaid recipients; and be it further

RESOLVED, That the Department of Healthcare and Family Services shall provide administrative support; and be it further

RESOLVED, That once all members have been appointed, the Task Force shall hold its first meeting at the call of the chair and then at least once a month after that; and be it further

RESOLVED, That the Task Force shall file its final report with the Governor and the General Assembly no later than December 31, 2020 and is dissolved upon the filing of the report.

#### **HOUSE JOINT RESOLUTION 106**

Offered by Representative Keicher:

WHEREAS, Local units of government, including school districts, often rely on the sale of bonds to finance local public works projects; and

WHEREAS, It is pertinent that the General Assembly review the existing bond sale processes of units of local government, including school districts, in an effort to remove potential conflicts of interest; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Local Government Bond Reform Task Force is created; and be it further

RESOLVED, That the Task Force shall review and analyze the current processes that units of local governments, including school districts, use to propose, invest in, and sell bonds, including any potential conflicts of interest; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) One member from the majority party of the House of Representatives appointed by the Speaker of the House of Representatives;
- (2) One member from the minority party of the House of Representatives appointed by the Minority Leader of the House of Representatives;
  - (3) One member from the majority party of the Senate appointed by the President of the Senate;
- (4) One member from the minority party of the Senate appointed by the Minority Leader of the Senate;
  - (5) The Director of the Department of Revenue or his or her designee;
  - (6) The State Superintendent of Education or his or her designee;
- (7) One member who represents an organization representing counties appointed by the Governor;

- (8) One member who represents an organization representing municipalities appointed by the Governor;
- (9) One member who represents an organization representing townships appointed by the Governor;
- (10) One member who represents an organization representing park districts appointed by the Governor;
- (11) One member who represents an organization representing school board members appointed by the Governor;
- (12) One member who represents an organization representing school superintendents appointed by the Governor;
- (13) One member who represents an organization representing school business officials appointed by the Governor; and
- (14) One member who represents an organization which serves as advocates for taxpayers and businesses appointed by the Governor;
- (15) One member who represents the bond industry appointed by the Governor; and be it further RESOLVED, That members of the Task Force shall be appointed within 30 days after approval of this resolution; and be it further

RESOLVED, That the Task Force shall hold its first meeting as soon as possible at the call of the Director of the Illinois Department of Revenue; at its first meeting, a Chairperson and a Vice Chairperson shall be appointed from among the members of the Task Force; following the first meeting, the Chairperson shall have the authority to call subsequent meetings; and be it further

RESOLVED, That the Illinois Department of Revenue shall provide administrative support for the Task Force; and be it further

RESOLVED, That the Task Force shall issue a final report to the General Assembly by January 1, 2021 that shall include recommendations to reform the bond process to remove any potential conflicts of interest and, upon the filing of its report, is dissolved; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor Pritzker and the Director of the Illinois Department of Revenue.

#### HOUSE JOINT RESOLUTION 107

Offered by Representative Bennett:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and, in doing so, have made the ultimate sacrifice for our nation; and

WHEREAS, William Eugene Campbell was born to Ida Marie and Kenneth Campbell on October 24, 1948; he was one of eight children along with his brother, Robert Dean Campbell, and his six sisters, Sandy Painter, Betty Evans, Judy Buchanan, Joyce Borchers, Janet Barker, and Jeanne Taylor; and

WHEREAS, William Eugene Campbell graduated in June of 1968 from Gibson City High School at a trying time for many young men due to the heavy involvement of the United States in the Vietnam War; and

WHEREAS, Like many others facing the draft, William Eugene Campbell was called to serve in the U.S. Army on August 12, 1968; and

WHEREAS, Just under a year into his service on August 2, 1969, William Eugene Campbell was killed in action, the first and only casualty from Gibson City; and

WHEREAS, William Eugene Campbell received several recognitions for his actions in Vietnam, including the Silver Star, which was presented to his mother Ida, for the time he "distinguished himself as a leader in Company B, First Airborne Battalion 501st Infantry during a search and clear operation near the city of Tam Ky, Republic of Vietnam"; and

WHEREAS, In addition to his Silver Star, William Eugene Campbell received the Bronze Star, the Purple Heart, the Good Conduct Medal, the National Defense Service Medal, the Vietnam Service Medal, the Vietnam Campaign Ribbon, and the Combat Infantryman Badge; and

WHEREAS, William Eugene Campbell's heroism and willingness to sacrifice his own well-being was an inspiration to his entire platoon; his bravery and devotion to duty and his fellow soldiers were in keeping with the highest traditions of military service; and

WHEREAS, William Eugene Campbell's actions reflect positively on himself, his family, his unit, and the U.S. Army; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate Illinois Route 47 as it travels through Gibson City as the "Vietnam Veteran William Eugene Campbell Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect, at suitable locations consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the "Vietnam Veteran William Eugene Campbell Memorial Highway"; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the family of William Eugene Campbell, the Mayor of Gibson City, and the Secretary of Transportation.

#### HOUSE JOINT RESOLUTION 108

Offered by Representative Wehrli:

WHEREAS, According to The K-12 Cybersecurity Resource Center (Center), there were 122 cataloged publicly-disclosed cybersecurity incidents affecting 199 public K-12 education agencies across 38 states during calendar year 2018; and

WHEREAS, The Center reports that there is a new publicly-reported incident every three days of the calendar year; and

WHEREAS, Primarily, the cyber incidents reported in 2018 were data breaches, including the unauthorized disclosure of data due to human error, by vendors in partnership with school districts, by students to modify student records, and by external actors, often for malicious purposes; and

WHEREAS, This increase in cyber threats directed at school districts continued into 2019, including in Illinois where school districts across the State have been hit by cybersecurity breaches; and

WHEREAS, In August 2019, the personal information of 53,000 students and 3,100 educators in Naperville District 203 and Indian Prairie District 204 was exposed following a data breach in connection to student assessments; and

WHEREAS, In September 2019, Rockford Public Schools were without Internet or access to student records for several days following a ransomware attack; and

WHEREAS, The Division of Elementary and Secondary Education for the State of Arkansas recently created the P-12 Cyber Threat Response Team (Team), a small group of IT professionals who provide onsite support at no cost to a school district whenever an Arkansas school district is faced with a cyber threat; and

WHEREAS, The Team works to ensure that school districts know they are not alone when faced with a cyber threat and to increase communication between schools and other interested entities; and

WHEREAS, In the face of constant cybersecurity threats, which are only going to increase in future years as the use of technology and the Internet become ever more prevalent in schools across the United States, it is imperative that Illinois works to protect school personnel, students, and their families from unauthorized data breaches and cybersecurity threats; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Illinois State Board of Education, by the 2020-2021 school year, to establish a P-12 Cyber Threat Response Team within the State Board of Education; and be it further

RESOLVED, That the P-12 Cyber Threat Response Team shall provide assistance to public schools, early childhood providers, and special education facilities across the State when faced with a cybersecurity threat; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Darren Reisberg, Chair of the State Board of Education, and Dr. Carmen Ayala, State Superintendent of Education.

#### **HOUSE JOINT RESOLUTION 109**

Offered by Representative Stephens:

WHEREAS, The neighbors of O'Hare International Airport understand the importance of this airport to Illinois' economy and its supply of good jobs; and

WHEREAS, The neighbors of O'Hare want to take an active and friendly role in helping the airport deal actively with its many noise problems; and

WHEREAS, Among the sponsors of this resolution are individuals who have talked with representatives of the City of Chicago and who appreciate the work that the Chicago Department of Aviation is doing to improve the technology used for gathering noise pollution data and improving data communications and database technology to consolidate and store this data; and

WHEREAS, This is not the first time that Chicago has reached out to its "noise neighbors"; as part of its long-term expansion plans, Chicago and many of O'Hare International Airport's principal airlines have maintained multi-year voluntary noise abatement flight procedures, instituted in 1997 and continuously revised since then as the "O'Hare International Airport Fly Quiet Program"; and

WHEREAS, Compliance with the Fly Quiet Program is overseen by the O'Hare Noise Compatibility Commission, an intergovernmental agency that includes Cook County, 41 municipalities, and 16 school districts adjacent to and around O'Hare International Airport; and

WHEREAS, The voluntary flight procedures listed in the Fly Quiet Program include approved, voluntary, recommended aircraft pathways for safe commercial jet takeoffs from O'Hare International Airport, effective from 10 P.M. to 7 A.M.; and

WHEREAS, The O'Hare Fly Quiet Program releases quarterly reports to measure compliance with the elements of the Program, including compliance by airlines and their pilots with approved runway departure flight paths; these reports show that, as of 2015, many aircraft departures currently deviate significantly from the approved "Fly Quiet" flight paths, thereby imposing noise pollution upon substantial areas of residences, schools, commercial and industrial structures, as well as property owners, whose properties are not sufficiently monitored for noise pollution and are not sufficiently mapped as impacted by aircraft noise; and

WHEREAS, The Fly Quiet report published by the Chicago Department of Aviation and covering the fourth quarter of calendar year 2014 showed massive partial compliance and noncompliance with Fly Quiet runway departure guidelines, with one runway departure point (22L) showing only 40% of aircraft departure flight paths being implemented so as to keep the aircraft within 0.5 nautical miles of the approved takeoff pathway, so that 60% of the planes during this time period, taking off from this runway location, applied engine power and climbed into the sky while the plane was located at least 0.5 nautical miles or more away from the approved pathway; and

WHEREAS, Above and beyond runway departure point 22L, other O'Hare International Airport runway departure points also showed significant patterns of partial compliance and non-compliance with Fly Quiet takeoff flight path guidelines in the fourth quarter of 2014; and

WHEREAS, Overall monitoring by the O'Hare Noise Compatibility Commission and others indicated that, in 2015, Fly Quiet voluntary guidelines were being adhered to in only 30% of total flights during nighttime hours; and

WHEREAS, These examples of partial compliance and noncompliance impose substantial financial and quality-of-life burdens upon the neighbors of O'Hare International Airport, including individuals and businesses that understand the importance of the airport and want to be good neighbors; and

WHEREAS, The airlines that operate at Chicago O'Hare International Airport also have many other interrelationships with the City of Chicago, the Federal Aviation Administration within the United States Department of Transportation, and many other entities; and

WHEREAS, These airlines include the use of a specified number of departure gates and related support facilities; access to these departure gates and these support facilities are essential assets for doing passenger and cargo business at O'Hare International Airport; access to support facilities is an essential asset for doing non-passenger cargo business at the same airport; and

WHEREAS, Whenever an airline changes hands, and under a wide variety of other circumstances, access to major airport departure gates and support facilities is closely examined by the owner of the airport, the United States Department of Transportation, and many other stakeholders in the United States airline industry; and

WHEREAS, The O'Hare International Airport Fly Quiet Program should be elevated to the rank of an independent, autonomous stakeholder in any future decisions made by O'Hare International Airport and its partners that will affect future allocations of airport departure gates and support facilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we state the belief that O'Hare International Airport's noise monitoring technology should be coupled with artificial-intelligence software, including, but not limited to, software that gauges Community Noise Equivalent Level noise levels, to the maximum extent allowed by current technology in order to match the noises perceived by each station at each time to specific individual flight operations and the operations of individual airline firms and to gauge the compliance of each individual airline firm with the noise, time-of-day, and flight path guidelines set down in the Fly Quiet Program; and be it further

RESOLVED, That we call for a measurable improvement in Fly Quiet compliance no later than January 1, 2021, with further improvements to follow; and be it further

RESOLVED, That we urge the Aviation Department of the City of Chicago to select a trusted third party that represents the interests of O'Hare International Airport's noise neighbors and to share the information enumerated in this resolution with this third party; such information-sharing should be carried out in a manner that does not violate the intellectual properties and executive status of secure information controlled by any significant stakeholders at the airport; and be it further

RESOLVED, That, as a part of this information sharing, we urge the Aviation Department and the trusted third party to collaborate to develop a rank-ordered chart of each airline firm's compliance with the guidelines contained in the O'Hare International Airport Fly Quiet Program; the chart should be public information and should be revised and republished not less than every 3 months on the same basis as the reports currently submitted by the Fly Quiet Program to the public; and be it further

- (c) The costs of administering laws related to firearms and firearm ammunition shall be limited to direct program expenses related to the following: the enforcement of firearm and firearm ammunition regulation laws; the safety of persons from unlawful use of firearms or firearm ammunition; or the regulation of the carrying of firearms.

The limitations to the costs of administering laws related to firearms and firearm ammunition under this subsection (c) shall also include direct program expenses related to workers' compensation claims for death or injury of employees enforcing firearm and firearm ammunition laws and investigations for improving the safety of the employees enforcing those laws.

- (d) None of the revenues described in subsection (a) of this Section shall, by transfer, offset, or otherwise, be diverted to any purpose other than those described in subsections (b) and (c) of this Section.

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IV of the Illinois Constitution by changing Sections 2 and 3 as follows:

### ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 2) SECTION 2. LEGISLATIVE COMPOSITION

- (a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.
- (b) Each Legislative District shall be divided into two Representative Districts. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years.
- (c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the

time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.

- (d) Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty-eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.
- (e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term.

#### SECTION 3. LEGISLATIVE REDISTRICTING

(a) As used in this Section:

"Coalition districts" means districts in which more than one group of racial minorities or language minorities may form a coalition to elect the candidate of the coalition's choice.

"Consumer price index-u" means the index published by the Bureau of Labor Statistics of the United States Department of Labor or a successor agency that measures the average change in prices of goods and services purchased by all urban consumers, United States city average, all items, 1982-84=100.

"Crossover districts" means districts in which a racial minority or language minority constitutes less than a majority of the voting-age population, but where this minority, at least potentially, is large enough to elect the candidate of its choice with help from voters who are members of the majority who cross over to support the minority's preferred candidate.

"Influence districts" means districts in which a racial minority or language minority can influence the outcome of an election even if its preferred candidate cannot be elected.

"Racial minorities or language minorities", in either the singular or the plural, means the same class of voters who are members of a race, color, or language minority group receiving protection under the federal Voting Rights Act.

- (b) Each Legislative District, Representative District, and Congressional District shall, in the following order of priority:
  - (1) fully comply with the United States Constitution and federal laws, such as the federal Voting Rights Act;
    - (2) be substantially equal in population;
  - (3) provide racial minorities and language minorities with the equal opportunity to participate in the political process and elect candidates of their choice;
  - (4) provide racial minorities and language minorities who constitute less than a voting-age majority of a Legislative District, Representative District, or Congressional District with an opportunity to substantially influence the outcome of an election through the creation of crossover districts, coalition districts, or influence districts;
    - (5) be contiguous;
    - (6) be compact;
    - (7) respect, to the extent practical, geographic integrity of units of local government;
    - (8) respect, to the extent practical, communities sharing common social or economic interests; and (9) not discriminate against or in favor of any political party or individual.
- (c) No later than March 1 of the year that follows the federal decennial census, the Chief Justice and the most senior Supreme Court Justice who is not elected from the same political party as the Chief Justice shall select 17 commissioners to form an Independent Redistricting Commission. The commissioners shall reflect the ethnic, gender, and racial demographics of Illinois to reflect the demographic data provided by the decennial census, each commissioner shall be a voter who has been continuously affiliated in Illinois with the same political party or unaffiliated with a political party and who has not changed political party

- affiliation for 5 or more years immediately preceding the date of his or her appointment. Fourteen of the commissioners shall represent, in equal number, the two political parties whose gubernatorial candidates received the greatest number of votes in the last gubernatorial election and 3 of the commissioners must represent neither of those parties. No more than one commissioner shall be from the same Congressional District. If the total number of Congressional Districts equal less than 17, then at-large commissioners will be appointed to fill vacancies, and no more than 2 commissioners shall be from the same Congressional District. The 2 Justices responsible for selecting the 17 commissioners shall consider party identification and all campaign contributions in determining a potential commissioner's eligibility.
- (d) A person is ineligible to serve on the Commission if within the previous 5 calendar years the person or his or her spouse or immediate family member, including his or her parents, children, step-children, or siblings, is or has been:
  - (1) appointed or elected to a position with the State, federal, or local government;
  - (2) a candidate for State, federal or local office;
  - (3) a paid consultant or employee of a State, federal, or local elected official or political candidate, of a federal, State, or local political candidate's campaign, or of a political action committee or any other electioneering entity;
    - (4) a State, federal, or local lobbyist as defined by law;
  - (5) an individual with an ownership interest in an entity with a State, federal, or local government contract; or
    - (6) appointed or elected to serve a State, federal, or local political party.
- (e) A commissioner is ineligible for a period of 10 years to serve in the General Assembly or to be appointed to a position subject to Senate confirmation.
- (f) Commissioners must file financial disclosure statements and abide by any ethics requirements established by law.
- (g) Each prospective applicant for commissioner shall attest under oath that they meet the qualifications set forth in this Section, and attest either that they affiliate with one of the 2 political parties whose gubernatorial candidates received the 2 greatest number of votes in the last gubernatorial election, and if so, identify the party with which they affiliate, or that they do not affiliate with either of the major parties.
- (h) Any vacancy, whether created by removal, resignation, death, or absence, in the 17 commission positions shall be filled within the 30 days after the vacancy occurs, from the pool of applicants of the same political party as the vacating nominee that was remaining as of the end of the commissioner selection process. If none of those remaining applicants are available for service, the Chief Justice of the Supreme Court and the most senior Supreme Court Judge of a different political party shall fill the vacancy from a new application pool created to maintain the partisan balance of the commission and to the extent possible, to keep the geographic and racial demographics of the commission the same as it was prior to the vacancy.
- (i) The Commission shall act in public meetings by the affirmative vote of 11 commissioners. The Commission shall elect its chairperson and vice chairperson, who shall not be affiliated with the same political party. Each meeting of the Commission shall be open to the public and there must be public notice at least 7 days before a meeting. All records of the Commission, including all communications to or from the Commission regarding the work of the Commission, shall be available for public inspection. The Commission shall adopt rules governing its procedures. The Commission shall be considered a public body subject to the Freedom of Information Act or a successor Act and the Open Meetings Act or a successor Act.
- (j) In each year in which the federal decennial census is taken but in which the United States Bureau of the Census allocates incarcerated persons as residents of correctional facilities, the Secretary of State shall request that each agency that operates a federal correctional facility in this State that incarcerates persons convicted of a criminal offense to provide the Secretary of State with a report that includes the last known place of residence prior to incarceration of each inmate, except an inmate whose last known place of residence is outside of Illinois. The Secretary of State shall deliver such report to the Commission by December 30 of that same year. For purposes of reapportionment and redistricting, the Commission shall count each incarcerated person as residing at his or her last known place of residence, rather than at the institution of his or her incarceration.
- (k) The Commission shall hold at least 20 public hearings throughout the State before adopting a redistricting plan, with a majority occurring before the Commission releases any proposed redistricting plan

and at least 10 public hearings must occur throughout the State after the release of any proposed redistricting plan.

The Commission must provide a meaningful opportunity for racial minorities and language minorities to participate in the public hearings, including, but not limited to, issuing notices in multiple languages and ensuring that translation services are available at all hearings at the Commission's expense or through partnership with outside organizations. These public hearings must be open to all members of the public and must be planned to encourage attendance and participation across the State, including the use of technology that allows for real-time, virtual participation and feedback during the hearings. When releasing a proposed redistricting plan, the Commission must also release population data, geographic data, election data, and any other data used to create the plan, when the Commission receives this information. The Commission must also provide terminals for members of the public to access the data and associated software. During the map drawing process, any member of the public may submit maps for consideration to the Commission. The Commission must consider public input and respond to it. Those submissions are public records that are open to comment.

The Commission may not adopt a redistricting plan until the Commission adopts and publishes a report explaining the plan's compliance with the United States Constitution and Illinois Constitution. Before the adoption of a redistricting plan, the Commission shall release to the public the final plan and its associated compliance report. The meeting to vote on adoption of a redistricting plan shall occur no sooner than 30 days after the release of the final plan and its associated compliance report. All proposed and adopted maps and any data used to develop these maps are public records. The Commission shall maintain a website or other similar electronic platform to disseminate information about the Commission, including records of its meetings and hearings, proposed redistricting plans, assessments and reports on plans, and to allow the public to view its meetings and hearings in both live and archived form. The website or electronic platform must allow the public to submit redistricting plans and comments on redistricting plans to the Commission for its consideration.

- (l) The Commission shall adopt and file with the Secretary of State a redistricting plan for the Legislative Districts, Representative Districts, and Congressional Districts by September 1 of the year following the federal decennial census. The Commission may adopt separate redistricting plans for the Legislative Districts, the Representative Districts, and the Congressional Districts.
- (m) Members of the Commission shall be compensated at the rate of \$37.50 for each hour the member is engaged in Commission business. For each succeeding Commission, the rate of compensation shall be adjusted in each year of the federal decennial census by the cumulative change in inflation based on the consumer price index-u or a successor metric. Members of the Commission are eligible for reimbursement of personal expenses incurred in connection with the duties performed pursuant to this Section. A member's residence is deemed to be the member's post of duty for purposes of reimbursement of expenses.
- (n) Within the first 30 days after the selection of the Independent Redistricting Commission, the Governor shall include in the budget submitted under Section 2 of Article VIII to the General Assembly amounts of funding for the Commission and the Secretary of State that are sufficient to meet the estimated expenses of each of those officers or entities in implementing the redistricting process required by this Section for a 3-year period, including, but not limited to, adequate funding for a statewide outreach program to solicit broad public participation in the redistricting process. The Governor shall also make adequate office space available for the operation of the Commission. The General Assembly shall make the necessary appropriation in a Budget Implementation Act, and the appropriation shall be available during the entire 3-year period. The appropriation made shall be equal to the greater of \$3,000,000 or the amount expended in accordance with this subsection (n) in the immediately preceding redistricting process, as each amount is adjusted by the cumulative change in inflation based on the consumer price index-u or a successor metric, since the date of the immediately preceding appropriation made in accordance with this subsection (n). The General Assembly may make additional appropriations in any year that it determines that the Commission requires additional funding in order to fulfill its duties. The Commission, with fiscal oversight from the Comptroller or its successor, shall have procurement and contracting authority and may hire staff and consultants, for the purposes of this Section, including legal representation.
- (o) A redistricting plan filed with the Secretary of State shall be presumed valid and shall be published promptly by the Secretary of State.
- (p) The Supreme Court shall have original and exclusive jurisdiction over actions concerning the redistricting of the Congressional, Legislative, and Representative Districts, which shall be initiated in the

name of the People of the State by the Attorney General. Each person who resides or is domiciled in the State, or whose executive office or principal place of business is located in the State, may bring an action in a court of competent jurisdiction to obtain any of the relief available.

- (a) Legislative Districts shall be compact, contiguous and substantially equal in population. Representative Districts shall be compact, contiguous, and substantially equal in population.
- (b) In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative Districts and the Representative Districts.

If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party.

The Speaker and Minority Leader of the House of Representatives shall each appoint to the Commission one Representative and one person who is not a member of the General Assembly. The President and Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a member of the General Assembly.

The members shall be certified to the Secretary of State by the appointing authorities. A vacancy on the Commission shall be filled within five days by the authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all members of the Commission.

Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1.

Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth member of the Commission.

Not later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State.

The Supreme Court shall have original and exclusive jurisdiction over actions concerning redistricting the House and Senate, which shall be initiated in the name of the People of the State by the Attorney General.

## HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 42

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article IV of the Illinois Constitution as follows:

ARTICLE IV THE LEGISLATURE (ILCON Art. IV, Sec. 3)

### SECTION 3. LEGISLATIVE REDISTRICTING

- (a) Legislative Districts shall be compact, contiguous and substantially equal in population. Representative Districts shall be compact, contiguous, and substantially equal in population.
- (b) In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative Districts and the Representative Districts.

If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party.

The Speaker and Minority Leader of the House of Representatives shall each appoint to the Commission one Representative and one person who is not a member of the General Assembly. The President and Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a member of the General Assembly.

The members shall be certified to the Secretary of State by the appointing authorities. A vacancy on the Commission shall be filled within five days by the authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all members of the Commission.

Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1.

Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth member of the Commission.

Not later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State.

If a municipality has been divided between two or more Legislative Districts under a redistricting plan, that municipality may petition to the General Assembly, or the Commission established by the General Assembly, to unify the municipality into one Legislative District. The General Assembly or Commission shall either unify the municipality or provide the municipality with an explanation of the necessity of dividing the municipality into two or more Legislative Districts.

The Supreme Court shall have original and exclusive jurisdiction over actions concerning redistricting the House and Senate, which shall be initiated in the name of the People of the State by the Attorney General

## HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 43

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IX of the Illinois Constitution by adding Section 12 as follows:

# ARTICLE IX REVENUE

(ILCON Art. IX, Sec. 12 new)

SECTION 12. Assessment limitation for school district levy purposes for certain persons who have attained age 65. The General Assembly shall, by law, prohibit increases in the assessed value, for school district levy purposes, of homestead property owned and occupied by a person who:

- (1) has attained age 65; and
- (2) has held legal or equitable title to the property and maintained permanent residence thereon for at least 25 years.
