**HOUSE RESOLUTIONS**

HOUSE RESOLUTION 813

Offered by Representative Yingling:

WHEREAS, There are over 350 specialized dentists known as endodontists in Illinois; and  
WHEREAS, Endodontists are dental specialists who are highly skilled in diagnosing and treating tooth pain and performing root canal treatment; along with two to three years of advanced training beyond dental school, endodontists have incredible precision and hand-eye coordination, making them highly skilled in performing complex treatments; they use the most specialized and advanced technology to treat tooth pain and perform root canal treatment; no one is better at saving your natural teeth; and  
WHEREAS, Endodontists perform many other endodontic treatments and surgeries, address traumatic dental injuries, and place dental implants; their goal is to save a patient's natural teeth whenever possible; and  
WHEREAS, Endodontists limit their practice solely to endodontic treatments, performing an average of 25 root canal treatments a week; specialized treatment gives patients the best outcome and leads to faster

healing; for this reason, dentists and endodontists often work as partners in care so that the best member of the dental team is handling each appropriate issue with a patient's teeth; and

WHEREAS, Poor oral hygiene can lead to other health problems; regular dental visits, flossing, brushing thoroughly at least twice a day, and refraining from foods and habits that can cause cavities are important steps for maintaining the overall health of one's gums, teeth, and mouth; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 2020 as Save Your Tooth Month, recognize the endodontists who are dedicated to saving patients' natural teeth by way of Root Canal Treatment, and encourage citizens of Illinois to practice good oral hygiene.

#### HOUSE RESOLUTION 814

Offered by Representative Mussman:

WHEREAS, School principals play an integral role in the education and growth of children in elementary, middle, and secondary schools across the State of Illinois; and

WHEREAS, School principals are responsible for promoting education and building relationships with parents and teachers to ensure that each and every child receives services that meet their needs in order to excel in the classroom; and

WHEREAS, It is the primary responsibility of the State of Illinois to preserve and improve resources for schools so that all students have access to a quality education and foundation for a successful future; and

WHEREAS, The Illinois Principals Association, which represents over 5,800 educational leaders statewide, believes that learning is a lifelong process and that the education of our children is the highest priority; and

WHEREAS, For that reason, the Illinois Principals Association is dedicated to developing, supporting, and advocating for innovative school leaders; and

WHEREAS, Educational leaders face many challenges in supporting and educating our young people, and it is through their perseverance and passion that Illinois continues to produce quality, career-ready students; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of October 18-24, 2020 as Principals Week and Friday, October 23, 2020 as Principals Day in Illinois, to recognize principals and the Illinois Principals Association for all that they do to help our children learn and succeed; and be it further

RESOLVED, That we urge citizens to continue to support and recognize those who have a positive impact on Illinois students and the educational system in the Land of Lincoln; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois State Board of Education and the Illinois Principals Association.

#### HOUSE RESOLUTION 815

Offered by Representative Carroll:

WHEREAS, The Korean War, which was among the most destructive armed conflicts of the modern era, remains one of the world's longest ongoing wars, in which the Republic of Korea (South Korea), the Democratic People's Republic of Korea (North Korea), and the United States have suffered hundreds of thousands of casualties and losses, millions of civilians killed and wounded, and millions of families separated; and

WHEREAS, On July 27, 1953, the United Nations Command, the North Korean People's Army, and the Chinese People's Volunteers entered into an armistice agreement; by its terms, it aimed to "insure a complete cessation of hostilities and of all acts of armed force in Korea until a final peaceful settlement is achieved"; and

WHEREAS, The Korean War Armistice Agreement, by its terms, neither formally ended the war nor amounted to a final peaceful settlement; and

WHEREAS, The persistence of a state of war poses a constant risk and threat to the national security of the United States and its allies; and

WHEREAS, On April 27, 2018, the leaders of South Korea and North Korea met in Panmunjom, located on the border between North and South Korea, and declared that "there will be no more war and a new era of peace has begun on the Korean peninsula"; they further committed "to declare the end of war" on the Korean peninsula, being in agreement to promote meetings involving the United States "with a view to replacing the Armistice Agreement with a peace agreement and establishing a permanent and solid peace regime"; and

WHEREAS, On June 12, 2018, the leaders of the United States and North Korea met in Singapore and promised "to establish new relations in accordance with the desire of the peoples of the two countries for peace and prosperity"; and

WHEREAS, The failure to reach a final peace settlement on the Korean peninsula has had long-term negative consequences on human rights, humanitarian conditions, and world peace, causing continued separation of families and incurred misappropriation of resources to excessive military spending rather than to the livelihoods of Americans and Koreans; and

WHEREAS, Fifteen Illinois National Guard units and their subordinate commands were called to federal service during the Korean War; and

WHEREAS, More than 1,789 Illinois servicemen shed blood for their country and the freedom of the Korean people in the Korean War; and

WHEREAS, The State of Illinois continues standing for world peace, the national security of the United States, universal human rights, and humanitarian conditions; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we pay tribute to the sacrifices of the veterans of the Korean War, its victims, and the families separated by the war; and be it further

RESOLVED, That we salute the Illinois National Guard Korean War veterans and honor them for their commitment to country, courage, and sacrifice; and be it further

RESOLVED, That we would welcome a statement by the United States, in coordination with South Korea, declaring the end of the state of war with North Korea; and be it further

RESOLVED, That we call for the conclusion of a binding peace agreement constituting a formal and final end to the state of war between South Korea, North Korea, and the United States; and be it further

RESOLVED, That we affirm the vital role that women, who would be particularly vulnerable to any resumption of armed conflicts, must play in building a permanent and peaceful settlement; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.
