### **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 859**

Offered by Representative Spain:

WHEREAS, Illinois is currently facing a global outbreak of the new coronavirus, a pandemic called COVID-19, which has led to widespread illness and death around the world, including in Illinois; and

WHEREAS, The Governor of Illinois has issued a series of emergency executive orders in response to the pandemic, ordering the shutdown of a wide variety of businesses, places of religious worship, places of education, and places of nonprofit enterprise throughout the State; and

WHEREAS, These shutdown orders have caused devastating harm to many Illinoisans who are already affected by the pandemic; and

WHEREAS, To slowly reverse the effects of these devastating shutdowns and executive orders, the Governor of Illinois has issued what he and his senior staff call the Restore Illinois Plan, a plan to "reopen Illinois" on the basis of defined variables based on data gathered throughout four huge geographic regions of the State; and

WHEREAS, Gathering data on the basis of these huge State geographic sub-regions will force this urgent work of re-opening to be accomplished much more slowly than it would otherwise be accomplished, with devastating secondary consequences to Illinoisans of all groups and social backgrounds; furthermore, "Restoring Illinois" on the basis of this mega data is completely dismissive and disrespectful of the current work being done by Illinoisans of all economic and social categories who are fighting as members of their local communities to reduce the rate of COVID-19 viral transmission from person to person; and

WHEREAS, As locally elected lawmakers and members of a co-equal branch of government, we in the Illinois House of Representatives can see and appreciate these efforts to fight COVID-19 up close; it implies no disrespect to the Governor of Illinois in the midst of the immense burdens he now bears to suggest that we can see these local efforts as well as he can or better than he can; and

WHEREAS, The Restore Illinois policy constitutes legal action of immense significance to the people of Illinois; this being so, this policy should be drafted as a law, debated as a law, considered as a law by members from all parts of Illinois, and enacted by legislative majority vote as a law; and

WHEREAS, As possessors of local information on the fight against COVID-19, we, the members of the Illinois House of Representatives, together with our colleagues in the Illinois Senate, should play a role in the reshaping of Restore Illinois, so that it truly restores Illinois in fact and not just in hope; and

WHEREAS, Due to the state of the calendar of the Illinois General Assembly at the time of the preparation of this resolution, there is ample time prior to the May 31, 2020 adjournment deadline for healthy discussion and debate on this issue of immense importance to our neighbors and constituents; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Restore Illinois plan promulgated by the Governor of Illinois that is in effect as of May 23, 2020 should be re-drafted as legislative language and submitted to the Illinois General Assembly for discussion, debate, and legal enactment as statutory law; and be it further

RESOLVED, That we pledge to discuss and debate the Restore Illinois plan in good faith, and we pledge that the suggested corrections we will make to it will be based not on political grandstanding but on informed public-health information about the situations in our own communities; and be it further

RESOLVED, That we pledge that we will stand with the people of Illinois to reopen our State safely and with the welfare of all of us in mind, including those among us who are most at risk from the dangerous virus that is causing this pandemic; and be it further

RESOLVED, That copies of this resolution be delivered to Governor JB Pritzker, Speaker of the House of Representatives Michael J. Madigan, and President of the Illinois Senate Don Harmon.

#### HOUSE RESOLUTION 860

Offered by Representative Bryant:

WHEREAS, On May 15, 2020, several members of the General Assembly received panicked phone calls and emails concerning private personal identification information, such as social security numbers, addresses, and birth dates, being published publicly on the Illinois Department of Employment Security's (IDES) website; and

WHEREAS, The private information being published by IDES pertained to tens of thousands of individuals who had applied for Pandemic Unemployment Assistance (PUA) benefits as a result of the government shut down of businesses in response to the COVID-19 pandemic; and

WHEREAS, Governor Pritzker and IDES entered into two no-bid contracts with private sector companies totaling \$22 million of taxpayer money to help assist in upgrading IDES's antiquated website and claims systems; and

WHEREAS, Prior to May 11, 2020, the day the new IDES became operational, the general public and members of the General Assembly were assured that upon completion of the upgrades to the system then IDES would be able to handle the large number of applications more efficiently, and the application process for unemployment benefits would be easier and more secure; and

WHEREAS, Since the beginning of the government shut down of businesses on March 16, 2020, a record number of over one million Illinoisans have filed for unemployment benefits, with many having to repeatedly call IDES while waiting for weeks without income; and

WHEREAS, Upon learning about the publication of the private personal information on IDES's website, Representative Terri Bryant immediately notified members of the Governor's staff and the IDES staff and asked them to resolve the data breach; and

WHEREAS, The day following the data breach, having not received sufficient answers as to how the breach happened and who was affected, Representative Terri Bryant submitted a letter to the Governor's office requesting those answers; and

WHEREAS, On May 21, 2020, five days after the request for answers from the Governor's office and still not having received an adequate response, a subsequent letter was sent from several members of the House Republican Caucus asking that the Governor respond; and

WHEREAS, Every day that goes by without knowing whose information was published, how long the information was available, and who was able to access the information leaves thousands of Illinoisans, who are already suffering from job loss, vulnerable to identity theft; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct an audit of the Illinois Department of Employment Security and the unemployment benefits application system; and be it further

RESOLVED, That the audit include, but not be limited to, the following determinations:

- (1) For what period of time the personal information of unemployment applicants was available for access by other applicants and the public;
- (2) Whether or not the data breach has been fully resolved;
- (3) The possibility of another data breach;
- (4) The number of applicants whose information was published;
- (5) The vulnerability to identity theft or other security issues of those whose information was published;
- (6) Any other vulnerabilities regarding the information of the millions of Illinoisans who have applied for unemployment benefits; and
- (7) A review of the contracts awarded to Deloitte Consulting for assisting IDES in the upgrading of its IT services; and be it further

RESOLVED, That IDES and any other State agency or entity having information relevant to the audit shall cooperate fully and promptly in the conduct of the audit; and be it further

RESOLVED, That the Auditor General shall commence this audit as soon as possible and report his findings and recommendations upon completion to the Governor and each of the four leaders of the General Assembly; and be it further

RESOLVED, That the Legislative Audit Commission is urged to review the findings of this audit in a public meeting, and the General Assembly is urged to take any actions that it deems necessary or desirable to implement the recommendations made by the audit and to remedy any problems or dysfunctions uncovered by the audit; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker, Department of Employment Security Acting Director Thomas Chan, Auditor General Frank J. Mautino, and Legislative Audit Commission Executive Director Jane Stricklin.

#### HOUSE RESOLUTION 862

Offered by Representative Durkin:

WHEREAS, The Illinois Constitution declares that it is the public policy of the State "to provide and maintain a healthful environment for the benefit of this and future generations"; and

WHEREAS, Illinois has historically demonstrated leadership and resolve to protect, conserve, and restore the natural environment, including through a network of protected areas; and

WHEREAS, There are over 130 state parks and multiple conservation programs in Illinois; and

WHEREAS, According to an estimate by the United States Department of Agriculture, there were approximately five million acres of forested land in Illinois in 2018, containing over two billion trees; that is an increase of over 100,000 acres of wooded land since 2013; of those five million acres, over 83% of them were owned by private land-owners; and

WHEREAS, The United States ranks among the top five countries in the world for the amount of wilderness-quality land and ocean it has remaining; and

WHEREAS, The United States Geological Survey classifies over seven-hundred million acres of land, or 30% of the U.S. landmass, as protected; that network of protected areas is preserved and supported by a variety of conservation laws; and

WHEREAS, The United States has the conservation experience and traditions necessary to make great strides in the preservation of natural areas for future generations; and

WHEREAS, The United States announced that it would join the Trillion Trees Initiative, a global campaign to plant at least one trillion new trees; and

WHEREAS, The U.S. Senate is considering a resolution calling for the establishment of a national goal of conserving at least 30% of U.S. lands and oceans by 2030; and

WHEREAS, Congressional leaders of both major parties have implemented legislation to protect the United States' rich natural heritage; and

WHEREAS, Despite these accomplishments, there are over 1,300 threatened or endangered species in the United States according to the federal Environmental Protection Agency; a study published in the journal Science found that the bird populations in the United States and Canada have declined by three billion since 1970; and

WHEREAS, Young people are taking the lead in the effort to conserve Illinois' environmental resources; the students of Pontiac Township High School raised \$100,000 and launched Operation Endangered Species to restore endangered species to their historical habitats; and

WHEREAS, Through the Operation Endangered Species program, these students have performed research, secured habitat, informed citizens, and empowered youth to take action; and

WHEREAS, Operation Endangered Species fostered cooperation between the students of Pontiac Township High School and the Illinois Department of Natural Resources, resulting in the reintroduction of the Alligator Snapping Turtle back into its natural habitat; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State should redouble its efforts to work with the federal government, local governments, the private sector, civil society, schools, students, farmers, ranchers, fishing communities, and sportsmen to conserve the land, rivers, and lakes of Illinois for present and future generations to enjoy, taking into account a wide range of flexible and enduring conservation solutions that will improve access to nature for all people within Illinois, especially for communities that have historically lacked access to natural spaces; and be it further

RESOLVED, That the State should pursue this goal in a way that protects private property rights and traditional land uses and enables landowners to pass down the working land of those landowners to the next generation; and be it further

RESOLVED, That a copy of this resolution be delivered to the students of Pontiac Township High School, Lemont High School, and Whitney M. Young Magnet High School.

#### HOUSE RESOLUTION 880

Offered by Representative Robinson:

WHEREAS, The United States of America continues the historical exploitation of and violence against marginalized groups that has helped form the foundations of its prosperity; and

WHEREAS, The modern police state has emerged from the institutions of slave catchers and strike breakers, which were later repurposed for use in upholding Jim Crow laws and for the suppression of the civil rights movement; the State of Illinois has a history of racially-biased policing and brutality by law enforcement and corrections officers, and prior attempts at reform have been unsuccessful; and

WHEREAS, There has been a lack of correlation between increased police spending and feelings of safety or decreases in crime; and

WHEREAS, Most crimes are never reported, and those that are reported often go unresolved; and

WHEREAS, Many of the people in the jails and prisons of Illinois have not been convicted, are awaiting trial, are non-violent offenders, or are at a low risk of recidivism; and

WHEREAS, There are many other data-driven and evidence-based ways to promote peace within our communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge every Illinois municipality and county to cut 10% of funding to law enforcement agencies that do not adopt and comply with an appropriately robust reform program; and be it further

RESOLVED, That an appropriately robust reform program would ensure law enforcement officers are held accountable for misconduct, policing agencies are held accountable for creating policies and priorities with public input that are transparent and evidence-based, and policing agencies' budgets are reviewed to ensure resources are used for holistic public safety and have transparency for police budgetary items; and be it further

RESOLVED, That we urge municipalities and counties to review municipal and county codes for the over-criminalization of minor offenses and the criminalization of poverty or other status; and be it further

RESOLVED, That we urge the State of Illinois to do the following:

- (1) Set a statutory minimum requirement for the use of lethal and less lethal force;
- (2) Set minimum standards for the training, equipment, and deployment of tactical teams, with a requirement to report the relevant data on all deployments;
- (3) Limit the use of and access to invasive surveillance technologies by police agencies or private companies contracted by police agencies, with oversight on how data is collected and handled;
- (4) Limit the use of traffic and pedestrian stops through the limiting of the use of reasonable suspicion stops for certain categories of offenses, requiring officers to inform individuals that they have the right to refuse to consent to a search and requiring reasonable suspicion of evidence or contraband before searches;
- (5) Limit arrests for low-level offenses and offenses where summonses and citations are adequate replacements;
- (6) Establish standards for policies on the release of body cam footage;
- (7) Require recordings of interrogations for accounts of the interrogations to be admissible in court;
- (8) Allow for the appointment of special independent investigators or prosecutors for critical incidents;
- (9) Re-evaluate the role of police unions in the setting of policy;
- (10) Require policing agencies to release to the public all department policies, information on the policing agency's use of surveillance technologies, complaint data, and crime and call for service data;
- (11) Mandate data collection and reporting for all enforcement actions;
- (12) Review criminal codes and consider decriminalizing low-level offenses for which arrests and criminal penalties are inappropriate; and
- (13) Discourage the use of police stops as a deterrent to criminal activity, rather than investigating it; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the families of those harmed by police violence, county and municipal boards, relevant state agencies, and Governor JB Pritzker.

#### HOUSE RESOLUTION 881

Offered by Representative Stava-Murray:

WHEREAS, July 20, 2020 will mark 21 years since the Chinese Communist Party (CCP) launched a systematic and brutal campaign to "eradicate" the spiritual discipline of Falun Gong, a traditional Buddhist-based meditation practice whose core principles are truthfulness, compassion, and tolerance; and

WHEREAS, When this persecution first began in 1999, there were 70 to 100 million people from all walks of life practicing Falun Gong in China according to the Chinese government's own estimate; persecution of Falun Gong is not limited to a specific region; it is in every province, every city, and every county throughout China; and

WHEREAS, A 2007 U.S. State Department Human Rights Report states, "[the UN Special Rapporteur on Torture Manfred] Nowak reported that Falun Gong practitioners accounted for 66 percent of victims of alleged torture while in government custody"; and

WHEREAS, Since July 1999, there have been over 4,300 documented cases of Falun Gong practitioners dying as a result of torture and abuse in police custody, yet due to the danger and difficulties of

verifying each case and sending that information overseas, the true death toll is widely believed to be many times higher; and

WHEREAS, On June 17, 2019, an independent tribunal in London, chaired by Sir Geoffrey Nice QC who worked at the International Criminal Tribunal and led the prosecution of Slobodan Milosevic, released its final judgment and concluded: "Forced organ harvesting has been committed for years throughout China on a significant scale and that Falun Gong practitioners have been one - and probably the main - source of organ supply"; and

WHEREAS, The U.S. Department of State Country Report on Human Rights for China in 2014 stated, "Advocacy groups continued to report instances of organ harvesting from prisoners"; and

WHEREAS, In 2015, Freedom House reported that Falun Gong practitioners comprise the largest portion of prisoners of conscience in China and face an elevated risk of dying or being killed while in custody; and

WHEREAS, The ramifications of such atrocities are beyond the Chinese border, as many organ recipients are westerners, and there has been much collaboration between the Chinese transplant industry and western medical professionals and the pharmaceutical industry; and

WHEREAS, As the current pandemic shows, a lack of international censure to these horrific crimes has not only cost the lives of innocent Chinese, but also those of many in the West; and

WHEREAS, One of the lead investigators of the CCP's killing of Falun Gong practitioners for their organs, David Matas, explained: "...if China had faced global pressure for transparency and accountability in its health system in dealing with organ transplant abuses, we wouldn't have this coronavirus now. And we are suffering the consequences now of turning a blind eye to organ transplant abuse"; and

WHEREAS, The CCP's mass campaign to vilify and eradicate Falun Gong and its core values of truthfulness, compassion, and tolerance is also an attack on the conscience of humanity and corrupts the moral fabric of Chinese society; and

WHEREAS, This less visible yet more profound damage can have consequences in the West too, as immigrants from such a Chinese society are more likely to act as the CCP's surrogates and conduct technology thefts or espionage activities; and

WHEREAS, A Chinese population with more access to free information and more exposure to western values will be less likely to become the CCP's accomplice or advance its agenda in the international community; and

WHEREAS, The Washington Post reported in 1999 that many influential people in the party, the government, and the military practiced Falun Gong at that time, and Falun Gong practitioners have a deep understanding about the CCP and know best how to disintegrate it; and

WHEREAS, Falun Gong practitioners have been operating 200,000 or more underground printing houses to produce such material across China in what likely constitutes the largest non-violent, grassroots resistance in the world; and

WHEREAS, It was Falun Gong practitioners who spearheaded international media companies that broadcast uncensored information to China via satellite TV and shortwave radio; and

WHEREAS, It was Falun Gong practitioners who developed free ground-breaking internet freedom software, Freegate and Ultrasurf, which allow millions in China to bypass the Great Firewall and reach entire sectors of the Internet that are blocked by the CCP, as reported by the New York Times, Wall Street Journal, and many other media outlets; and

WHEREAS, As a result, to date, over 300-million Chinese people have withdrawn from the CCP and/or its affiliated organizations (most used pseudo-names to avoid the CCP's retaliation), a phenomenon similar to what happened right before the collapse of the Soviet Union; and

WHEREAS, The killing of religious or political prisoners for the purpose of selling their organs for transplant is an egregious and intolerable violation of the fundamental right to life; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the persecution of Falun Gong, a traditional Buddhist-based meditation practice whose core principles are truthfulness, compassion, and tolerance, as it reaches the 21 year mark since the Chinese Communist Party launched a systematic and brutal campaign to "eradicate" the spiritual discipline of Falun Gong; and be it further

RESOLVED, That we encourage the medical community in the United States to help raise awareness of unethical organ transplant practices in China; and be it further

RESOLVED, That we condemn the practice of state-sanctioned forced organ harvesting in the People's Republic of China.

HOUSE RESOLUTION 885

Offered by Representative Durkin:

WHEREAS, The Speaker of the House has many responsibilities and powers placed on that position through the Illinois Constitution and the House Rules of the 101st General Assembly; and

WHEREAS, The federal charges and conduct outlined in the Deferred Prosecution Agreement entered into between Commonwealth Edison Company and the United States Attorney's Office for the Northern District of Illinois on July 17, 2020, together with the testimony of ComEd officials before the Illinois Commerce Commission on July 29, 2020, highlight a scheme perpetrated by ComEd solely for the benefit of Michael J. Madigan, in exchange for favorable actions before the Illinois General Assembly; and

WHEREAS, These facts clearly show that the trust placed in the Office of the Speaker has been misplaced for many years and that Michael J. Madigan is unable to execute his responsibilities as Speaker of the Illinois House of Representatives; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the members have no confidence that Michael J. Madigan can continue in his role as Speaker and hereby remove him from that position.

HOUSE RESOLUTION 886

Offered by Representative Lilly:

WHEREAS, Parks and recreation programs are an integral part of communities throughout this country, including the State of Illinois; and

WHEREAS, Parks and recreation are vitally important to establishing and maintaining the quality of life in communities, ensuring the health of all citizens, and contributing to the economic and environmental well-being of a community and region; and

WHEREAS, Parks and recreation programs build healthy, active communities that aid in the prevention of chronic disease, provide therapeutic recreation services for those who are mentally or physically disabled, and also improve the mental and emotional health of all citizens; and

WHEREAS, Parks and recreation programs increase a community's economic prosperity through increased property values, expansion of the local tax base, increased tourism, the attraction and retention of businesses, and crime reduction; and

WHEREAS, Parks and recreation areas are fundamental to the environmental well-being of our communities; and

WHEREAS, Parks and natural recreation areas improve water quality, protect groundwater, prevent flooding, improve the quality of the air we breathe, provide vegetative buffers to development, and produce habitat for wildlife; and

WHEREAS, Our parks and natural recreation areas ensure the ecological beauty of our communities and provide a place for children and adults to connect with nature and recreate outdoors; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare July of 2020 Parks and Recreation Month; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Illinois Park and Recreation Association, the Illinois Association of Park Districts, the Illinois Department of Natural Resources, and the National Park and Recreation Association.

HOUSE RESOLUTION 893

Offered by Representative Lilly:



WHEREAS, African American communities have demonstrated a history of perseverance in the face of adversity, rising from chattel slavery to form thousands of successful businesses in the years after abolition; and

WHEREAS, White supremacy manifested through individual and institutional racism has historically targeted Black Americans and Black businesses through government policy and extrajudicial means, resulting in stolen land, destroyed property, the loss of capital, and the loss of life, eliminating wealth building opportunities for Black businessmen and businesswomen and damaging the potential to pass wealth to future generations; and

WHEREAS, Black communities have continually responded to these setbacks with renewed vigor to fight not only for civil rights and political freedom but also economic empowerment, equity, and economic justice; and

WHEREAS, The spirit of entrepreneurship displayed by the freedmen and freedwomen in the wake of abolition has continued through African American communities today, leading to the existence of over two million Black-owned businesses in the United States; and

WHEREAS, The spirit of enterprise is demonstrated by African American business owners who create businesses to pursue their passions and manage their future, manifested through the two-thirds of African American-owned businesses operated by members of Generation X and millennials and the over one-third of African American-owned businesses operated by Black women, who are the fastest-growing segment of entrepreneurs in the United States; and

WHEREAS, Immense challenges still exist for African American entrepreneurs as they face a general lack of access to capital sources available to other groups, steering by financial institutions into less desirable capital sources, a nearly total lockout from venture capital, and unequal access to amounts of capital provided to other people in similar circumstances, and the COVID-19 pandemic has exacerbated challenges for Black-owned businesses; and

WHEREAS, With the same spirit of enterprise and entrepreneurship demonstrated throughout African American history, Black businesses will recover and will thrive in a post-pandemic world; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare August 2020 as Black Business Month in the State of Illinois; and be it further

RESOLVED, That we are committed to providing equal opportunity for Black entrepreneurs and African American-owned businesses and to the elimination of business redlining targeting Black American entrepreneurs, and we will dedicate ourselves to developing and implementing laws and policies to achieve these goals.

#### HOUSE RESOLUTION 894

Offered by Representative West:

WHEREAS, The year 2020 marks the 100th anniversary of the ratification of the 19th Amendment to the United States Constitution, guaranteeing and protecting the right to vote for women in the United States; and

WHEREAS, This centennial provides an opportunity to celebrate a milestone in our democracy, that the right of citizens of the United States to vote shall not be denied or abridged by federal or state governments on account of gender; and

WHEREAS, Illinois has a history of being at the forefront of the women's suffrage movement, as Illinois women played a pivotal role in obtaining the right to vote for women; and

WHEREAS, In 1855, Susan Hoxie Richardson, cousin of Susan B. Anthony, organized the first suffrage association in Illinois in Earlville, a small town in LaSalle County west of Chicago; and

WHEREAS, In 1869, the first statewide suffrage organization in Illinois, the Illinois Woman's Suffrage Association (IWSA), was formed, and it held its first annual convention in the state capitol of Springfield in 1870; and

WHEREAS, In 1890, Catherine Waugh McCulloch was elected IWSA Superintendent of Legislative Work and drafted legislation that would give Illinois women the right to vote; and

WHEREAS, In 1891, Illinois women gained the right to vote in school board elections; and

WHEREAS, From 1911 to 1914, Jane Addams, who long fought for suffrage in Illinois, served as Vice-President of the National American Women Suffrage Association as the organization helped to push for a national amendment for the right to vote for women; and

WHEREAS, In 1913, Illinois became the first state east of the Mississippi River to grant women the right to vote with the passage of the Presidential Suffrage Bill; and

WHEREAS, On June 4, 1919, the U.S. Congress passed the 19th Amendment that guaranteed all American women the right to vote; and

WHEREAS, On June 10, 1919, Illinois became the first state to vote to ratify the 19th Amendment; and

WHEREAS, On August 18, 1920, the 19th Amendment was ratified, thanks to the efforts of women from Illinois, including Elizabeth Boynton Harbert, Frances E. Willard, Jane Addams, Ida B. Wells, Catharine McCulloch, and Grace Wilbur Trout; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize August 18, 2020 as a day to celebrate the right to vote for all women in America and acknowledge the contributions of the women from Illinois who worked so hard for so long to bring women across the United States the full benefit of citizenship.

#### HOUSE RESOLUTION 896

Offered by Representative Flowers:

WHEREAS, It is in the interest of the House of Representatives to make sure the dark chapters of the history of the United States are not forgotten, so we do not repeat them; one such chapter is the eugenics movement in the United States; and

WHEREAS, The term eugenics was first coined by Francis Galton in the late 1800s and comes from the Greek roots for "good" and "origin" or "good birth"; eugenics involves applying principles of genetics and heredity for the purpose of improving the human race; eugenics claimed the scientific ability to classify individuals and groups as "fit" or "unfit"; the "unfit" were defined by race, mental and physical disabilities, country of origin, and poverty; and

WHEREAS, The eugenics movement took root in the United States in the early 1900s and was led by Charles Davenport, a prominent biologist, and Harry Laughlin, a former teacher and principal interested in breeding; in 1910, Davenport founded the Eugenics Record Office (ERO) at Cold Spring Harbor Laboratory on Long Island "to improve the natural, physical, mental, and temperamental qualities of the human family"; eugenics was widely accepted by academics, politicians, intellectuals, government, the U.S. Supreme Court and progressives; and

WHEREAS, While the English eugenics movement focused on selective breeding for positive traits, the eugenics movement in the U.S. focused on eliminating negative traits; these "undesirable" traits, such as poverty, mental disability, dwarfism, promiscuity, criminality, and others, were most often concentrated in poor, uneducated, and minority populations; and

WHEREAS, Along with being a scientific movement, eugenics also became a popular social movement that peaked in the 1920s and 30s; during this period, the American Eugenics Society was founded, in addition to many local societies and groups around the country; many movies and books promoting eugenic principles became popular; and

WHEREAS, Supporters of eugenics helped drive legislation for the forced sterilization of people deemed to have undesirable traits; the first state to enact a sterilization law was Indiana in 1907, quickly followed by California and 28 other states by 1931; these laws resulted in the forced sterilization of over 64,000 people in the United States; the eugenics movement even received support from the Supreme Court in 1927 when the Court ruled that the State of Virginia had the legal right to forcibly sterilize Carrie Buck for promiscuity (Buck vs Bell); and

WHEREAS, California's eugenics program was so robust that the Nazis turned to the state for advice on perfecting their own efforts; Hitler proudly admitted to following the laws of several American states that allowed for the prevention of reproduction of the "unfit"; the Nazis defense at the Nuremberg trials even cited Buck vs Bell as justification for Germany's sterilization program; and

WHEREAS, While Illinois did not pass any eugenics-related sterilization laws, the General Assembly did pass a law in 1915 which allowed for the indefinite institutionalization of any person deemed "feeble-minded" by an expert; and

WHEREAS, The U.S. eugenics movement finally began to lose power in the 1940s and was completely discredited following the horrors of Nazi Germany; and

WHEREAS, While atrocities such as slavery and the treatment of Native Americans are well known, the U.S. eugenics movement is not as recognized and hardly appears in many high school U.S. history textbooks; this is despite the widespread impact of the eugenics movement, especially on national policy making and on our educational system, including the framework of school curriculum and standardized testing; and

WHEREAS, With the current political focus on discrimination and racism, the inclusion of information about the U.S. eugenics movement in the high school American history curriculum would help increase awareness about this horrific part of American history, would help prevent future generations from repeating the mistakes of the past, and would help in rectifying the impact of those mistakes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the history of the eugenics movement in the United States be included in U.S. history classes; and be it further

RESOLVED, That we encourage the people of Illinois to educate themselves on the history of eugenics in the United States; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the State Board of Education to be disseminated to all schools in Illinois, the Illinois Library Association to be disseminated to all libraries in the State, The Library of Congress, The National Archives and Records Administration, The National Museum of African American History and Culture, The DuSable Museum of African American History, Governor JB Pritzker, Mayor of Chicago Lori Lightfoot, and to all members of the General Assembly.

#### HOUSE RESOLUTION 903

Offered by Representative Madigan:

WHEREAS, Lou Henson had a distinguished coaching career, especially at the University of Illinois, one of the premier universities in the world; and

WHEREAS, Beloved couple Lou Henson and his wife Mary were deeply involved in the Champaign-Urbana community and throughout the State of Illinois; and

WHEREAS, Lou Henson contributed a large amount of his time and resources to charities and organizations in the State; and

WHEREAS, As a result of nearly 800 wins as a college coach, of achieving Big 10 and Big West Championships, and of playing in two NCAA Final Four Championships with Illinois and New Mexico State, Lou Henson has been inducted into the Illinois Basketball Coaches Hall of Fame and the National Collegiate Basketball Hall of Fame; and

WHEREAS, Lou Henson is one the top 20 winningest college basketball coaches of all time; and

WHEREAS, Lou Henson had basketball courts at both Illinois and New Mexico State named in his honor; he is one of two coaches ever to achieve that kind of recognition; and

WHEREAS, Lou Henson coached one of the most exciting teams in the history of college basketball, the 1989 Flying Illini, which was comprised entirely of Illinois-born players who had graduated from high schools in Illinois, which included Chicago, Jacksonville, Aurora, Alton, and Matteson, among others; and

WHEREAS, In 1962, Lou Henson refused to accept the head coaching position at Hardin-Simmons University until the trustees agreed to desegregate the school, the basketball team, and the coaching staff, demonstrating leadership when it was not fashionable; and

WHEREAS, Upon Lou Henson's death, tributes from around the country from players, coaches, fans, and neighbors described him as a man of great faith, a man defined by patience, a man always willing to talk to a stranger, a man never given to swearing or demeaning his players, and a man who showed respect to everyone; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we honor the life of Coach Lou Henson and

recognize the contributions he made to the State of Illinois, and we support his nomination for inclusion in the Naismith Memorial Basketball Hall of Fame; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Selection Committee of the Naismith Memorial Basketball Hall of Fame.

#### HOUSE RESOLUTION 905

Offered by Representative Flowers:

WHEREAS, The American field of medicine has long been predominantly white, and systemic racism and discrimination have driven health disparities along racial lines; implicit bias has had an impact on the quality of provider services, while living in poverty has limited access to healthy food and preventive care; and

WHEREAS, Currently, Black patients experience worse health outcomes and higher rates of conditions like hypertension and diabetes; Black babies in the U.S. are up to three times more likely to die in the days and weeks following their births compared to white babies; Blacks, Latinos, and Native Americans have suffered disproportionately during the COVID-19 pandemic; and

WHEREAS, The racist past of the medical profession has had a devastating effect on the lives and careers of Black Americans, both for those seeking care from the medical profession and for those serving in the medical profession; and

WHEREAS, In 1934, Dr. Roland B. Scott was the first African-American to pass the pediatric board exam; he was a faculty member at Howard University and established its center for the study of sickle cell disease; he gained national acclaim for his research on the blood disorder; and

WHEREAS, When Dr. Scott applied for membership with the American Academy of Pediatrics with its one criteria for admission being board certification, he was rejected multiple times beginning in 1939; and

WHEREAS, Dr. Scott was eventually accepted along with his Howard professor, Dr. Alonzo deGrate Smith, another Black pediatrician; they were only allowed to join for educational purposes and were not permitted to attend meetings in the South, ostensibly for their safety; and

WHEREAS, More than a half-century later, the American Academy of Pediatrics has formally apologized for its racist actions, including its initial rejections of Drs. Scott and Smith on the basis of their race; the group also changed its bylaws to prohibit discrimination on the basis of race, religion, sexual orientation or gender identity; they acknowledged that the apology was long overdue and was prompted by the example of another organization that confronted its racist past, the American Medical Association; and

WHEREAS, Few medical organizations have confronted the roles they played in blocking opportunities for Black advancement in the medical profession until the formal apologies by the American Medical Association and, more recently, the American Academy of Pediatrics; and

WHEREAS, The A.M.A. issued an apology in 2008 for its more than century-long history of discriminating against African-American physicians; for decades, the organization predicated its membership on joining a local or state medical society, many of which excluded Black physicians, especially in the South; the A.M.A.'s apology came in the wake of a paper published in the Journal of the American Medical Association that examined a number of discriminatory aspects of the group's history, including its efforts to close African-American medical schools; and

WHEREAS, For some Black physicians, exclusion from the A.M.A. meant the loss of career advancement opportunities; others struggled to gain access to the postgraduate training they needed for certification in certain medical specialties; as a result, many Black physicians were limited to becoming general practitioners, especially in the South; some facilities also required A.M.A. membership for admitting privileges to hospitals; and

WHEREAS, By 1964, the A.M.A. changed its position and refused to certify medical societies that discriminated on the basis of race, but persistent segregation in local groups still limited Black physicians' access to certain hospitals, as well as opportunities for specialty training and certification; and

WHEREAS, The A.M.A. also played a role in limiting medical educational opportunities available to Black physicians; in the early 20th century, before the medical field held the same prestige it does today, the A.M.A. commissioned a report assessing the country's medical schools for their rigor; the report deemed

much of the country's medical education system substandard; it also recommended closing all but two of the country's seven Black medical schools; as the field became more exclusive, it also became more white; and

WHEREAS, Between its restrictions on medical education and its exclusionary membership, the A.M.A. played a role in cultivating the profession's homogeneity, which it acknowledged in its 2008 statement; it has since appointed a chief health equity officer and established a center for health equity; and

WHEREAS, In an effort to address this history of racial discrimination and biases in the medical profession, Chicago's largest hospitals and clinics have officially named racism a public health crisis, a very real threat to the health of their patients, families and communities; in an open letter, 36 organizations committed to improving health equity across the city; and

WHEREAS, In addition to supporting programs that help people of color find healthcare jobs, each organization is pledging to provide anti-racism training for staff and create new policies that promote equity; and

WHEREAS, The group, which collectively treats more than 8 million patients, includes large Chicago-based hospital chains like Rush, safety nets like Loretto Hospital that treat large numbers of low-income patients, and a number of government-funded clinics like Esperanza Health Centers; and

WHEREAS, It is time for our State to collectively address this racial discrimination throughout the medical profession, past and present, to improve the quality of life for all; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all branches of the medical profession to commit to eliminating racism and recognizing biases; and be it further

RESOLVED, That we urge all colleges and medical institutions that prepare students for careers in the medical profession to focus on the recruitment of more minorities; and be it further

RESOLVED, That we urge the State Board of Higher Education to pursue and provide more scholarships opportunities for minority applicants seeking to enter all aspects of the medical profession; and be it further

RESOLVED, That suitable copies of this resolution be presented to all members of the Illinois General Assembly, the office of the Governor, the State Board of Higher Education, all medical schools in Illinois, all hospitals in Illinois, all clinics in Illinois, all public libraries in Illinois, and the Illinois Department of Professional Regulation, with the hope that they distribute a copy to all seeking licensure or re-licensure for any medical-related field.

#### HOUSE RESOLUTION 913

Offered by Representative Carroll:

WHEREAS, In 2016, Bahrain was the only Gulf Arab state to publicly mourn the passing of former Israeli President Shimon Peres; and

WHEREAS, In 2017, Bahrain's King Hamad bin Isa Al Khalifa called for an end to the Arab League boycott of Israel; and

WHEREAS, In 2018, Bahrain's then Foreign Minister Khaled bin Ahmed al Khalifa asserted Israel's right to defend itself and welcomed Israeli visitors to Bahrain in 2019; and

WHEREAS, In 2018, the Israeli national anthem was publicly played for the first time in the United Arab Emirates (UAE) during an international judo tournament in Abu Dhabi; and

WHEREAS, In 2019, Sheikh Khalifa bin Zayed Al Nahyan, President of the UAE, announced the appointment of the first chief rabbi in the UAE; and

WHEREAS, In 2019, Israel was invited to attend the 2021 World Expo in the UAE; and

WHEREAS, On August 13, 2020, Israeli Prime Minister Benjamin Netanyahu, Crown Prince of Abu Dhabi Sheikh Mohammad Bin Zayed, and Deputy Supreme Commander of the United Arab Emirates (UAE) Sheikh Mohammed bin Zayed bin Sultan Al Nahyan announced an agreement to fully normalize relations between their countries, and Israel agreed to suspend their proposed annexation of parts of the West Bank; and

WHEREAS, On August 13, 2020, United Nations Special Coordinator for the Middle East Peace Process Nickolay Mladenov declared his support for the agreement between the UAE and Israel, including the Israeli pledge to halt proposed annexations; Stephane Dujarric, spokesperson for the United Nations Secretary-General António Guterres, also welcomed the agreement; and

WHEREAS, On August 29, 2020, the UAE revoked their 1972 law which prohibited business relations between individuals in Israel and the UAE, including the exchange of goods; and

WHEREAS, On September 9, 2020, the Arab League declined to condemn the normalization of relations between Israel and the UAE by voting down a proposal to denounce the normalization deal; and

WHEREAS, On September 10, 2020, Senior Advisor to the President Jared Kushner announced the opening of airspace over Saudi Arabia to commercial flights between Israel and Bahrain after Saudi Arabia opened their airspace to flights between Israel and the UAE on September 2, 2020; and

WHEREAS, On September 11, 2020, Israeli Prime Minister Benjamin Netanyahu and Bahrain's King Hamad bin Isa Al Khalifa announced the establishment of full diplomatic relations between their countries; and

WHEREAS, Bahrain and the UAE are the first Gulf Arab states to announce formal relations with Israel; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois House of Representatives supports the establishment of full diplomatic relations between the State of Israel and both the United Arab Emirates and Bahrain; and be it further

RESOLVED, That the Illinois House of Representatives calls on other Arab and Muslim countries to establish full relations with Israel with the goal of realizing peace and stability throughout the Middle East; and be it further

RESOLVED, That the Illinois House of Representatives reaffirms its support for a negotiated solution to the Israeli-Palestinian conflict.

#### HOUSE RESOLUTION 917

Offered by Representative Pappas:

WHEREAS, Thaddeus Kosciuszko was a Polish-Lithuanian military engineer, statesman, and military leader who became a national hero in Poland, Lithuania, Belarus, and the United States; he built Fortress West Point, which he suggested be used as the United States Military Academy, and devised the winning strategy for the Battle of Saratoga, which was the turning point of the American Revolution; and

WHEREAS, Thaddeus Kosciuszko fought to free the white indentured peasants of Europe; he stood up for the rights of enslaved Africans, Native Americans, Jews, women, and many others; and

WHEREAS, Thaddeus Kosciuszko set aside his salary from the American Revolution with instructions that it be used to purchase and free slaves and that money be left to provide for their education and for the purchase of land, cattle, and farming tools for them so they could support themselves in our free country; and

WHEREAS, The U.S. Army has 10 bases named after confederate officers, such as Braxton Bragg, who were traitors and declared war on the United States; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Government to rename Fort Bragg as Fort Kosciuszko in honor of Thaddeus Kosciuszko; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, all members of the Illinois Congressional Delegation, and the Kosciuszko Foundation.

#### HOUSE RESOLUTION 923

Offered by Representative Hernandez, Barbara:

WHEREAS, Illinois is coping with a global outbreak of the coronavirus, the COVID-19 pandemic, which has led to widespread illness and death and has disrupted the lives of all Illinoisans; and

WHEREAS, The Governor of Illinois has issued a series of emergency executive orders in response to the COVID-19 pandemic; and

WHEREAS, Illinois public and private colleges have faced unprecedented financial challenges, spending hundreds of millions of dollars in unbudgeted funds supporting their students, faculty, and staff; these colleges have also had to reduce programs in addition to laying off and furloughing workers; and

WHEREAS, Many Illinois public and private college students are African American or Latinx and first-generation college students, meaning they are the first in their family to go to college, and they are facing an urgent situation because of family financial pressures; and

WHEREAS, The Coronavirus Aid, Relief, and Economic Security (CARES) Act passed by Congress brought only minimal relief to Illinois public and private colleges and universities for investments in campus safety, including social distancing, sanitation, and diagnostic testing measures; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Congress to approve a COVID-19 relief package of at least \$120 billion that includes funding for public and private colleges and universities for student and institutional needs, reopening costs, technology costs, and lost revenue due to the pandemic and also includes limited liability protection for these institutions; and be it further

RESOLVED, That a suitable copy of this resolution be presented to each member of the Illinois Congressional Delegation and the President of the United States.

#### HOUSE RESOLUTION 925

WHEREAS, National Apprenticeship Week celebrates the awareness of the vital role apprenticeships provide in creating a qualified and highly-skilled workforce in diverse industries in Illinois and across the nation; and

#### HOUSE RESOLUTION 931

Offered by Representative West:

WHEREAS, African Americans have had a rich history in Rockford and in Illinois and have made significant contributions to our communities; and

WHEREAS, The Colored Soldiers Club under War Camp Community Services was founded and led by Dr. Richard S. Grant and his wife, Lelia, during World War I; and

WHEREAS, The club was chartered and converted into a community center named the Booker Washington Association in 1919; and

WHEREAS, Throughout its history, the African-American Resource Center at Booker has provided consistent access to resources, programing, and services to uplift the community; and

WHEREAS, The African-American Resource Center at Booker is the oldest African-American community center in Illinois and gained historical landmark status in 2015; and

WHEREAS, The African-American Resource Center at Booker remains committed to its mission to provide an environment that promotes the quality of life, values, and the welfare of the people of its community through education, art, and recreational and cultural programs, and to promote learning and sharing within the greater multicultural community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that that we declare November 14, 2020 as Booker Washington Center Day to commemorate the history of the African-American Resource Center at Booker and celebrate the Center's existence as it serves as a testament to the willingness of the entire community to help one another.

HOUSE RESOLUTION 936

Offered by Representative Evans:

WHEREAS, The COVID-19 pandemic is a public health emergency that has resulted in 300,000 cases and nearly 10,000 deaths in Illinois; and

WHEREAS, In the early stages of the pandemic, the Cook County Department of Corrections (CCDOC) was considered the largest cluster of COVID-19 infections in the country; and

WHEREAS, At one point, 1 in 6 COVID-19 cases in Illinois could be traced back to the Cook County Jail; and

WHEREAS, While some Cook County workers have jobs that can be worked from home, CCDOC workers represented by Teamsters Local 700 have responsibilities that require them to work as frontline employees outside their homes and have jobs that require them to be in public and to interact with COVID-19 positive individuals; and

WHEREAS, The members of Teamsters Local 700 at CCDOC risk their lives and the health and safety of their families to provide Cook County residents with safe, clean, efficient, and effective services; and

WHEREAS, CCDOC officers on the front line of the pandemic are unable to practice social distancing because of the confined conditions at the jail; and

WHEREAS, Corrections officers' positions were identified months ago by their essential nature, and CCDOC officers have continued to provide critical services during the COVID-19 pandemic; and

WHEREAS, CCDOC officers represented by Teamsters Local 700 put themselves in harm's way on a daily basis, many working 16-hour days without hazard pay; and

WHEREAS, CCDOC officers are 10 times more likely to contract COVID-19 than the average American; and

WHEREAS, More than 500 CCDOC officers have contracted COVID-19; and

WHEREAS, Six CCDOC officers represented by Teamsters Local 700 and one Court Services Deputy lost their lives due to COVID-19; and

WHEREAS, Sheila Rivera, a corrections officer since 2012, lost her life to COVID-19; she leaves behind a husband and a 16-year-old son; and

WHEREAS, Antoine Stewart, a corrections officer since 2010 and a resident of Crestwood, lost his life to COVID-19; and

WHEREAS, Antoine Jones, a corrections officer since 2002 and a South Side resident and grandfather of seven, lost his life to COVID-19; and

WHEREAS, Jose Pedro Marquez, a corrections officer since 2004 and a resident of Berwyn, lost his life to COVID-19; he leaves behind five children and three grandchildren; and

WHEREAS, Richard O'Brien, a Cook County Sheriff's Deputy for 25 years, lost his life to COVID-19; he leaves behind a wife and three children; and

WHEREAS, Jason Bobzin, a corrections officer since 2005 and a resident of Countryside, passed away after completing his shift at the jail; he leaves behind three children and six grandchildren; and

WHEREAS, Richard Santiago, a 31-year-old corrections officer and a resident of Elmwood Park, passed away due to COVID-19; he leaves behind his fiancé, Priscilla, and his son, Janius; and

WHEREAS, These members lost their lives while providing essential public safety services; and

WHEREAS, The 3,000 CCDOC officers represented by Teamsters Local 700 continue to risk their lives in service to the public; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the sacrifices made by Sheila Rivera, Antoine Stewart, Antoine Jones, Jose Pedro Marquez, Richard O'Brien, Jason Bobzin, and Richard Santiago, and all of the men and women of the Cook County Department of Corrections represented by Teamsters Local 700; and be it further



RESOLVED, That we urge Cook County to provide hazard pay to all corrections officers, in recognition of their continued public service under dangerous circumstances; and be it further

RESOLVED, That suitable copies of this resolution be presented to the families of Sheila Rivera, Antoine Stewart, Antoine Jones, Jose Pedro Marquez, Richard O'Brien, Jason Bobzin, and Richard Santiago and to Teamsters Local 700.

#### HOUSE RESOLUTION 941

Offered by Representative Greenwood:

WHEREAS, The Honorable Wyvetter H. Younge was one of the longest serving representatives in the Illinois House of Representatives; she was first elected to the House in 1975 and made urban renewal one of her top priorities; and

WHEREAS, Rep. Younge was born on August 23, 1930 in St. Louis, Missouri, the youngest of five children; her mother, Annie Hoover, managed a restaurant in East St. Louis, and her father sold insurance and owned various properties; and

WHEREAS, Rep. Younge graduated from Lincoln Senior High School in East St. Louis; after graduating, she attended the Hampton Institute for her undergraduate degree; in 1953, she earned a law degree from the St. Louis University School of Law, and in 1972, she earned a second law degree from the Washington University School of Law; and

WHEREAS, While in Springfield, Rep. Younge was a true champion for the people of her district; many of the bills she sponsored focused on issues such as substance abuse treatment, services for the homeless, and economic development in St. Clair County; after her passing, Illinois House Speaker Michael Madigan told reporters, "Wyvetter was a tireless advocate for East St. Louis who never stopped trying to improve the lives of her constituents"; and

WHEREAS, The East St Louis Higher Education Center offers educational courses and programs with collaborative partners, including community colleges and Southern Illinois University Edwardsville; higher education and training have been offered at the center since 1999 after the closing of the Metropolitan Community College; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that as a means to remember the great work of Rep. Wyvetter H. Younge, the General Assembly is urged to change the name of the East St. Louis Higher Education Center to the Wyvetter H. Younge Higher Education Center; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Speaker of the House, the Senate President, the House Minority Leader, the Senate Minority Leader, and the East St. Louis Higher Education Center.

#### HOUSE RESOLUTION 950

Offered by Representative Villa:

WHEREAS, In response to the COVID-19 pandemic, we have, as a nation, been advised to adhere to all public health and CDC guidelines in order to prevent further spread; and

WHEREAS, While most have yielded and exercised responsibility, there are marginalized groups of workers in essential sectors all across the State who are inadvertently exempt and unable to adhere to the advisory; and

WHEREAS, Farm, agricultural, and manufacturing workers, all of whom must leave their homes day in and day out to assist in the cultivation, harvest, and preparation of the food and produce we put on our tables, find themselves within this unprotected marginalized group; and

WHEREAS, The nature of this painstaking and backbreaking work, in addition to the equipment necessary to perform it, makes social distancing impractical and impossible for workers, which puts them at a heightened risk of contracting the COVID-19 virus; and

WHEREAS, Since mid-March, President Donald J. Trump has correctly analogized the fight against the COVID-19 virus as a war and has since used presidential wartime powers to combat the virus; and

WHEREAS, Farm, agricultural, and manufacturing workers, especially those who cannot practice social distancing at work, as well as their immediate families, are arguably mirroring the risks taken by our military personnel during the COVID-19 crisis; and

WHEREAS, Federal law currently grants the right to naturalization and citizenship to all English-speaking persons of good moral character who serve in our armed forces during wartime or hostilities, even when undocumented; and

WHEREAS, Nearly fifty percent of farm, agricultural, and manufacturing workers currently laboring during this pandemic crisis have been labeled essential workers by state and federal governments alike; it is our duty to reciprocate their sacrifice by assisting and providing them with a path to residency followed by a path to naturalization; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress and the President of the United States to grant the right and privilege of United States residency to all farm, agricultural, and manufacturing workers who have served and labored during the COVID-19 crisis; and be it further

RESOLVED, That this right and privilege of residency should be granted without regard to previous immigration status; and be it further

RESOLVED, That, in order to facilitate the identification of these essential workers, employers and their agents should be granted immunity from any adverse action for having employed, or otherwise acquired the services of, persons who were identified as being essential workers during the COVID-19 crisis; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States and the leaders of the U.S. House and Senate.

#### HOUSE JOINT RESOLUTION 126

Offered by Representative McSweeney:

WHEREAS, Senate Joint Resolution Constitutional Amendment No. 1 proposes to amend the Revenue Article of the Illinois Constitution by removing language that requires a uniform rate for personal income tax imposed by the State, and by authorizing the General Assembly to set by law the rate or rates for personal income tax imposed by the State; and

WHEREAS, Senate Joint Resolution Constitutional Amendment No. 1 was adopted by a three-fifths majority of the Senate on May 1, 2019, and by a three-fifths majority of the House of Representatives on May 27, 2019, meeting the requirements of subsection (a) of Section 2 of Article XIV of the Illinois Constitution to be placed on the ballot at the next general election; and

WHEREAS, The proposal to amend the Illinois Constitution authorized by Senate Joint Resolution Constitutional Amendment No. 1 is scheduled to appear on the general election ballot for November 3, 2020; and

WHEREAS, Subsection (a) of Section 2 of Article XIV of the Illinois Constitution specifically authorizes proposed constitutional amendments adopted by the General Assembly under Section 2 of Article XIV of the Illinois Constitution to be removed from the ballot when "withdrawn by a majority of the members elected to each house"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the proposal to amend the Illinois Constitution authorized by Senate Joint Resolution Constitutional Amendment No. 1 is hereby withdrawn from the general election ballot for November 3, 2020; and be it further

RESOLVED, That the Governor, the Secretary of State, the Illinois State Board of Elections, and all Illinois election authorities shall be provided with copies of this resolution.

#### HOUSE JOINT RESOLUTION 128

Offered by Representative Ammons:

WHEREAS, The American Medical Association states that racism contributes to health inequities in the United States; and

WHEREAS, Social determinants of health, meaning the social and material factors that influence health outcomes, have a lifelong impact beginning even before birth; and

WHEREAS, The American Public Health Association (APHA) has expressed that racism is a driving force of the social determinants of health due to the resulting inequalities in a number of matters, including housing, education, and employment; and

WHEREAS, The APHA clarifies that racism is a social system with multiple dimensions; individual racism is internalized or interpersonal, while systemic racism is institutional or structural and is a system of structuring opportunity and assigning value based on the social interpretation of how one looks; this system unfairly disadvantages specific individuals and communities while unfairly giving advantages to other individuals and communities and saps the strength of the whole society through the waste of human resources; and

WHEREAS, Almost all of the four hundred years of Black Americans' experience was under slavery and Jim Crow laws that subjected Black people to hardship and disadvantage in all areas of life; and

WHEREAS, The Heartland Alliance Social IMPACT Research Center's 2018 Poverty Report explains that poverty and violence disproportionately impact minority communities, which are characterized by lack of adequate public services, lack of educational opportunities, poorer health outcomes, asset and income inequality, and more; the underlying cause of all mentioned above is rooted in historic and current systemic racism, such as redlining, discrimination in schools, and other practices; and

WHEREAS, The American Anthropological Association asserts that genetic analyses show race to be a social construct not rooted in meaningful biological difference; and

WHEREAS, There is clear data that racism negatively impacts the lives of people of color in Illinois; and

WHEREAS, The American Psychological Association says that, because of poverty and discrimination, racial minority children are more likely to experience traumatic events than White children; childhood trauma has negative impacts on academic, behavioral, and physical health outcomes; and

WHEREAS, Statistics compiled by the Centers for Disease Control show a national disparity between Black and White infant mortality rates with the State of Illinois having one of the highest disparities between Black and White infant mortality rates; and

WHEREAS, 2018 data collected by the Illinois Department of Public Health reveals that non-Hispanic Black women are six times as likely to die of a pregnancy-related condition when compared to a non-Hispanic White woman; Black women had the highest rate of severe maternal morbidity in Illinois from 2016 to 2017 with a rate of 101.5 per 10,000 deliveries; and

WHEREAS, The Illinois Department of Juvenile Justice reported that seventy-one percent of youth in youth correctional facilities were Black despite Black youth representing only three percent of the people in Illinois; and

WHEREAS, The September 2020 Poverty, Income & Health Insurance Update by the Heartland Alliance shows that the poverty rate for Black Illinoisans is three times the poverty rate of White Illinoisans, and the median income for Black households is only fifty-eight per cent of the statewide median; and

WHEREAS, Illinois Department of Public Health data indicates that Black Illinoisans have higher mortality rates in heart disease, cancer, and opioid overdose and higher incidence of diabetes compared to White Illinoisans; and

WHEREAS, The Illinois Department of Public Health stated that although health indicators such as life expectancy and infant mortality have improved for most Americans, minorities still experience shorter life expectancy and higher rates of disability compared with non-minorities; and

WHEREAS, The APHA has identified law enforcement violence as a public health issue that disproportionately affects marginalized groups, including people of color, impacting both physical and mental health outcomes; and

WHEREAS, The impact of racism on public health deserves action from all levels of government; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we declare racism to be a public health crisis affecting our entire State; and be it further

RESOLVED, That we ask the Governor to establish a working group to promote racial equity throughout this State; and be it further

RESOLVED, That we support the establishment of a working group to address these issues and to:

(1) Create a publicly accessible glossary of terms and definitions concerning racism and health equity;

(2) Promote community engagement and provide tools for government agencies to engage actively and authentically with communities of color;

(3) Continue to work to build alliances with organizations that have a legacy and track record of confronting racism;

(4) Encourage community partners and stakeholders in the education, employment, housing, and criminal justice and safety arenas to recognize racism as a public health crisis and take appropriate action;

(5) Continue to promote racially equitable economic and workforce development in Illinois;

(6) Continue to promote racially equitable hiring and promotion of all employees, including State employees;

(7) Provide training to all elected officials, staff, funders, and grantees on workplace biases and how to mitigate them;

(8) Promote and encourage all policies that prioritize the health of people of color;

(9) Support local, state, regional, and federal initiatives that advance efforts to dismantle systematic racism and mitigate exposure to adverse childhood experiences and trauma;

(10) Incorporate educational efforts to address and dismantle racism and to expand understanding of racism and how racism affects individual and population health; and

(11) Secure adequate resources to successfully accomplish the aforementioned activities; and be it further

RESOLVED, That we are committed to reviewing all portions of Illinois state law with a racial equity lens; and be it further

RESOLVED, That we are committed to conducting all human resource, vendor selection, and grant management activities with a racial equity lens, including reviewing all internal policies and practices such as hiring, promotion, leadership appointments, and funding; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor's Office and to all members of the General Assembly.
