HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 32

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article XIII of the Illinois Constitution as follows:

ARTICLE XIII GENERAL PROVISIONS

(ILCON Art. XIII, Sec. 3)
SECTION 3. OATH OR AFFIRMATION OF OFFICE

Each prospective holder of a State office or other State position created by this Constitution, before taking office, shall take and subscribe to the following oath or affirmation:

"I do solemnly swear (affirm) that I will support the Constitution of the United States, and the Constitution of the State of Illinois, and protect and honor the diversity of the people of this great State as provided in the Illinois Human Rights Act, and that I will faithfully discharge the duties of the office of to the best of my ability."
