WHEREAS, Sheriff Scott created and developed dozens of Sheriffs' Citizens Police Academies from 1996 to 2020, established a Domestic Violence Unit in 2005, was a founding member of the DeKalb County Major Crime Unit, and was a member of the 911 Steering Committee in 1988; and

WHEREAS, Sheriff Scott's accomplishments as sheriff include the Governor's Award for Excellence in Training in 1999, the National Sheriffs' Association Presidential Award for distinguished service in 2010, and serving as president of the Illinois Sheriffs' Association from 2005 to 2006; and

WHEREAS, Sheriff Scott was born and raised in DeKalb County and lives in DeKalb with his wife, Marcia, and his children; they are members of the Waterman Bible Church; and

WHEREAS, Sheriff Scott and Marcia have raised three biological children and seven adopted children and have fostered almost 40 children since 1989; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we congratulate Sheriff Roger Scott on his retirement on June 23, 2021 after over 50 years of faithful service with the DeKalb County Sheriff's Office; and be it further

RESOLVED, That we declare June 23, 2021 as Sheriff Roger Scott Day in the State of Illinois to honor his dedication to DeKalb County and the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to Sheriff Scott and the DeKalb County Sheriff's Office as an expression of our esteem and respect.

#### HOUSE RESOLUTION 387

Offered by Representative Halbrook:

WHEREAS, The COVID-19 pandemic has shaken the State of Illinois and the world; and

WHEREAS, The COVID-19 pandemic, as dangerous as it has been, has also been overblown by the Director of the National Institute of Allergy and Infectious Diseases Dr. Anthony Fauci; and

WHEREAS, In his position since 1984, Dr. Fauci has been a leader of every policy decision regarding infectious diseases for the past three decades; and

WHEREAS, During the COVID-19 pandemic, Dr. Fauci repeatedly urged Americans to wear masks, at multiple points even suggesting individuals should wear more than one mask at a time, while sending internal emails suggesting that typical store-bought masks are not effective in keeping out the virus; and

WHEREAS, Dr. Fauci changed his recommendation on when and where to wear masks multiple times since the onset of the COVID-19 pandemic, often times leaving Americans more confused than informed, which encouraged a more judgmental society of those who did not choose to wear masks or those who did; and

WHEREAS, A growing number of individuals nationwide have become critical of Dr. Fauci's constant fluctuation of guidelines; and

WHEREAS, Congressman Warren Davidson (R-OH) has introduced HR 2316, known as the "Fauci's Incompetence Requires Early Dismissal" or "FIRED" Act; this Act provides that an individual may not hold the position of Director of the National Institute of Allergy and Infectious Diseases for more than twelve years, effective retroactively; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that due to the constant changing of guidance pertaining to the COVID-19 pandemic and the continuation of Dr. Fauci's more than three-decade "reign" over the United States' policies pertaining to any infectious disease outbreak, we believe Dr. Anthony Fauci must be relieved of his role; and be it further

RESOLVED, That we urge the United States Congress and President Joe Biden to pass the "Fauci's Incompetence Requires Early Dismissal" or "FIRED" Act; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Joe Biden, U.S. Senate Majority Leader Chuck Schumer, U.S. Senate Minority Leader Mitch McConnell, U.S. Speaker of the House of Representatives Nancy Pelosi, U.S. House of Representatives Minority Leader Kevin McCarthy, and all members of the Illinois Congressional Delegation.

#### HOUSE RESOLUTION 391

Offered by Representative Harris:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 102nd General Assembly are amended by changing Rule 56 and by adding Rule 49.5.

(House Rule 49.5)

##### 49.5. Remote Participation and Voting in Session.

(a) On any session day after May 31, 2021 and before the first day of fall veto session in 2021, the House may adopt a motion to allow members to remotely participate and vote in session on any matter before the House that day, provided that at all times a quorum of members is physically present at the location of session. Members participating remotely shall be added to quorum roll call of the House by the Clerk and considered present and in attendance at the session for all purposes under these Rules; provided that the members shall not be entitled to per diem expense reimbursements unless they appear in person before the Clerk or the Clerk's designee after the quorum roll call but prior to the close of the Clerk's Office for the day. Action taken by a member who is participating remotely shall have the same legal effect as if the member were physically present when the action is taken.

(b) While a record vote is being taken, the Presiding Officer shall direct the Clerk to call the names of those members participating remotely and each such member shall announce his or her vote to be recorded.

(c) The Speaker may establish additional procedures for remote participation or voting under this Section.

(House Rule 56)

##### 56. Verification.

(a) After any record vote, except for a vote that requires a specific number of affirmative votes and that has not received the required votes, and before intervening business, it is in order for any member that voted on the question to request verification of the results of the record vote, except that (i) a member voting in the affirmative may not request verification of the affirmative votes and (ii) a member voting in the negative may not request a verification of the negative votes. A Representative who voted "present" or failed to vote on the question does not have the right to move for a verification. If a member is disqualified from requesting a verification, a qualifying member who makes a subsequent request for a verification shall be allowed to proceed with the verification.

(b) In verifying a record vote, the Presiding Officer shall instruct the Clerk to call the names of those members whose votes are to be verified. The member requesting the verification may thereafter identify those members he or she wishes to verify. If a member does not answer, his or her vote shall be stricken; the

member's vote shall be restored to the roll, however, if his or her presence is recognized before the Presiding Officer announces the final result of the verification. The Presiding Officer shall determine the presence or absence of each member whose name is called, and shall then announce the results of the verification.

(c) While the results of any record vote are being verified, it is in order for any member to announce his or her presence ~~on the floor~~ and thereby have his or her vote verified. The Presiding Officer may announce the presence of any member and thereby have his or her vote verified prior to ordering the Clerk to call the names of the members whose votes are to be verified.

(d) A request for a verification of the affirmative and negative results of a record vote may be made only once on each record vote.
