WHEREAS, Endodontists limit their practice solely to endodontic treatments and perform an average of 25 root canal treatments a week; specialized treatment gives patients the best outcome and allows them to heal faster; for this reason, dentists and endodontists often work as partners in care so that the best member of the dental team is handling each appropriate issue with a patient's teeth; and
