SENATE BILLS ON FIRST READING

Having been reproduced, the following bill was taken up, read by title a first time and placed in the Committee on Rules: SENATE BILL 2320(Ugaste).

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 175

Offered by Representative Blair-Sherlock:

WHEREAS, There are thousands of therapy animal teams serving in communities across the United States; and

WHEREAS, Therapy animal teams play an essential role in improving human health and well-being through the human-animal bond; and

WHEREAS, Therapy animal teams make millions of visits per year in such settings as hospitals, nursing homes, schools, and hospice; and

WHEREAS, Therapy animal teams interact with a variety of people in our communities, including veterans, seniors, patients, students facing literacy challenges, and those approaching end of life; and

WHEREAS, These exceptional therapy animals who partner with their human companions bring comfort and healing to those in need; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 30, 2023 as Therapy Animal Day in the State of Illinois; and be it further

RESOLVED, That we encourage Illinoisans to celebrate therapy animals and their human handlers, and we salute the service of therapy animal teams in our communities across Illinois and the nation.

HOUSE RESOLUTION 176

Offered by Representative Sosnowski:

WHEREAS, The Free Republic of Liberland was proclaimed on April 13, 2015 upon Terra Nullius, a parcel of land unclaimed by any other nation or private entity since the dissolution of the Socialist Federal Republic of Yugoslavia in 1991; and

WHEREAS, Liberland meets the criteria for statehood as codified in the Montevideo Convention on the Rights and Duties of States, a treatise that has been ratified by the United States of America; and

WHEREAS, Liberland's constitution and systems of governance have been established with significant guidance from the writings of Thomas Jefferson, James Madison, and other founders of the United States of America; and

WHEREAS, The foreign ministry of Liberland has continuously and publicly expressed its aspirations for strong, peaceful, and mutually-beneficial relations with the United States; and

WHEREAS, All cabinet members of Liberland have proclaimed the continued maintenance of peace in the Balkan Peninsula as a vital national interest; and

WHEREAS, Liberland is committed to be a catalyst for economic development, free trade, and investment, both within its borders and throughout the Balkan region; and

WHEREAS, The primary domestic foundation of Liberland's government is the preservation of the inherent natural rights and individual liberties of its citizens, residents, visitors, and guests; and

WHEREAS, Welcoming Liberland into the community of nations will further the vision of the State of Illinois to secure the freedoms of self-determination for all peoples; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the further development of Liberia and the efforts of its government and citizens to establish a new partner in guaranteeing the rights of life, liberty, and the pursuit of happiness; and be it further

RESOLVED, That we request the President of the United States, the Secretary of the State, the Senate Foreign Relations Committee, and the House Committee on Foreign Affairs to consider recognizing the Free Republic of Liberia; and be it further

RESOLVED, That a suitable copy of this resolution be presented to President Vit Jedlicka, President of the Free Republic of Liberia, as a symbol of our esteem and respect.

HOUSE RESOLUTION 180

Offered by Representative Davis, Will:

WHEREAS, Alpha Kappa Alpha Sorority, Incorporated® was founded on January 15, 1908, with the mission to promote unity and friendship among college women, to study and help alleviate problems concerning girls and women in order to improve their social stature, to maintain a progressive interest in college life, and to be of "Service to All Mankind"; and

WHEREAS, In 1915, Alpha Kappa Alpha Sorority, Inc. hosted its first political action conference with Illinois Congressman and human rights activist Martin B. Madden as the speaker; and

WHEREAS, Through the years, establishing headquarters in Chicago since 1949, Alpha Kappa Alpha Sorority, Inc.'s function has become more complex, expanding to mobilize members worldwide for advocacy and service projects to improve socioeconomic, racial, political, and environmental conditions; and

WHEREAS, Alpha Kappa Alpha Sorority, Inc.'s diverse collaborative work throughout the United States, the Caribbean, Europe, Africa, and the United Arab Emirates integrates an elevated level of personal engagement with the strong bonds of sisterhood and a productive network of community partners; and

WHEREAS, Alpha Kappa Alpha Sorority, Inc.'s annual event is an opportunity for members to speak with local lawmakers, engage in workshops, and advocate for critical issues such as Black maternal health, education, and suicide prevention; and

WHEREAS, Illinois is home to 43 Alpha Kappa Alpha Sorority, Inc. chapters, 15 of which are located on college and university campuses and 28 active alumnae chapters are located in communities throughout the State; and

WHEREAS, The Central Region is home to 95 empowered and engaged chapters, serving Illinois, Indiana, Kentucky, Minnesota, Southeastern Missouri, North Dakota, South Dakota, and Wisconsin; and

WHEREAS, Currently, one member of Alpha Kappa Alpha Sorority, Inc. is serving in the Illinois State Legislature, Senator Mattie Hunter; and

WHEREAS, Currently, one member of Alpha Kappa Alpha Sorority, Inc. is serving in the Illinois Executive Branch, 48th Lieutenant Governor Julianna Stratton; and

WHEREAS, On May 10, 2023, Illinois members of Alpha Kappa Alpha Sorority, Inc. will participate in "AKA Day at the Illinois State Capital"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 10, 2023 as Alpha Kappa Alpha Sorority, Incorporated® Day in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Alpha Kappa Alpha Sorority, Inc. Nu Omicron Omega Chapter and Tau Chi Chapters in recognition of all Illinois chapters.

HOUSE RESOLUTION 189

Offered by Representative Nichols:

WHEREAS, On March 27, 2023, three children and three adults were killed in a mass shooting at The Covenant School in Nashville, Tennessee; and

WHEREAS, The loss of lives spurred thousands of Tennesseans to make their voices heard through protests at the Tennessee State Capitol, advocating for reform of laws governing firearm access and availability; and

WHEREAS, Channeling the voices of their constituents who were among those demonstrating, Reps. Justin Jones, Justin Pearson, and Gloria Johnson attempted to speak in support of reforming gun laws but were denied, and their microphones were cut off, preventing them from speaking on that topic and on any measure or order of business; denied the ability to speak using their desks and microphones, they instead echoed the chants for reform from Tennesseans present at their capitol; and

WHEREAS, Immediately, the Tennessee House of Representatives majority began an extraordinary campaign of retaliation against Reps. Jones, Pearson, and Johnson, including stripping them of committee assignments, removing their access to their office space and parking, and threatening expulsion, the most extreme action a legislative body can take against one of its members; and

WHEREAS, Expelling a member from the legislative body is an act so extraordinary that, since the Civil War, the Tennessee House had only previously used it to remove members attempting to block ratification of the 14th Amendment to the United States Constitution, which granted citizenship to formerly enslaved people and equal protection of the law to all Americans, and to remove members for bribery and sexual misconduct; and

WHEREAS, Even pursuing the extraordinary step of expulsion, the Tennessee House majority never intended to have a fair proceeding for Reps. Jones, Pearson, and Johnson, with one member of Tennessee's House leadership referring to Rep. Jones as a "former representative" prior to the filing of any expulsion resolution, any hearings, or proceedings on expulsion and without pursuing any other form of conflict resolution for alleged violations of decorum; and

WHEREAS, On April 6, 2023, after less than a day of proceedings, Reps. Jones and Pearson were expelled from the Tennessee House for these alleged violations of decorum, but Rep. Johnson was not; this, despite lawmakers from the majority party admitting that the expulsion resolutions contained "deficiencies", dishonored the legislative process and occurred without the Tennessee House's normal step of empaneling an ethics committee to review alleged violations of their rules; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the expulsion of Tennessee State Representatives Justin Jones and Justin Pearson and condemn the attempted expulsion of Tennessee State Rep. Gloria Johnson from the Tennessee House of Representatives; and be it further

RESOLVED, That suitable copies of this resolution be presented to Reps. Jones, Pearson, and Johnson as a symbol of our respect and esteem.

HOUSE RESOLUTION 190

Offered by Representative Nichols:

WHEREAS, Phi Beta Sigma Fraternity, Inc. was founded at Howard University in Washington, D.C. on January 9, 1914 by three African-American students, A. Langston Taylor, Leonard F. Morse, and Charles I. Brown, who united to form a fraternity that would exemplify the ideals of brotherhood, scholarship, and service; and

WHEREAS, The founders of Phi Beta Sigma offered support and encouragement to Arizona Cleaver Stemons, Pearl Anna Neal, Myrtle Tyler Faithful, Viola Tyler Goings, and Fannie Pettie Watts as they founded Zeta Phi Beta Sorority, Inc. at Howard University on January 16, 1920 to raise people's consciousness, encourage scholastic achievement, and foster unity among members, making Phi Beta Sigma and Zeta Phi Beta the first fraternity and sorority to be constitutionally bound to each other; and

WHEREAS, Phi Beta Sigma brothers believe that each member and potential member should be judged by their own merits, rather than family background, affluence, race, nationality, skin tone, or hair texture and should work to return newly acquired skills to the communities from which they come, with this conviction mirrored in the fraternity's motto, "Culture For Service and Service For Humanity"; and

WHEREAS, Phi Beta Sigma brothers contributed greatly to the literary and artistic movement known as the Harlem Renaissance, to the cause of civil rights, civic engagement, and freedom, and to the sciences, and membership has included writer Alain LeRoy Locke, poet and diplomat James Weldon Johnson, workers rights activist A. Philip Randolph, scientist George Washington Carver, astronaut Victor Glover,

Congressman Elijah Cummings, Congressman John Lewis, and Nnamdi Azikiwe, the first president of independent Nigeria; and

WHEREAS, Zeta Phi Beta was the first Black greek-lettered organization to centralize its operations in a national headquarters, first to charter a chapter in Africa, and the first to form auxiliary groups and currently boasts hundreds of chapters worldwide and over 100,000 members who seek to uphold its ideals of "Scholarship, Service, Sisterhood, and Finer Womanhood"; and

WHEREAS, Zeta Phi Beta sisters contributed greatly to the literary and artistic movement known as the Harlem Renaissance, to the cause of civil rights, civic engagement, and freedom, and to the sciences, and membership has included writer and anthropologist Zora Neale Hurston, attorney Violette Anderson, educator Dr. Elizabeth Koontz, journalist and media entrepreneur Clara McLaughlin, and psychiatrist and substance abuse treatment expert Dr. Alyce Gullattee; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 26, 2023 as Phi Beta Sigma and Zeta Phi Beta Day at the Illinois State Capitol; and be it further

RESOLVED, That we commend the efforts of the members of Zeta Phi Beta and Phi Beta Sigma for their commitment to community service and recognize their collective contributions to making their communities a better place to live, play, and work; and be it further

RESOLVED, That a suitable copy of this resolution be presented Zeta Phi Beta Sorority, Inc. and Phi Beta Sigma Fraternity, Inc. as a symbol our respect and esteem.

HOUSE RESOLUTION 194

Offered by Representative Weaver:

WHEREAS, On May 21, 1881, the United States Tennis Association (USTA), originally known as the United States National Lawn Tennis Association, was founded in New York City, New York to create rules and standards for the emerging game of lawn tennis; and

WHEREAS, The USTA is the nonprofit, national governing body for tennis in the United States and leads the promotion and growth of the sport at every level of play, from beginners to professionals at the US Open; and

WHEREAS, The USTA is the largest tennis organization in the world, with over 550,000 members from every corner of the country; and

WHEREAS, The USTA proudly partners with local tennis programs to showcase the important health, social, and educational benefits of tennis and to make the sport available to everyone, regardless of age, environment, condition, or ability, through its USTA Adaptive grants; and

WHEREAS, The latest research by the Physical Activity Council shows that more than 23.6 million Americans played tennis in 2022, an unprecedented 33% increase in participation over 2019 and the highest number of players since the PAC study began in 2007; and

WHEREAS, By increasing the accessibility of tennis for Illinoisans of all ages and ability, the USTA has contributed to making Illinois communities happier and healthier; and

WHEREAS, The USTA has declared the month of May as National Tennis Month to encourage players, organizations, facilities, retailers, tennis manufacturers, and more to promote local programs and activities at parks and facilities, to showcase tennis and spread the word about the sport and its benefits, and to help players and non-players alike find courts and play opportunities in their communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 2023 as "Tennis Month" in the State of Illinois and extend to all those affiliated with the USTA our sincere best wishes for the future; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the USTA as a symbol of our respect and esteem.

HOUSE RESOLUTION 195

Offered by Representative Swanson:

WHEREAS, The members of the Illinois House of Representatives wish to raise awareness surrounding the rare disease of spinal muscular atrophy; and

WHEREAS, Spinal muscular atrophy is a degenerative, genetic neurological condition that affects and prevents motor-control neurons from sending signals from the central nervous system to the body's muscles that, in turn, causes the loss of muscle control and ultimately muscle wasting; and

WHEREAS, Spinal muscular atrophy is a rare genetic neuromuscular disease; and

WHEREAS, In the United States, an estimated one in 11,000 babies are born with spinal muscular atrophy; and

WHEREAS, There are four types of spinal muscular atrophy, the most severe of which may require a ventilator and feeding tubes; and

WHEREAS, Spinal muscular atrophy affects everyone differently, and symptoms can vary greatly according to the age of onset and the severity of the disease; and

WHEREAS, Those who suffer from spinal muscular atrophy have normally developed brains and are bright, sensitive, and full of life despite their diagnosis; and

WHEREAS, Unlike many other rare neuromuscular diseases, there is a clear understanding of the specific genetic cause of spinal muscular atrophy; and

WHEREAS, Ongoing research offers the promise that a cure for spinal muscular atrophy may one day be found; and

WHEREAS, Increased awareness of spinal muscular atrophy will lead to increased knowledge and increased support for both disease research and the families affected by the disease; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare August 2023 as Spinal Muscular Atrophy Awareness Month in the State of Illinois, and we encourage continuing research on spinal muscular atrophy and community support for those affected with the disease.

HOUSE RESOLUTION 196

Offered by Representative Hoffman:

WHEREAS, The premise of equine therapy is that interacting with a horse under the supervision of a mental and physical health professional can complement traditional treatments to best support recovery; such interactions may include riding or assisted riding, feeding, grooming, and providing other kinds of care; and

WHEREAS, During a session of equine therapy, the client, therapist, and animal come together and form a unique bond; the inclusion of animals in therapy provides a non-judgmental environment; and

WHEREAS, For clients who have experienced trauma, equine-assisted psychotherapy (EAP) is a great addition for those who may find it easier to talk to animals rather than another person; and

WHEREAS, The Equine Assisted Growth and Learning Association (EAGALA) is a non-profit organization dedicated to setting the standard for professionals working with horses in a therapeutic setting; they offer training and have established a specialized certification process for those wanting to become a recognized, trained equine-assisted therapy professional; and

WHEREAS, In both children and adults, equine-based psychotherapy can be used for a variety of mental health conditions, including but not limited to ADHD, autism, depression, eating disorders, generalized anxiety disorder, PTSD, social anxiety disorder, and substance misuse; and

WHEREAS, In a 2011 study, seven young people considered "at risk" of harming themselves or others were introduced to equine therapy; they reported positive effects on their resilience and reduced risks of crime, self-harm, and other issues, as well as benefits to their empathy, confidence, self-esteem, mastery, and self-efficacy; and

WHEREAS, Research on equine-assisted psychotherapy is limited as it is an emerging treatment, but recent findings report that it can calm and soothe the nervous system, promote healthy attachment, and cultivate social learning and connections; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the benefits that equine therapy can have on the lives of children, especially those that have experienced trauma, abuse, and neglect; and be it further

RESOLVED, That the Department of Children and Family Services is urged to consider implementing an equine therapy pilot program in order to help children process trauma and address their behavioral and emotional needs; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Department of Children and Family Services.

HOUSE RESOLUTION 198

Offered by Representative Rashid:

WHEREAS, It is appropriate and right to celebrate the diversity of cultures and heritages, as such celebrations serve as a reminder that, despite our differing backgrounds, everyone in Illinois is bound by a common hope for a better and more inclusive future for our children; and

WHEREAS, The Arab American community has a long and integral history in the United States; and

WHEREAS, Men and women of Arab descent have shared their rich culture, strong work ethic, and dedication to education, while embracing the American spirit of opportunity and helping build a better State and nation for all; and

WHEREAS, For over a century, Arab Americans have been making valuable contributions to every aspect of American society, including medicine, law, business, technology, government, and culture; and

WHEREAS, People of Middle Eastern descent began migrating to the United States in significant numbers in the 1800s; today, it is estimated that the current population of Arab Americans is approximately four million people; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of April 2023 as Arab American Heritage Month in the State of Illinois; and be it further

RESOLVED, That we recognize and celebrate the contributions to cultural diversity, economic growth, and the overall development of our State and nation made by the Arab American community; and be it further

RESOLVED, That we encourage all Illinoisans and their families to learn about and celebrate the contributions of Arab Americans to Illinois and the United States.

HOUSE JOINT RESOLUTION 28

Offered by Representative Niemerg:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who have given their lives in service to their communities; and

WHEREAS, Wayne County Sheriff's Deputy Sean Riley was killed in the line of duty on December 29, 2021; and

WHEREAS, Deputy Riley was born to Doug and Mary Jo (Hill) Riley on November 5, 1983; he married Leslie Young on August 11, 2007; and

WHEREAS, Deputy Riley was preceded in death by his mother, Mary Jo Riley; and

WHEREAS, At the time of his passing, Deputy Riley was survived by his wife, Leslie; his children, Logan Brown, Deegan Riley, and Mia Jo Riley; his father, Doug Riley; his sister, Spring (Darrin) Bonney; his mother-in-law, Glenda Young; his sister-in-law, Glenna (Jim) Michael; and several aunts, uncles, cousins, and a special aunt, Margaret (Joe) Molt; therefore, be it

Representative Gabel, Chairperson, from the Committee on Rules to which the following were referred, action taken on April 18, 2023, reported the same back with the following recommendations:

That the bill be reported "approved for consideration" and placed on the order of Second Reading: HOUSE BILLS 54 and 2447.

That the bill be reported "approved for consideration" and placed on the order of Consideration Postponed: HOUSE BILLS 2520, 3479, 3572 and 3957.
