RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 237

Offered by Representative Jones:

WHEREAS, Helen Jett-Caldwell has had a long and sterling career with the State of Illinois, beginning such public service with the Illinois Department of Labor as a clerk-typist in 1960; and

WHEREAS, Helen Jett-Caldwell continued to provide exemplary public service in an increasingly responsible manner, she received several promotions, one of which was to the position of Administrative Assistant to the Superintendent of the Madden Mental Health Center in the then Illinois Department of Mental Health; and

WHEREAS, Helen Jett-Caldwell during her eight-year tenure at the Madden Mental Health Center, distinguished herself by developing an affirmative action program which was later used as a model for the entire State; and

WHEREAS, Helen Jett-Caldwell continued to demonstrate outstanding leadership, management, interpersonal and communication skills which resulted in her promotion to a leadership position of Chief of Staff and Executive Assistant to the Director of the Illinois Department of Mental Health and Developmental Disabilities, the then largest agency in the State; and

WHEREAS, Helen Jett-Caldwell's contributions and dedication have been recognized throughout the years with various awards and certifications, all of which are too numerous to list, but a few examples are the YMCA National Black Achiever for Youth Motivation; Who's Who in State Government; President's Award, International Association of Official Human Rights Agencies; and the Chicago Commission on Human Relations' Governmental Award of Merit; and

WHEREAS, Helen Jett-Caldwell is the wife of Lamon Caldwell; she is the proud parent of a son, Chris Cunningham; a daughter, Dr. Lynne Cunningham-McCoy; and the very proud grandmother of LaCresha Cunningham, Kristoffer Jett, Michael McCoy, Joshua Bradley, Brittney Cunningham, Ashley Richardson, Jordan Bradley, Adrienne Cunningham, Ebony Richardson, and Bailey Cunningham; and

WHEREAS, Helen Jett-Caldwell became recognized as an effective leader in the State, and particularly in the field of Equal Opportunity and Affirmative Action, she was appointed to the position of Deputy Director to the newly created Department of Human Rights, where she has served to this day; and

WHEREAS, Helen Jett-Caldwell has served as the Deputy Director of the Illinois Department of Human Rights for more than 20 years and has distinguished herself as a leader among her peers around the nation as evidenced by the fact that she has been elected to various leadership positions on the Board of Directors for the International Association of Official Human Rights Agencies for the past 16 years; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim the date of April 30, 2003 Helen Jett-Caldwell Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Helen Jett-Caldwell as an expression of our respect and esteem.

HOUSE RESOLUTION 241

Offered by Representative Mendoza:

WHEREAS, When we think of the world being a better place, we think of how it begins with young children; and

WHEREAS, Children need a safe and loving environment to grow, learn, excel, and be happy; and

WHEREAS, Children have dreams and wishes, and society will do its best to help their dreams come true; and

WHEREAS, Children are brilliant and ingenious in their own way; and

WHEREAS, Society should have an established date to recognize the achievements and value of its children; and

WHEREAS, El Dia de los Ninos (Children's Day) is celebrated to recognize every single child and acknowledge each of them; and

WHEREAS, By celebrating April 30th, we are making a commitment to children that we will continue to listen, teach, and nurture them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we commemorate the lives of our children and our future by designating April 30th as El Dia de los Ninos (Children's Day).

HOUSE RESOLUTION 242

Offered by Representative Ryg:

WHEREAS, Funding for Department of Veterans Affairs health care under the federal budget is a discretionary program, meaning that it is within the discretion of Congress to determine how much money it will allocate each year for veterans' health care; and

WHEREAS, Section 1710(a) of Title 38 of the United States Code provides that the Secretary of Veterans Affairs "shall" furnish hospital care and medical services, but only to the extent Congress has provided money to cover the costs of care; and

WHEREAS, Veterans have earned the right to VA medical care through their extraordinary sacrifices and service to this nation; and

WHEREAS, The cumulative effects of insufficient health care funding have now resulted in the rationing of health care; and

WHEREAS, Veterans Affairs has reached capacity at many of its health care facilities and is unable to provide timely access to quality health care; and

WHEREAS, The annual shortfall in the VA medical care budget translates directly into higher national health care expenditures; and

WHEREAS, When veterans cannot get needed health care services from Veterans Affairs, they go elsewhere and the cost of care is shifted to State welfare and Medicaid programs or other safety net hospitals where society pays more and the patient suffers; and

WHEREAS, The Veterans Health Administration is the most efficient and cost-effective health care system, providing care for 25% to 30% less than comparable Medicare services; and

WHEREAS, Even though Veterans Affairs serves a population of veterans that is older and sicker and that has a higher prevalence of mental and behavioral health problems, it does so at well below Medicare rates; and

WHEREAS, Many veterans need and depend on the VA health care system and its specialized services in prosthetics, post traumatic stress disorder, spinal cord injury, and rehabilitation of the blind to treat their service-connected disabilities and meet their unique health care needs; and

WHEREAS, It is disingenuous for our government to promise health care to veterans, but then make it unattainable because of inadequate funding; and

WHEREAS, Making veterans' health care mandatory would ensure that the government met its obligation to provide timely, quality health care to all veterans eligible for care in the VA health care system; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to amend Title 38 of the United States Code to provide a guaranteed level of funding for veterans' health care with mandatory funding; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the President pro tempore of the U.S. Senate and Chairman of the Senate Veterans' Affairs Committee, the Speaker of the U.S. House of Representatives and Chairman of the House Veterans' Affairs Committee, and each member of the Illinois congressional delegation.

HOUSE RESOLUTION 243

Offered by Representative Watson:

WHEREAS, The State of Illinois benefits from the revenues and economic activity of countless businesses and public utilities that rely on flood control structures to protect individuals and property from the ravages of the Illinois, Kaskaskia, Mississippi, and Ohio rivers; and

WHEREAS, The State of Illinois benefits from improved public health and quality of life for its citizens due to well-drained land and access to marinas that offer waterborne recreational activities; and

WHEREAS, The State of Illinois benefits from hundreds of miles of navigable waterways and waterborne commerce on the Illinois, Kaskaskia, Mississippi, and Ohio rivers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the members of the House of Representatives support strengthening flood control structures to a common level of protection to improve the safety and well-being of the State's citizens, wildlife sanctuaries, and economic assets; and be it further

RESOLVED, That the members of the Illinois House of Representatives support the federally-funded Upper Mississippi River Comprehensive Plan that is to develop recommendations for systematic flood protection and for coordinating the varied uses of the Illinois and Mississippi rivers; and be it further

RESOLVED, That the State of Illinois needs to encourage the modernization of the navigation locks and dams on the Illinois, Kaskaskia, and Mississippi rivers to maintain the Midwest's position in global markets and to facilitate movement of commodities that produce energy, such as coal and oil, build the foundations of communities, and protect Midwestern communities from extreme weather conditions, and to facilitate movement of recreational boaters on the rivers; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the Speaker of the United States House of Representatives, the President of the United States Senate, and each member of the Illinois Congressional delegation.

HOUSE RESOLUTION 256

Offered by Representative Millner:

WHEREAS, the State of Illinois is committed to protecting the safety of motorists on Illinois highways and protecting taxpayers' investment in our highway infrastructure; and

WHEREAS, the federal government by law has, since 1991, prohibited the introduction of triple trailers, trucks with weights greater than 80,000 pounds, and trailers longer than 53 feet on the interstate highway system; and

WHEREAS, a recent U.S. Department of Transportation study found that (1) double and triple trailer trucks are at least 11% more likely to be involved in a fatal accident than a single trailer truck, and (2) nationwide use of these trucks would result in \$53 billion in bridge construction costs and an additional \$266 billion in congestion costs; and

WHEREAS, there are attempts to convince the congress of the United States to permit longer and heavier trucks; and

WHEREAS, heavy trucks are responsible for a disproportionate amount of pavement damage; according to the American Association of State Highway and Transportation Officials (AASHTO), one 80,000 pound five-axle truck does as much pavement damage as 9,600 cars; a 100,000 pound five-axle truck would do as much damage as 27,000 cars; and

WHEREAS, each introduction of longer and heavier trucks in American history has resulted in a substantial increase in the number of trucks on the road because goods previously shipped by more environmentally friendly methods -- waterways and rail -- are placed on trucks instead; thus allowing longer, heavier trucks will increase congestions; and

WHEREAS, heavier trucks will take more time to stop, thus increasing their potential for accidents; therefore be it

RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support maintaining the current federal truck size and weight limitations and oppose proposals to experiment with longer and heavier trucks on public

highways; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois congressional delegation.

HOUSE RESOLUTION 267

Offered by Representative Flowers:

WHEREAS, There are over 142,000 registered nurses and 26,000 licensed practical nurses in the State of Illinois; and

WHEREAS, May 6 is recognized annually as National RN Recognition Day to honor the compassion, knowledge, and skills of nursing professionals; and

WHEREAS, Registered nurses provide the necessary treatment, continual assessment of conditions, and education that patients require when hospitalized; and

WHEREAS, Recent studies published in the Journal of the American Medical Association and the New England Journal of Medicine found a direct link between higher number of nurses assigned to patients and lower adverse patient outcomes; and

WHEREAS, Nurses, as patient advocates, are joining together to call for quality health care measures including safe staffing, reporting of employee turnover and hours worked, and public disclosure of hospital infection and mortality rates; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we do hereby recognize Tuesday, May 6, 2003, as National Nurses Day in Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Service Employees International Union Nurse Alliance of Illinois with our respect and esteem.

HOUSE RESOLUTION 270

Offered by Representative Hassert:

WHEREAS, The family, serving as the primary source of love, identity, self-esteem, and support, is the very foundation of our communities and State; and

WHEREAS, In the State of Illinois there are 23,000 children and youth in foster care being provided with safe, secure, and stable homes along with the compassion and nurture of a foster family; and

WHEREAS, Foster families who open their homes and hearts to children whose families are in crisis play a vital role in helping children and facilities heal and reconnect and launch children into successful adulthood; and

WHEREAS, Dedicated foster families frequently adopt foster children, resulting in greater need for more foster families; and

WHEREAS, There are numerous individuals and public and private organizations that work to increase public awareness of children in and leaving foster care as well as the enduring and valuable contribution of foster parents, and the foster care system is only as good as those who choose to be a part of it; therefore, be it

WHEREAS, It has come to our attention that Ralph E. Walberg of Mount Prospect is retiring from his position as Executive Director for Countryside Association after 37 years of service; and

WHEREAS, Mr. Walberg attended Augustana College for his Bachelor's Degree and Loyola University for his Master's Degree; he attended graduate classes in the rehabilitation field at De Paul University; and

WHEREAS, Mr. Walberg has played a very important role in the success of Countryside Association; he became Countryside's Executive Director in 1966 at which time the annual budget was \$65,000, and through his leadership the agency has grown to a \$5 million United Way funded human service agency with 200 full and part-time employees that serves 654 children and adults who are disabled; Mr. Walberg has been Countryside's only Executive Director overseeing continuity of quality programs and longevity of personnel; since 1975, Countryside Association has been receiving 3-year accreditations from the Commission on Accreditation of Rehabilitation Facilities; this accreditation confirms the efficiency and effectiveness of the operations of the Association and its four programs; and

WHEREAS, Mr. Walberg has earned the esteem of the community based non-profit sector and the respect of his colleagues; Countryside's Board President, Amy Luczkiw, stated that Mr. Walberg is the "heart and soul" of Countryside Association; and

WHEREAS, Mr. Walberg has been a board member for 28 years for the Illinois Association of Rehabilitation Facilities; he was one of the founders and served as the Board President; he served on the College of Lake County Early Childhood Committee for 4 years and as president of the Lake County ABIC Council; he was a board member of the Mount Prospect/Prospect Heights United Way for 7 years; he served on the District 57 School Board for 3 years; he was the United Way of Suburban Chicago Ambassador of Mercy Speaker and Tour Program Co-Chairperson for 2 years and Ambassador of Mercy for 21 years; and he was a Surveyor Consultant for the Commission on Accreditation of Rehabilitation Facilities for approximately 18 years and performed more than 100 surveys; and

WHEREAS, Mr. Walberg is married to Barbara, a retired teacher, and is the father of 3 children: Brian, Nancy, and Susan; he is the grandfather of 8 grandchildren, 7 girls and one boy; the Walbergs have lived in Mount Prospect since 1958; Mr. Walberg's mother, Anne Walberg, is 97 years old and is very proud of his many accomplishments; he is an avid outdoors person particularly interested in fishing, boating, and snowmobiling; most of his activities are enjoyed at his get-away home located in the Upper Peninsula of Michigan; therefore, be it

HOUSE RESOLUTION 268

Offered by Representative Currie:

WHEREAS, Pegasus Players has been bringing quality theatre to the people of Chicago for 25 years; and

WHEREAS, Pegasus is committed to providing theatre to those who have limited access to the arts: the young, the elderly, the disabled, and the disenfranchised; and

WHEREAS, The theatre consistently premieres plays that ask its audiences to take a hard and sometimes painful look at some of society's most pressing social issues; and

WHEREAS, The theatre's Young Playwrights Festival builds writing skills and self-esteem among thousands of Chicago's high school students each year; and

WHEREAS, Pegasus made theatrical history, and a significant contribution to African-American culture, by reviving the "lost" Duke Ellington review, "Jump for Joy", in 1991; and

WHEREAS, Pegasus has consistently been singled out by composer Steven Sondheim, who chose the theatre for the American premiere of his first musical, "Saturday Night", in 1999 and who awarded Pegasus the rights to be the first theatre in Chicago to produce "The Frogs", "Passion", "Assassins", "Anyone Can Whistle", "Pacific Overtures", and "Merrily We Roll Along"; and

WHEREAS, The U.S. Information Agency asked Pegasus to be the first American theatre to present musical theatre in West Africa (the theatre's 1992 production of "Bubbling Brown Sugar"); and

WHEREAS, Pegasus has sought to overcome barriers of culture and language by reaching out to audiences in the Middle East, bringing its productions of "Side by Side by Sondheim" and "The Fantasticks" to more than 15,000 people in Egypt, Jordan, Turkey, and Morocco; and

WHEREAS, The theatre's work with inner-city educators has touched the hearts, minds, and futures of

thousands of Chicago youth; and

WHEREAS, Pegasus has received more awards, including 67 Jefferson Citations, than any other non-equity theatre in Chicago; and

WHEREAS, Artistic Director Arlene Crewdson has twice been named by the Chicago Tribune as one of the top Chicago artists who has made lasting and memorable contributions to the arts during the year; therefore, be it
