THEREFORE, pursuant to Article IV, Section 5 (b) of the Illinois Constitution of 1970, I hereby call and convene the 93rd General Assembly in a special session to commence on June 25, 2004, at 12:00 p.m., to consider any legislation (new or pending), which will address directly the budget of the Department of Transportation for fiscal year 2005.
