WHEREAS, The Department of Central Management Services recently decided to replace Vision Service Plan (VSP) with Spectera as the administrator of the vision care benefit plan for State employees, dependents, and retirees beginning in Fiscal Year 2005; and

WHEREAS, Developing a long-term relationship with a trusted family ophthalmologist or optometrist and a trusted family optician can greatly improve the quality of vision care; however, a move from VSP to Spectera would require some State employees to seek new providers in order to continue to receive in-network services since Spectera would be the only vision care benefit plan choice; and

WHEREAS, Job preservation is a high priority for the State of Illinois; however, a move from VSP to Spectera would adversely affect Illinois jobs and businesses and our State's economy because Spectera would require some providers to use Spectera's dispensing laboratory in Maryland rather than the dispensing laboratories throughout Illinois that are now used by VSP providers; and

WHEREAS, The Illinois Economic and Fiscal Commission reportedly voted on May 18, 2004 to extend the State's contract with VSP for Fiscal Year 2005, and it the Department of Central Management Services has reportedly agreed to reverse its earlier decision and negotiate with VSP for a contract for Fiscal Year 2005; however, this is a matter of continuing concern; and

WHEREAS, All of the consequences of any action taken should be fully considered in determining whether that action is in the best interests of the State of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Central Management Services to give due consideration to the needs of State employees, retirees, and dependents and the economic needs of the State of Illinois in any decision regarding the selection of the administrator of the vision care benefit plan for State employees and retirees; and be it further

RESOLVED, That a copy of this resolution be delivered to Michael M. Rumman, the Director of Central

Management Services.

### **HOUSE RESOLUTION 977**

Offered by Representative Black:

WHEREAS, The Director of the Department of Central Management Services (CMS) is the chief procurement agent of the State of Illinois; and

WHEREAS, CMS is responsible for administering the State's Group Health Insurance coverage; and

WHEREAS, The State provides health insurance benefits to over 350,000 employees, retirees, and dependents; and

WHEREAS, CMS has the primary responsibility for negotiating and entering into contractual arrangements to provide Group Health Insurance benefits for the State's employees, retirees, and dependents; and

WHEREAS, CMS conducted the bidding process for managed care organizations to bid on the contracts to provide health benefits to the State's employees, retirees, and dependents; and

WHEREAS, CMS has established criteria for this Request for Proposals (RFP) bidding process and for awarding contracts for the provision of health benefits to the State's employees, retirees, and dependents; and

WHEREAS, Recent evidence has shown that CMS failed or refused to comply with its own process for selecting managed care organizations to participate in the State's Group Health Insurance program; and

WHEREAS, Recent evidence shows that managed care organizations that were ranked higher in the bidding criteria were not awarded a contract to provide health benefits to the State's employees, retirees, and dependents while managed care organizations that were ranked lower were awarded such a contract; and

WHEREAS, CMS recently concluded that the process used in selecting managed care organizations to provide health benefits to the State's employees, retirees, and dependents was inadequate; and

WHEREAS, CMS plans to re-bid these contracts due to the questions that have arisen about the original bidding process; and

WHEREAS, The General Assembly is concerned that CMS did not follow its own criteria in the awarding of the original contracts for providing health benefits to the State's employees, retirees and dependents; and

WHEREAS, the Attorney General is the Chief Legal Officer of the State and is charged with investigating alleged violations of the law; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois House of Representatives requests that the Attorney General conduct a thorough investigation of the Request for Proposals (RFP) process used by CMS to select managed care organizations to participate in the State's Group Health Insurance program; and be it further

RESOLVED, That the Illinois House of Representatives requests that the Attorney General proffer an opinion on the validity of the process used by CMS to select managed care organizations to participate in the State's Group Health Insurance program; and be it further

RESOLVED, That the Attorney General is asked to pay particular attention to the points awarded to each bidder in CMS's own RFP process and conclude whether the initial selection of managed care organizations was proper and adequately adhered to the criteria of CMS's own RFP; and be it further

RESOLVED, That a copy of this resolution be delivered to the Attorney General in an expedited manner.

### **HOUSE RESOLUTION 979**

Offered by Representative Grunloh:

WHEREAS, Approximately 40% of the meat and poultry operations in the United States operate under state inspection in 28 of the 50 states, including a large number of operations in the State of Illinois, which operates a State inspection program; and

WHEREAS, The Federal Meat Inspection Act prohibits state-inspected plants from selling their products in other states, even though they follow the same inspection regulations as USDA plants; and

WHEREAS, There have been attempts made to change the law to allow the shipping of state-inspected meat and poultry products in interstate commerce for the past 30 years; and

WHEREAS, The changing of the law is tied to the survival and success of the small meat and poultry processing industry in the United States, and while there has been more of a drop in the number of small and very small plants in the United States that operate under USDA inspection (mostly in states where that is the only kind of inspection available), there has been a greater stability in the number of small and very small plants that operate under state inspection; and

WHEREAS, A broad array of stakeholders inside and outside of the meat industry across the United States now support shipment of products across state lines by plants that are inspected by "equal to" state meat inspection programs; this group of stakeholders includes large, medium, and small meat establishments, groups, and governments, including the USDA and members of Congress; and

WHEREAS, The issue has become even more critical today as a result of the continuing consolidation of the meat industry, including the closing and disappearance of small and very small meat establishments and their acquisition by larger companies, including those small and very small meat establishments in the State of Illinois; and

WHEREAS, One way to fight this consolidation, which Congress has expressed concern about, is to strengthen small businesses by allowing them to ship across state lines, thereby increasing their markets, strengthening their economic power, and helping the rural regions of Illinois and other states where meat plants operate under state inspection; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we endorse the changing of the Federal Meat Inspection Act to allow state-inspected meat and poultry plants to ship their products across state lines in this State and in other states where "equal to" state inspection programs operate; and be it further

RESOLVED, That we urge Congress to take action as soon as possible to change the law to allow interstate shipment of state-inspected meat products; and be it further

RESOLVED, That we urge the Congressional delegation of Illinois to play a leadership role in this action, including the Speaker of the House and members of the Senate Committee on Agriculture, Nutrition and Forestry, House Committee on Agriculture, Senate Committee on Small Business and Entrepreneurship, and House Committee on Small Business; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the President pro tempore of the United States Senate, the Speaker of the United States House of Representatives, each member of the Senate Committee on Agriculture, Nutrition and Forestry, House Committee on Agriculture, Senate Committee on Small Business and Entrepreneurship, and House Committee on Small Business, and each member of the Illinois Congressional delegation.

### **HOUSE RESOLUTION 982**

Offered by Representative Currie:

WHEREAS, The House Special Committee on Fee-For-Service Initiatives has held three open hearings on the Department of Human Services' proposal to adopt a fee-for-service methodology to pay providers for serving the State's clients with problems of substance abuse, developmental disability, and mental illness; and

WHEREAS, The Committee appreciates the willingness of the Governor's Office of Management and Budget and the Department of Human Services to work with provider groups to ensure a smooth transition to the new payment methodology; and

WHEREAS, The Committee, while supporting the fee-for-service methodology, remains concerned that the Department's transition schedule could jeopardize treatment for these most vulnerable populations; and

WHEREAS, The Committee believes the Department must show it has the infrastructure capacity and field-tested experience before a wholesale shift to the new system; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Committee urges the Department of Human Services to make periodic progress reports to the Committee over the next several months, specifically including reports in September, October, November, and December of 2004; and be it further

RESOLVED, That the Committee urges the General Assembly to adopt an operational budget for the Department of Human Services that reflects only the first six months of funding for the coming fiscal year, while appropriating the full year of grant lines.

### **HOUSE RESOLUTION 985**

Offered by Representative Jones:

WHEREAS, Nielsen Media Research has a national monopoly on measuring viewership of television shows: and

WHEREAS, The Nielsen ratings are used to determine the amount that television stations will charge for advertising and to determine what programming content will be offered; and

WHEREAS, Nielsen Media Research intends to deploy Local People Meters (LPMs), a new technology, in Chicago this summer to rate television shows according to the number of viewers; and

WHEREAS, The use of LPMs, by Nielsen Media Research's own admission, has resulted in dramatic decline in the number of minority viewers that are counted, as demonstrated by the fact that, in tests of the LPM system in New York, the ratings declined by as much as 62% for virtually every top-rated program among African-Americans, and similar declines were seen for top-rated Spanish language networks, while programming targeted primarily to white audiences saw no such decline; and

WHEREAS, Nielsen Media Research initially delayed the deployment of LPMs in New York based on complaints about the undercounting of minorities, but now has refused to delay the deployment of LPMs in Chicago as well as in New York; and

WHEREAS, Because the LPM system undercounts minority viewers and because the Nielsen ratings are the sole measure of audience for television shows, minority viewers are deprived of an equal say in determining programming content that appeals to them and advertisers are deprived of accurate information; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Nielsen Media Research to delay its deployment of LPMs until it has thoroughly investigated and explained the reason for the undercount of minorities and developed and tested new approaches that correct this deficiency; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Nielsen Media Research.
