# RESOLUTION

The following resolution was offered and placed in the Committee on Rules.

# **HOUSE RESOLUTION 1196**

Offered by Representative Churchill:

WHEREAS, Approximately 1 in 7 women will develop breast cancer in their lifetime; and

WHEREAS, The incidence rate of women with breast cancer in Illinois has continued to increase throughout the past ten years; and

WHEREAS, The amount of research and development of new breast cancer treatments for women has worked to exponentially increase the number of breast cancer survivors in Illinois; and

WHEREAS. When diagnosed at early stages (Stage 1), the 5-year breast cancer survival rate for women is 97%: and

WHEREAS, Recent data indicate that nearly one out of every five enrollees in the National Breast and Cervical Cancer Early Detection Program, which specializes in providing critical breast and cervical cancer screening services to underserved women, do not adhere to recommended mammography rescreening schedules; and

WHEREAS, Lower-income breast cancer patients are more likely to be diagnosed with advanced stages of the disease and have lower 5-year survival rates; and

WHEREAS, Illinois' FY 2005 appropriation of \$10 million for tobacco use prevention from the 1998 tobacco Master Settlement Agreement entered in the case of People of the State of Illinois v. Philip Morris, et al. in the Circuit Court of Cook County falls well short of the Centers for Disease Control and Prevention's suggested appropriation of \$63 million for tobacco use prevention; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Susan G. Komen Foundation is annually recognized on October 14th for its vigorous efforts to eradicate breast cancer through research, education, screening, and treatment; and be it further

RESOLVED, That we encourage the continued citizen participation in the Penny Severns Breast and Cervical Cancer Research Fund Income Tax check-off, which raised more than \$100,000 in FY 2004 alone; and be it further

RESOLVED, That we strongly encourage women age 40 and older to have mammogram screenings every 1-2 years; and be it further

RESOLVED, That we urge the General Assembly to appropriate additional funding for breast cancer awareness and prevention from the tobacco Master Settlement Agreement; and be it further

RESOLVED, That we urge the Congress of the United States to pass an FY 2005 appropriation for the National Breast and Cervical Cancer Early Detection Program in the amount of \$250 million; and be it

RESOLVED, That we urge the State of Illinois to continue maximizing its federal funding allocation from the National Breast and Cervical Cancer Early Detection Program by continuing to appropriate the maximum annual matching dollars to this vital program; and be it further

RESOLVED, That we urge the Director of the Illinois State Fair to annually designate one day at the State Fair as a day of recognition for Breast Cancer Awareness; and be it further

RESOLVED, That suitable copies of this Resolution be forwarded to each member of the Illinois Congressional delegation and to the Director of the Illinois State Fair.

WHEREAS, Mr. Sibille moved his tack to California in 1981 and returned to the Chicago scene in 1993; his greatest racing thrill occurred in 1988, when he won the \$2 million Breeders' Cup Turf with 12-1 long shot Great Communicator at Churchill Downs; he also won the San Juan Capistrano and Hollywood Derby with the same horse; and

WHEREAS, Mr. Sibille earned career win number 4,000 at Sportsman's Park on April 18, 2000 aboard Beware The Ides; his career totals from Equibase Company list him with 4,264 wins from 36,858 mounts as of Wednesday, July 21, 2004; and

WHEREAS, Mr. Sibille had his final mount on Wednesday, July 21, 2004 at Arlington Park, where going into the race he was the fourth leading jockey in Park history with 981 wins; therefore, be it

WHEREAS, The members of the House of Representatives of the State of Illinois learned with regret of the death of Dr. Stanley Yachnin on Monday, August 30, 2004; and

WHEREAS, Dr. Yachnin was born on June 28, 1930 and raised in Brooklyn, New York in a devout Jewish household; he attended Midwood High School as well as the Yeshiva in the borough's Flatbush district; and

WHEREAS, From 1947 to 1950, he studied at Cornell University, but without earning a degree; instead of graduating from Cornell, Dr. Yachnin opted to go straight to medical school at New York University, where he earned his medical degree in 1954 and was first in his class; and

WHEREAS, His residency training was interrupted when he served two years as a captain in the U.S. Army Medical Corps; he was stationed in a small town outside of Paris, where he cared for ailing soldiers, learned French, and cultivated a lifelong interest in wines and food; and

WHEREAS, Dr. Yachnin met and married his wife, Irene, during his residency; she preceded him in death 1972; and

WHEREAS, He resumed medical training in 1958, completing his residency and a fellowship in hematology in 1961 at the Peter Bent Brigham Hospital in Boston, part of the Harvard system; he became an assistant professor at the University of Chicago in 1961 and spent his entire career there, helping to build a small hematology-oncology section into one of the world's leading clinical cancer research groups; he became section chief of hematology in 1966, a full professor in 1969, and chief of the combined section of hematology and oncology from 1972 to 1982; he retired in 1996, having recruited many physicians and scientists to the section; he also served as a member and chairman of the university committee that approves faculty appointments and promotions, and from 1988 to 1996 directed the Pew program, one of the earliest interdisciplinary graduate programs for students interested in completing both an M.D. and a Ph.D.; and

WHEREAS, Much of Dr. Yachnin's work concentrated on blood cells and related disorders; during the 1960s, he explored paroxysmal nocturnal hemoglobinuria, a rare disease that leads to anemia, bleeding in urine while asleep, and potentially deadly blood clots; his 1970s research took him into the biochemistry of lymphocyte transformation, how white blood cells respond to infections; and

WHEREAS, Inside the laboratory, Dr. Yachnin demanded not only high standards and thorough research from his students and assistants, but also a reverence and exactitude in their use of English in their science; and

WHEREAS, The passing of Dr. Yachnin has been deeply felt by many, especially his children, Benson (Melinda) Yachnin and Catherine (Addison) Braendel; and his grandchildren Noah, Clea, William Braendel, and Emma Yachnin; therefore, be it

WHEREAS, Mr. Palmer was born in Newport News, Virginia; he graduated from Virginia Union University in 1942, received his master's degree from Syracuse University in 1947, and his Ph.D. in Mass Media Communications from Iowa State University in 1955; he is the recipient of an honorary degree from St. Martin's College and Seminary, which bestowed upon him a Doctor of Human Letters in 1983; and

WHEREAS, Mr. Palmer worked as a reporter for several Chicago papers including the Chicago Defender, the Chicago Courier, the Chicago American, and the Chicago Daily News, where he was also a syndicated columnist; he served as the editor of the Tri-State Defender, based in Nashville, Tennessee; he also worked as a recruiter, organizer, and preceptor for the Associated Colleges of the Midwest from 1970 to 1990; and

WHEREAS, In addition to his work in newspapers, Mr. Palmer became famous through his radio broadcasts of "Lu's Notebook", which at one time was aired on four radio stations; at the end of his broadcast career, he hosted a night on WVON's "On Target" show; he was a writer and editorial director for Congressman Ralph Metcalfe in the 1970s and the 1980s, and he worked in public relations for Michael Reese Hospital in the 1960s and 1970s; and

WHEREAS, Mr. Palmer was the founder of Chicago Black United Communities (CBUC) and served as chairman of the organization from 1979 until 1987; through his work at CBUC, he spear-headed the move to elect Chicago's first African-American mayor, Harold Washington, through the "We Shall See in '83" campaign; he also founded the Black Independent Political Organization (BIPO) and the Black Business Network, and he founded, edited, and published the Black X-Press Info-Paper in Chicago from 1971 to 1974; and

WHEREAS, Mr. Palmer's final position was chairman of United Services of Chicago, Inc., where he was chairman of the Board of Directors of this State-funded program, a group living facility on Chicago's south side: and

WHEREAS, All over the country, Mr. Palmer conducted seminars and participated in workshops where his expertise and his messages have been that of imparting valuable information and providing direction for untold masses of people regarding the enrichment and lifting up of African Americans; in Chicago, he led such fights as the removal of asbestos from Chicago schools and the fight against the wrongful draft of African Americans in the armed services; behind the scenes, he helped in the mobilization to unseat Edward Hanrahan after the murders of Fred Hampton and Mark Clark of the Black Panther Party and also provided assistance in the mobilization against police brutality in the 1970s; and

WHEREAS, Mr. Palmer provided vital research to the groups that fought over-crowding of schools in African-American neighborhoods and did the same for groups that coalesced to have the first African American selected as Superintendent of the Chicago School Board; and

WHEREAS, During his years of journalistic activism in the Chicago area, Mr. Palmer received several notable honors for his work; he was inducted into the Black Press Hall of Fame on October 22, 1989; in addition to his numerous awards and honors, he was a recipient of the Journalistic Excellence Award given by the National Conference of Black Lawyers in 1977, the Frederick Douglas Award in 1998, the Jomo Kenyatta Award for Political Activism in 1994, and a Thank You Picture Plaque from Nelson Mandela and the ANC in 1990; and

WHEREAS, It was Lu Palmer who solidified KWANZAA as an African-American observance; on his radio program, he presented the Seven Principles of Nguzo Saba on a daily basis in an effort to help listeners understand, absorb, and seek more clarity and participation in African-based cultural rhythms; and

WHEREAS, The passing of Mr. Palmer has been deeply felt by many, especially his wife, Jorja Palmer; his three daughters; his two sons; his five grandchildren; and his two great-grandchildren; therefore, be it

### SENATE BILL ON SECOND READING

SENATE BILL 1641. Having been printed, was taken up and read by title a second time. The following amendment was offered in the Committee on Veterans Affairs, adopted and printed:

AMENDMENT NO. \_\_1\_. Amend Senate Bill 1641 by replacing everything after the enacting clause with the following:

"Section 5. The Line of Duty Compensation Act is amended by changing Sections 2 and 3 as follows: (820 ILCS 315/2) (from Ch. 48, par. 282)

Sec. 2. As used in this Act, unless the context otherwise requires:

(a) "Law enforcement officer" or "officer" means any person employed by the State or a local governmental entity as a policeman, peace officer, auxiliary policeman or in some like position involving the enforcement of the law and protection of the public interest at the risk of that person's life. This includes supervisors, wardens, superintendents and their assistants, guards and keepers, correctional officers, youth supervisors, parole agents, school teachers and correctional counsellors in all facilities of both the Juvenile and Adult Divisions of the Department of Corrections, while within the facilities under the control of the Department of Corrections or in the act of transporting inmates or wards from one location to another or

while performing their official duties, and all other Department of Correction employees who have daily contact with inmates.

The death of the foregoing employees of the Department of Corrections in order to be included herein must be by the direct or indirect willful act of an inmate, ward, work-releasee, parolee, parole violator, person under conditional release, or any person sentenced or committed, or otherwise subject to confinement in or to the Department of Corrections.

- (b) "Fireman" means any person employed by the State or a local governmental entity as, or otherwise serving as, a member or officer of a fire department either for the purpose of the prevention or control of fire or the underwater recovery of drowning victims, including volunteer firemen.
  - (c) "Local governmental entity" includes counties, municipalities and municipal corporations.
- (d) "State" means the State of Illinois and its departments, divisions, boards, bureaus, commissions, authorities and colleges and universities.
- (e) "Killed in the line of duty" means losing one's life as a result of injury received in the active performance of duties as a law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, or chaplain if the death occurs within one year from the date the injury was received and if that injury arose from violence or other accidental cause. In the case of a State employee, "killed in the line of duty" means losing one's life as a result of injury received in the active performance of one's duties as a State employee, if the death occurs within one year from the date the injury was received and if that injury arose from a willful act of violence by another State employee committed during such other employee's course of employment and after January 1, 1988. The term excludes death resulting from the willful misconduct or intoxication of the officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, or State employee. However, the burden of proof of such willful misconduct or intoxication of the officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, or State employee is on the Attorney General. Subject to the conditions set forth in subsection (a) with respect to inclusion under this Act of Department of Corrections employees described in that subsection, for the purposes of this Act, instances in which a law enforcement officer receives an injury in the active performance of duties as a law enforcement officer include but are not limited to instances when:
  - (1) the injury is received as a result of a wilful act of violence committed other than by the officer and a relationship exists between the commission of such act and the officer's performance of his duties as a law enforcement officer, whether or not the injury is received while the officer is on duty as a law enforcement officer;
  - (2) the injury is received by the officer while the officer is attempting to prevent the commission of a criminal act by another or attempting to apprehend an individual the officer suspects has committed a crime, whether or not the injury is received while the officer is on duty as a law enforcement officer;
  - (3) the injury is received by the officer while the officer is travelling to or from his employment as a law enforcement officer or during any meal break, or other break, which takes place during the period in which the officer is on duty as a law enforcement officer.

In the case of an Armed Forces member, "killed in the line of duty" means losing one's life while on active duty in connection with <u>the September 11, 2001 terrorist attacks on the United States</u>, Operation Enduring Freedom, or Operation Iraqi Freedom.

- (f) "Volunteer fireman" means a person having principal employment other than as a fireman, but who is carried on the rolls of a regularly constituted fire department either for the purpose of the prevention or control of fire or the underwater recovery of drowning victims, the members of which are under the jurisdiction of the corporate authorities of a city, village, incorporated town, or fire protection district, and includes a volunteer member of a fire department organized under the "General Not for Profit Corporation Act", approved July 17, 1943, as now or hereafter amended, which is under contract with any city, village, incorporated town, fire protection district, or persons residing therein, for fire fighting services. "Volunteer fireman" does not mean an individual who volunteers assistance without being regularly enrolled as a fireman.
- (g) "Civil defense worker" means any person employed by the State or a local governmental entity as, or otherwise serving as, a member of a civil defense work force, including volunteer civil defense work forces engaged in serving the public interest during periods of disaster, whether natural or man-made.
- (h) "Civil air patrol member" means any person employed by the State or a local governmental entity as, or otherwise serving as, a member of the organization commonly known as the "Civil Air Patrol", including volunteer members of the organization commonly known as the "Civil Air Patrol".
  - (i) "Paramedic" means an Emergency Medical Technician-Paramedic certified by the Illinois Department

- of Public Health under the Emergency Medical Services (EMS) Systems Act, and all other emergency medical personnel certified by the Illinois Department of Public Health who are members of an organized body or not-for-profit corporation under the jurisdiction of a city, village, incorporated town, fire protection district or county, that provides emergency medical treatment to persons of a defined geographical area.
- (j) "State employee" means any employee as defined in Section 14-103.05 of the Illinois Pension Code, as now or hereafter amended.
  - (k) "Chaplain" means an individual who:
    - (1) is a chaplain of (i) a fire department or (ii) a police department or other agency consisting of law enforcement officers; and
  - (2) has been designated a chaplain by (i) the fire department, police department, or other agency or an officer or body having jurisdiction over the department or agency or (ii) a labor organization representing the firemen or law enforcement officers.
- (l) "Armed Forces member" means an Illinois resident who is: a member of the Armed Forces of the United States; a member of the Illinois National Guard while on active military service pursuant to an order of the President of the United States; or a member of any reserve component of the Armed Forces of the United States while on active military service pursuant to an order of the President of the United States. (Source: P.A. 93-1047, eff. 10-18-04.)

(820 ILCS 315/3) (from Ch. 48, par. 283)

Sec. 3. Duty death benefit.

- (a) If a claim therefor is made within one year of the date of death of a law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, State employee, or Armed Forces member killed in the line of duty, compensation shall be paid to the person designated by the law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, State employee, or Armed Forces member. However, if the Armed Forces member was killed in the line of duty before October 18, 2004 the effective date of this amendatory Act of the 93rd General Assembly, the claim must be made within one year of October 18, 2004 the effective date of this amendatory Act of the 93rd General Assembly.
- (b) The amount of compensation, except for an Armed Forces member, shall be \$10,000 if the death in the line of duty occurred prior to January 1, 1974; \$20,000 if such death occurred after December 31, 1973 and before July 1, 1983; \$50,000 if such death occurred on or after July 1, 1983 and before January 1, 1996; \$100,000 if the death occurred on or after January 1, 1996 and before May 18, 2001; \$118,000 if the death occurred on or after May 18, 2001 and before July 1, 2002 the effective date of this amendatory Act of the 92nd General Assembly; and \$259,038 if the death occurred occurs on or after July 1, 2002 the effective date of this amendatory Act of the 92nd General Assembly and before January 1, 2003. For an Armed Forces member killed in the line of duty (i) at any time before January 1, 2005, the compensation is \$259,038 plus amounts equal to the increases for 2003 and 2004 determined under subsection (c) and (ii) on or after January 1, 2005, the compensation is the amount determined under item (i) plus the applicable increases for 2005 and thereafter determined under subsection (c).
- (c) Except as provided in subsection (b), for For deaths occurring on or after January 1, 2003, the death compensation rate for death in the line of duty occurring in a particular calendar year shall be the death compensation rate for death occurring in the previous calendar year (or in the case of deaths occurring in 2003, the rate in effect on December 31, 2002) increased by a percentage thereof equal to the percentage increase, if any, in the index known as the Consumer Price Index for All Urban Consumers: U.S. city average, unadjusted, for all items, as published by the United States Department of Labor, Bureau of Labor Statistics, for the 12 months ending with the month of June of that previous calendar year.
- (d) If no beneficiary is designated or surviving at the death of the law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, State employee, or Armed Forces member killed in the line of duty, the compensation shall be paid as follows:
  - (1) (a) when there is a surviving spouse, the entire sum shall be paid to the spouse;
  - (2) (b) when there is no surviving spouse, but a surviving descendant of the decedent, the entire sum shall be paid to the decedent's descendants per stirpes;
  - (3) (e) when there is neither a surviving spouse nor a surviving descendant, the entire sum shall be paid to the parents of the decedent in equal parts, allowing to the surviving parent, if one is dead, the entire sum; and
  - (4) (d) when there is no surviving spouse, descendant or parent of the decedent, but there are surviving brothers or sisters, or descendants of a brother or sister, who were receiving their principal support from the decedent at his death, the entire sum shall be paid, in equal parts, to the dependent

brothers or sisters or dependent descendant of a brother or sister. Dependency shall be determined by the Court of Claims based upon the investigation and report of the Attorney General.

- (e) When there is no beneficiary designated or surviving at the death of the law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, State employee, or Armed Forces member killed in the line of duty and no surviving spouse, descendant, parent, dependent brother or sister, or dependent descendant of a brother or sister, no compensation shall be payable under this Act.
- (f) No part of such compensation may be paid to any other person for any efforts in securing such compensation.
- (g) This amendatory Act of the 93rd General Assembly applies to claims made on or after October 18, 2004 with respect to an Armed Forces member killed in the line of duty.

"Section 1. "AN ACT making appropriations", Public Act 93-842, approved July 30, 2004, is amended by changing Section 43 of Article 33 as follows:

(P.A. 93-842, Art. 33, Sec. 43)

Sec. 43. The amount of \$250,000 is appropriated from the General Revenue Fund to the Illinois Historic Preservation Agency for a grant for the establishment of the Vernon Jarret Museum of Civil Rights a civil rights museum.

Section 99. Effective date. This Act takes effect upon becoming law.".

The motion prevailed and the amendment was adopted and ordered printed.

There being no further amendments, the foregoing Amendment No. 1 was adopted and the bill, as amended, was advanced to the order of Third Reading.
