AMENDMENT NO.   1  . Amend House Bill 768 by replacing everything after the enacting clause with the following:

"Section 5. The School Construction Law is amended by changing Section 5-5 as follows:

(105 ILCS 230/5-5)

Sec. 5-5. Definitions. As used in this Article:

"Approved school construction bonds" mean bonds that were approved by referendum after January 1, 1996 but prior to January 1, 1998 as provided in Sections 19-2 through 19-7 of the School Code to provide funds for the acquisition, development, construction, reconstruction, rehabilitation, improvement, architectural planning, and installation of capital facilities consisting of buildings, structures, durable-equipment, and land for educational purposes.

"Grant index" means a figure for each school district equal to one minus the ratio of the district's equalized assessed valuation per pupil in average daily attendance to the equalized assessed valuation per pupil in average daily attendance of the district located at the 90th percentile for all districts of the same category. For the purpose of calculating the grant index, school districts are grouped into 2 categories, Category I and Category II. Category I consists of elementary and unit school districts. The equalized assessed valuation per pupil in average daily attendance of each school district in Category I shall be computed using its grades kindergarten through 8 average daily attendance figure. A unit school district's Category I grant index shall be used for projects or portions of projects constructed for elementary school pupils. Category II consists of high school and unit school districts. The equalized assessed valuation per pupil in average daily attendance of each school district in Category II shall be computed using its grades 9 through 12 average daily attendance figure. A unit school district's Category II grant index shall be used for projects or portions of projects constructed for high school pupils. The changes made by this amendatory Act of the 92nd General Assembly apply to all grants made on or after the effective date of this amendatory Act, provided that for grants not yet made on the effective date of this amendatory Act but made in fiscal year 2001 and for grants made in fiscal year 2002, the grant index for a school district shall be the greater of (i) the grant index as calculated under this Law on or after the effective date of this amendatory Act or (ii) the grant index as calculated under this Law before the effective date of this amendatory Act. The grant index shall be no less than 0.35 and no greater than 0.75 for each district; provided that the grant index for districts whose equalized assessed valuation per pupil in average daily attendance is at the 99th percentile and above for all districts of the same type shall be 0.00.

"School construction project" means the acquisition, development, construction, reconstruction, rehabilitation, improvement, architectural planning, and installation of capital facilities consisting of buildings, structures, durable equipment, and land for educational purposes.

"School district" includes a cooperative high school, which shall be considered a high school district for the purpose of calculating its grant index.

"School maintenance project" means a project, other than a school construction project, intended to provide for the maintenance or upkeep of buildings or structures for educational purposes, but does not include ongoing operational costs.

AMENDMENT NO.   1  . Amend House Bill 1000 by replacing the title with the following:

"AN ACT concerning professional regulation."; and  
by replacing everything after the enacting clause with the following:

"Section 5. The Pyrotechnic Operator Licensing Act is amended by changing Sections 5 and 30 as follows:

(225 ILCS 227/5)

Sec. 5. Definitions. In this Act:

"Display fireworks" means any substance or article defined as a Division 1.3G ~~or 1.4~~ explosive by the United States Department of Transportation under 49 CFR 173.50, except a substance or article exempted under the Fireworks Use Act.

"Fireworks" has the meaning given to that term in the Fireworks Use Act.

"Lead pyrotechnic operator" means the individual with overall responsibility for the safety, setup, discharge, and supervision of a pyrotechnic display.

"Office" means Office of the State Fire Marshal.

"Person" means an individual, firm, corporation, association, partnership, company, consortium, joint venture, commercial entity, state, municipality, or political subdivision of a state or any agency, department, or instrumentality of the United States and any officer, agent, or employee of these entities.

"Pyrotechnic display" or "display" means the detonation, ignition, or deflagration of display fireworks to produce a visual or audible effect of an exhibitional nature before the public, invitees, or licensees, regardless of whether admission is charged.

(225 ILCS 227/30)

Sec. 30. Rules. The State Fire Marshal shall adopt all rules necessary to carry out its responsibilities under this Act including rules requiring the training, examination, and licensing of lead pyrotechnic operators engaging in or responsible for the handling and use of Division 1.3G (Class B) ~~and 1.4 (Class C)~~ explosives. The test shall incorporate the rules of the State Fire Marshal, which shall be based upon nationally recognized standards such as those of the National Fire Protection Association (NFPA) 1123 guidelines for outdoor displays and NFPA 1126 for indoor displays. The Fire Marshal shall adopt rules as required for the licensing of a lead pyrotechnic operator involved in an outdoor or indoor pyrotechnic display.

## RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

### HOUSE RESOLUTION 1261

Offered by Representative Nekritz:

WHEREAS, Illinois has a competitive advantage over other states with our extensive network of railroads that are the envy of other states; and

WHEREAS, Our passenger train service is not up to par with other states and a faint echo of the passenger train service enjoyed by other Western nations; and

WHEREAS, The City of Chicago is a rail hub of the nation, with dozens of different lines converging in downtown Chicago, creating economic opportunities but also massive gridlock that affects freight and passenger train service all over the State of Illinois; and

WHEREAS, The CREATE (Chicago Region Environmental and Transportation Efficiency) Program is a proposed \$1.5-billion modernization of the freight and passenger rail infrastructure serving Chicago and northeast Illinois that will improve passenger rail service, reduce freight rail and highway congestion, eliminate numerous conflicts between rail and road traffic, reduce motorist delays, and enhance safety; and

WHEREAS, The plan calls for creation of five rail corridors through the city, including one primarily for passenger trains, improvements at 33 grade crossings in the Chicago region, and the opening of a key corridor in downtown Chicago for commercial development; and

WHEREAS, The private railroad companies are contributing a significant amount of funds to the project, along with the City of Chicago and the federal government; and

WHEREAS, The federal government's share of the program has not been appropriated or authorized; and

WHEREAS, The State's \$200 million investment in upgrading the track between Chicago and St. Louis relies on the CREATE Program to improve service from Joliet to Chicago; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, That we call on the Congress and the President to work to secure full funding for the CREATE Program; and be it further

RESOLVED, That we call on the Congress and the President to work to secure federal funding to complete the necessary infrastructure work on the Chicago-Springfield-St. Louis corridor; and be it further

RESOLVED, That we call on Governor Blagojevich to include sufficient funding in the State's 2006 budget to increase service on the Chicago-Springfield-St. Louis corridor from three daily departures to five daily departures; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, each member of the Illinois congressional delegation, and the Governor.

### HOUSE RESOLUTION 1266

Offered by Representative Saviano:

WHEREAS, The status of fragmented building requirements in Illinois is of serious concern to those involved in building, design, and construction; and

WHEREAS, Of the 102 counties in this State, less than half have adopted a building code; and

WHEREAS, Over 40 states have adopted some portion of a model building code; and

WHEREAS, Illinois already has adopted a statewide plumbing code and a statewide accessibility code; and

WHEREAS, Building codes promote public safety; and

WHEREAS, Illinois does not have a statewide building code, but does have a collection of building requirements not equitably administered and enforced within the construction industry; and

WHEREAS, Illinois citizens are entitled to safe, affordable, and responsible accommodations; therefore,

be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created a Task Force on a Uniform Building Code for the purpose of examining and making recommendations pertaining to the adoption of a uniform building code for the State of Illinois; and be it further

RESOLVED, That the Task Force shall be comprised of 2 House members, one appointed by the Speaker of the House and one appointed by the House Minority Leader; 2 Senate members, one appointed by the Senate President and one appointed by the Senate Minority Leader; one person appointed by the Governor; one person appointed by an organization representing home builders; one person appointed by an organization representing roofing contractors; one person appointed by an organization representing the plumbing industry; one person appointed by an organization representing the construction industry; one person appointed by an organization representing architects; one person appointed by an organization representing structural engineers; one person appointed by an organization representing building trades; one person appointed by an organization representing realtors; one person appointed by an organization representing code administrators; one person appointed by an organization representing municipal governments in the State; one person appointed by the Office of the State Fire Marshal; and representatives of any other organizations who express interest in writing of their participation to the Illinois Building Commission or its successor agency; and be it further

RESOLVED, That the Task Force members shall serve on a voluntary basis and shall be responsible for any costs associated with their participation in the Task Force; and be it further

RESOLVED, That the Task Force shall meet a minimum of 4 times; and be it further

RESOLVED, That the Illinois Building Commission or its successor agency shall facilitate the Task Force and shall summarize its findings and recommendations in a written report to the Governor and the General Assembly no later than May 1, 2005.

#### HOUSE RESOLUTION 1273

Offered by Representative Hultgren:

WHEREAS, It is with great sadness that the members of the House of Representatives of the State of Illinois have learned of the death of United States Marine Lance Corporal Nicholas Larson of Wheaton who died while proudly serving his country in combat in Iraq; and

WHEREAS, Nicholas Larson, 19, was the son of Anne and David Larson of Wheaton, Illinois; and

WHEREAS, Lance Corporal Larson was a 2003 graduate of Wheaton North High School, who selflessly volunteered to serve in the U.S. armed services as his father and grandfather had done before him; and

WHEREAS, Lance Corporal Larson was attached to the 1st Battalion, 1st Marine Division based out of Camp Pendleton, California and proudly served the nation as an infantryman; and

WHEREAS, Even in high school, Aaron diligently prepared himself for military service, hanging a rope in the back yard to work on navy seal exercises, and lifting weights after school to prepare himself for the rigors of enlistment; and

WHEREAS, On November 9, 2004, Lance Corporal Larson was killed during combat operations to capture the Iraqi city of Fallujah from Islamic insurgents and will be remembered by many as a hero; and

WHEREAS, The passing of Lance Corporal Larson has been deeply felt by many, especially his parents, Anne and David Larson; sister Katie; maternal grandparents, Patrick and Virginia O'Sullivan; and his many aunts, uncles, cousins and friends; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we honor U.S. Marine Lance Corporal Nicholas Larson for his commitment, dedication, and sacrifice in the service of his family, community, and country; and be it further

RESOLVED, That we pray for the safety and well-being of Lance Corporal Larson's fellow service members as they continue to stand in harm's way in service in Iraq and around the world; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the family of Lance Corporal Nicholas Larson, as an expression of our deepest sympathy for their loss.

#### AGREED RESOLUTIONS

The following resolutions were offered and placed on the Calendar on the order of Agreed Resolutions.

HOUSE RESOLUTION 1257

Offered by Representative Mendoza:

WHEREAS, The People's Republic of China is participating in the expansion of the Chicago Public Schools' internationally recognized Chinese World Language Program by donating 1,000 Mandarin language books in a ceremony at McCormick Elementary School in Chicago, Illinois on November 18, 2004; and

WHEREAS, This first annual donation represents an important contribution to Chicago's Chinese World Language Program, a program that is recognized by the Chinese National Office of Teaching Chinese as a Foreign Language as a model program; and

WHEREAS, This donation lays a foundation for the further expansion of the program, including three additional schools, which will provide more than 1,000 new slots for students, which currently includes 2,320 students at 12 Chicago Public Schools; and

WHEREAS, The generous gift of the Chinese people will help to connect Illinois students with relevant language and cultural skills, prepare them for an increasingly global marketplace, connect Illinois schools and educators with those in China, and strengthen a bond with the Chinese people; therefore, be it
