**HOUSE RESOLUTIONS**

**HOUSE RESOLUTION 100**

Offered by Representative Hamos:

WHEREAS, The members of the House of Representatives of the State of Illinois congratulate Rotary International on its 100th anniversary; and

WHEREAS, To celebrate Rotary's centennial anniversary, the organization is taking time to reflect on all its accomplishments over the years; throughout 2005, there will be several events and volunteer efforts that will carry on the spirit of service to the community that began so many years ago; and

WHEREAS, Rotary International was established in Chicago on February 23, 1905 by Paul P. Harris; Mr. Harris founded Rotary International with the mission of promoting benevolence amongst club members and the community; as Rotary International began to expand, so did its mission of service to the community; with a motto of "Service Above Self", they inspire members to provide humanitarian service, encourage high ethical standards, and promote good will and peace throughout the world; and

WHEREAS, The Rotary Foundation, a not-for-profit organization, was formed in 1928 for the purpose of funding the many projects sponsored by Rotary International; today, contributions to the foundation total more than \$80 million dollars annually; this money supports a wide range of programs that enable citizens of the world to function better within their communities; and

WHEREAS, In 1985, Rotary International began one of its most ambitious missions, and that was to eradicate the world of polio; through their program, Polio Plus, they coordinated with the World Health Organization, U.S. Centers for Disease Control and Prevention, and UNICEF to provide polio immunizations to children around the world; and

WHEREAS, Rotary International has grown exponentially over the last 100 years; from its humble beginnings in Chicago to a world-wide organization, Rotary now boasts 1.2 million members who belong to over 31,000 clubs in more than 165 countries; in Illinois alone, there are 14,500 Rotary members in 330 different clubs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we do hereby proclaim February 23, 2005 as Rotary International Day in Illinois and encourage all citizens to be cognizant of the many great services this organization provides to people throughout the world.

**HOUSE RESOLUTION 102**

Offered by Representative Holbrook:

WHEREAS, The price of natural gas in the United States is already the highest in the industrial world, has spiked again, and shows continued volatility; and

WHEREAS, According to the federal Energy Information Administration, total natural gas demand is projected to grow by 48% over the next 25 years; and

WHEREAS, The United States and the State of Illinois are increasingly reliant on natural gas in our energy supply, creating an imbalance between natural gas supply and demand; and

WHEREAS, Higher natural gas costs are passed on to consumers in the form of spiraling home heating bills, more expensive food, and higher prices for many pharmaceuticals and consumer goods; and

WHEREAS, The volatility of natural gas prices is having a negative effect on metal-treating, chemical, fertilizer, plastics, aluminum, and steel producers as well as the agricultural sector; and

WHEREAS, The chemical and plastics industries of the United States, once leading exporters, now have large trade deficits, in part due to rising natural gas prices, and have lost more than \$500 billion in business to overseas competition and more than 90,000 jobs; and

WHEREAS, Thousands of jobs in Illinois are threatened in industries using natural gas as a raw material, including the chemistry industry; and

WHEREAS, The chemistry industry annually generates a total of 351,000 jobs and \$23 billion worth of chemistry products in the State of Illinois, with exports totaling \$3.5 billion; and

WHEREAS, The natural gas imbalance is a multi-faceted issue and will require various solutions, including, but not limited to, increased production, improved energy efficiency, greater conservation, and increased importation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the President and the Congress of the United States of America to enact legislation in the 109th Congress establishing a domestic energy policy that will ensure an adequate supply of energy and the appropriate infrastructure and that includes a concerted national effort to promote greater energy efficiency and produce a political consensus that will open promising new areas for environmentally responsible natural gas production; and be it further

RESOLVED, That suitable copies of this resolution be presented to the President of the United States, the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois congressional delegation.
