The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 106

Offered by Representative Miller:

WHEREAS, The Illinois economy is transforming; despite having the nation's fifth largest state economy, the State ranked only 35th in economic growth over the last 15 years; and

WHEREAS, Illinois' economic growth is lagging because we are losing good jobs; between 1990 and 2005, the number of manufacturing jobs in Illinois declined by 24.3%, or 222,500; during this same period, 34% of job growth occurred in education, health services, and hospitality, sectors that currently pay, on

average, 29% less than manufacturing jobs; adjusted for inflation, median wages have declined leaving families with the same income they had in 1989; nearly 685,000 working Illinoisans earn less than the living wage for a single adult - \$17,950 annually; and

WHEREAS, 40% of new job growth will be in mid- to high-wage sectors; manufacturers will continue to be a major employer, but most of these jobs will require increasingly sophisticated levels of skill; in fact, over 35% of Illinois' new jobs will require an associate degree or higher and 71% of the highest wage jobs will require a post-secondary degree; and

WHEREAS, To attract high wage jobs, Illinois will need high-skilled workers; but, at the same time that our economy demands skilled workers in order to remain competitive and thrive, federal funds for workforce development continue to shrink, after adjusting for inflation; and

WHEREAS, It is time for Illinois to make a new commitment; about 594,000 twenty-five to fifty-four year olds have no high school diploma or equivalent; 60% of these working age individuals are without an associate degree or higher; just 35% of Illinois' young adults are enrolled in postsecondary education; over the next 15 years, 33% of the State's labor force will retire and the fastest growing segments of our population who must replace them have generally lower education levels; and

WHEREAS, Strong workforce development is a key driver of long-term business retention and growth; additionally, Illinois must use its economic development policies strategically targeting disadvantage areas to foster high-wage job creation and to leverage infrastructure investments; these are the tools that can ensure Illinois' families, businesses, and communities enjoy a prosperous future; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that, to compete successfully in a global economy and end poverty, Illinois needs an integrated economic and workforce development policy that works for everyone and that includes producing skilled workers in strong businesses with good jobs that foster thriving communities; and be it further

RESOLVED, That this new policy must provide lasting value to Illinois' 10 economic regions and offer sustainable programming that allows for the flexibility necessary to address regional differences in the economy, business climate and the workforce; and be it further

RESOLVED, That the General Assembly create, upon passage of this resolution, a bipartisan task force that shall hold public hearings, gather evidence, develop, and propose legislation and ultimately furnish a report that will:

- (1) Ensure Illinoisans develop the skills businesses demand in a modern economy.
- (2) Create career paths and job opportunities for all working-age Illinoisans, from the least skilled and most disadvantaged to middle income workers whose skills have become obsolete.
- (3) Invest resources in the capital and human infrastructure needed to attract and retain "high road" employers that provide quality jobs, wages, and benefits.
- (4) Encourage entrepreneurship, small business growth, technology transfers from Illinois' higher education system, and other economic/workforce development innovation in all communities across Illinois to grow competitive State businesses.
 - (5) Support economic and workforce development that is environmentally, socially, and economically sustainable.

HOUSE RESOLUTION 107

Offered by Representative Bill Mitchell:

WHEREAS, Medical schedule reports from the Department of Healthcare and Family Services state that as of January 12, 2007 nearly \$1.2 billion dollars in unpaid Medicaid claims are pending; and

WHEREAS, Because Illinois is so far behind on paying Medicaid bills, doctors, pharmacies, hospitals, and other medical providers are faced with the decision to limit care provided to Medicaid-covered individuals or find ways to remain economically viable such as securing loans and exhausting lines of credit; and

WHEREAS, The amount of unpaid Medicaid bills at the end of FY 2007 is expected to continue to grow to a total of at least \$1.5 billion; and

WHEREAS, The payment cycle for Medicaid providers is expected to grow to an average of 68 days by the end of FY 2007, and the cycle for non-expedited providers will be considerably higher considering that some providers are promised payments based on a 30-day payment cycle; and

WHEREAS, The FY 2006 budget under-funded pensions by \$1.2 billion compared to the funding schedule established by the 1995 Pension Funding Law; and

WHEREAS, The FY 2007 budget under-funds pensions by another \$1.1 billion, bringing the two-year pension diversion to a total of \$2.3 billion; and

WHEREAS, Even though \$2.3 billion in funding has been diverted from the funding of pensions, the Medicaid payment cycle and bills on hand at the end of the fiscal year continue to endanger the ability of Medicaid providers to continue to provide services to the needy; and

WHEREAS, At the same time that Medicaid bills go unpaid and pensions go under-funded, recent budgets have contained funding for member initiatives and special add-on projects benefiting only a small portion of the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that until sufficient funding is appropriated to bring the Medicaid payments cycle down to an average of 30 days and pensions are funded based on a funding schedule consistent with the guidelines of the original 1995 Pension Funding Law, future budgets should not contain appropriations for member initiatives or special add-on projects benefiting only a small portion of the State; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Governor of the State of Illinois.

HOUSE RESOLUTION 109

Offered by Representative Cross:

WHEREAS, Ronald Edward Santo was born on February 25, 1940 in Seattle, Washington; he and his wife Vicki have four children, Ron Jr., Jeff, Linda, and Kelly, as well as two grandsons, Samuel and Spencer; and

WHEREAS, At the age of 18, and just prior to signing with the Chicago Cubs, Ron Santo was diagnosed with Type 1 diabetes; nevertheless, he became one of the best third basemen in all of Major League Baseball, playing for the Chicago Cubs from 1960 through 1973 and for the Chicago White Sox in 1974; and

WHEREAS, During his career, Ron Santo won five consecutive Rawlings Gold Glove awards, was a nine-time National League All-Star selection, batted .277 during his career with 342 home runs and 1,331 RBI; he also led the National League in walks four times and in triples once; he hit 337 home runs with the Cubs, the fourth highest total in Cubs history, and ranks among the Cubs' all time top 10 in games played, at-bats, runs scored, hits, total bases, doubles, RBI, extra-base hits, bases on balls, slugging percentage, and batting average; and

WHEREAS, Ron Santo was the first third baseman to hit over 300 home runs and win five Gold Gloves; and

WHEREAS, After retiring from baseball, Ron Santo was a member of the inaugural Cubs Walk of Fame Class of 1992 and was selected to the Cubs' All-Century team in 1999; Ron Santo has also been inducted into the Seattle Hall of Fame, the Italian Hall of Fame, and the Chicago Sports Hall of Fame; in addition, Ron Santo has been a WGN Radio color commentator for the Cubs since 1990, completing his 17th season in 2006; and

WHEREAS, Ron Santo's extraordinary accomplishments extend far beyond baseball; in addition to his duties as a Chicago Cubs commentator, Ron Santo has been involved with the Juvenile Diabetes Research Foundation since 1974, and is currently a member of the Foundation's Board of Directors; he has personally known the hardships that diabetes can have on an individual, having both of his legs amputated due to complications with diabetes; through Ron Santo's involvement with the Juvenile Diabetes Research Foundation, together they have raised over \$63 million for diabetes research; he was also instrumental in helping the Juvenile Diabetes Research Foundation form a partnership with charitable organizations Cubs Care and WGN Radio 720 Neediest Kids Fund in order to raise more money for those organizations, as well as more money for the Foundation for additional diabetes research; in 2002, he was the Juvenile Diabetes Research Foundation's Person of the Year; and

WHEREAS, In recognition of his greatness and accomplishments, both on and off the field, on September 28, 2003, the Chicago Cubs organization retired Ron Santo's number, #10, in honor of all that Ron Santo has achieved in his life; Ron Santo became only the third player in Cubs history to have his number retired by the Chicago Cubs, joining Hall of Fame inductees Ernie Banks (#14) and Billy Williams

(#26); therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that because of all Ron Santo has accomplished throughout his life, and because Ron Santo is eligible for election by the Veterans Committee of the Baseball Hall of Fame, we, along with the entire State of Illinois, strongly urge the Veterans Committee to elect Ron Santo to the Baseball Hall of Fame; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Veterans Committee of the Baseball Hall of Fame; and that a suitable copy of this resolution be presented to Mr. Santo as an expression of our sincere respect and esteem.

HOUSE RESOLUTION 110

Offered by Representative Schock:

WHEREAS, All Americans should be paid a living wage for the work they perform; and

WHEREAS, The State of Illinois has recently enacted legislation that will increase the minimum wage in this State from its current level, in stages, from \$6.50 per hour currently to \$8.25 per hour on July 1, 2010; and

WHEREAS, Many other American states have minimum wage levels much lower than \$8.25 per hour, making these states more attractive for many employers to relocate to if they have substantial needs for entry level employees; under current Illinois law, those other states will be viewed as better places for many employers to create jobs and hire new workers at the expense of people living in Illinois; and

WHEREAS, As the United States forms a single marketplace, all wage levels, including the minimum wage, should trend towards a common level, including a nationwide minimum wage for all American workers who are citizens or persons legally entitled to work in the United States; and

WHEREAS, On a trip to Springfield, Illinois in November 2006, U.S. House Majority Leader, Steny Hoyer, incisively stated the concern, "Frankly, in my opinion this needs to be national law so we don't have states competing with one another on either going to the bottom on the minimum wage or going to a level that makes them uncompetitive. It's much better to have a national law."; and

WHEREAS, The efforts of the State of Illinois to provide a living wage will be greatly strengthened if the nation as a whole adopts a standard, adequate minimum wage that eliminates competitive disparities on the minimum wage between states and especially our neighboring states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Congress of the United States should wield its constitutional power to create a single common minimum wage, at least at a level of \$8.25 per hour by July 1, 2010, for the United States of America; and be it further

RESOLVED, That the common minimum wage should provide an adequate hourly income for all American workers; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Majority Leader of the United States Senate, the Minority Leader of the Senate, the Speaker of the United States House of Representatives, the Minority Leader of the House of Representatives, and to each member of the Illinois congressional delegation.

HOUSE RESOLUTION 113

Offered by Representative Ryg:

WHEREAS, Untreated mental health problems in children have serious fiscal consequences for the State because they affect children's ability to learn and increase their propensity for violence, alcohol and substance abuse, and other delinquent behaviors that are extremely costly to treat; and

WHEREAS, One in 10 children in Illinois suffers from a mental illness severe enough to cause some level of impairment; yet, in any given year only about 20% of these children receive mental health services; and

WHEREAS, Many mental health problems are largely preventable or can be minimized with prevention and early intervention services that have been shown to be effective and that reduce the need for more

costly interventions; and

WHEREAS, Children's social development and emotional development are essential underpinnings to school readiness and academic success; and

WHEREAS, A comprehensive, coordinated children's mental health system can help maximize resources and minimize duplication of services; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge that the following be included in amounts appropriated for State services in Fiscal Year 2008:

- (1) A continued appropriation of the current \$5,000,000 under the Children's Mental Health Partnership line items (that is, \$3,000,000 in the Illinois State Board of Education budget and \$2,000,000 in the Illinois Department of Human Services budget);
- (2) An additional \$15,000,000 in appropriations under Children's Mental Health Partnership line items allocated as described in paragraph (3); and
- (3) Allocation of \$20,000,000 for the Illinois Children's Mental Health Partnership as follows:
- (A) Allocation of \$10,000,000 under the Children's Mental Health Partnership line item in appropriations to the Department of Human Services for: the Children's Mental Health Consultation Project; Birth to Five Treatment Services; Screening, Assessment, and Support Services (SASS) aftercare services; Early Intervention Services; the Family Leadership and Support Network; and the Children's Mental Health Public Awareness Campaign;
- (B) Allocation of \$6,000,000 under the Children's Mental Health Partnership line item in appropriations to the Illinois State Board of Education for: Social and Emotional Learning Standards Professional Development and Implementation; expansion of Positive Behavior Intervention and Supports (PBIS); and increased School based Mental Health Support Services;
- (C) Allocation of \$3,500,000 under the Children's Mental Health Partnership line item in appropriations to the Department of Children and Family Services for: Transitional Services; and Trauma Services; and
- (D) Allocation of \$500,000 under the Children's Mental Health Partnership line item in appropriations to the Illinois Violence Prevention Authority for the Children's Mental Health Policy and Research Center; and be it further

RESOLVED, That copies of this resolution be delivered to each of the following: the Governor; the State Superintendent of Education; the Secretary of Human Services; the Director of Children and Family Services; and the Attorney General.

HOUSE RESOLUTION 115

Offered by Representative Tryon:

WHEREAS, School impact fees are an ongoing problem in many Illinois communities that are experiencing high population growth; and

WHEREAS, The Illinois School Impact Fee Task Force was created by House Resolution 1006 of the 93rd General Assembly for the purpose of studying impact fees in Illinois; the Task Force was unable to complete its work in the allotted time frame; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is established the Illinois School Impact Fee Task Force for the purposes set forth in House Resolution 1006 of the 93rd General Assembly; and be it further

RESOLVED, That the Task Force shall consist of the following members: (i) 2 members of the House of Representatives, or their designees, appointed by the Speaker of the House, one of whom shall serve as co-chairperson of the Task Force; (ii) 2 members of the House of Representatives, or their designees, appointed by the Minority Leader of the House, one of whom shall serve as co-chairperson of the Task Force; (iii) 2 members of the public, one of whom shall be appointed by the Speaker of the House and one of whom shall be appointed by the Minority Leader of the House; (iv) 2 members appointed by an association that represents school administrators; (vi) 2 members appointed by an association that represents realtors; (viii) one member appointed by an association that represents municipalities; (ix) one representative of municipal government; and (x) one representative of

county government; and be it further

RESOLVED, That the School Impact Fee Task Force shall present a report of its findings to the General Assembly by January 1, 2009.

HOUSE RESOLUTION 117

Offered by Representative Froehlich:

WHEREAS, Worldwide exposure to chemical pesticides brings about greater harm than most people realize; and

WHEREAS, More than 3 billion kilograms of pesticides are spread on the earth annually, exposing both human and wildlife populations to chemicals, with potentially serious repercussions for life everywhere; and

WHEREAS, Our children are uniquely vulnerable to chemical pesticides due to their developing physiology and to their habit of frequently putting their hands into their mouths; and

WHEREAS, Chemical pesticides applied outdoors are washed into our waterways and our drinking water sources; several types of cancer, neurological diseases, endocrine disorders, and birth defects have all been associated with exposure to common pesticides; and

WHEREAS, Pregnant women, children, asthmatics, cancer patients, the elderly, and other immune compromised people and migratory birds are all highly vulnerable to toxic effects of chemical pesticides; and

WHEREAS, More than 40 years ago, the well-known writer, scientist, and ecologist Rachel Carson alerted America and the world to the potential hazards of pesticides in her landmark book, Silent Spring; despite the warning, the quantity of pesticides used in our country has continued to grow over the years and poses a potential threat to all life forms; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim May 27, 2007 as Rachel Carson Day throughout the State of Illinois in honor of her prophetic work, and urge the citizens of the State of Illinois to focus their attention on the potentially serious hazards associated with chemical pesticides; and be it further

RESOLVED, That we invite citizens throughout the State of Illinois to observe this day, the birth date of Rachel Carson, by refraining from using chemical pesticides on this day and ask the citizens of the State of Illinois for their cooperation in seeking alternative methods of pest management.

HOUSE JOINT RESOLUTION 19

Offered by Representative Currie:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that that part of Interstate Route 90 of the National System of Interstate and Defense Highways, which is in the State of Illinois between the intersection with Interstate Route 294 and the State line with Wisconsin, is hereby designated as the Jane Addams Memorial Tollway; and be it further

RESOLVED, That the Illinois State Toll Highway Authority is requested to erect at suitable locations, consistent with State regulations, appropriate plaques or signs giving notice of the designation.

HOUSE JOINT RESOLUTION 20

Offered by Representative Reis:

WHEREAS, Workers' compensation laws provide workers important protection from the economic hardship wrought by injuries and diseases caused by employment; and

WHEREAS, Illinois employers favor a workers' compensation system that not only treats injured workers appropriately and fairly but also minimizes unnecessary costs, prevents abuse, and settles disputes

quickly and impartially; and

WHEREAS, The General Assembly and Governor approved significant changes to the law in 2005, yet both Illinois workers and employers have continued concerns about the current state of workers' compensation laws, and both desire to make changes to improve the law for both workers and employers; and

WHEREAS, The workers' compensation system should equitably remunerate Illinois physicians and health care providers for services rendered to relieve employees of work-related injuries and diseases; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that a Workers' Compensation Reform Task Force shall be created to bring together legislators and stakeholders to consult each other and the public for the purpose of gathering information and recommending reforms to workers' compensation laws; and be it further

RESOLVED, That the Speaker of the House, the Minority Leader of the House, the President of the Senate, and the Minority Leader of the Senate shall each make 2 appointments to the Task Force and each appointee shall be a member of the General Assembly; and be it further

RESOLVED, That the Chairman of the Illinois Workers' Compensation Commission and the Director of the Division of Insurance shall act as ex-officio members of the Task Force; and be it further

RESOLVED, That additional members shall be appointed from organizations as follows: one member appointed by the Illinois Manufacturers Association; one member appointed by the Illinois Retail Merchants Association; one member appointed by the Illinois State Chamber of Commerce; one member appointed by the Illinois chapter of the National Federation of Independent Business; one member appointed by the Associated General Contractors of Illinois; one member appointed by the Illinois State Medical Society; one member appointed by the Illinois Hospital Association; and three members appointed by the Illinois AFL-CIO; and be it further

RESOLVED, That all members appointed to the Task Force shall receive no compensation for serving as a member but shall be eligible to receive reimbursement for reasonable costs associated with membership if such funds are appropriated; and be it further

RESOLVED, That 2 Task Force co-chairpersons, who are members of the General Assembly, shall be nominated and elected by Task Force members to preside as co-chairpersons over meetings of the Task Force; and be it further

RESOLVED, That the Task Force shall commence operation no later than August 1, 2007; the Task Force shall conduct public hearings at the call of the co-chairpersons; at least one hearing shall be scheduled and convened in each of the 10 Illinois Entrepreneurship Network Regions currently designated by the Department of Commerce and Economic Opportunity; time shall be allotted for members of the public to offer remarks at meetings of the Task Force; and a report detailing the findings and recommendations of the Task Force for reform of workers' compensation laws shall be presented to the Governor and the General Assembly no later than March 15, 2008; and be it further

RESOLVED, That the Task Force Report shall address each of the following issues, among other workers' compensation issues and topics without limit: (i) an analysis of the 2005 statutory changes to the workers' compensation medical provisions and how employer costs and access and quality of care to injured workers have been impacted; (ii) recommendations to combat and prevent abuse and fraud within the workers' compensation system; (iii) recommendations for the provision of adequate compensation for workers and families of workers for lost wages while off work and future lost wages because of injury or disease that also allows Illinois employers to be competitive regionally and globally; (iv) the existence and adequacy of programs that promote and encourage workplace safety and injury and disease prevention; (v) an analysis of workers' compensation benefits and costs to employers in states adjacent to Illinois with recommendations to help Illinois employers compete with companies in states with lower workers' compensation costs; and (vi) an analysis and recommendations as to the ability of the Illinois Workers' Compensation Commission to mediate and adjudicate disputes in a timely and impartial manner.

HOUSE JOINT RESOLUTION 21

Offered by Representative Turner:

WHEREAS, House Joint Resolution 80 which established the Long-Term Prisoners Study Committee

was adopted by both houses of the Ninety-Fourth General Assembly; and

WHEREAS, The Long-Term Prisoners Study Committee was directed to: consider whether life without parole and long-term sentences in excess of 30 years are necessary for public safety and provide the best use of State funds; and report its findings and recommendations to the General Assembly in a final report which was to be filed on or before June 1, 2007; and

WHEREAS, The Long-Term Prisoners Study Committee does not have sufficient time to carry out its duties before the June 1, 2007 date set for its report and recommendations; and

WHEREAS, The Ninety-Fifth General Assembly needs to reauthorize the Long-Term Prisoners Study Committee with the same membership and charge as the Committee authorized by HJR 80 of the Ninety-Fourth General Assembly and set the date for the report and recommendations as on or before December 31, 2007; and

WHEREAS, As stated in HJR 80, it costs at least \$1,000,000 to confine a person in prison for 30 years; and

WHEREAS, As stated in HJR 80, The recidivism rate for long termers is the lowest of any group of prisoners and a large number of lifers and long-term prisoners are sentenced under the accountability theory and not for the actual commission of the crime, and some are first time offenders; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is hereby established the Long-Term Prisoners Study Committee; and be it further

RESOLVED, That the Committee shall have the following members: 17 members, as follows: 3 members appointed by the President of the Senate, 2 members appointed by the Senate Minority Leader, 3 members appointed by the Speaker of the House of Representatives, 2 members appointed by the House Minority Leader; one member appointed by the Attorney General; one member appointed by the Governor; one member appointed by the Cook County State's Attorney; one member appointed by the Office of the Cook County Public Defender; one member appointed by the Office of the State Attorneys Appellate Prosecutor; and one member appointed by the Director of Corrections; and be it further

RESOLVED, That any member of the Ninety-Fifth General Assembly who was previously appointed to the Committee established by HJR 80 of the Ninety-Fourth General Assembly shall remain as member of the Committee, unless the individual who holds the position responsible for making the appointment determines otherwise; and be it further

RESOLVED, That all actions of the Committee require the affirmative vote of at least 9 members; and be it further

RESOLVED, That the members of the Committee shall select a chairperson; and be it further

RESOLVED, That the Committee shall hold public hearings and shall study and examine issues related to prisoners sentenced to life without parole and prisoners sentenced to terms in excess of 30 years; and be it further

RESOLVED, That the Department of Corrections shall provide staff and administrative support to the Committee; and be it further

RESOLVED, That the Committee shall report its findings and recommendations to the General Assembly in a final report which shall be filed on or before December 31, 2007; the requirement for reporting to the General Assembly shall be satisfied by filing copies of the report with the Speaker, the Minority Leader and the Clerk of the House of Representatives and the President, the Minority Leader and the Secretary of the Senate and the Legislative Research Unit, as required by Section 3.1 of the General Assembly Organization Act, and filing additional copies with the State Government Report Distribution Center for the General Assembly as required under paragraph (t) of Section 7 of the State Library Act; and be it further

RESOLVED, That suitable copies of this Resolution be transmitted to the members of the Committee.

HOUSE JOINT RESOLUTION 22

Offered by Representative Black:

WHEREAS, The increased use of technological devices has created a distraction for drivers in the State of Illinois; and

WHEREAS, The number of traffic accidents resulting from drivers becoming distracted by such

technological devices as cell phones, MP3 players, car stereos, navigation systems, and DVD players has increased in the State; and

WHEREAS, The safety of those using the roadways in Illinois is being compromised by those drivers who use these devices; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is hereby created the Distracted Drivers Task Force that shall study the problem of distracted driving in Illinois, with particular attention to the impact of recent communications technology on this problem; and be it further

RESOLVED, That the Task Force shall consist of 10 members, consisting of the Secretary of State or his or her designee, who shall serve as chair; the Secretary of Transportation or his or her designee; the Director of the State Police or his or her designee; the President of the Illinois State Bar Association or his or her designee; the President of the Illinois Association of Chiefs of Police or his or her designee; one member appointed by the Speaker of the House of Representatives, one member appointed by the Minority Leader of the House of Representatives, one member appointed by the Minority Leader of the Senate; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation but shall reimbursed for actual expenses incurred in the performance of their duties from funds appropriated to the Office of the Secretary of State for that purpose; and be it further

RESOLVED, That the Task Force shall meet no fewer than 3 times and shall present its report and recommendations to the General Assembly no later than July 1, 2007.

HOUSE JOINT RESOLUTION 23

Offered by Representative Tryon:

WHEREAS, The Partnership for Local Government Education is a collaboration formed to increase interest and involvement in local government in the State of Illinois; and

WHEREAS, The Partnership for Local Government Education is composed of the Illinois Association of County Board Members and Commissioners, the Illinois Municipal League, the Township Officials of Illinois, and the University of Illinois Extension; and

WHEREAS, Local government is the branch of government which is closest to the people; and

WHEREAS, Illinois has more local governments than any other state; 6,700 local governments, an estimated 70,000 elected officials, and 100,000 appointed officials, providing critical services to the citizens of the State of Illinois and our communities; and

WHEREAS, Citizens do not have a clear understanding of the functions of local government; and

WHEREAS, The mission of the Partnership is to further the understanding of the role that local government plays in individual lives and collectively, and appreciate the many services that the various forms of local governments provide their constituents; and

WHEREAS, "Local Government Week" focuses attention on the need for strong, independent and active local government in this State and recognizes the valuable contributions made by citizens serving their communities in public office; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that in recognition of the Partnership for Local Government Education and the leadership, innovation, and valuable service provided by our State's local elected and appointed official, we proclaim the week of March 4-10, 2007, and the first full week of March each year thereafter, as "Local Government Week" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Partnership for Local Government Education as an expression of our esteem.

HOUSE JOINT RESOLUTION 24

Offered by Representative Pihos:

WHEREAS, In the 2005-2006 school year, over 322,000 children with disabilities were served in special education programs across Illinois; and

WHEREAS, The number of children in special education programs has risen 5.4% in the last 5 years, and special education accounts for approximately 23% of all State education spending; and

WHEREAS, The federal government has established a goal of reimbursing 40% of the costs of special education incurred by school districts, but it currently provides only 18% of costs nationally and only 14% in Illinois; and

WHEREAS, Illinois has failed for decades to update reimbursement rates for special education costs, with the last reimbursement rate set in 1973 for special education orphanage tuition, in 1985 for special education personnel, in 1978 for special education private tuition, in 1976 for special education summer school, and in 1965 for special education transportation; and

WHEREAS, Illinois has continued to prorate special education mandated categoricals at less than 100%, with the FY07 budget prorating these mandated categoricals at 97%; and

WHEREAS, Even if Illinois fully funded mandated categoricals at 100%, this would still only represent partial funding, as the reimbursement rates are severely outdated; and

WHEREAS, Illinois school districts currently spend an estimated \$1 billion from their own general education funds to meet the unreimbursed costs of special education services that are mandated by federal and State laws and administrative rules; and

WHEREAS, Special education continues to represent a growing financial burden on school districts as the need for services increases while State and federal funding fails to increase along with that need; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that a task force shall be created to study current special education funding needs and to make recommendations as to how the State can increase special education funding and ease the financial burden on school districts; and be it further

RESOLVED, That the task force shall consist of the State Superintendent of Education (or his or her designee) plus 16 members appointed as follows: the House Majority Leader and the House Minority Leader shall each appoint one representative, the Senate President and the Senate Minority Leader shall each appoint one senator, and these 4 leaders shall each appoint 3 public members representing the interests of special education administrators and services, school districts, and disability advocates; and be it further

RESOLVED, That the task force shall be facilitated by the State Board of Education; and be it further

RESOLVED, That the task force shall report its findings and recommendations to the Governor and the General Assembly by January 1, 2008; and be it further

RESOLVED, That a suitable copy of this resolution be transmitted to the State Superintendent of Education.

HOUSE JOINT RESOLUTION 25

Offered by Representative Winters:

Whereas, Each year, some adults intentionally ingest antifreeze to commit suicide and children are accidentally exposed to antifreeze that is left unattended or in open containers; and

Whereas, Pets and other animals can die from mistakenly ingesting antifreeze that has leaked, spilled, or is carelessly left in improperly secured containers in the garage or driveway; and

Whereas, The National Safety Council, the American Medical Association, and the American Association of Poison Control Centers have noted that the addition of a nontoxic bittering agent can make antifreeze so unpalatable that adults, children, and animals will reject such products upon tasting them, preventing injury or death; and

Whereas, Legislation has been introduced in the United States Congress to require the inclusion of denatonium benzoate at a minimum of 30 parts per million as a bittering agent to any engine coolant or antifreeze that contains more than 10% ethylene glycol; and

Whereas, The Doris Day Animal League, the Humane Society of the United States, the American Veterinary Medical Association, the Society for Animal Protective Legislation, the Pet Food Institute, the United States Conference of Mayors, the Consumer Specialty Products Association, and the retail antifreeze industry have endorsed this legislation with the goal of protecting consumers and animals; and

Whereas, The State of Illinois supports protecting the health and safety of adults, children, and animals through the inclusion of a bittering agent in ethylene glycol-based antifreeze; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the United States Congress to help protect adults, children, and animals by enacting legislation to require denatonium benzoate be added to antifreeze that contains ethylene glycol; and be it further

Resolved, That we urge the Illinois congressional delegation to help protect adults, children, and animals by supporting the passage of this legislation; and be it further

Resolved, That the Illinois General Assembly urges the President of the United States to advance this legislation this year to help protect adults, children, and animals; and be it further

Resolved, That copies of this resolution be presented to the President of the United States and each member of the Illinois Congressional delegation.

HOUSE JOINT RESOLUTION 26
