WHEREAS, The Commission was required to report no later than December 1, 2006, to the General Assembly, the Governor, and the general public on its activities, accomplishments, and recommendations, and that the Commission was to be dissolved after the filing of this report; and

WHEREAS, As of the required reporting date, the Commission's work was still ongoing and further investigation was needed prior to the preparation and submission of its report; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE

OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Commission to Study the Transatlantic Slave Trade and its Past and Present Effects on African-Americans, organized pursuant to SJR 31 of the 94th General Assembly, is hereby reconstituted; and be it further

RESOLVED, That the Commission shall be comprised of those persons appointed pursuant to SJR 31 of the 94th General Assembly until such time as those appointing authorities established in SJR 31 appoint different persons to the Commission; and be it further

RESOLVED, That the Commission shall have the authority, duties, and purposes as set forth in SJR 31 of the Ninety-fourth General Assembly; and be it further

RESOLVED, That no later than December 31, 2008, the Commission shall report to the General Assembly, the Governor, and the general public on its activities, accomplishments, and recommendations; and that the Commission shall be dissolved after the filing of this report; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor of the State of Illinois.

WHEREAS, The People of the Mountains and their descendants can legitimately claim their Cherokee ancestry and heritage in all capacities, both public and private; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we support the People of the Mountains in their efforts to become a federally-recognized Cherokee Tribe; and be it further

RESOLVED, That we support the efforts of the People of the Mountains to be allowed free access once each year to the Trail of Tears State Forest, including camp sites, to honor their ancestors who died there; and be it further

RESOLVED, That we support the efforts of the People of the Mountains to be allowed free access once each year during the third weekend in May to Pere Marquette State Park, including camp sites, in order to have the opportunity to view the sacred bald eagle in Illinois; and be it further

RESOLVED, That we support the efforts of the People of the Mountains to be permitted to possess sacred items, such as eagle feathers, hawk feathers, and turtle rattles, so long as they are acquired without harming the animals that are the sources of those items.

SENATE JOINT RESOLUTION NO. 30

WHEREAS, Lung cancer is the leading cause of cancer deaths in both men and women in Illinois, the United States, and the world, this year killing more Americans than breast, prostate, and colon cancer combined; and

WHEREAS, There were an estimated 173,000 new cases of lung cancer and an estimate 428 deaths from

lung cancer each day in the United States; and

WHEREAS, There will be an estimated 7,290 new cases of lung cancer in Illinois this year, and there will be an estimated 6,790 deaths from lung cancer this year; and

WHEREAS, Smoking is the number one cause of lung cancer, yet former smokers and persons who have never smoked comprise 60% of the majority of new cases of lung cancer each year; and

WHEREAS, Other causes of lung cancer are exposure to cancer-causing substances or carcinogens, such as asbestos, radon, uranium, arsenic, and certain petroleum products; and

WHEREAS, In the early stages of lung cancer, symptoms are usually not apparent, however, when symptoms occur, the cancer is often advanced; and

WHEREAS, Symptoms of lung cancer include chronic cough, hoarseness, coughing up blood, weight loss and loss of appetite, shortness of breath, fever without a known reason, wheezing, repeated bouts of bronchitis or pneumonia and chest pain; and

WHEREAS, There is currently no standard screening for lung cancer; and

WHEREAS, Funding for lung cancer medical research falls far short of that for other less fatal diseases; and

WHEREAS, To help build awareness and save lives, the Lung Cancer Alliance, a national patient advocacy group for lung cancer dedicated to helping build awareness of this disease, has proclaimed November as Lung Cancer Awareness Month; and

WHEREAS, It is only fitting and proper for the State of Illinois to join the nation in designating November as "Lung Cancer Awareness Month" so that through better education, more cases of lung cancer may be found in the early stage, when the chances of long-term survival are as high as 85 percent; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the month of November annually be designated "Lung Cancer Awareness Month" in the State of Illinois; and be it further

RESOLVED, That the Governor is requested to issue a proclamation calling upon the public officials and the citizens of Illinois to observe the month with appropriate activities and programs annually; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor Rod Blagojevich.

WHEREAS, During the kindergarten years, children often make considerable gains in reading and math; in addition, they begin to develop advanced social skills from the constant interaction that they have with one another; and

WHEREAS, Those different skills and abilities that kindergartners acquire lay the foundation for success at future grade levels; history has shown that in many cases, these children go on to become more competent learners, and are less likely to be held back in school; and

WHEREAS, The Illinois General Assembly is committed to improving education in Illinois at all levels; the State of Illinois is aiming to not only enhance the educational experiences of current students, but also to continue increasing enrollment in pre-school and kindergarten programs in the State; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we proclaim the second Tuesday of September in each year to be Kindergarten Day in the State of Illinois, and we encourage all parents to enroll their children in kindergarten to enhance their abilities and provide their children with better chances to succeed later in life.

SENATE JOINT RESOLUTION NO. 5

WHEREAS, The Illinois General Assembly wishes to present this resolution as a tribute to and acknowledgment of Oprah Winfrey's contributions to the State of Illinois, the nation, and the world; we benefit immensely from her presence in Illinois; and

WHEREAS, Oprah Gail Winfrey was born on January 29, 1954 in Kosciusko, Mississippi; and

WHEREAS, She began her broadcasting career at WVOL radio in Nashville while still in high school; at the age of 19, she became the youngest person and the first African-American woman to anchor the news at Nashville's WTVF-TV; and

WHEREAS, In 1976, she moved to Baltimore, Maryland to join WJZ-TV news as a co-anchor of the Six O'Clock News, and in 1978, discovered her talent for hosting talk shows when she became co-host of WJZ-TV's talk show "People Are Talking", while continuing to serve as anchor and news reporter; in January 1984, she moved to Chicago to host WLS-TV's morning talk show "AM Chicago", which became the number one local talk show just one month after she began; in less than a year, the show expanded to

one hour and, in September 1985, was renamed "The Oprah Winfrey Show"; in 1986, "The Oprah Winfrey Show" was syndicated and aired in 107 countries with 23 million viewers; and

WHEREAS, She has impacted the media of television, publishing, film, philanthropy, education, and health and fitness; and

AMENDMENT NO. 2. Amend House Bill 318, AS AMENDED, by replacing everything after the enacting clause with the following:

"Section 5. The Consumer Fraud and Deceptive Business Practices Act is amended by changing Section 2HH as follows:

(815 ILCS 505/2HH)

Sec. 2HH. Billing and collection practices of utility ~~electric~~ service providers. Each person selling generation, transmission, distribution, metering, or billing of any utility ~~electric~~ service shall display the name, the toll-free telephone number of such service provider, and a description of the services provided on all bills submitted to subscribers of such services. All personal information relating to the subscriber of generation, transmission, distribution, metering, or billing of any utility ~~electric~~ service shall be maintained by the service providers solely for the purpose of generating the bill for such services, and shall not be divulged to any other persons with the exception of credit bureaus, collection agencies, and persons licensed to market utility services ~~electric service~~ in the State of Illinois, without the written consent of the subscriber. Credit bureaus that receive personal consumer information from a utility service provider may not use that information to determine credit scores.

(Source: P.A. 90-561, eff. 12-16-97.)"

The foregoing motion prevailed and Amendment No. 2 was adopted.

There being no further amendments, the foregoing Amendment No. 2 was ordered engrossed; and the bill, as amended, was again advanced to the order of Third Reading.

HOUSE BILL 33. Having been reproduced, was taken up and read by title a second time.

The following amendment was offered in the Committee on Agriculture & Conservation, adopted and reproduced:

AMENDMENT NO. 1. Amend House Bill 33 by replacing everything after the enacting clause with the following:

"Section 5. The Rivers, Lakes, and Streams Act is amended by adding Section 23b as follows:

(615 ILCS 5/23b new)

Sec. 23b. Dams; signs and buoys.

(a) The Department of Natural Resources shall establish specifications for signs and devices that provide

warnings of the presence of dams for persons using the public waters of the State. The Department shall establish such specifications pursuant to administrative rule.

(b) For dams located in public waters and that are not subject to federal regulation regarding safety standards, the Department of Natural Resources shall examine each dam to determine hazards that may exist at each dam.

(c) The Department of Natural Resources shall, after conducting the examination required under subsection (b) of this Section, submit administrative rules setting forth appropriate safety devices to be required at each dam.

(d) The Department of Natural Resources shall be authorized to designate enforceable exclusion zones around dams pursuant to administrative rule. Violation of such exclusion zones shall constitute a Class A misdemeanor.

(e) Except for willful and wanton misconduct, neither the Department of Natural Resources nor employees or agents of the Department shall be liable for damages, injuries, or deaths occurring at dams located in public waters by reason of the Department's regulation thereof pursuant to this Section. Nothing in this Act shall relieve an owner or operator of a dam from the legal duties, obligations, and liabilities arising from ownership or operation.

Section 99. Effective date. This Act takes effect upon becoming law."

There being no further amendments, the foregoing Amendment No. 1 was ordered engrossed; and the bill, as amended, was advanced to the order of Third Reading.

HOUSE RESOLUTION 233

Offered by Representative Richard Bradley:

WHEREAS, It is to the benefit of the State of Illinois to prevent the expenditure of Illinois public

pension funds with out-of-state financial services providers when there are Illinois financial services providers that provide the same returns and risks on investments; and

WHEREAS, It will benefit the economy of the State of Illinois to increase the earnings of qualified Illinois financial service providers and simultaneously satisfy all fiduciary responsibilities of the pension systems; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage all Illinois public pension systems to use, whenever possible without violating fiduciary responsibilities, the Chicago Stock Exchange rather than using a stock exchange based outside of the State of Illinois; and be it further

RESOLVED, That a copy of this resolution be sent to each of the pension systems created under the Illinois Pension Code and to the Illinois State Board of Investment.
