#### **HOUSE RESOLUTION 344**

Offered by Representative Cross:

WHEREAS, We, the members of the Illinois House of Representatives, are bound by our constitutional oath to "provide for the health, safety and welfare of the people" of Illinois, and we recognize this can best be done by having the lowest possible tax burden and by maximizing the number and diversity of jobs and opportunities in Illinois, to make Illinois competitive, fiscally sound, and economically productive; and

WHEREAS, A free, stable, and growing economy, low tax rates, and low prices for Illinois consumers, leads to the creation of the maximum number of new Illinois jobs, whereas higher tax rates and higher prices of goods and services for Illinois consumers would actually destroy Illinois jobs; and

WHEREAS, There are essential public functions that are legitimately filled by government, which derives its just powers from the consent of the governed, including the power to tax the people of Illinois at the minimum rate necessary to fulfill these essential functions; and

WHEREAS, Whenever Illinois taxes are higher than the minimum needed to carry out essential public functions, that government is moving away from the health, safety, and welfare of the people of Illinois, no matter what the motivations are of the people that raise these taxes; and

WHEREAS, A proposed Gross Receipts Tax may soon be imposed upon all Illinois goods and services

sold by the private sector within Illinois at a rate of up to 1.95%; and

WHEREAS, The proposed tax would be imposed upon all businesses regardless of whether they make a profit, and would fall most harshly upon start-ups, struggling firms, and small businesses; and

WHEREAS, This proposal is poor tax policy, criticized by economists and economic development experts across the nation as exactly the direction Illinois should not go if we hope to enjoy a growing economy; and

WHEREAS, This proposed Illinois Gross Receipts Tax, the highest gross receipts tax rate in the nation, would be imposed repeatedly upon the entire value of an Illinois good or service each time it changes hands as it moves through the economic process; and

WHEREAS, An example of this "pyramiding effect" can be seen in agriculture, Illinois' primary industry, where the seeds, the fertilizers, the farm chemicals, the machinery, and the elevator services used by an Illinois grain farmer are all scheduled to be taxed, and the full burden of all of these taxes would be borne by the farmer; and

WHEREAS, Inputs used by many other Illinois industries and professionals would also be taxed repeatedly under the "pyramid effect"; and

WHEREAS, Much of the cost of this new tax, if it is enacted, will be indirectly passed on to consumers of Illinois goods and services, thereby creating a significant increase in these costs and giving Illinoisans an incentive to buy elsewhere, thereby destroying more Illinois jobs; and

WHEREAS, The better-trained a worker is, and the more specialized the work that he or she does, the harsher the tax would be upon his or her workplace; and

WHEREAS, The proposed Illinois Gross Receipts Tax is precisely what a tax ought not to be in the modern economy, and, if implemented, it would have a destructive effect upon Illinois by repeatedly taxing specialized work and services; and

WHEREAS, Only five U.S. states currently have a gross receipts tax, and all of them levy this tax at a rate much lower than 1.95%, which would be by far the highest GRT tax rate in the nation; and

WHEREAS, Three of these five states use their (much lower) gross receipts taxes to replace their income tax or their sales tax, rather than trying to implement a gross receipts tax on top of these two other taxes; and

WHEREAS, The neighboring and comparable State of Indiana repealed its Gross Receipts Tax in 2002 for many reasons including those described here; and

WHEREAS, House members and motivated local citizens have held hearings throughout Illinois on the proposed Gross Receipts Tax, and testimony and comments have been gathered from a diverse variety of workers, consumers, farmers, and small businesspeople, and the vast majority of these Illinois citizens have told Springfield that they fervently oppose the proposed new tax; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we oppose the Gross Receipts Tax proposed by the Governor of Illinois; and be it further

RESOLVED, That a copy of this resolution be presented to the Governor of Illinois.

#### HOUSE JOINT RESOLUTION 54

Offered by Representative Coulson:

WHEREAS, In Illinois, over 300,000 children under the age of 18 are living with and being cared for by more than 100,000 grandparents; and

WHEREAS, Grandparent caregivers, the majority of whom are single women ranging in age from 30 to 90 with an average annual income of \$15,000 to \$25,000 typically raise one to 2 grandchildren and have been doing so for 5 years or longer; and

WHEREAS, Factors contributing to the growing number of grandparents raising grandchildren include, but are not limited to, alcohol and drug abuse, neglect, abuse, abandonment, death of a parent, HIV/AIDS, divorce, unemployment, poverty, parental incarceration, teen pregnancy, and welfare reform; and

WHEREAS, Many grandparents provide care for children without legal custody or guardianship; to establish a legal relationship with the children, the caregiver must institute a long, costly, and emotionally difficult legal proceeding against the parents, one of whom is their child; and

WHEREAS, Many relatives do not qualify for legal assistance due to age, income, type of case, or attorney conflict; and

WHEREAS, Article X of the Illinois Constitution states that it is a fundamental goal of the State that every child have the right to a free public education; and

WHEREAS, \$11.6 billion was paid in local property taxes to school districts in 2005; grandparents assuming responsibility for a child are funding their local schools through property taxes either paid directly or through their rent; and

WHEREAS, Some school districts have required grandparents to have legal custody or guardianship for regular education students; in these instances, school districts have misinterpreted Section 10-20.12b of the School Code, which gives rights to a non-parent raising a child for whom they do not have legal custody to register the child in school; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we affirm that every child, under the Illinois Constitution, has the right to a free public education; and be it further

RESOLVED, That the State Superintendent of Education issue a policy statement, no later than July 1, 2007, to all school districts in the State clarifying Section 10-20.12b of the School Code; and be it further

RESOLVED, That the policy statement shall clarify that legal guardianship is not needed to register a child in school and that an attestation of residency is sufficient for registration; and be it further

RESOLVED, That a copy of this resolution be delivered to the State Superintendent of Education.

### **HOUSE BILL ON SECOND READING**

HOUSE BILL 754. Having been read by title a second time on April 27, 2007, and held on the order of Second Reading, the same was again taken up.

Representative Howard offered the following amendment and moved its adoption.

AMENDMENT NO. 2. Amend House Bill 754 by replacing everything after the enacting clause with the following:

"Section 1. Short title. This Act may be cited as the High Speed Internet Services and Information Technology Act.

Section 5. Findings. With respect to high speed Internet services and information technology, the General Assembly finds the following:

(1) The deployment and adoption of high speed Internet services and information technology has resulted in enhanced economic development and public safety for the State's communities, improved health care and educational opportunities, and a better quality of life for the State's residents.

(2) Continued progress in the deployment and adoption of high speed Internet services and information technology is vital to ensuring that this State remains competitive and continues to create business and job growth.

(3) The State must encourage and support the partnership of the public and private sectors in the continued growth of high speed Internet and Information technology for the State's residents and businesses.

(4) Local governmental entities play a role in assessing the needs of their communities with respect to high speed Internet services and information technology.

Section 10. Definitions. In this Act:

"Nonprofit organization" means an organization that (i) is a nonprofit organization as described in Section 501(c)(3) of the federal Internal Revenue Code of 1986 and exempt from tax under Section 501(a) of that Code; (ii) has no part of the net earnings of which inures to the benefit of any member, founder,

contributor, or individual; and (iii) is organized under, subject to, and has all the powers and duties of a not-for-profit corporation under the General Not For Profit Corporation Act of 1986.

Section 15. Connect IL.

(a) Notwithstanding any other statute, the Lieutenant Governor, with the advice of the Broadband Deployment Council, shall authorize the creation of a nonprofit corporation called Connect IL to implement a comprehensive, statewide high speed Internet deployment strategy and demand creation initiative with the purpose of:

- (1) ensuring that all State residents and businesses have access to affordable and reliable high speed Internet service;
- (2) achieving improved technology literacy, increased computer ownership, and home high speed Internet use among State residents and businesses;
- (3) establishing and empowering local technology planning teams in each county to plan for improved technology use across multiple community sectors; and
- (4) establishing and sustaining an environment ripe for high speed Internet access and technology investment statewide.

(b) Connect IL's governing board shall be appointed by the Lieutenant Governor, with the advice of the Broadband Deployment Council, and shall not exceed 11 members, with a maximum of 6 representing the private sector and a maximum of 5 representing the government and nonprofit sectors. Four of the private sector members shall be from the largest incumbent local exchange carriers, one shall be from the cable television industry, and one shall be from the Internet Service Provider (ISP) industry. Members representing the public sector shall include one member from a public Illinois university, one member that represents Community Technology Centers, one member from the Department of Commerce and Economic Opportunity, one member from the Lieutenant Governor's office, and one member from the Department of Central Management. The board shall select its chairperson to serve a 2-year term.

(c) In lieu of, or in addition to creating a nonprofit, the Lieutenant Governor, with the Broadband Deployment Council's advice, shall enlist an existing nonprofit organization that has an established competency and proven record of working with public and private sectors to accomplish wide-scale deployment and adoption of broadband and information technology.

Section 20. Duties of Connect IL.

(a) The high speed Internet deployment strategy and demand creation initiative to be performed by the nonprofit organization shall include, but not be limited to, the following actions:

- (1) Create a geographic statewide inventory of high speed Internet service and other relevant broadband and information technology services. The inventory shall:
  - (A) identify geographic gaps in high speed Internet service through a method of GIS mapping of service availability and GIS analysis at the census block level; and
  - (B) provide a baseline assessment of statewide high speed Internet deployment in terms of percentage of Illinois households with high speed Internet availability.
- (2) Track and identify, through customer interviews and surveys and other publicly available sources, statewide residential and business adoption of high speed Internet, computers, and related information technology and any barriers to adoption.
- (3) Build and facilitate in each county or designated region a local technology planning team with members representing a cross section of the community, including, but not limited to, representatives of business, K-12 education, health care, libraries, higher education, community-based organizations, local government, tourism, parks and recreation, and agriculture. Each team shall benchmark technology use across relevant community sectors, set goals for improved technology use within each sector, and develop a plan for achieving its goals, with specific recommendations for online application development and demand creation.
- (4) Collaborate with high speed Internet providers and technology companies to encourage deployment and use, especially in underserved areas, by aggregating local demand, mapping analysis, and creating market intelligence to improve the business case for providers to deploy.
- (5) Establish a program to increase computer ownership and Internet access for disenfranchised populations across the State.

(b) The nonprofit organization may apply for federal grants consistent with the objectives of this Act.

(c) The Lieutenant Governor shall use the funds in the High Speed Internet Services and Information Technology Fund to provide grants to the nonprofit organization created or enlisted under this Act.

(d) The nonprofit organization shall have the power to obtain or to raise funds other than the grants receive from the Lieutenant Governor under this Act.

(e) The nonprofit organization and its Board of Directors shall exist separately and independently from the Office of the Lieutenant Governor and any other governmental entity, but shall cooperate with the Office of the Lieutenant Governor, the Broadband Deployment Council, and other public or private entities it deems appropriate in carrying out its duties.

(f) Notwithstanding anything in this Act or any other Act to the contrary, any information that is designated confidential or proprietary by an entity providing the information to the nonprofit organization or any other entity to accomplish the objectives of this Act shall be deemed confidential, proprietary, and a trade secret and treated by the nonprofit organization, Connect IL's governing board, or anyone else possessing the information as such and shall not be disclosed.

Section 25. Scope of authority. Nothing in this Act shall be construed as giving the Lieutenant Governor, the Broadband Deployment Council, the nonprofit organization, or other entities any additional authority, regulatory or otherwise, over providers of telecommunications, broadband, and information technology.

Section 30. High Speed Internet Services and Information Technology Fund.

(a) There is created in the State treasury a special fund to be known as the High Speed Internet Services and Information Technology Fund, to be used, subject to appropriation, by the Lieutenant Governor for purposes of providing grants to the nonprofit organization enlisted under this Act.

(b) On the effective date of this Act, all moneys in the Digital Divide Elimination Infrastructure Fund which have not already been distributed or ordered distributed by the Illinois Commerce Commission shall be transferred to the High Speed Internet Services and Information Technology Fund. Nothing contained in this subsection (b) shall affect the validity of grants issued under this Act before June 30, 2007.

Section 35. Local broadband projects. Any municipality or county may undertake local broadband projects and the provision of services in connection therewith; may lease infrastructure that it owns or controls; may aggregate customers or demand for broadband services; may apply for and receive funds or technical assistance to undertake such projects to address the level of broadband access available to its businesses and residents. To the extent that it seeks to serve as a retail provider of telecommunications services, the municipality or county shall be required to obtain appropriate certification from the Illinois Commerce Commission as a telecommunications carrier.

Section 90. The State Finance Act is amended by adding Section 5.675 as follows:

(30 ILCS 105/5.675 new)

Sec. 5.675. The High Speed Internet Services and Information Technology Fund.

Section 99. Effective date. This Act takes effect upon becoming law."

The foregoing motion prevailed and Amendment No. 2 was adopted.
