WHEREAS, Promoting "fire stop systems" will equate to the construction of all types of buildings being better equipped in the event of a fire; this compartmentalization will prevent fire and smoke from spreading throughout the building; and

WHEREAS, Fire stopping would prevent smoke from moving from one area to another; most people in fires die from smoke inhalation and not the fire itself; and

WHEREAS, Fire stopping can keep dust and airborne contaminants from moving from one segment of a building to another; and

WHEREAS, Fire stopping works in conjunction with sprinklers to afford the best protection to help save lives in the event that the sprinkler system fails and to keep developed smoke from the fire in the area of the burn; and

WHEREAS, Installation and inspection of proper fire stop systems should be promoted by the State Fire Marshal in its curriculum that is part of the training and certification for the hundreds of fire inspectors in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created a Fire Stop Council under the Office of the State Fire Marshal for the purposes of examining the current state of fire stop systems in Illinois, encouraging education, training, and promoting awareness of the importance of proper fire stop system installation and inspection; and be it further

RESOLVED, That the Fire Stop Council shall consist of the following members: the State Fire Marshal or his or her designee; one member appointed by the Speaker of the House of Representatives; one member appointed by the Minority leader of the House of Representatives; one member appointed by an association representing fire stop systems; one member appointed by an association representing municipalities; one member appointed by an association representing fire inspectors; and one member appointed by an association representing fire stop insulators; and be it further

RESOLVED, That the Council is charged with the development of means and methods of training building inspectors to recognize proper installation and inspection of fire stop systems, including destructive tests; and be it further

RESOLVED, That the Council shall meet initially at the call of the State Fire Marshal and thereafter as necessary and shall report its findings and recommendations to the House of Representatives by filing copies of its report with the clerk of the House of Representatives, no later than January 1, 2010; and that upon filing its report the Council is dissolved; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois State Fire Marshal.

### **HOUSE RESOLUTION 1060**

Offered by Representative Granberg:

WHEREAS, Amtrak service between Chicago, Homewood, Kankakee, Gilman, Rantoul, Champaign-Urbana, Mattoon, Effingham, Centralia, Du Quoin, and Carbondale is a vital economic development tool; and

WHEREAS, The City of New Orleans train serves these communities, as well as the communities of Fulton, Kentucky, Newbern-Dyersburg, Tennessee, Memphis, Tennessee, Greenwood, Mississippi, Yazoo City, Mississippi, Jackson, Mississippi, Hazlehurst, Mississippi, Brookhaven, Mississippi, McComb, Mississippi, Hammond, Louisiana, and New Orleans, Louisiana with one daily round trip; and

WHEREAS, The State of Illinois finances 2 additional daily trains, the Illini and the Saluki, for a total of 3 daily round trips; and

WHEREAS, Since the State of Illinois financed the second daily round trip in 2006, ridership has grown at exceptional rates, showing the enormous demand for the service; and

WHEREAS, Illinois is now a national model for Amtrak expansion; and

WHEREAS, The tracks are owned and maintained by the Canadian National Railway Company; and

WHEREAS, The Canadian National Railway Company has been a responsible partner with Amtrak and the State of Illinois in providing relatively on-time performance for Amtrak trains on the route; and

WHEREAS, There is no direct connection between Canadian National tracks and Chicago's Union Station, requiring Amtrak trains to stop and then travel in a reverse direction at low speeds into Chicago's Union Station; and

WHEREAS, This lack of a direct connection causes travel delays of 15 to 20 minutes; and

WHEREAS The additional 15 to 20 minutes of travel time is the main reason why current Amtrak service is not faster than driving for northbound travel; and

WHEREAS, The additional 15 to 20 minutes of travel time makes Amtrak service a less powerful economic development tool for Illinois communities and particularly hurts the economic progress of Southern and Central Illinois; and

WHEREAS, The best method for eliminating this 15 to 20 minute delay is to build a rail interchange connection between the Canadian National tracks and the Norfolk Southern tracks near 76th Street in Chicago in an area known as Grand Crossing; and

WHEREAS, Building the Grand Crossing interchange will allow a direct connection for Amtrak trains to Chicago's Union Station and eliminate the 15 to 20 minute delay; and

WHEREAS, Canadian National has announced plans to purchase the EJ&E Railway that loops through Chicago's suburbs; and

WHEREAS, Such a purchase would eliminate the value of the current track used by Amtrak from the area known as Grand Crossing to Chicago's Union Station for Canadian National, leading to its eventual abandonment; and

WHEREAS, The cost of maintaining the track between 76th Street and Chicago's Union Station would then be borne by Amtrak at an unknown cost; and

WHEREAS, Canadian National has filed a request with the federal Surface Transportation Board seeking required approval for this purchase of the EJ&E Railway; and

WHEREAS, Federal regulators with the Surface Transportation Board are charged with considering the public interest in deciding whether to approve or deny Canadian National's proposed purchase of the EJ&E Railway; and

WHEREAS, There are many other issues that affect Chicago suburban communities regarding the proposed purchase by the Canadian National of the EJ&E Railway, notable increased freight traffic for many communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that it is State policy that the 15 to 20 minute delay in Amtrak's travel time be eliminated; and be it further

RESOLVED, That the Grand Crossing Connection be built and operational for Amtrak service as at least one condition before federal regulators approve the purchase by Canadian National of the EJ&E Railway; and be it further

RESOLVED, That the Grand Crossing Connection be built and operational before the St. Charles Air Line is ever dismantled; and be it further

RESOLVED, That a copy of this resolution be presented to the mayors of each of the communities served by the City of New Orleans, the Illini, and the Saluki trains, the Surface Transportation Board, the governors and legislative leaders of the states of Louisiana, Mississippi, Kentucky, and Tennessee, and the congressional delegations of the states of Louisiana, Mississippi, Kentucky, Tennessee, and Illinois.

WHEREAS, The report was drafted over several years and points out severe health issues within a few miles of 25 known areas of concern around the lakes; and

WHEREAS, Of the 108 hazardous waste sites in those areas, 71 had a potential human health impact, according to a draft of the report made available by the Center for Public Integrity; and

WHEREAS, The report calls for further investigation of adverse health effects in the areas with the most overlap between health hazards, health problems, and at-risk populations, including reproductive-age women, the elderly, and children younger than 6 years old; and

WHEREAS, The study, entitled "Public Health Implications of Hazardous Substances in the Twenty-Six U.S. Great Lakes Areas of Concern" began in 2001 and was completed in July 2007 after several rounds of scientific peer review; and

WHEREAS, Senior scientists at the Centers for Disease Control and Prevention blocked the report's publication while they review it because of questions concerning the underlying data raised a few weeks before its intended release to the public; therefore, be it
