**HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

**HOUSE RESOLUTION 1214**

Offered by Representative Munson:

WHEREAS, The members of the Illinois House of Representatives are pleased to honor the life and legacy of America's greatest champion of racial justice and equality, Dr. Martin Luther King Jr.; and

WHEREAS, Martin Luther King Jr. was born on January 15, 1929 in Atlanta, Georgia; after attending Morehouse College in Atlanta, Dr. King went on to study at Crozer Theological Seminary in Pennsylvania

and Boston University, where he deepened his understanding of theological scholarship and explored Mahatma Gandhi's nonviolent strategy for social change; and

WHEREAS, Dr. Martin Luther King Jr. married Coretta Scott in 1953; the following year, he accepted the pastorate at Dexter Avenue Baptist Church in Montgomery, Alabama; he received his Ph.D. in systematic theology in 1955; and

WHEREAS, On December 5, 1955, after civil rights activist Rosa Parks refused to comply with Montgomery, Alabama's segregation policy on buses, African-American residents launched a bus boycott; the group elected Dr. Martin Luther King Jr. president of the newly-formed Montgomery Improvement Association; the ensuing boycott continued throughout 1956, with Dr. King gaining national prominence for his role in the campaign; in December of 1956, the United States Supreme Court declared Alabama's segregation laws unconstitutional and Montgomery buses were desegregated, landing Dr. King his first major civil rights victory; and

WHEREAS, Building upon the success in Montgomery, Dr. Martin Luther King Jr. and other southern black ministers founded the Southern Christian Leadership Conference (SCLC) in 1957; in 1959, Dr. King toured India and further developed his understanding of Gandhian nonviolent strategies; he resigned from Dexter later that year, returning to Atlanta to become co-pastor of Ebenezer Baptist Church with his father; and

WHEREAS, In the spring of 1963, Dr. Martin Luther King Jr. and SCLC led mass demonstrations in Birmingham, Alabama, where local white police officials were known for their violent opposition to integration; clashes between unarmed black demonstrators and police armed with dogs and fire hoses generated newspaper headlines throughout the world; President John F. Kennedy responded to the Birmingham protests by submitting broad civil rights legislation to Congress, which led to the passage of the Civil Rights Act of 1964; and

WHEREAS, Further civil rights mass demonstrations culminated in the March on Washington for Jobs and Freedom on August 28, 1963, in which more than 250,000 protesters gathered in Washington, D.C.; on that day, Dr. Martin Luther King Jr. delivered his famous "I Have a Dream" speech on the steps of the Lincoln Memorial; his renown continued to grow as he became Time Magazine's Man of the Year in 1963 and the recipient of the Nobel Peace Prize in 1964; and

WHEREAS, Undeterred by rival civil rights factions and resistance from national political leaders, Dr. Martin Luther King Jr. continued his march for freedom with his public criticism of U.S. intervention in the Vietnam War, which led to strained relations with President Lyndon Johnson's administration; in late 1967, Dr. King initiated a Poor People's Campaign designed to confront economic problems that had not been addressed by earlier civil rights reforms; the following year, while supporting striking sanitation workers in Memphis, Tennessee, he delivered his final address, "I've Been to the Mountaintop" ; and

WHEREAS, On April 4, 1968, the day after delivering his final speech, Dr. Martin Luther King Jr. was shot and killed as he stood on the balcony of the Lorraine Motel in Memphis, Tennessee; this tragic event marked the end of the life of this great leader, yet did not destroy the movement he helped create; and

WHEREAS, The intense effort and incredible sacrifices that Dr. Martin Luther King Jr. gave in order to secure the basic freedoms of all men and women must be honored in the greatest fashion; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate Route 20 within the Elgin city limits as the Dr. Martin Luther King Jr. Memorial Highway in honor of this visionary leader; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the designation of the Dr. Martin Luther King Jr. Memorial Highway; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Elgin City Council, the Kane County Board, the Secretary of the Illinois Department of Transportation, and the family of Dr. Martin Luther King Jr. as a symbol of our esteem and respect.

#### HOUSE RESOLUTION 1215

Offered by Representative Meyer:

WHEREAS, The Department of Commerce and Economic Opportunity (DCEO) is the lead State agency for economic development in Illinois; and

WHEREAS, In that capacity, DCEO expended over \$730 million in Fiscal Year 2007 appropriations for

community and business development, technology and industrial competitiveness, tourism, coal development and marketing, and other projects to encourage economic development; and

WHEREAS, Efficient and effective management of the State's economic development programs is critical to the fiscal soundness of the State, local communities, business, and Illinois workers; and

WHEREAS, The management and program audit released in February of 2006, conducted by the Auditor General, outlined definitive shortcomings in such areas as performance measurement effectiveness and methodology, documentation accuracy, program monitoring, and the tracking and compliance of statutory mandates; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a follow-up audit of the Department of Commerce and Economic Opportunity's administration of its economic development programs; and be it further

RESOLVED, That the audit include, but need not be limited to, the following determinations: (i) whether DCEO's economic development programs are operated in conformity with applicable federal and State requirements; (ii) whether DCEO has established and implemented procedures to periodically review both the efficiency and effectiveness of its economic development programs; (iii) whether DCEO has in place appropriate monitoring and reporting procedures to ensure that it receives timely and accurate information from its grant and loan recipients; (iv) whether DCEO's reported performance measures are periodically reviewed and adequately supported by underlying documentation; and (v) whether DCEO's performance measures indicate that its economic development programs are effective in accomplishing their stated purposes; and be it further

RESOLVED, That the Department of Commerce and Economic Opportunity and its predecessor agencies, recipients of State funds, and any other entity or person that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and distribute the report upon completion in accordance with Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a copy of this resolution be delivered to the Auditor General and to the Director of Commerce and Economic Opportunity.

#### HOUSE RESOLUTION 1224

Offered by Representative Phelps:

WHEREAS, Soil and Water Conservation Districts provide an invaluable service to the citizens of the State; they protect the State's rivers, streams, and other water sources from contamination; they also play an important role in ensuring the State's agricultural health and economy; and

WHEREAS, In the Fiscal Year 2008 budget passed by the General Assembly, approximately \$7.4 million was appropriated for the operational expenses of Soil and Water Conservation Districts; however, nearly \$6 million of those funds have not been released; and

WHEREAS, The University of Illinois Extension offices provide many programs throughout the State, including 4-H, nutrition, and other agricultural programs; more than 2.5 million Illinois residents take part in Extension programs each year; and

WHEREAS, In the Fiscal Year 2008 budget passed by the General Assembly, approximately \$18 million was appropriated for the University of Illinois Extension programs; those funds have not yet been released; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to release the funds appropriated to Soil and Water Conservation Districts and the University of Illinois Extension program; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Director of Agriculture, the Director of Natural Resources, and the President of the University of Illinois.

#### HOUSE RESOLUTION 1232

Offered by Representative Nekritz:

WHEREAS, On May 10, 1869, the "golden spike" was driven into the final tie at Promontory Summit, Utah to join the Central Pacific and the Union Pacific Railroads, ceremonially completing the first transcontinental railroad and therefore connecting both coasts of the United States; and

WHEREAS, Today, Illinois and Chicago are the railroad capitals of the United States and Chicago Union Station is the fourth busiest Amtrak station in the country, with almost 3 million passengers annually; and

WHEREAS, Illinois was one of the first States to enter into a partnership with Amtrak for the operation of a passenger train, the daily Illinois Zephyr, which has served the communities of Quincy, Macomb, Galesburg, Kewanee, Princeton, Mendota, Plano, LaGrange, and Chicago, since November 4, 1971; and

WHEREAS, Illinois has continued to show its commitment to a viable passenger rail network, providing support so residents and visitors have Amtrak trains to and from metro areas, mid-sized cities, and small towns, helping to reduce congestion on roads and in the skies; and

WHEREAS, For many rural Americans, Amtrak represents the only major intercity transportation link to the rest of the country; and

WHEREAS, Passenger rail provides a more fuel-efficient transportation system, thereby providing cleaner transportation alternatives and energy security; when combined with all modes of transportation, passenger railroads emit only 0.2 percent of the travel industry's total greenhouse gases; and

WHEREAS, Amtrak annually provides intercity passenger rail travel to over 25 million Americans residing in 46 states; and

WHEREAS, An increasing number of people are using trains for travel purposes beyond commuting to and from work; in the State of Illinois, 3,888,577 people made use of Amtrak trains in 2007; and

WHEREAS, Rail passenger service in the State of Illinois is a source of pride, a gateway for many into our State, and a tool for economic growth; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State of Illinois endorses National Train Day on May 10, 2008.
