The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 88

Offered by Representative Chapa LaVia:

WHEREAS, The celebration of a special Children's Day in the United States dates back to the 1860s and earlier; Children's Day observations predate both Mother's Day and Father's Day celebrations in the United States; and

WHEREAS, The people of the State of Illinois and the United States recognize Mother's Day and Father's Day, yet do not celebrate a Children's Day, a day to celebrate and commit to our children and their future and a day with deep historical roots in our country; and

WHEREAS, The Methodist Episcopal Church at the Methodist Conference of 1868 recommended that every second Sunday in June be annually observed as Children's Day; in 1883, the National Council of Congregational Churches and nearly all the state bodies of that denomination in the United States passed resolutions commending the observance of the day, with many other denominations adopting similar recommendations; and

WHEREAS, Children are tender and precious gifts to all mankind; they deserve to be given hope, faith, love, and commitment to allow them a successful and bright future; the very act of safeguarding childhood is the noblest achievement of a society; and

WHEREAS, Children need much more than just the basic necessities of being clean and safe; children must be celebrated and given a healthy social-emotional growth in order to become healthy and productive citizens; in addition, we must encourage them to maintain the innocence, imagination, and freedom of worry of their childhood; and

WHEREAS, The future of our society will be more successful and bright in knowing that our children are loved and well-cared for; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the second Sunday in June of each year as Children's Day in the State of Illinois.

#### HOUSE RESOLUTION 95

Offered by Representative Reitz:

WHEREAS, According to data published in 1990 and again in 1997 in the Journal of the American Medical Association by David Eisenberg, MD of Harvard Medical School, over 40% of Americans use at least one alternative therapy; over 70% of the patients using alternative therapies in Dr. Eisenberg's study did not disclose this use to their medical doctors; and

WHEREAS, The provision of complementary and alternative therapies is increasing by practitioners who have varied to no training, testing, or legitimate certification; and

WHEREAS, In recognizing the demand for natural medicine, the challenge for regulators is to identify those practitioners who have the appropriate education and training to safely practice complementary and alternative therapies; and

WHEREAS, Naturopathic physicians are among the highest trained practitioners in the broadest scope of complementary and alternative medicine; and

WHEREAS, Prior to 1987, naturopathic physicians were eligible for licensure in Illinois under the Medical Practice Act; and

WHEREAS, Legislative recognition in the form of State licensure creates a climate for patients to trust the credentials of naturopathic physicians providing complementary and alternative therapies; and

WHEREAS, Fifteen states, the District of Columbia, and the U.S. territories of Puerto Rico and the U.S. Virgin Islands have licensing laws for naturopathic physicians; and

WHEREAS, The licensing of naturopathic physicians assures the public of a high standard of education and training of these practitioners while providing consumers access to evidence based natural therapies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the Task Force on the Licensure of Naturopathic Physicians within the Department of Financial and Professional Regulation to (i) evaluate whether the standards of naturopathic medical education and training are adequate to protect the public and

(ii) make recommendations as to the extent to which regulation of naturopathic physicians will benefit the health of the citizens of Illinois; and be it further

RESOLVED, That the Task Force shall be composed of the Chairperson of the House Registration and Regulation Committee, who shall serve as the Task Force Chairperson; the Minority Spokesperson of the House Registration and Regulation Committee; 3 members of the House of Representatives appointed by the Speaker of the House; and 2 members of the House of Representatives appointed by the Minority Leader of the House; and be it further

RESOLVED, That the Task Force shall hold hearings to determine the public demand for appropriately educated and trained naturopathic physicians and the risk and detriment to the public welfare in the absence of regulation; the Task Force shall also examine naturopathic medical education institutions in order to establish the adequacy of naturopathic medical education and training; and be it further

RESOLVED, That the Task Force shall present a written report of its findings to the House of Representatives no later than December 31, 2009.

WHEREAS, Each project will serve multiple goals related to developing the green-collar workforce; the projects will create green-job skills, decrease campus energy consumption by 30% to 50%, provide hands-on experience for renewable energy technician training, serve as demonstration sites for business, industry, and homeowners, and be shovel-ready immediately or within 180 days; and

WHEREAS, Accountability for outcomes will occur through independent measuring and verification for carbon reduction strategies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Congress to fund the Illinois Community College Sustainability Network's request for \$648,600,000 from the federal government for the training and development of a green-collar workforce and the creation of green-collar jobs through community college renewable energy and energy conservation projects; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois congressional delegation.
