HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 172

Offered by Representative Colvin:

WHEREAS, Every hour, every school day, 16 students become dropouts in Chicago, and the majority of these students are African-American and Latino; and

WHEREAS, Youth Connection Charter School is a not-for-profit charter school association that caters to drop-out students, allowing them a second chance to earn a degree and providing them with professional skills to achieve rewarding careers; and

WHEREAS, The average dropout rate for Chicago Public Schools for the past five years was 41%; alarmingly, the average age of a student who drops out is 18 or 19, and the average reading comprehension is at the 7th grade level; forty percent of these dropouts read below a sixth grade level; and

WHEREAS, 75 percent of America's state prison inmates are high school dropouts; additionally, young adults who become dropouts are more than three times more likely than high school graduates to be arrested in their lifetime; and

WHEREAS, It is tragically clear that a high number of high school dropouts do not achieve at the same level that people with high school degrees, more frequently are incarcerated, and are predominately African-American or Latino; and

WHEREAS, The Chicago Public Schools has been battling the problem of high drop-out rates, but sadly the number has not been able to drop below 40%; and

WHEREAS, Youth Connection Charter School re-enrolls high school dropouts, and achieves a higher graduation rate than Chicago Public Schools with this already marginalized population; and

WHEREAS, Youth Connection Charter School has a current waiting list of 1,200 students; sadly, these students who are unable to enroll face the same challenges and negative consequences that other drop-outs face, despite the fact that they are trying to obtain a degree; and

WHEREAS, It is our obligation as a society to ensure that all students regardless of race or socioeconomic status have the right to achieve a high quality secondary education, and Youth Connection Charter School has the ability and the capacity to help more young adults reach the achievement of obtaining a high school diploma; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we request that Chicago Public Schools allocate 2,100 seats to Youth Connection Charter School over a seven-year period to address the immediate and urgent need to help as many young adults as possible achieve an education; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Chicago Public Schools CEO Ron Huberman.

HOUSE RESOLUTION 175

Offered by Representative Ramey:

WHEREAS, When the University of Illinois decided to close its Elgin extension center, Public School District U-46 voted to establish Elgin Community College (ECC) in January 1949; the college opened its doors the following fall with 97 students, one administrator, 17 part-time faculty, and one full-time faculty member; during the year 1950 the college initiated its sponsorship of the Elgin Symphony Orchestra, a partnership that continues to this day; and

WHEREAS, Throughout the 1950s, ECC operated as part of District U-46; however, a movement in Springfield to create a community college system started in the early 1960s and became a reality in 1965; and

WHEREAS, Throughout the 1970s, ECC expanded curricula, faculty, staff, and services such as on-campus child care, financial aid, job placement, student activities, and tutoring; in 1975 the special services program began providing support service and tutoring to physically disabled students and others in need of specialized support; and in 1976, the college launched its Conservatory of music; and

WHEREAS, During the 1980s, ECC's enrollment skyrocketed, in part due to an economic recession, and the college accommodated students by exploring new spaces and alternative delivery systems of classes; in 1980 ECC offered its first telecourses, featuring college credit courses on videocassette; in February of 1988 the Elgin Community College hospitality management program gained accreditation by the American Culinary Federation Educational Institute Accrediting Commission, the only Illinois school to earn the designation and one of only 15 schools nationwide; and in 1988 Corporate Development, a partnership between industry and education, was founded when ECC and Safety-Kleen joined forces to offer middle management coursework through the college to Safety-Kleen employees; and

WHEREAS, In the 1990s, District 509 experienced unprecedented population growth and demand for the college's services soared; by 1991, enrollment had increased 42 percent in just four years; in August of 1996 ECC became the first college in Illinois to begin offering credit classes via the Internet; and in January of 1997 ECC entered into the first of several partnerships with four-year colleges and universities to provide greater and more immediate access to upper-level undergraduate offerings and baccalaureate degree completion, and to allow for dual admission and/or seamless transfer to four-year schools; and

WHEREAS, Entering the 21st century, Elgin Community College prepared for expanding expectations of community colleges; in August of 2004 the college opened its Culinary Arts Center, including a real-world working lab for students, Spartan Terrace Restaurant, and home to the Culinary Arts and Hospitality Institute of Elgin; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we congratulate the staff, faculty, alumni, and students of Elgin Community College on the 60th anniversary of this important institution for Elgin and surrounding communities; and be it further

RESOLVED, That we proclaim May 22, 2009 as Elgin Community College Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Dr. David Sam, President of Elgin Community College, as a symbol of our respect and esteem.

HOUSE RESOLUTION 176

Offered by Representative Ramey:

WHEREAS, Vasculitis is an inflammation of the blood vessels; also called angiitis, vasculitis causes changes in the walls of blood vessels, including thickening, weakening, narrowing, and scarring; the inflammation from these changes can be short-term (acute) or long-term (chronic) and can be so severe that the tissues and organs supplied by the affected vessels don't receive enough blood; this shortage of blood can result in organ and tissue damage, and even death; and

WHEREAS, Many types of vasculitis exist and, although rare, vasculitis can affect anyone; some age groups are affected more than others, depending on the type of vasculitis; while some forms of vasculitis improve on their own, others require treatment, which often includes long-term medication; each year, 100,000 Americans are hospitalized for vasculitis care; and

WHEREAS, Diseases resulting from vasculitis include Behcet's disease, Buerger's disease, Central Nervous System, Churg Strauss syndrome, Cryoglobulinemia, Giant Cell Arteritis, Henoch-Schönlein purpura, Hypersensitivity vasculitis, Kawasaki disease, Microscopic Polyangiitis, Polyarteritis nodosa, Polymyalgia rheumatica, Rheumatoid vasculitis, Takayasu's arteritis, and Wegener's Granulomatosis; and

WHEREAS, The Vasculitis Foundation, with the help of grassroots support, works to support positive change in the lives of people who live with vasculitis; the foundation's members work in Washington D.C. to educate Congress about Vasculitis and the need to support research funding so that a modern science can better understand the disease and identify advanced treatments and, one day, find a cure; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of May 3-9, 2009 as Vasculitis Awareness Week in the State of Illinois in order to help educate the public about vasculitis diseases and the need for research funding; with this resolution, Illinois will be the first State to officially recognize this disease with an Awareness Week; and be it further

RESOLVED, That a suitable copy of this resolution be presented to The Vasculitis Foundation as a symbol of our support.

HOUSE RESOLUTION 177

Offered by Representative Brady:

WHEREAS, Pre-arrangement plans for funerals and burials or other means of final disposition have increasingly become embattled in controversy in the State of Illinois; and

WHEREAS, The types of investment plans chosen by pre-need sellers have come under increased scrutiny, including but not limited to investments in life insurance policies, trust accounts, and other funding means; and

WHEREAS, A lack of oversight has resulted in certain investments by the Illinois Funeral Director's Association losing millions of dollars of consumer trust funds and all accounts being marked down to compensate for the losses; and

WHEREAS, Litigation has been filed and criminal investigations have been ongoing accusing both Trust and Pre-Need life insurance companies of a "pattern and practice of deceit"; and

WHEREAS, A growing number of individuals who have contracted pre-arranged funeral and burial services are discovering that the funds deposited as part of the pre-need sales contract do not adequately cover the costs of the funeral and burial pre-arrangements chosen by the consumer; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Funeral and Burial Pre-Arrangement Investigation Task Force be created to investigate and study the reasons for losses of the Pre-Need Funeral Trust Fund of the Illinois Funeral Directors and any and all other Funeral and Burial Pre-Need funding plans and investments offered in Illinois; and be it further

RESOLVED, That the Task Force make recommendations for the oversight and operation of all funeral and burial pre-need programs offered by whatever funding means, and develop possible new licenses and continuing education components to protect the consumer and profession, and to educate sellers in the industry, in the State of Illinois; and be it further

RESOLVED, That the Task Force shall consist of the following members: three members appointed by the Speaker of the House of Representatives and three members appointed by the Minority Leader of the House of Representatives (one of the six appointed House members shall be appointed chairperson); one member appointed by the Director of the Division of Insurance within the Department of Financial and Professional Regulation; and one member appointed by the Secretary of the Department of Financial and Professional Regulation; and be it further

RESOLVED, That the Task Force take voluntary assistance and testimony from legal and professional organizations and institutions; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation, but may be reimbursed for actual expenses incurred while serving on this Task Force from funds appropriated to the Department of Financial and Professional Regulation for that purpose; and be it further

RESOLVED, That the Task Force shall submit its final report to the Governor and the General Assembly by December 31, 2009.
