WHEREAS, Accommodations and food services accounted for 450,400 jobs in Illinois in 2007, according to the Illinois Department of Employment Security, Current Employment Statistics; food service workers range from chefs in fine restaurants to short-order cooks, waiters, and cafeteria workers; and

WHEREAS, Food service workers are younger than the average employee, with 37 percent below the age of 24; one-third of these workers are employed part time; and

WHEREAS, Food service workers often work in small, cramped kitchens with hot stoves and ovens; the workers are under pressure to produce and serve food quickly while maintaining quality standards; work conditions for these workers are tough, requiring employees to stand for hours at a time, with slips, falls, cuts, and burns as common job hazards; and

WHEREAS, In 2006, about 29 percent of cooks and 44 percent of food preparation workers had part-time schedules, compared to 15 percent of workers throughout the economy; work hours in restaurants may include early mornings, late evenings, holidays, and weekends, while the work schedules of chefs, cooks, and other kitchen workers in factory and school cafeterias may be more regular; and

WHEREAS, Food service worker positions teach valuable skills, including communication skills; the workers also learn to work quickly, efficiently, and how to deal with pressure situations; in addition, workers learn proper customer service techniques, including how to deal with upset customers; all of these skills prove invaluable to workers that move on to future careers in the public or private sectors; and

WHEREAS, Food service workers provide a vital service to the State of Illinois, both through their positions in the restaurants and cafeterias of this State and their role in the overall economic welfare of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the second Tuesday in October of each year as Food Service Workers Day in the State of Illinois in honor of these workers and their immense contributions to this State.

#### HOUSE RESOLUTION 655

WHEREAS, The United States Army Corps of Engineers constructed the Lucas-Berg Confined Dredged Material Disposal Facility in the early 1980s with the intention of dumping sediments dredged from the Cal-Sag Channel about 1,200 feet into the Lucas-Berg Pit in the Village of Worth; and

WHEREAS, The Lucas-Berg Pit is located in an area surrounded by schools, churches, homes, public transportation, food establishments, and housing for the elderly; and

WHEREAS, Previous studies of dredged sedimentary materials from the Cal-Sag Channel found that the dredged materials contained dangerous levels of toxins; and

WHEREAS, The dumping of these dredged sedimentary materials into the Lucas-Berg Pit would settle in proximity to groundwater and pose a potential hazard to the air and drinking water of the community; and

WHEREAS, The dumping of dangerous dredged sedimentary materials into the Lucas-Berg Pit poses a threat to the Village of Worth and its residents due to the possibility of causing serious illnesses, including mercury poisoning, lead poisoning, anemia, brain damage, birth defects, kidney dysfunction, and lung impairments; and

WHEREAS, Previous studies regarding the Lucas-Berg Pit were used to defeat attempts by the United States Army Corps of Engineers from disposing the dredged sedimentary materials into the pit; and

WHEREAS, A new study conducted by the United States Army Corps of Engineers has identified 20 potential alternative sites that could replace the Lucas-Berg Confined Placement Facility; and

WHEREAS, New attempts by the United States Army Corps of Engineers have been initiated to dispose of 17,250 cubic yards of contaminated sediment per year from the Cal-Sag Channel into the Lucas-Berg Pit; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our opposition to the use of the Lucas-Berg



Confined Dredged Material Disposal Facility and the dumping of dredged sedimentary materials into the Lucas-Berg Pit due to the threat to human life and safety in the surrounding area; and be it further

RESOLVED, That we urge the United States Army Corps of Engineers to find an alternative, safe resting site for sediments dredged from the Cal-Sag Channel; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the United States Army Corps of Engineers, the Illinois Environmental Protection Agency, and the Village of Worth.

#### HOUSE RESOLUTION 657

WHEREAS, The Tenth Amendment to the Constitution of the United States specifically provides that, "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people"; and

WHEREAS, The Tenth Amendment was part of the original Bill of Rights, which was proposed on September 25, 1789, ratified by three-fourths of the states, and went into effect on December 15, 1791; and

WHEREAS, The Tenth Amendment limits the scope of federal power and prescribes that the federal government was created by the states specifically to be an agent of the states, rather than the states being agents of the federal government; and

WHEREAS, When taking the oath of office, all members of the Illinois General Assembly solemnly swear that they will support the Constitution of the United States and the Constitution of the State of Illinois; and

WHEREAS, Many federal mandates are in direct violation of the Tenth Amendment to the Constitution of the United States and infringe upon both Illinois' reserve powers and the people's reserved powers; and

WHEREAS, The United States Supreme Court ruled in *New York v. United States*, 505 U.S. 144 (1992), that Congress may not simply commandeer the legislative and regulatory processes of the states by compelling them to enact and enforce regulatory programs; and

WHEREAS, The United States Supreme Court, in *Printz v. United States/Mack v. United States*, 521 U.S. 898 (1997), reaffirmed that the Constitution of the United States established a system of "dual sovereignty" that retains "a residuary and inviolable sovereignty" by the states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State of Illinois hereby claims sovereignty under the Tenth Amendment to the Constitution of the United States over all powers not otherwise enumerated and granted to the federal government by the Constitution of the United States; and be it further

RESOLVED, That this resolution shall serve notice to the federal government of our demand to maintain the balance of powers where the Constitution of the United States established it; and be it further

RESOLVED, That we state our intentions to ensure that all government agencies and their agents and employees operating within the geographic boundaries of the State of Illinois, or whose actions have an effect on the inhabitants, lands, or water of Illinois, shall operate within the confines of the original intent of the Constitution of the United States; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the President pro tempore of the United States Senate, the Speaker of the United States House of Representatives, and each member of the Illinois congressional delegation.

- (5) the adequacy of the system used by the Department of Central Management Services to record the use and maintenance of passenger cars in the State fleet;
- (6) the adequacy of the system of checks used by the Department of Central Management Services to ensure that passenger vehicles in the State fleet are not used by State employees for non-official business; and
- (7) whether it is possible to implement a system that would allow the Department of Central Management Services to track vehicles and identify whether they are being used only for official business; and be it further

Such veto by the president may extend to any one or more items or appropriations contained in any resolution making an appropriation, or to the entire resolution; and in case the veto only extends to a part of such resolution making an appropriation, the residue thereof not embraced within the veto shall take effect and be in force from the time of the receipt by said clerk of such veto of such part. Upon the return of any such ordinance, resolution or motion by the president, with his objections thereto as aforesaid, the vote by which the same was passed shall be reconsidered by the board of commissioners as to so much thereof as may have been vetoed; and if, after such reconsideration, three-fifths ~~four-fifths~~ of all the members elected to the board shall agree to pass the same by yeas and nays, to be entered on the journal, the same shall take effect, notwithstanding the president may have refused to approve thereof. In case the president shall fail or omit to either sign and approve or return, with his objections as aforesaid, any such ordinance, motion or resolution which shall have been passed or adopted by the board within six days after it shall have been so passed or adopted, the same shall take effect without the approval of the president.

If imposed, this tax shall only be imposed in 1/4% increments. On and after September 1, 1991, this additional tax may not be imposed on the sales of food for human consumption which is to be consumed off the premises where it is sold (other than alcoholic beverages, soft drinks and food which has been prepared for immediate consumption) and prescription and nonprescription medicines, drugs, medical appliances and insulin, urine testing materials, syringes and needles used by diabetics. The tax imposed by a home rule county pursuant to this Section and all civil penalties that may be assessed as an incident thereof shall be collected and enforced by the State Department of Revenue. The certificate of registration that is issued by the Department to a retailer under the Retailers' Occupation Tax Act shall permit the retailer to engage in a business that is taxable under any ordinance or resolution enacted pursuant to this Section without registering separately with the Department under such ordinance or resolution or under this Section. The Department shall have full power to administer and enforce this Section; to collect all taxes and penalties due hereunder; to dispose of taxes and penalties so collected in the manner hereinafter provided; and to determine all rights to credit memoranda arising on account of the erroneous payment of tax or penalty hereunder. In the administration of, and compliance with, this Section, the Department and persons who are subject to this Section shall have the same rights, remedies, privileges, immunities, powers and duties, and be subject to the same conditions, restrictions, limitations, penalties and definitions of terms, and employ

the same modes of procedure, as are prescribed in Sections 1, 1a, 1a-1, 1d, 1e, 1f, 1i, 1j, 1k, 1m, 1n, 2 through 2-65 (in respect to all provisions therein other than the State rate of tax), 4, 5, 5a, 5b, 5c, 5d, 5e, 5f, 5g, 5h, 5i, 5j, 5k, 5l, 6, 6a, 6b, 6c, 7, 8, 9, 10, 11, 12 and 13 of the Retailers' Occupation Tax Act and Section 3-7 of the Uniform Penalty and Interest Act, as fully as if those provisions were set forth herein.

No tax may be imposed by a home rule county pursuant to this Section unless the county also imposes a tax at the same rate pursuant to Section 5-1007.

Persons subject to any tax imposed pursuant to the authority granted in this Section may reimburse themselves for their seller's tax liability hereunder by separately stating such tax as an additional charge, which charge may be stated in combination, in a single amount, with State tax which sellers are required to collect under the Use Tax Act, pursuant to such bracket schedules as the Department may prescribe.

Whenever the Department determines that a refund should be made under this Section to a claimant instead of issuing a credit memorandum, the Department shall notify the State Comptroller, who shall cause the order to be drawn for the amount specified and to the person named in the notification from the Department. The refund shall be paid by the State Treasurer out of the home rule county retailers' occupation tax fund.

The Department shall forthwith pay over to the State Treasurer, ex officio, as trustee, all taxes and penalties collected hereunder. On or before the 25th day of each calendar month, the Department shall prepare and certify to the Comptroller the disbursement of stated sums of money to named counties, the counties to be those from which retailers have paid taxes or penalties hereunder to the Department during the second preceding calendar month. The amount to be paid to each county shall be the amount (not including credit memoranda) collected hereunder during the second preceding calendar month by the Department plus an amount the Department determines is necessary to offset any amounts that were erroneously paid to a different taxing body, and not including an amount equal to the amount of refunds made during the second preceding calendar month by the Department on behalf of such county, and not including any amount which the Department determines is necessary to offset any amounts which were payable to a different taxing body but were erroneously paid to the county. Within 10 days after receipt, by the Comptroller, of the disbursement certification to the counties provided for in this Section to be given to the Comptroller by the Department, the Comptroller shall cause the orders to be drawn for the respective amounts in accordance with the directions contained in the certification.

In addition to the disbursement required by the preceding paragraph, an allocation shall be made in March of each year to each county that received more than \$500,000 in disbursements under the preceding paragraph in the preceding calendar year. The allocation shall be in an amount equal to the average monthly distribution made to each such county under the preceding paragraph during the preceding calendar year (excluding the 2 months of highest receipts). The distribution made in March of each year subsequent to the year in which an allocation was made pursuant to this paragraph and the preceding paragraph shall be reduced by the amount allocated and disbursed under this paragraph in the preceding calendar year. The Department shall prepare and certify to the Comptroller for disbursement the allocations made in accordance with this paragraph.

For the purpose of determining the local governmental unit whose tax is applicable, a retail sale by a producer of coal or other mineral mined in Illinois is a sale at retail at the place where the coal or other mineral mined in Illinois is extracted from the earth. This paragraph does not apply to coal or other mineral when it is delivered or shipped by the seller to the purchaser at a point outside Illinois so that the sale is exempt under the United States Constitution as a sale in interstate or foreign commerce.

Nothing in this Section shall be construed to authorize a county to impose a tax upon the privilege of engaging in any business which under the Constitution of the United States may not be made the subject of taxation by this State.

An ordinance or resolution imposing or discontinuing a tax hereunder or effecting a change in the rate thereof shall be adopted and a certified copy thereof filed with the Department on or before the first day of June, whereupon the Department shall proceed to administer and enforce this Section as of the first day of September next following such adoption and filing. Beginning January 1, 1992, an ordinance or resolution imposing or discontinuing the tax hereunder or effecting a change in the rate thereof shall be adopted and a certified copy thereof filed with the Department on or before the first day of July, whereupon the Department shall proceed to administer and enforce this Section as of the first day of October next following such adoption and filing. Beginning January 1, 1993, an ordinance or resolution imposing or discontinuing the tax hereunder or effecting a change in the rate thereof shall be adopted and a certified copy thereof filed with the Department on or before the first day of October, whereupon the Department shall proceed to administer and enforce this Section as of the first day of January next following such



adoption and filing. Beginning April 1, 1998, an ordinance or resolution imposing or discontinuing the tax hereunder or effecting a change in the rate thereof shall either (i) be adopted and a certified copy thereof filed with the Department on or before the first day of April, whereupon the Department shall proceed to administer and enforce this Section as of the first day of July next following the adoption and filing; or (ii) be adopted and a certified copy thereof filed with the Department on or before the first day of October, whereupon the Department shall proceed to administer and enforce this Section as of the first day of January next following the adoption and filing.

When certifying the amount of a monthly disbursement to a county under this Section, the Department shall increase or decrease such amount by an amount necessary to offset any misallocation of previous disbursements. The offset amount shall be the amount erroneously disbursed within the previous 6 months from the time a misallocation is discovered.

Except as otherwise provided in this Section, beginning on the first day of the first month to occur not less than 30 calendar days after the effective date of this amendatory Act of the 96th General Assembly, the maximum rate of any tax imposed under this Section is 0.75%. If the rate of tax exceeds 0.75% on the effective date of this amendatory Act of the 96th General Assembly, then the rate shall be reduced to 0.75% beginning on the first day of the first month to occur not less than 30 calendar days after the effective date of this amendatory Act of the 96th General Assembly. The county board of a county that is authorized to impose a tax under this Section may increase the rate to more than 0.75%, but only after the question is approved by the voters of the county at an election held in accordance with the general election law. The county board proposing the increase shall certify the proposition to the proper election officials who shall submit the proposition to the voters at an election in accordance with the general election law. The proposition shall be in substantially the following form:

"Shall (county) be authorized to increase its retailers' occupation tax to (percent)?"

Votes shall be recorded as "Yes" or "No". If a majority of the votes cast on the proposition are in favor of the increase, then the increase is authorized.

A home rule unit may not impose retailers' occupation taxes in a manner that is inconsistent with this Section. This Section is a limitation of home rule powers and functions under subsection (g) of Section 6 of Article VII of the Illinois Constitution.

This Section shall be known and may be cited as the Home Rule County Retailers' Occupation Tax Law. (Source: P.A. 90-689, eff. 7-31-98; 91-51, eff. 6-30-99.)

(55 ILCS 5/5-1007) (from Ch. 34, par. 5-1007)

Sec. 5-1007. Home Rule County Service Occupation Tax Law. The corporate authorities of a home rule county may impose a tax upon all persons engaged, in such county, in the business of making sales of service at the same rate of tax imposed pursuant to Section 5-1006 of the selling price of all tangible personal property transferred by such servicemen either in the form of tangible personal property or in the form of real estate as an incident to a sale of service. If imposed, such tax shall only be imposed in 1/4% increments. On and after September 1, 1991, this additional tax may not be imposed on the sales of food for human consumption which is to be consumed off the premises where it is sold (other than alcoholic beverages, soft drinks and food which has been prepared for immediate consumption) and prescription and nonprescription medicines, drugs, medical appliances and insulin, urine testing materials, syringes and needles used by diabetics. The tax imposed by a home rule county pursuant to this Section and all civil penalties that may be assessed as an incident thereof shall be collected and enforced by the State Department of Revenue. The certificate of registration which is issued by the Department to a retailer under the Retailers' Occupation Tax Act or under the Service Occupation Tax Act shall permit such registrant to engage in a business which is taxable under any ordinance or resolution enacted pursuant to this Section without registering separately with the Department under such ordinance or resolution or under this Section. No tax may be imposed by a home rule county pursuant to this Section unless such county also imposes a tax at the same rate pursuant to Section 5-1006.

Persons subject to any tax imposed pursuant to the authority granted in this Section may reimburse themselves for their serviceman's tax liability hereunder by separately stating such tax as an additional charge, which charge may be stated in combination, in a single amount, with State tax which servicemen are authorized to collect under the Service Use Tax Act, pursuant to such bracket schedules as the Department may prescribe.

Whenever the Department determines that a refund should be made under this Section to a claimant instead of issuing credit memorandum, the Department shall notify the State Comptroller, who shall cause the order to be drawn for the amount specified, and to the person named, in such notification from the Department. Such refund shall be paid by the State Treasurer out of the home rule county retailers' occupation tax fund.

This Section shall be known and may be cited as the Home Rule County Service Occupation Tax Law. (Source: P.A. 90-689, eff. 7-31-98; 91-51, eff. 6-30-99.)

Section 99. Effective date. This Act takes effect upon becoming law."
