HOUSE RESOLUTION

The following resolution was offered and placed in the Committee on Rules.

HOUSE RESOLUTION 131

Offered by Representative Madigan:

WHEREAS, The Department of Central Management Services (CMS) is responsible for establishing "rules, procedures, and forms to be used by State agencies in the administration and payment of workers' compensation claims" and for the initial evaluation, determination, administration, and payment of workers' compensation claims involving State agencies [20 ILCS 405/405-105 and 405/405-411]; and

WHEREAS, According to the CMS website (http://www.cms.il.gov/cms/2_servicese_ben/workcomp.htm), "CMS Workers' Compensation Adjustors and unit supervisors are available to ensure efficient and proper claims administration in the following principal areas: 1) initial claim review for determining compensability; 2) ongoing benefit management (including payment of medical charges and temporary disability); and 3) proper negotiation of settlements based on partial or total permanent disability"; and

WHEREAS, Also according to the CMS website, the "Office of the Attorney General is responsible for

the defense of claims arising from work-related injuries or disease. The CMS Workers' Compensation Adjustors work closely with the Office of the Attorney General to bring litigated cases to a resolution if such resolution is advantageous to the State. Otherwise, when both parties fail to reach an agreement, a disputed claim is heard in front of an Illinois Workers' Compensation Commission Arbitrator for disposition."; and

WHEREAS, By statute, the "hearings before the Arbitrator shall be held in the vicinity where the injury occurred after 10 days' notice of the time and place of such hearing shall have been given to each of the parties or their attorneys of record" [820 ILCS 305/19(b)]; and

WHEREAS, By rule, designation of an alternative hearing site "may be had upon showing to the Commission of extreme hardship worked upon a party or parties by the designated site, or by agreement of the parties" [50 Ill. Adm. Code 7020.50]; and

WHEREAS, According to the Illinois Workers' Compensation Commission's FY09 annual report, of 57,192 cases closed in FY09 by arbitrators, 50,610 were closed through a settlement process in which the employer and employee enter into a Settlement Contract and present it for approval to the arbitrator assigned to the case; and

WHEREAS, Parties who are dissatisfied with an arbitrator's decision may appeal that decision to a panel of three IWCC commissioners, and the panel's decision is final for cases involving State of Illinois employees; and

WHEREAS, According to the IWCC's website (<http://www.iwcc.il.gov/news.htm>), under a procedure in effect prior to March 1, 2011, over 3,500 pro se settlement contracts were reviewed by arbitrators before being assigned a case number in calendar year 2010, making it difficult for the IWCC to "determine if any of those contracts go astray and fail to get entered into the system"; and

WHEREAS, Recent news reports raised questions about the practices of two workers' compensation arbitrators, each of whom has since been placed on administrative leave; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a management audit of the Workers' Compensation program as it applies to State employees; and be it further

RESOLVED, That the audit include, but not be limited to, the following:

- (1) the roles of the Department of Central Management Services, the Attorney General's Office, and the Illinois Workers' Compensation Commission in processing, reviewing, determining, and paying on workers' compensation claims filed by State workers;
- (2) the number of claims filed by State workers during the last 4 years, including a classification of the types of alleged injuries, employing unit, disposition, and claims payments;
- (3) a review of the settlement contract process and, in particular, documentation supporting any decisions on these claims;
- (4) an analysis of any fraud identification and control policies and procedures governing the workers' compensation program;
- (5) whether the processing of State employee workers' compensation claims complies with applicable State law and regulations;
- (6) an analysis of arbitrator caseloads over the 4-year period, including the number of cases closed, a classification of the types of alleged injuries involved in those cases, the employing unit involved in the claims, and claim dispositions and payments;
- (7) a review of conflict of interest policies applicable to arbitrators, commissioners, and other principals involved in the workers' compensation program, including any procedures for handling workers' compensation claims filed by arbitrators, commissioners, and other principals involved in the workers' compensation program; and
- (8) a comparison of claims history by State workers to claims filed by all other workers covered under the Workers' Compensation program; and be it further

WHEREAS, J. Garrett Tolan was a President of the American Angus Association and an inductee into the National Cattlemen's Hall of Fame; and

WHEREAS, J. Garrett Tolan's son John J. Tolan began working in the family business of breeding Angus show cattle before he started elementary school; and

WHEREAS, As a young teen, John J. Tolan received a national award, sponsored by Firestone Rubber Company, which recognized the most promising agricultural youth in the country; and

WHEREAS, J. Garrett Tolan's son John J. Tolan was a master breeder of multiple breeds of horses and cattle, but will likely be best remembered for his influence on the Angus cattle business; and

WHEREAS, The cattle and show circuit were John's life, and each year the main focus was to do well at the Chicago International, the world's premiere show for Angus cattle; and

WHEREAS, At the Chicago International, Tolan Farms showed 102 class winners and 85 Champions, bred 15 International Grand Champions, and exhibited 10 Best Ten Head groups; and

WHEREAS, The Tolan career record for Angus at all shows totaled 845 class winners and 385 Champions; and

WHEREAS, In 1951, Tolan Farms set a world record sale, which was the record sales price per head not only for Angus cattle, but also for livestock of any description, including Thoroughbred racehorses; and

WHEREAS, John J. Tolan served as a Director of the American Angus Association for 6 years; and

WHEREAS, John J. Tolan received many national honors and was voted by his peers as the number one breeder/judge of Angus cattle in the nation for 4 consecutive years; and

WHEREAS, John J. Tolan exhibited and judged Angus cattle at nearly every top tier show in North America; and

WHEREAS, John J. Tolan exhibited world and national champions of countless breeds and raced quarter horses and thoroughbreds for decades; and

WHEREAS, John J. Tolan could evaluate an animal's conformation in a split second and possessed a nearly photographic memory for both livestock and pedigrees; and

WHEREAS, John J. Tolan always loved that the livestock industry afforded one the opportunity to do business with and become friends with many interesting people; and

WHEREAS, Although John was widely viewed as a master breeder of livestock and was highly regarded, he was a modest man that deflected most praise that came his way; and

WHEREAS, The Tolans' immense contribution to Illinois agriculture and the development of Angus cattle should be recognized, and they deserve to have their achievements noted and remembered by current and future generations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate Barn 13 at the Illinois State Fairgrounds in Springfield as the J. Garrett and John J. Tolan Barn in recognition of the contributions of J. Garrett and John Tolan to agriculture in the State; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Director of Agriculture and the Director of Central Management Services.

HOUSE RESOLUTION 117

Offered by Representative Golar:

WHEREAS, Since the founding of Illinois' State hospitals, residents of Illinois with mental illnesses and developmental and other disabilities have been removed from Illinois communities and committed to live in State institutions; and

WHEREAS, Some residents of these State institutions were forced to labor without compensation; and

WHEREAS, Some residents of these State institutions were subjected to medical experiments and procedures without their consent, including the routine subjection of female inmates to involuntary sterilizations; and

WHEREAS, Some residents of these State institutions were subjected to punitive shock treatments, frontal lobotomies, aversive treatments, and isolation; and

WHEREAS, Thousands of children grew up in these State institutions learning none of the comforts, joys, and cultural norms that are learned in family life; and

WHEREAS, Thousands of parents whose children required intensive care were forced to make painful decisions about whether to institutionalize their children or to provide all the care and education they required themselves, incurring in the process immeasurable financial, career, social, and familial burdens; and

WHEREAS, Parents of persons with developmental disabilities were sometimes advised to institutionalize their children, and to break their familial bonds by making them wards of the State irrespective of the family's and community's ability to support and nurture these children; and

WHEREAS, These fellow Illinoisans were portrayed by some as subhuman organisms, as deviant individuals to be feared by society, and as eternal children unaccountable for their behavior and incapable of speaking for themselves or shaping their own lives, which greatly diminished their fellow citizens' ability and willingness to accept them for their own unique qualities; and

WHEREAS, Institutional care for persons with developmental disabilities has been scientifically demonstrated to be detrimental to people's basic development, including social development, development of self-determination, and the development of the basic skills of daily living; and

WHEREAS, Many residents of Illinois once viewed this institutional treatment as acceptable and subjected tens of thousands of citizens to it, but now recognize how wrong this treatment was; and

WHEREAS, Illinois' State institutions are closing and, through this process, their history and the acknowledgment of our collective responsibility for it may be forgotten; and

WHEREAS, People who were relegated to State institutions and their families have never received a formal apology from the State; and

WHEREAS, The states of Virginia, Oregon, South Carolina, California, and North Carolina have apologized for similar actions towards people with disabilities in their own states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State of Illinois apologizes publicly to all persons with mental illness and developmental and other disabilities who have been wrongfully committed to State institutions, acknowledging that it regrets this history of institutionalization of persons with those disabilities, and that it commits itself in their memory to move steadfastly to help residents of Illinois with those disabilities who in the future turn to the State for services to receive them in the least restrictive manner; and be it further

RESOLVED, That suitable copies of this resolution be delivered to appropriate organizations of people with disabilities and to the news media.

HOUSE RESOLUTION 119

Offered by Representative Bill Mitchell:

WHEREAS, The Central Illinois Economic Development Authority was created by Public Act 94-995 to coordinate the development of infrastructure and job-creation efforts in the central Illinois region; and

WHEREAS, The Central Illinois Economic Development Authority, by law, is responsible for supervising public efforts by the State and units of local government to develop infrastructure and create jobs within the counties of Macon, Sangamon, Menard, Logan, Christian, DeWitt, Macoupin, Montgomery, Calhoun, Greene, and Jersey; and

WHEREAS, Many of these counties are suffering from high rates of unemployment and other negative effects stemming from the worldwide economic recession; and

WHEREAS, The Central Illinois Economic Development Authority Act requires that the Board of Directors of the Central Illinois Economic Development Authority consist of 15 members including the Director of Commerce and Economic Opportunity, or a designee of that Department, 3 members appointed by the Governor, and one member appointed by the county board chairperson of each of the following counties: Macon, Sangamon, Menard, Logan, Christian, DeWitt, Macoupin, Montgomery, Calhoun, Greene, and Jersey; and

WHEREAS, Although the Central Illinois Economic Development Authority was created in 2006, the Governor has not appointed his 3 members of the Board of Directors of the Central Illinois Economic Development Authority as of November 19, 2010; and

WHEREAS, Because the Board of Directors is not fully constituted, the Central Illinois Economic Development Authority is not able to effectively help persons and entities who are being negatively affected by the economic recession; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to make his appointments to the Board of Directors of the Central Illinois Economic Development Authority, so that the Authority may commence full operations and carry out the responsibilities assigned to it by law; and be it further

RESOLVED, That a copy of this resolution be presented to the Governor.

HOUSE RESOLUTION 120

Offered by Representative Rose:

Offered by Representative Stephens:

WHEREAS, Pharmacists serve as an immediate link between the patient and the healthcare industry; citizens turn to and trust pharmacists to provide them with their prescribed medications, as well as healthcare information regarding the usage and safety precautions of both prescription and non-prescription therapies; and

WHEREAS, Pharmacists practice in a variety of settings, including local communities, hospitals, long-term care facilities, the pharmaceutical industry, managed care programs, academia, and government;

WHEREAS, There are currently over 12,000 pharmacists practicing and residing in the State of Illinois, and each one of them is dedicated to providing services that seek to improve and optimize medication use and advance patient care; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize March 16, 2011 as "Pharmacy Legislative Day" in the State of Illinois, giving Illinois Pharmacists the opportunity to continue their work with the General Assembly to advance issues of healthcare; and be it further

We never succumb to mediocrity, uncertainty or fear. We never fail because we never give up. We make no excuses. We choose to live honestly, nonviolently and honorably. We respect ourselves and, in doing so, respect all people. We have a future for which we are accountable. We have a responsibility to our families, community and world. We are our brothers' keepers. We believe in ourselves. We believe in each other. We believe in Urban Prep. WE BELIEVE."; and

WHEREAS, Of the 107 African-American graduates at the Urban Prep Academy for Young Men, only 4% of the graduates could read at their grade level when they were freshman; 82% of the students came from low-income families; and

WHEREAS, The Urban Prep Academy for Young Men managed to get all of the graduates accepted into 72 colleges around the nation through its innovative, pro-active stance on education; before the male students started their first freshman class 4 years ago, each student was assigned a college counselor; the students then took double periods of English and spent 72,000 more minutes in the classroom than their peers at regular Chicago public schools; the students also visited the esteemed Northwestern University; and

WHEREAS, The Urban Prep Academy for Young Men's counselors will also provide comprehensive support for the students throughout their college years; and

WHEREAS, These young men serve as models of hard work, integrity, and dedication for the people of the State of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we congratulate the 107 graduates of the Urban Prep Academy for Young Men for their success and wish them continued success and happiness in the future; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the principal of the Urban Prep Academy for Young Men on behalf of the 107 graduates as a symbol of our esteem and respect.

HOUSE JOINT RESOLUTION 17

Offered by Representative May:

WHEREAS, Article XIII, Section 5 of the Illinois Constitution provides that "[m]embership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired"; and

WHEREAS, The Illinois Supreme Court has held that the purpose of this provision is to ensure that pension benefits of public employees are not diminished or impaired; and

WHEREAS, Before the adoption of the present Illinois Constitution in 1970, pension benefits were considered in the nature of a gratuity or bounty that could be revoked at will; and

WHEREAS, An increasingly important question is whether a prospective diminishment in pension benefits, meaning a diminishment that applies only to an employee's future service, not to benefits already accrued from the employee's prior service, causes pension benefits to be diminished or impaired; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the Pension Reform Task Force; and be it further

RESOLVED, That the Task Force shall be charged with assessing whether a prospective diminution in pension benefits for current public employees is consistent with the prohibition on the diminishment and impairment of pension benefits under Article XIII, Section 5 of the Illinois Constitution; and be it further

RESOLVED, That the Task Force shall be composed of the following:

- (1) one member appointed by the Speaker of the House;
- (2) one member appointed by the President of the Senate;
- (3) one member appointed by the House Minority Leader;
- (4) one member appointed by the Senate Minority Leader;
- (5) one member who shall serve as the Chair of the Task Force, appointed by the Governor; and

(6) and one member appointed by the Attorney General; and be it further

RESOLVED, That the staff of the Commission on Government Forecasting and Accountability shall be responsible for staffing the Task Force in conjunction with the Illinois pension systems' actuaries and staff; and be it further

RESOLVED, That the Task Force shall hold hearings, no less than one per month, between June of 2011 and December of 2011; and be it further

RESOLVED, That the Task Force shall report its findings to the General Assembly and the Governor on or before January 1, 2012.

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the section of Interstate 57 between Exit 339 at Sauk Trail Road, and Exit 353 at 127th Street and Burr Oak Avenue, be renamed the Tuskegee Airmen Memorial Highway; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the Tuskegee Airmen Memorial Highway; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Secretary of the Illinois Department of Transportation.

HOUSE JOINT RESOLUTION 19

Offered by Representative Hays:

WHEREAS, Farmers' markets provide not only a valuable marketplace for farmers to sell their products directly to consumers, but also a place for consumers to access fresh fruits, vegetables, and other agricultural products; and

WHEREAS, These markets successfully operate across Illinois; however, there is a lack of comprehensive regulation from one county to the next, resulting in discrepancies between counties regarding the products that may be sold; and

WHEREAS, In 1999, the Department of Public Health published "Technical Information Bulletin/Food #30," in order to outline the sanitation guidelines required for farmers' markets, producer markets, and other outdoor food sales events; and

WHEREAS, This bulletin has not been uniformly interpreted across the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the Task Force on Farmers' Markets, consisting of 14 members appointed as follows: the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, and the Minority Leader of the House of Representatives shall each appoint one member; the Director of Public Health or his or her designee, the Director of Agriculture or his or her designee, a representative of a general agricultural production association appointed by the Department of Agriculture, 3 representatives of local county public health departments appointed by the Director of Public Health and selected from 3 different counties representing each of the northern, central, and southern portions of Illinois, and 4 members of the general public who are engaged in local farmers' markets appointed by the Director of Agriculture; and be it further

RESOLVED, That the Director of Public Health shall serve as the chair; the Task Force shall meet at the call of the Chair; and the members of the Task Force shall serve without compensation; and be it further

RESOLVED, That the Task Force can appoint members as it sees fit to serve as representatives of local farmers' markets or other concerned parties; and be it further

RESOLVED, That the duty of the Task Force is to undertake a comprehensive and thorough review of the current implementation of the various Acts that define which products and practices are permitted and which products and practices are not permitted at farmers' markets and other outdoor food sale events; and be it further

RESOLVED, That the Task Force shall assist the Department of Public Health in developing interagency agreements and programs and procedures regarding the implementation of the various Acts that define which products and practices are permitted and which products and practices are not permitted at farmers' markets and other outdoor food sale events; and be it further

RESOLVED, That the Illinois Department of Public Health shall provide staffing support to the Task

Force and shall administer and prepare all reports deemed necessary in conjunction with the Task Force; and be it further

RESOLVED, That the Task Force may request assistance from any entity necessary or useful for the performance of its duties; and be it further

RESOLVED, That the Task Force shall issue a report with its recommendations to the Secretary of the Senate and the Clerk of the House on or before December 31, 2012.

HOUSE JOINT RESOLUTION 20

RESOLVED, That the Advisory Panel shall report its findings and recommendations for reductions to the General Assembly by filing a report with the Secretary of the Senate and the Clerk of the House of Representatives before June 30, 2012; and be it further

RESOLVED, That the Advisory Panel shall have 12 voting members, as follows: 3 members of the Senate appointed by the President of the Senate, 3 members of the Senate appointed by the Senate Minority Leader, 3 members of the House of Representatives appointed by the Speaker of the House of Representatives, and 3 members of the House of Representatives appointed by the Minority Leader of the House of Representatives; and be it further

RESOLVED, That the Governor, or his or her designee, shall serve as an ex-officio, non-voting member of the Advisory Panel; and be it further

RESOLVED, That one member from each political party shall be selected by the Advisory Panel members to serve as a co-chairperson; and be it further

RESOLVED, That the Advisory Panel shall meet at the call of the co-chairpersons and that the members shall serve without compensation; and be it further

RESOLVED, That all actions of the Advisory Panel require the affirmative vote of at least 7 voting members; and be it further

RESOLVED, That the Governor's Office of Executive Appointments shall provide staff support to the Advisory Panel; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor of the State of Illinois.

Rev. Dr. Isaac Singleton, who recently passed away; and

WHEREAS, Rev. Dr. Isaac Singleton was one of the most influential spiritual leaders of our time; he dedicated his entire life to making a difference for mankind; during the 50's and 60's, Dr. Singleton played a major role in the civil rights movement, marching alongside Dr. Martin Luther King, Jr.; Dr. Singleton shared Dr. King's dream, his vision, and the struggle for equality; and

WHEREAS, As a result of believing right is right and wrong is wrong, he gained national recognition for his efforts in the civil rights movement; Dr. Singleton was known throughout the world as a leader for all people; he was also recognized as one of the most prolific speakers/teachers of the gospel; for over four decades, Dr. Singleton spread the good news of Jesus Christ around the world; for nearly 50 years, he served as the pastor of Mt. Zion Baptist Church in Joliet; and

WHEREAS, Prior to pastoring Mt. Zion, Dr. Singleton pastored the Russell Street Church in East St. Louis, and he pastored the Colette Street Church in Danville; under his leadership at Mt. Zion Baptist Church, membership grew from 100 to 2,000 members; and

WHEREAS, Dr. Singleton served as president for the Metropolitan Alliance Council (MAC); he was the founder and past president of the Joliet Affiliate Rainbow/P.U.S.H. Coalition; he served as the religious coordinator for the Illinois Rainbow/P.U.S.H. and as an active National Board Member; he was also the founder of the Hill Memorial Center of Joliet; and

WHEREAS, In 1986, Dr. Singleton was one of 150 African-American pastors invited to the White House by former President Ronald Reagan to consult on civil rights issues; Dr. Singleton served the community, State, and nation in many capacities, including serving as a former trustee for the Will County Regional Education Board, a member of the Joliet Township High School Foundation, an appointee to the Illinois Department of Children and Family Services Advisory Council by former Governor James Thompson (served 12 years and was chairman for two terms), Board of Directors of the Joliet Region Chamber of Commerce and Industry (served one year as vice president), a board member on the Economic Commission of Will County Downtown Redevelopment, President of the Baptist General State Congress of Christian Education of Illinois, instructor of the National Baptist Congress of Christian Education-USA, vice president of the National Baptist Congress, superintendent of Human Relations of the Baptist General State Convention of Illinois for 25 years, and moderator of the Lebanon Baptist District Association; and

WHEREAS, Dr. Singleton received many honorary distinctions, including inductions into the Who's Who Among Black Americans and the Joliet/Will County Hall of Pride; he was awarded the honor of having a street named after him (Singleton Place), and the board room within the Joliet Region Chamber of Commerce and Industry is also named in his honor (The Rev. Isaac Singleton Room); and

WHEREAS, Dr. Singleton was also the recipient of the Joliet Chamber Lifetime Achievement Award; he was also awarded the Community Relations Award from the city of Joliet (1970), the Distinguished Citizen Award from Lewis University (1975), the Outstanding Dedication to Service in Education from the Educational Service Region of Will County, and the Community Leader of American National Editors of America Award (1969); and

WHEREAS, Rev. Dr. Isaac Singleton is survived by his wife, the former Pearl B. Dexter; his six children; his 19 grandchildren; his 8 great grandchildren; and his 4 great-great grandchildren; therefore, be it
