**HOUSE JOINT RESOLUTIONS
CONSTITUTIONAL AMENDMENTS
FIRST READING**

Representative Lang introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 29**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 8.1 of Article I of the Illinois Constitution as follows:

ARTICLE I

BILL OF RIGHTS

SECTION 8.1. CRIME VICTIM'S RIGHTS.

(a) ~~To preserve and protect a victim's right to justice and due process, a crime victim~~ Crime victims, as defined by law, shall have the following rights ~~as provided by law:~~

(1) ~~The right to be treated with fairness and respect for the victim's their dignity and privacy and to be free from harassment, intimidation, and abuse~~ throughout the criminal justice process.

(2) ~~The right to refuse to disclose information that is privileged or confidential by law.~~

(3) ~~(2) The right to timely notification of all court proceedings, including related post-trial proceedings.~~

(4) ~~(3) The right to confer communicate with the prosecution.~~

(5) ~~(4) The right to be heard in person or in any other reasonable manner the victim chooses at any proceeding involving a post-arraignment release decision, plea, sentencing, post-conviction or post-adjudication release decision, or any proceeding in which a right of the victim is at issue~~ make a statement to the court at sentencing.

(6) ~~The right to receive a report prepared for sentencing, reduction in sentence, parole, early release, or clemency, when available to the accused.~~

(7) ~~(5) The right to be notified of information about the conviction, the sentence, any proposal that would reduce the sentence or result in release, the imprisonment, and the release of the accused.~~

(8) ~~(6) The right to timely disposition of the case following the arrest of the accused, including related post-trial proceedings.~~

(9) ~~(7) The right to be reasonably protected from the accused throughout the criminal justice process.~~

(10) ~~The right to have the safety of the victim and the victim's family considered in denying or fixing the amount of bail, determining whether to release the defendant, and setting conditions of release after arrest and conviction.~~

(11) ~~(8) The right to be present at the trial and all other court proceedings, including related post-trial proceedings on the same basis as the accused, unless the victim is to testify and the court determines that the victim's testimony would be materially affected if the victim hears other testimony at the trial.~~

(12) ~~(9) The right to have present at all court proceedings, subject to the rules of evidence, an advocate or other support person of the victim's choice.~~

~~(13)~~ (14) The right to full and prompt restitution.

(b) Definition. For the purposes of this Section, the term "crime victim" means a person directly and proximately harmed as a result of the commission of a criminal offense. In the case of a crime victim who is under 18 years of age, incompetent, incapacitated, or deceased, the legal guardians of the crime victim or the representatives of the crime victim's estate, family members, or any other persons appointed as suitable by the court may assume the crime victim's rights under this Section, but in no event shall the accused be named as such guardian or representative. The General Assembly may provide by law for the enforcement of this Section.

(c) A victim, the victim's lawyer, or the prosecuting attorney upon request of the victim may assert the rights enumerated in subsection (a) in any circuit or appellate court with jurisdiction over the case as a matter of right. The court shall act promptly on such a request.

(d) ~~(e)~~ The General Assembly may provide for an assessment against convicted defendants to pay for crime victims' rights.

(e) ~~(d)~~ Nothing in this Section or in any law enacted under this Section shall be construed as creating a basis for vacating a conviction ~~or a ground for appellate relief in any criminal case.~~

(f) Nothing in this Section creates any cause of action for compensation or damages against the State, any political subdivision of the State, any officer, employee, or agent of the State or of any of its political subdivisions, or any officer or employee of the court.

RESOLVED, That a copy of this resolution be delivered to the Attorney General.

HOUSE RESOLUTION 180

Offered by Representative Brady:

WHEREAS, The prescription of psychotropic drugs to treat psychiatric disorders has greatly increased in recent years; and

WHEREAS, The U.S. Food and Drug Administration has, since 2004, required manufacturers of selective serotonin reuptake inhibitor antidepressant medications (SSRIs) to add black box warnings to their product labeling, advising that studies have shown an increase in suicidal thinking and behavior among children and adolescents suffering from psychiatric disorders; and

WHEREAS, Health authorities in Canada, the European Union, Australia, and Great Britain have issued warnings regarding the increased risk of self-harm or harm to others associated with SSRIs; and

WHEREAS, In recent years there have been numerous documented instances of suicides and acts of violence against others by persons reported to have been taking antidepressants and/or other psychotropic medications; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Psychotropic Substances Suicide Risk Task Force be created within the Department of Public Health to (1) study and report upon the available research relevant to the reputed causal link between prescription of psychotropic substances and acts of suicide or violence against others; (2) to evaluate whether the State of Illinois' current policies with regard to psychotropic substances are adequate to protect the public; and (3) to make recommendations as to whether Illinois should consider adopting additional policies with regard to psychotropic substances, including but not limited to requiring county coroners to test for psychotropic substances in cases of suspected suicide; and be it further

RESOLVED, That the Task Force shall consist of the following members: 3 members appointed by the Speaker of the House of Representatives, one of whom shall be appointed co-chairperson, and 3 members appointed by the Minority Leader of the House of Representatives, one of whom shall be appointed co-chairperson; and 2 members appointed by the Director of the Department of Public Health, one a mental health advocate and one a psychiatric medical professional; and be it further

RESOLVED, That the Task Force shall take voluntary assistance and testimony from individuals and/or professional organizations and institutions; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation, but may be reimbursed for actual expenses while serving on the Task Force from funds appropriated to the Department of Public Health for that purpose; and be it further

RESOLVED, That the Task Force shall submit its final report to the Governor and the General Assembly no later than December 31, 2011.

HOUSE RESOLUTION 183

Offered by Representative May:

WHEREAS, Modern medicine has made amazing advances in fighting pediatric cancer; pediatric cancer survivors are faced with a unique set of problems because of these advances; and

WHEREAS, Cure rates for pediatric cancers have risen dramatically during the past 20 years; it is estimated that one in every 900 people, ages 16 to 44, is a survivor of pediatric cancer; and

WHEREAS, Today, almost 70% of children that are diagnosed with brain cancer survive treatment; this statistic calls into focus the need to look at a child's quality of life in the years following treatment; and

WHEREAS, Even well-insured, middle-class families with health insurance can find themselves in financial distress because of a single catastrophic illness; even when insurance doesn't run out, health care costs can be staggering for the families of children with cancer; and

WHEREAS, The State of Illinois recognizes that amazing advances have been made in the treatment of pediatric cancer and survivor rates; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of March 27 - April 2, 2011 as Pediatric Cancer Survivorship Week in the State of Illinois and urge the citizens of this State to show their support for those who have survived pediatric cancer.
