INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 3889. Introduced by Representative Ford, AN ACT concerning revenue.

HOUSE BILL 3890. Introduced by Representative Bellock, AN ACT concerning transportation.

HOUSE BILL 3891. Introduced by Representative Bellock, AN ACT concerning regulation.

HOUSE BILL 3892. Introduced by Representative Osmond, AN ACT concerning local government.

HOUSE BILL 3893. Introduced by Representative Golar, AN ACT concerning health.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 635

Offered by Representative Brown:

WHEREAS, The State National Guard was established under Title 10 and Title 32 of the U.S. Code and serves as part of the first-line of defense for the United States; and

WHEREAS, The reserve components of the United States armed forces are military organizations whose members generally perform a minimum of 39 days of military duty per-year and who supplement

the active duty military when necessary; and

WHEREAS, The purpose of each reserve component is to provide trained units and qualified persons available for active duty in the armed forces, in time of war or national emergency, and at such other times as the national security may require, to fill the needs of the armed forces whenever, and during and after the period needed to procure and train additional units and qualified persons to achieve the planned mobilization when more units and persons are needed than are in the regular components; and

WHEREAS, There are Guard and Reserve members who have served for 20 years of qualified service for retirement without being called for active duty service during their military career, and at age 60, they are eligible for reserved military retirement pay, government health care, and other benefits of service including some veterans' benefits, but due to current federal statute they are denied full standing as a "veteran" of the armed forces; and

WHEREAS, There are numerous Guard and Reserve members whose position is to train, prepare, and support the armed forces that are called to active duty, and these members are ready for deployment, but based on their assignment jobs are not called upon to be deployed; and

WHEREAS, These Guard and Reserve members have served and deserve the status of "veteran" of the armed forces; and

WHEREAS, S.491 and H.R. 1025, currently pending in the United States Congress, would authorize National Guard and Reserve members entitled to Reserves retirement pay the honor of claiming "Veteran of the Armed Forces of the United States" status; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Congress to pass S.491 and H.R. 1025 to provide National Guard and Reserve members entitled to Reserves retirement pay the honor of claiming veterans status; and be it further

RESOLVED, That suitable copies of this resolution be presented to the majority and minority leaders of the United States Senate, the Speaker and minority leader of the United States House of Representatives, and to each member of the Illinois Congressional delegation.

HOUSE RESOLUTION 654

Offered by Representative DeLuca:

WHEREAS, In 1970, Congress enacted the Clean Air Act to improve air quality and reduce air pollution; and

WHEREAS, In 1977, the Clean Air Act was amended and broadened to include an Inspection and Maintenance program; and

WHEREAS, In 1983, the USEPA began formal sanctions to withhold federal highway funding from Illinois for failure to meet ozone health requirements; and

WHEREAS, In response, Public Act 83-1477 created an Inspection and Maintenance program, which began in 1986 and is known as the Illinois Vehicle Emissions Testing Program; and

WHEREAS, Illinois tests the emissions of certain gasoline-powered vehicles that are more than 4 model years old; and

WHEREAS, These tests are performed in Chicago and Metro-East St. Louis areas that have exceeded federal air quality standards; and

WHEREAS, The Illinois Environmental Protection Agency (IEPA) uses a contractor to perform these tests, and the program's total cost is approximately \$50 million per year; and

WHEREAS, In calendar year 2000, the contractor performed 1,647,995 emissions tests, and 8.4% of the vehicles tested, most of which had model years earlier than 1990, failed; and

WHEREAS, The last time this program was audited was in 2001; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Auditor General to conduct a management audit of the Illinois Environmental Protections Agency's Vehicle Emissions Inspection Program in the Chicago metropolitan and East St. Louis areas and to make, at the close of that audit, specific determinations related to: (i) IEPA monitoring of the contractor; (ii) the training of the contractor's employees; (iii) the effectiveness of the contractor's process for responding to damage complaints; and (iv) the differences between tests used in Illinois and those used in other states; and be it further

RESOLVED, That the Office of the Auditor General submit its findings to the House of Representatives as soon as is practical after the conclusion of the audit.

HOUSE RESOLUTION 655

Offered by Representative Ford:

WHEREAS, The current difficult economic conditions have heavily impacted the small businesses in our nation through decreased sales and difficulties in obtaining small business financing; and

WHEREAS, The National Bureau of Economic Research (NBER), noting the significant role that small business plays in the U. S. economy, found that: (1) roughly 6 million small businesses with fewer than 20 employees account for 20 percent of aggregate paid employment and about 15 percent of all sales receipts and payroll in the United States; and (2) if small business firms with fewer than 100 employees are considered, the firms comprised 35 percent of aggregate employment in the country; and

WHEREAS, The National Federation of Independent Business (NFIB) has collected small business economic trends data with surveys since 1973; in October 2011, the NFIB reported that its Index of Small Business Optimism fell again to its fourth-lowest reading in the 38-year history of the survey; and

WHEREAS, The NFIB's October 2011 survey further revealed low ratings in the small business sector's expectations concerning employment (overall reduction in employment for fifth month in a row), inventories and sales (26 percent of the owners indicated, "poor sales" is their top business problem), and improved business conditions (the net percent of owners expecting better business conditions in 6 months was a negative 16 percent, 6 points better than September, but still 26 points worse than January); and

WHEREAS, The NFIB October 2011 analysis also noted that consumer confidence posted only marginal gains over the last few months and consumer confidence in economic policies remains at 50-year record low levels according to the University of Michigan's consumer confidence survey; and

WHEREAS, Small businesses in the State of Illinois have been greatly impacted by the weak economic conditions, with many small business owners becoming uncertain of their future prospects and seeing diminishing returns as the difficult economic circumstances continue; and

WHEREAS, Small businesses serve as the backbone of the economies of the State of Illinois and the nation at large and are deserving of the State's full support and encouragement; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of January 2012 as "Small Business Month" in the State of Illinois in honor of the small business owners of this State and their vital role in the economy.

HOUSE JOINT RESOLUTION 51

Offered by Representative Chapa LaVia:

WHEREAS, Gifted and talented students make up 5% to 10% of the prekindergarten to grade 12 student population in Illinois; and

WHEREAS, Students with gifts and talents, and high-ability students who have not been formally identified for gifted education services, require modifications to the general education curriculum to fully meet their educational needs; and

WHEREAS, There is a growing gap at the highest levels of achievement between the performance of subgroups of students, particularly those students who are African-American or Hispanic and those who are Caucasian, on statewide assessments of academic progress; and

WHEREAS, Effective assessment and instruction of students with gifts and talents require educators to have specialized knowledge and skills; and

WHEREAS, Interventions and strategies that have been demonstrated to be successful with gifted and talented students can be modified to improve the achievement of all students; and

WHEREAS, Illinois has not provided funding designated for the education of gifted and talented students directly to local school districts since 2003; and

WHEREAS, There are currently no accountability mechanisms in place in Illinois for education services for gifted and talented children; and

WHEREAS, Students who are both gifted and have a disability (twice-exceptional) present special challenges because their disability often masks their academic potential or their academic strengths may mask their disability, resulting in the lack of services and supports for this population; and

WHEREAS, Legislation creating the Talent Act, H.R. 1674 and S. 857, has been introduced in Congress by Representative Elton Gallegly (R-California) and by Senator Charles Grassley (R-Iowa), respectively; and

WHEREAS, The Talent Act would assist states and school districts in addressing the needs of gifted and talented students, including twice-exceptional students, and in improving the teaching of gifted and talented students; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the United States Congress to pass the Talent Act either as a separate Act or as an amendment to the Elementary and Secondary Education Act or another Act of Congress; and be it further

RESOLVED, That we urge members of the Illinois congressional delegation to become co-sponsors of the Talent Act legislation; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker and Minority Leader of the United States House of Representatives, the Majority and Minority Leaders of the United States Senate, and each member of the Illinois congressional delegation.

HOUSE JOINT RESOLUTION 52

Offered by Representative Bill Mitchell:

WHEREAS, The State of Illinois is functional to the extent that its people agree on politics, society, and economics; and

WHEREAS, The people who constitute a majority of Cook County and the people who constitute a majority of the other 101 counties in Illinois hold different and firmly seated views on these important questions; and

WHEREAS, Cook County, on one hand, and the other 101 counties, on the other, are each roughly equal in population; and

WHEREAS, Both groups should enjoy the chance to govern themselves with their firmly seated values; and

WHEREAS, Article IV, Section 3 of the Constitution of the United States provides that "(n)ew States may be admitted by the Congress into this Union; but no new States shall be formed or erected within the Jurisdiction of any other State; nor any State be formed by the Junction of two or more States, or parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress."; and

WHEREAS, From 1776 to 1820, Maine was a physically separate but politically contiguous part of the State of Massachusetts; and

WHEREAS, This arrangement did not work very well and Massachusetts agreed to the secession in a law approved by the Governor of Massachusetts on June 19, 1819; and

WHEREAS, The law authorized that the inhabitants of Maine vote on secession, and the inhabitants voted in July 1819 to secede from Massachusetts; and

WHEREAS, A constitutional convention was held in Portland in October 1819 and the delegates adopted a constitution which was approved at town meetings held on December 6, 1819; and

WHEREAS, Congress passed a bill admitting Maine into the Union as a separate state and President Monroe signed that bill into law on March 3, 1820 and Maine became a state on March 15, 1820; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly agrees to the separation of Cook County and the other 101 counties into 2 separate states; and be it further

RESOLVED, That the General Assembly authorizes a referendum to be held to confirm the desire of the

voters of Illinois to separate Cook County and the rest of Illinois into 2 separate states; and be it further

RESOLVED, That following the adoption of the referendum, the General Assembly urges Congress to pass a bill that consents to the division of Cook County and the other 101 counties of Illinois into 2 separate states and urges the President to sign such bill into law.
