HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 859

Offered by Representative DeLuca:

WHEREAS, There are many inefficiencies in the healthcare industry within the State of Illinois; and
 WHEREAS, It is important to identify possible efficiencies that can produce savings to the State in the area of healthcare; and

WHEREAS, In regards to the costs of the uninsured and from observations of trends within the healthcare industry, the consolidation of certain divisions within State agencies is viewed as a cost-effective way to create systematic efficiencies; and

WHEREAS, Given the direction Illinois and other states are taking as they move toward healthcare integration and a complete system of care for Medicaid services, the Department of Human Services' Divisions of Mental Health, Alcohol and Substance Abuse, and Developmental Disabilities have been identified for consolidation into a new Division of Behavioral Health within the Department of Healthcare and Family Services for the following reasons:

- (1) to eliminate redundant infrastructure by consolidating information technology and claims processing into one comprehensive system that works;
- (2) to eliminate redundant administrative positions;
- (3) to reduce administrative overhead costs;
- (4) to ensure care coordination for Medicaid enrollees;
- (5) to streamline enrollment processes for consumers;
- (6) to streamline claims processing by requiring all service providers to report and to bill to one entity for all of the healthcare needs of Medicaid enrollees;
- (7) to increase provider accountability by producing accurate data of service provider outcomes and measures; and
- (8) to achieve the goal of less administrative overhead for providers, resulting in more individuals served with no new expenditures; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created a task force to examine the advisability of consolidating the Department of Human Services' Divisions of Mental Health, Alcohol and Substance Abuse, and Developmental Disabilities into a new Division of Behavioral Health within the Department of Healthcare and Family Services; and be it further

RESOLVED, That the task force shall consist of 9 members, 3 of whom shall be appointed by the Speaker of the House of Representatives, 3 of whom shall be appointed by the Minority Leader of the House of Representatives, and 3 of whom shall be appointed by the Governor, all of whom shall serve without compensation; and be it further

RESOLVED, That the Department of Human Services and the Department of Healthcare and Family Services shall provide administrative and other support to the task force; and be it further

RESOLVED, That the task force shall report its findings to the House Human Services Committee on or before June 1, 2013; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Director of the Department of Healthcare and Family Services and the Secretary of the Department of Human Services.

HOUSE RESOLUTION 860

Offered by Representative Pihos:

WHEREAS, Nursys (www.nursys.com) is the national nurse licensure database operated by the National Council of State Boards of Nursing (NCSBN), located in Chicago; and

WHEREAS, Boards of nursing in 48 states and territories presently participate in Nursys and 3 additional jurisdictions have signed agreements to fully participate in Nursys; and

WHEREAS, Nursys is a vital tool for boards of nursing to protect the public; and

WHEREAS, Full-participating boards of nursing contribute licensure and discipline data to Nursys; and

WHEREAS, Participation in Nursys is a no-cost benefit to members of NCSBN and allows member boards of nursing to share licensure and discipline data with other boards of nursing; and

WHEREAS, Participating boards of nursing retain complete control of their data and are thus

responsible and accountable for their data in Nursys; and

WHEREAS, Nursys contains personal, licensure, education, verification, and discipline information supplied as regular updates by boards of nursing in the U.S. and its territories; and

WHEREAS, Nursys provides centralized license information to boards of nursing, which in turn, use this data to verify applicant license information, enter and review disciplinary actions, and send electronic communications between boards of nursing for information requests; and

WHEREAS, Employers and the public have free online access to information about nurses who hold a license in a Nursys fully-participating jurisdiction, including past disciplinary history via the "Licensure Quick Confirm" feature on www.nursys.com; and

WHEREAS, The Illinois Board of Nursing's current online licensure lookup service will only display Illinois licenses and does not display additional licenses held by Illinois licensees in other jurisdictions; and

WHEREAS, The Illinois Board of Nursing is a dues-paying member of NCSBN, but does not fully participate in the Nursys database; and

WHEREAS, The Illinois Board of Nursing will not incur any revenue loss by full participation in Nursys in view of participation in the license verification service being optional; and

WHEREAS, As a public protection function of Nursys, a board of nursing that fully participates in Nursys receives immediate notification whenever one of its state licensees is disciplined in another jurisdiction, while, as a non-participant in Nursys, Illinois does not benefit from such instant notifications; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Board of Nursing of the Illinois Department of Financial and Professional Regulation to take the necessary steps to become a full participant of the Nursys national nurse licensure database; and be it further

RESOLVED, That we further urge the Illinois Board of Nursing to sign the Nursys participation agreement in 2012; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Board of Nursing of the Illinois Department of Financial and Professional Regulation.

HOUSE RESOLUTION 861

Offered by Representative Greg Harris:

WHEREAS, No resident of Illinois should have to be food-insecure; and

WHEREAS, 1,873,010, or 1 in 7 residents of the State of Illinois are experiencing food insecurity, meaning they lack access to adequate nutritious food for a healthy lifestyle; and

WHEREAS, 745,310, or just under 1 in 4 children in the State of Illinois are experiencing food insecurity; and

WHEREAS, Food insecurity is experienced in every county in the State of Illinois; and

WHEREAS, Feeding Illinois food banks have seen a 73% increase in requests for emergency food assistance over the past 3 years; and

WHEREAS, Hunger increases health care costs, lowers workers' productivity, harms children's development, and diminishes children's educational performance; and

WHEREAS, Fighting hunger is a public-private partnership; in Illinois, a strong private network exists that has provided 1.4 million people in Illinois with more than 127 million pounds of food in 2010; however, private charity cannot do it alone and a strong federal hunger relief safety net is required; and

WHEREAS, The Illinois General Assembly established the Commission to End Hunger in 2010 in recognition of the need to end food insecurity in the State of Illinois; and

WHEREAS, The Commission to End Hunger acknowledges in its recommendations the critical importance of federal programs that address food and nutrition; and

WHEREAS, The federal Farm Bill establishes the funding and policy for vital food and nutrition programs, such as the Supplemental Nutrition Assistance Program (SNAP), The Emergency Food Assistance Program (TEFAP), and the Commodity Supplemental Food Program (CSFP); and

WHEREAS, SNAP is the cornerstone of the nutrition safety net, with 1.9 million, or 1 in 6, Illinois residents enrolled in the program; just under half of those utilizing the program are children; and

WHEREAS, Any reduction in funding of the SNAP Program will increase the number of food-insecure

people in Illinois; and

WHEREAS, Maintaining the current model of 100% federal funding of SNAP assistance is essential to retaining the program's effectiveness in fighting hunger; and

WHEREAS, TEFAP is a means-tested federal program that provides food commodities at no cost to Illinoisans in need of short-term hunger relief through organizations like food banks, pantries, soup kitchens, and emergency shelters; and

WHEREAS, CSFP leverages government buying power to provide nutritious food packages to 17,473 vulnerable individuals in Illinois in Fiscal Year 2011, nearly 97% of which are seniors; and

WHEREAS, The decisions made in developing the next Farm Bill will impact the ability of food-insecure Illinoisans to access the food and nutrition safety they need; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to develop the 2012 Farm Bill with a strong Title IV that protects and strengthens federal food and nutrition programs; and be it further

RESOLVED, That we state our belief that the 2012 Farm Bill must oppose proposals to cap or reduce funding for SNAP, restrict eligibility, or reduce benefits; support proposals to increase benefit adequacy to ensure that households have the resources to purchase a nutritionally adequate diet; support proposals that would make mandatory funding for TEFAP food more responsive to changes in need; enhance the United States Secretary of Agriculture's authority to purchase bonus commodities in times of high need for emergency food relief in addition to times of low commodity prices; reauthorize funding for TEFAP Storage and Distribution and TEFAP Infrastructure grants; and protect funding for CSFP while transitioning the program to a senior-only program and grandfathering in current participants; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the members of the Illinois congressional delegation, the President of the United States, and the United States Secretary of Agriculture.

HOUSE RESOLUTION 872

Offered by Representative Dugan:

WHEREAS, The Illinois Emergency Medical Services (EMS) System, comprised of dozens of individual EMS systems operating throughout the State, has since the early 1970s represented one-third of our crucial 911 emergency response infrastructure; and

WHEREAS, Illinois' EMS system and the thousands of people it employs continue to play a vital and life-saving role for the people of Illinois; and

WHEREAS, Approximately two-thirds of non-police 911 calls are calls requesting an ambulance; and

WHEREAS, In addition to responding to 911 calls placed from homes and businesses, Illinois' EMS system covers all 16,000 miles of Illinois' roads; and

WHEREAS, EMS ambulances annually respond to tens of thousands of motor vehicle crashes, treating 88,937 injured motorists in 2010, the latest year of available data; and

WHEREAS, Timely, efficient, and appropriate emergency medical care is one of the most significant factors in determining a patient's outcome for a great many medical issues in addition to trauma, notably including acute cardiovascular disease, the nation's number one killer of adults; and

WHEREAS, Properly maintained ambulances outfitted with advanced medical equipment are necessary to provide optimal emergency medical care on scene and enroute to the hospital; and

WHEREAS, Advanced levels of training are necessary for all practitioners of emergency medicine, with higher licensure levels representing greater lengths of training and a greater range of advanced medical procedures; and

WHEREAS, Despite longer average drive times from the scene of a medical emergency to a hospital, and thus longer periods of time in which patients are in the sole care of emergency medical practitioners, many rural EMS systems are staffed primarily by volunteer Emergency Medical Technicians often with comparably lower levels of training and less available medical equipment than is found in most urban EMS systems; and

WHEREAS, While many well-funded federal grants were deservedly made available to police and fire services over the last 11 years, the same cannot be said of federal funds available to EMS services, forcing many joint fire/EMS departments and stand-alone EMS departments to rely on ad-hoc local fundraising

efforts to keep up aging ambulances and basic equipment; and

WHEREAS, The State has often found it necessary to sweep expected EMS funds due to ongoing budget challenges, resulting in the fact that actual EMS funding has largely remained flat or declined over the last 10 years; and

WHEREAS, Attrition of more highly-trained EMTs, especially within volunteer EMS departments, has led to a situation in which recruitment, up-training, and retention of qualified EMTs has become incredibly challenging for many EMS departments; and

WHEREAS, These various challenges are indicative of the fact that despite over 40 years of crucial service, and in contrast to the equally worthy Police and Fire Services, Emergency Medical Service has never been declared an essential service by the State of Illinois; and

WHEREAS, Despite these many challenges they face as an equal third of the State's emergency response infrastructure, the brave and talented men and women of Illinois' EMS system continue to save lives and improve medical outcomes for patients across the State on a daily basis; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that Emergency Medical Service should be prioritized in line with its value to the people of Illinois and should formally be declared an Essential Service.
