#### **HOUSE RESOLUTION 1098**

Offered by Representative Reboletti:

WHEREAS, In 2007, Public Act 95-596 was enacted into law, directing the Governor to issue an official notice to all persons and entities covered by the Flag Display Act to fly the United States flag, the State flag of Illinois, and in the case of a Armed Forces member's death, the appropriate military flag, at half-staff upon the death of a resident of Illinois killed by hostile fire as a member of the United States Armed Forces, in the line of duty as a law enforcement officer, or in the line of duty as a firefighter; and

WHEREAS, Not every person or local government entity that displays the United States flag, the State flag of Illinois, or the military flag of any branch of the United States Armed Forces or the Illinois National Guard is covered by the Flag Display Act; and

WHEREAS, Those persons and entities in Illinois who choose to display the United States flag, the State flag of Illinois, or the military flag of any branch of the United States Armed Forces or the Illinois National Guard, but who are not covered by the Flag Display Act, may in some cases be unaware that the Governor has issued an official notice to fly the flags at half-staff to honor a fallen Armed Forces member, law enforcement officer, or firefighter; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge local government entities and other persons who display the United States flag, the State flag of Illinois, or the military flag of any branch of the United States Armed Forces or the Illinois National Guard to subscribe to the Illinois Flag Honors e-News Summaries service on the Office of the Governor's website in order to honor fallen U.S. Armed Forces members, law enforcement officers, and firefighters; and be it further

RESOLVED, That we urge State and local government entities and private state-wide associations and organizations to provide links on their websites to the Illinois Flag Honors e-News Summaries service subscription page on the Office of the Governor's website, and to include information about that service in their newsletters and publications in order to further encourage the flying of the United States flag, the State flag of Illinois, and military flags at half-staff to honor fallen U.S. Armed Forces members, law enforcement officers, and firefighters.

WHEREAS, Illinois ranks fifth nationally in submitted questionable claims related to bodily injury; and

WHEREAS, Illinois has adequate insurance fraud laws, especially in relation to immunity for reporting and sharing information; and

WHEREAS, Illinois has strong criminal penalties for insurance fraud; and

WHEREAS, A fraud bureau exists to investigate workers' compensation fraud; and

WHEREAS, Illinois has a Motor Vehicle Theft Prevention Council, funded by a \$1 charge per auto insurance policy, that helps combat vehicle theft and has contributed to a 60% decline in vehicle theft since 1991; and

WHEREAS, A bureau or other facility to investigate property and casualty and medical fraud does not exist; and

WHEREAS, The top recommendation arising from the 2008 Illinois Insurance Fraud Summit held by the NICB was the need for a dedicated insurance fraud prosecutor; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the Illinois Insurance Fraud Task Force; and be it further

RESOLVED, That the Task Force shall be composed of the following members: the Director of the Illinois Department of Insurance or his or her designee, the Director of the Illinois State Police or his or her designee, the Director of the Criminal Justice Information Authority or his or her designee; the Attorney General or his or her designee; the Cook County State's Attorney or his or her designee; the Superintendent of the Chicago Police Department or his or her designee; a local Police Chief designated by the Illinois Association of Chiefs of Police; a County Sheriff designated by the Illinois County Sheriffs Association; three property and casualty insurance companies designated by the Illinois Insurance Association; the President of the National Insurance Crime Bureau or his or her designee; the President of the Illinois Insurance Association or his or her designee; and the Governor of the State of Illinois or his or her designee; and be it further

RESOLVED, That at the first meeting of the Task Force a chairperson be selected from among its members; and be it further

RESOLVED, That the Illinois Insurance Fraud Task Force shall (i) investigate the issue of organized insurance fraud crime, especially as related to the rapidly escalating problem of medical fraud, (ii) examine methods to unite the collective resources of the insurance industry with appropriate components of federal, State, and local law enforcement agencies to pinpoint organized criminal schemes, and (iii) examine concepts for establishing a permanent and financially sustained public-private partnership to combat insurance fraud crimes with emphasis placed on the establishment of a dedicated investigative and prosecutorial focus on insurance fraud crimes; and be it further

RESOLVED, That the Illinois Insurance Fraud Task Force submit a report of its findings and recommendations to this body on or before August 30, 2013.

(2) the relationship between the Safety Net Works program and the Initiative;

(3) the nature and extent of monitoring by the Illinois Violence Prevention Authority of how the Initiative used the State-provided moneys and whether certain residential communities of similar crime rates were excluded;

(4) the actual use of State moneys by the Authority, including the identity of any sub-recipients and the amounts and purposes for employment;

(5) the number of positions paid through the Initiative by organizational unit, job title, function, and salary and whether employees completed and filled out appropriate timesheets;

(6) the number of positions supervised or managed by each management position and whether any of those employees are supervised or managed by more than one management position;

(7) whether, through a review of available documentation, the Initiative has met or is meeting the purposes for which the State moneys were provided, with specific information concerning the Initiative staffing levels, hiring procedures, and its compensation of employees; and

(8) whether the Initiative is in compliance with the applicable laws, regulations, contracts, and grant agreements pertaining to the Initiative's receipt of State moneys; and be it further

RESOLVED, That the Illinois Violence Prevention Authority and any other State agency or other entity or person that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office in its audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as practical and report his findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Auditor General.
