HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 1186

Offered by Representative Brown:

WHEREAS, The ongoing drought is having a profound effect on both crop and livestock production; and

WHEREAS, The United States Department of Agriculture (USDA) has designated 98 out of 102 counties in Illinois disaster areas due to drought conditions; and

WHEREAS, The severe drought conditions are creating poor pasture conditions and reducing forage yields making it more difficult for farmers to feed their livestock; and

WHEREAS, The USDA Farm Service Agency (FSA) has announced that emergency haying and grazing will be allowed as of August 2, 2012, for certain Conservation Reserve Program (CRP) practices; and

WHEREAS, The CRP practices included for emergency haying and grazing do not currently include filter strips as an eligible practice; and

WHEREAS, Allowing CRP filter strips to be utilized for emergency haying and grazing would provide desperately needed acreage for farmers to use as feed for their livestock; and

WHEREAS, The Illinois State FSA has requested that filter strips be utilized for emergency haying and grazing but the federal government has not yet approved this request; and

WHEREAS, Filter strips should immediately be added to the list of conservation practices eligible for emergency haying and grazing; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor, the Director of the Illinois Department of Agriculture, and the members of the Illinois Congressional delegation to take all action possible to encourage the U.S. Secretary of Agriculture to immediately allow filter strips to be recognized as a conservation practice eligible for emergency haying and grazing in Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor, the Illinois Director of Agriculture, and the Illinois Congressional delegation.

HOUSE RESOLUTION 1187

Offered by Representative Flowers:

WHEREAS, Proper dental care is a vital health concern that is overlooked by or unavailable to many Americans; a lack of routine oral health care can lead to serious consequences, including severe tooth decay, gum disease, and potentially deadly infections; unchecked dental problems can also increase the risk of serious and chronic health conditions, such as diabetes and heart disease; and

WHEREAS, In June of 2012, United States Senator Bernie Sanders (VT) introduced the Comprehensive Dental Reform Act of 2012 into the Senate; and

WHEREAS, The Comprehensive Dental Reform Act of 2012 seeks to end the oral health crisis in

America by expanding coverage, creating new access points, enhancing the workforce, improving education, and funding new research; the Act would extend comprehensive dental health insurance to millions of Americans who do not have coverage today, while increasing both the number of places that would accept such coverage and the number of qualified oral health care professionals in communities with the greatest need for them; and

WHEREAS, The Comprehensive Dental Reform Act of 2012 would also address the need to educate current and future oral health care providers to better serve vulnerable populations and to integrate oral health care into overall health care, as well as authorize greater amounts of funding for research on prevention and disease management techniques to improve oral health care delivery and the oral health status of the nation; and

WHEREAS, The passage of the Comprehensive Dental Reform Act of 2012 would be a step in the proper direction of ensuring that all Americans can receive the quality, consistent health care that they deserve; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the President and Congress to pass H. 3272, the Comprehensive Dental Reform Act of 2012; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker and Minority Leader of the United States House of Representatives, the Majority and Minority Leaders of the United States Senate, and the President of the United States.

HOUSE RESOLUTION 1188

Offered by Representative Turner:

WHEREAS, Many State-supported passenger trains in Illinois currently are operating at full capacity; and

WHEREAS, Passenger train demand has doubled in the last 5 years and continues to grow; and

WHEREAS, The federal government has provided Illinois and the Midwest states with capital grants to acquire new "Next-Generation" passenger trains; and

WHEREAS, The "Next-Generation" train order is designed to replace, not supplement, the number of trains in service; and

WHEREAS, The State of Illinois will not be able to accommodate increased ridership solely through the use of "Next-Generation" trains; and

WHEREAS, Federal law has mandated that states shall begin to make capital payments for trains in service as of October 2013; and

WHEREAS, The State of Illinois' capital payments can favor the continued growth and reduced cost of its State-supported passenger trains; and

WHEREAS, The State of Illinois can increase its ridership capacity by directing these capital payments to high-speed, high-capacity trains that are interoperable with the State's "Next-Generation" train specification to supplement "Next-Generation" trains; and

WHEREAS, The State of Illinois may offset the capital payments for these trains by selling more tickets made available by the greater number of seats on these trains; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in order to address the above capacity and cost issues, the Illinois Department of Transportation (IDOT) shall develop a strategy to acquire additional passenger railcars in advance of the Next Generation deliveries and shall deliver an action plan to implement this strategy; and be it further

RESOLVED, That any trains used to supplement the current fleet must be able to operate at speeds of 110 MPH, must have a high-capacity of over 72 seats per coach, must be interoperable with the State's "Next-Generation" train specification, and must be delivered in advance of the receipt of the State's "Next-Generation" trains; and be it further

RESOLVED, That IDOT shall deliver the action plan in writing no later than 30 days from adoption of this resolution to the members of the Illinois House of Representatives, the Governor of the State of Illinois, the Illinois Director of Commerce and Economic Opportunity, and the Director of the Governor's Office of Management and Budget.

HOUSE RESOLUTION 1197

Offered by Representative Beiser:

WHEREAS, The State of Illinois is home to more than 10,000 Armenians living in communities throughout the State; the Armenian Apostolic Church has been the spiritual, cultural, and historic center of Armenian communities for more than 1,700 years; and

WHEREAS, His Holiness Catholicos Aram I has been the spiritual leader of the Holy See of Cilicia of the Armenian Apostolic Orthodox Church since 1995; he previously visited the State of Illinois in 1997 and 2005; and

WHEREAS, From October 22-25, 2012, His Holiness Catholicos Aram I will be visiting Armenian Apostolic Churches in Glenview, Granite City, and Waukegan during his Pontifical Visit, entitled "Witness and Renewal: Taking the Church to the People"; and

WHEREAS, The goals of His Holiness' visit are to make the life of the Church a part of the everyday life of the faithful of all ages, to hear the concerns and thoughts of the faithful, and to share his vision for the Church in a rapidly changing world; and

WHEREAS, His Holiness was born in 1947 in Beirut, Lebanon; he is a graduate of the Armenian Theological Seminary in Antelias, Lebanon, and the Ecumenical Institute of Bossey, Switzerland and holds his Ph.D. from Fordham University in New York; he was ordained as a priest in 1968 and earned the title of vartabed (Doctor of the Armenian Church) in 1970; he was consecrated as Catholicos on July 1, 1995; and

WHEREAS, For nearly 50 years, His Holiness has been a participant in the worldwide Ecumenical Movement and today is considered to be one of the ecumenical giants of our time; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of October 21-27, 2012 as "Armenian Apostolic Church Week" in the State of Illinois and urge all members of the community to unite with the Armenian Apostolic Churches in welcoming His Holiness Catholicos Aram I to our State as he spreads his theme of "Witness and Renewal: Taking the Church to the People" during visits to Armenian All Saints Apostolic Church in Glenview, St. Gregory the Illuminator Armenian Apostolic Church in Granite City, and St. Paul Armenian Apostolic Church in Waukegan; and be it further

RESOLVED, That a suitable copy of this resolution be presented to His Holiness Catholicos Aram I as a symbol of our esteem and respect.

HOUSE JOINT RESOLUTION 95

Offered by Representative Morrison:

WHEREAS, Since being admitted into the Union in 1818, The State of Illinois has only recognized marriages between one man and one woman; and

WHEREAS, The Illinois Constitution of 1970, based on its text, history and interpretation, does not confer any right to enter into a same-sex marriage, but only a right to enter into an opposite-sex marriage; and

WHEREAS, In 1996, the Illinois General Assembly amended the Illinois Marriage and Dissolution of Marriage Act to make explicit what has always been implicit in our marriage laws: that marriage is a relationship that may exist only between one man and one woman (Section 201), to prohibit same-sex marriages (Section 212(a)(5)), and to state that a marriage between 2 persons of the same sex is "contrary to the public policy of this State" (Section 213.1); and

WHEREAS, Federal law recognizes and provides the benefits of marriage only to those marriages between a man and a woman; and

WHEREAS, For thousands of years, religious faiths have recognized only marriages between one man and one woman; and

WHEREAS, By popular vote, 30 states have amended their constitutions to reserve marriage as a

relationship that may exist only between a man and a woman and to prohibit recognition of same-sex marriages; and

WHEREAS, Two lawsuits have been filed in the Circuit Court of Cook County challenging, under the Illinois Constitution, the prohibition of same-sex marriage in the Illinois Marriage and Dissolution of Marriage Act: *Darby, et al. vs. David Orr, in his official capacity as Cook County Clerk*, Circuit Court of Cook County, No. 12 CH 19718; and *Lazaro, et al. vs. David Orr, in his official capacity as Cook County Clerk*, Circuit Court of Cook County, No. 12 CH 19719; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we show our support for the Illinois laws reserving the institution of marriage to one man and one woman; and be it further

RESOLVED, That we oppose any efforts to extend the institution of marriage to 2 individuals of the same sex, whether by statute or by court decision; and be it further

RESOLVED, That we urge the members of the General Assembly, acting under their authority under Article XIV, Section 2 of the Illinois Constitution, to adopt House Joint Resolution - Constitutional Amendment 50, an amendment to the Illinois Constitution stating that "Only a marriage between a man and a woman shall be valid or recognized in Illinois", which if adopted would be on the ballot at the 2014 General Election; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Illinois Attorney General Lisa Madigan, Cook County State's Attorney Anita Alvarez, Cook County Clerk David Orr, and all other County Clerks and State's Attorneys in the State of Illinois.

HOUSE JOINT RESOLUTION 96

Offered by Representative Osmond:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and, in doing so, have gone above and beyond the call of duty to take part in truly heroic tasks; and

WHEREAS, Of the millions of men and women who have served this country with the Army, Navy, Air Force, Marines, or Coast Guard, only 3,468 have ever been awarded the highest military decoration awarded by the United States government, the Medal of Honor; and

WHEREAS, The Medal of Honor is awarded for conspicuous gallantry and intrepidity at the risk of one's life above and beyond the call of duty while engaged in an action against any enemy of the United States, while engaged in military operations involving conflict with an opposing foreign force, or while serving with friendly foreign forces engaged in an armed conflict against an opposing armed force in which the United States is not a belligerent party; and

WHEREAS, It is a true honor for an individual to be awarded the Medal of Honor and serves to distinguish those individuals as true American heroes; and

WHEREAS, Allen J. Lynch was born on October 28, 1945, in Chicago; he grew up in the Lake Eliza area of Indiana, where he attended Union Center Elementary School and Wheeler Junior High School; and

WHEREAS, After graduating from high school, Allen Lynch joined the United States Army in 1964; he was later sent to Vietnam in the fall of 1966 and was assigned to the 12th Cavalry; he served as a rifleman for several months before becoming his platoon's radiotelephone operator; and

WHEREAS, On December 15, 1967, Allen Lynch was serving as a specialist four in Company D, 1st Battalion (Airmobile), 12th Cavalry Regiment of the 1st Cavalry Division (Airmobile); during a firefight near the Binh Dinh Province of Vietnam, he saw 3 wounded soldiers out in the open who were under intense enemy fire; he quickly dropped his radio and went to help the soldiers; under intense fire, he carried the wounded soldiers to safety and single-handedly defended them against the advancing enemy force for several hours; and

WHEREAS, Following this courageous action, Allen Lynch was subsequently promoted to the rank of sergeant and awarded the Medal of Honor for conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty; and

WHEREAS, Allen Lynch's quick thinking and disregard for his own safety were vital in saving those lives, but his fight on behalf of his fellow soldiers did not end on the battlefield; after the war, he settled in

Gurnee and worked for the Department of Veterans Affairs, where he advocated for increased benefits for disabled veterans; he later served as chief of the Illinois Attorney General's Veterans Rights Bureau until his retirement in 2005; and

WHEREAS, Allen Lynch continues his dedication to our nation as a volunteer with the Vietnam Veterans of America organization; he serves as the liaison for the Congressional Medal of Honor Society and frequently gives speeches at military-related events; he also performs ministry work with the Lake County Jail; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the Grand Avenue Overpass over Interstate 94 in Gurnee as the "Allen J. Lynch Congressional Medal of Honor Overpass"; and be it further

RESOLVED, That upon completion of any unfinished sections of highway, the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name; and be it further

RESOLVED, That suitable copies of this resolution be presented to Allen J. Lynch, his family, the Village of Gurnee, the Lake County Board, the Lake County Veterans Assistance Commission, and the Secretary of the Illinois Department of Transportation.

HOUSE JOINT RESOLUTION 97

Offered by Representative Verschoore:

WHEREAS, The Rock River, known for its beauty and ecological importance, flows south through Rockford, then southwest across northwestern Illinois, passing Oregon, Dixon, Sterling, and Rock Falls before joining the Mississippi River at Rock Island; and

WHEREAS, The Rock River provides opportunities for conservation and recreation for many residents of this State; and

WHEREAS, The Rock River has had an important role in Illinois history, and it attracts many tourists each year to such spots as the area in Dixon where former President Ronald Reagan once served as a lifeguard and his favorite fishing spot, now called "Dutch Landing", located just southwest of Lowell Park; and

WHEREAS, Designating the roads along the Illinois portion of the Rock River as a Scenic and Historic Route will encourage residents and visitors alike to explore, appreciate, and enjoy the many wonders of the Rock River; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Rock River Scenic and Historic Route is designated as follows:

- (1) from the Illinois-Wisconsin State Line at Shirland Avenue, along South Bluff Road in Rockton Township to Rockton Road on County Highway 9;
- (2) along Rockton Road from South Bluff Road to Race Street in Rockton;
- (3) along Race Street from Rockton Road to West Main Street in Rockton;
- (4) along West Main Street from Race Street to South Blackhawk Boulevard;
